**Road commencing at end of L11013 extending for a length of 950 metres westward ending at Paddy Mc Donagh’s field gate, all in the townland at Derryherbert, Tullycross, Letterfrack.**

**4. Declaration of roads to be public roads – Section 11 of Roads Act 1993 – Details as follows:-**

**A section of road in the townland of Cill Éinne on Inis Mór, Oileáin Árann extending from the road L52007 at Cill Rónáin Harbour towards and along Tra an Fhrancaigh for a length of 800metres in a northeast direction from Cill Ronain Harbour.**

**A section of road in the townland of Cill Muirbhí on Inis Mor, Oileáin Árainn, extending from the road L52006 westwards and northwards for a length of 990 metres to a junction with the road L5200.**

**A section of the road known as Bóthar na Leachta in the townland of Cill Éinne on Inis Mór, Oileáin Árainn, extending from the end of the road L 52003 at the National School eastwards to the junction with the Tran a Fhrancaigh Road for a length of 260 metres.**

**A section of road in the townland of Cill Éinne on Inis Mor, Oileáin Árainn extending westwards from its junction with the road L52002 known as the Back Road for a length of 45 metres towards Mulkerrin’s house.**
