TEMPORARY CLOSURE OF ROADS

ROADS ACT 1993 – SECTION 75 ROADS REGULATIONS 1994 – ARTICLE 12

NOTICES OF INTENTION

NOTICE IS HEREBY GIVEN that Galway County Council proposes to make an order closing the R-351 from its junction with R-446 Bride Street/Main Street to its junction with the Bohercom Lane from 8.00a.m. on Monday 30th August, 2010 to 5.00p.m. on Friday 17th September, 2010 to facilitate the reconstruction of footpaths on Moore Street, Loughrea.

Alternative Route

Traffic travelling on R-446 Bride St./Main St. wishing to access the northern end of Moore Street will continue along the R-446 Main St. until its junction with L-8278 Piggot St. Traffic will enter L-8278 Piggot Street and continue south until its junction with L-4228 Barrack Street. Here traffic will turn left onto L-4228 Barrack St. and continue eastward until its junction with R-351 Moore St. Here traffic will turn left and continue to Bohercom junction. This is the end of the diversion route.

Traffic travelling from the R-351 Lake Road, L-4228 Barrack St. and L-4213 Cross St. direction wishing to access the Northern end of R-351 Moore St. will be diverted onto L-4228 Barrack St. until its junction with L-8278 Piggot St. Here traffic will turn into L-8278 Piggot Street and continue north until its junction with R-446 Main St. Here traffic will turn right onto R-446 Main St. and continue eastwards until its junction with R-351 Moore Street. This is the end of the diversion.
