Uisce Éireann has reviewed your enquiry in relation to a diversion of Uisce Éireann's watermain and sewer as part of the proposed Development in Oughterard, Co Galway.

Based upon the details you have provided with your enquiry and as assessed by Uisce Éireann, we wish to advise you that, subject to valid agreement/s being put in place, the proposed diversions can be facilitated.

- 1. The applicant shall provide Uisce Éireann with a full CCTV report of the existing sewer prior to entering into a diversion agreement.
- 2. The applicant shall complete full site investigation works to confirm all details on the existing sewer and watermain layouts.
- 3. The applicant shall provide Uisce Éireann with a full detailed design package of the diverted sewer and watermain for Uisce Éireann to review and is subject to Uisce Eireann approval prior to entering into a diversion agreement.
- 4. The applicant shall enter into a Diversion Agreement with Uisce Éireann prior to any works commencing on site.
- 5. The applicant shall provide Uisce Éireann with a wayleave through the private lands, so Uisce Eireann have full access to the sewer and watermain in order to access for maintenance purposes.

You are advised that this correspondence does not constitute an agreement in whole or in part to provide a diversion to any Uisce Éireann infrastructure and is provided subject to diversion agreement being executed at a later date. You are advised to make contact with the diversions team at <u>diversions@water.ie</u> once planning permission has been granted and prior to any works commencing on site in order to enter into a diversion agreement with Uisce Éireann Water.
