Road Commencing at its junction with house no 239 and extending East for a distance of 254m ending outside house no 211 in the Townland of Demesne.

Road Commencing at its junction with house no 53 and extending West for a distance of 221m ending outside house no 76 in the Townland of Demesne.

Point H on TIC Map

Road Commencing at its junction with house no 203 and extending East for a distance of 221m ending outside house no 180 in the Townland of Demesne.

Point J on TIC Map

Road Commencing at its junction with house no 81 and extending North West for a distance of 131m ending outside house no 97 in the Townland of Demesne.

Point K on TIC Map

Road Commencing at its junction with house no 104 and extending North East for a distance of 72m ending outside house no 109 in the Townland of Demesne.
