Normal place of residence means the domestic housing unit where a person lives and resides overnight for more than 183 days per year.</p> <p>3. <u>One</u> Parking Permit only, will be issued per household.</p> <p>4. ‘Vehicle’ means a private motor car, a station wagon, or a passenger vehicle having accommodation for not more than seven passengers excluding the driver, and liable for taxation class ‘Private’.</p> <p>5. A Parking Permit shall be valid for one year from the date of issue.</p> <p>6. The fee for a Parking Permit shall be €10.00.</p> <p>7. A valid Parking Permit shall be displayed in the interior of the vehicle in respect of which it is issued, so that it can be read from outside the vehicle.</p> <p>8. If the holder of a valid Permit ceases to reside at the address given on the island of Inisbofin or ceases to be the owner of the vehicle specified on the Permit, the Permit is no longer valid and must be returned to Galway County Council.</p> <p>9. The renewal of a Permit is the responsibility of the Permit holder.</p> <p>10. The Parking Permit must be renewed within the renewal period, which ends 28 days after the expiry date of the existing permit. Fixed Charge Offence notices issued 28 days after the expiry of a Permit will be valid.</p> <p>11. Galway County Council will cancel and withdraw, or refuse to renew any Parking Permit where it establishes, that the permit holder has obtained the permit, by the submission of inaccurate information or documentation.</p>
