

# YOUTH / COMMUNITY BUS DECLARATION

**RF8C**

*Article 3 of the Road Vehicles (Registration & Licensing) (Amendment) Regulations 1992 provides that a Licensing Authority must be satisfied that a vehicle is correctly taxed. In this regard, this Declaration must be completed to assess eligibility for this tax class, i.e.*

- *That the Club/Organisation is a properly constituted and recognised organisation.*
- *That the vehicle is either a bus or a minibus and has seating capacity for more than 8 passengers, i.e. minimum of 9 passengers + 1 driver = minimum total of 10 seats.*

*Documentary evidence may be requested or the vehicle may be inspected to confirm the tax class.*
