- The maximum fee payable for an outline application: €8,500
- The maximum fee payable in respect of a reduced fee: €9,500
- The maximum fee payable in respect of retention: €125,000
- The maximum fee payable in respect of any application: €38,000
- The minimum fee payable: €4
- In the case of an outline permission, three-quarters of full fee is payable.
