

Mr Chairman and Gentlemen,

The ro ds in the Rural District are in very poor order just now, and considering that the past fer months were the most important during the year for the surpose of road making, it is much to be reguested that contractors did not take advantage of this and make some serious effort to carry out the terms of their contracts. In very fer c ses indeed has any genuine attempt been made to meet or prepare for the works mentioned in the specifications. It was strongly impressed upon contractors in all previous reports to District Council meetings that at least half the specified qu ntity of suitable material should be spread before Christmas. This caution has been practically neglected. Along with the principal work of the supply of material being neglected, that

- 9.—The well at Oghilbeg is not kept clean : a pump should be erected here. The well at Liscune is liable to pollution from cattle.
- 10.—The sewerage of Lawrencetown is defective.

Copy of Extracts from Sir Acheson McCullagh's Report dated the 28th December, 1907.

I.—The District Council meet regularly on the first Saturday in each month for the transaction of Public Health business. The meetings ought to be held fortnightly.

2.—There are four Sanitary Sub-Officers in the District. They reside in convenient positions, They do not appear to do very much work. Sanitary Sub-Officer Hession does practically nothing. I have had to make the same report regarding him at each inspection. Sanitary Sub-Officer Connolly made 4 reports in the last 12 months; Sanitary Sub-Officer Beegan, 9; Sanitary Sub-Officer Beegan, 9; Sanitary Sub-Officer Connor, 11; and Sanitary Sub-Officer Hession, 4. With the exception of Sanitary Sub-Officers Beegan, all the Sanitary Sub-Officers keep diaries showing the sanitary work which they perform.

3.—There is no Inspector of Dairies, Cowsheds, and Milkshops in the District.

4—There is no systematic inspection of the meat, and milk supplies in the District.

5.—I think all the Medical Officers, except, perhaps Dr. Callaghan, should send in more reports, and would probably do so were the Sanitary Sub-Officers more active. Dr. Rossiter, Medical Officer, made 5 reports to the Sanitary Authority since last inspection ; Dr. Gavin, Medical Officer, 8 ; Dr. Fair, Medical Officer, 7 ; Dr. Egan, Medical Officer, 8 ; Dr. Callaghan, 16. The Council consider monthly meeting quite sufficient.
