I will feel so much obliged if you be kind enough to explain its nature to them as my position does not admit of my doing so in person however should any of the Guardians wish to call I will feel most happy to show them the Convent and explain its duties as regards the Poor. It would be really difficult to say what portion of the Convent is not for them - merely our little sleeping Rooms. In the first place one wing of the House belongs to the service of the Religious, the second to the Schools and

and all the Rooms on the ground floor are merely stores where Potatoes, turf &c are at present kept and even the Kitchen is made a Dining Hall where the most destitute of our children are relieved as far as our small means will permit. I feel assured it is only necessary to explain all this to the Guardians and that they will admit that this Institution is quite different from all other Religious Establishments being entirely devoted to the service of the Poor.

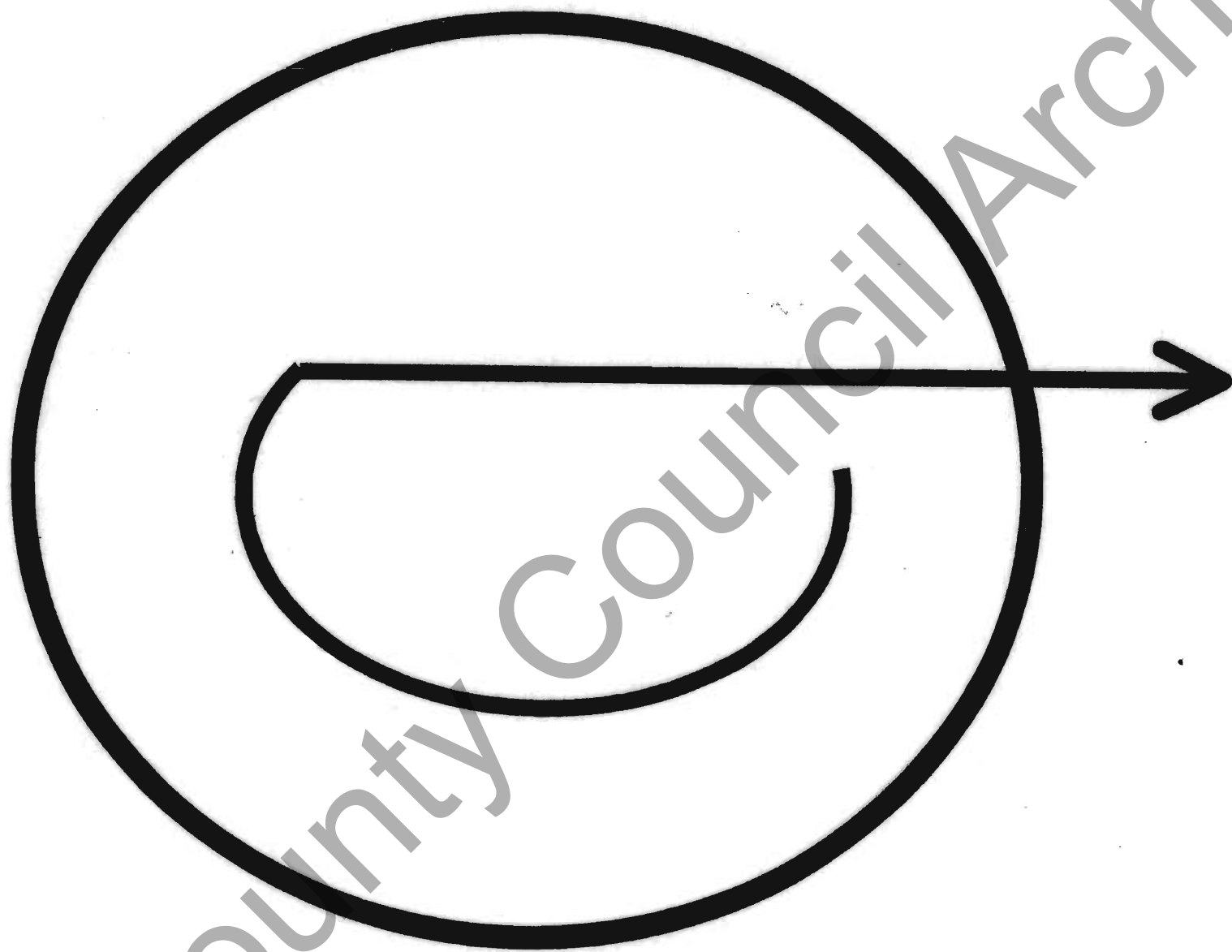
