 all consequent upon one visiting ticket
 horses, cars and boats. cost me at
 least sixty pounds a year. I have
 then fifty to pay for everything else

 known to most of you -

The increase was fully considered and approved in a very large meeting of the Board, with but one dissentient voice, except the Roffin increase which was carried by a large majority of the Board. The Board have long felt the very inadequate Salaries of the Medical Officers for the very arduous and important duties they

perform, and which few but those who reside on the spot can form an estimate - They refrained from increasing the rates, while the entire burthen lay on a highly rated district. But the treasury grant having come into operation they conceive it to be only just to make reasonable provision for the Medical Officers - After allowing the reasonable allowance the rate will not be much or at all above half of the former rate -

As to the proposal to divide the Dispensary District of Roundstone - the Board beg to state that the present Medical Officer has discharged the duties of said district for over 19 years in a most efficient and satisfactory manner, besides discharging Lettermore Dispensary duties for 5 years with perfect satisfaction to all parties -

The Board respectfully urge on the again matured consideration of the proposed increase in the Dispensary Medical Officers Salaries. That the Comrs will be pleased to sanction the course the Board have so long decided on - The Board would further remark that the emolument derived by the Roundstone Medical Officer in respect of vaccination and Registration fees set down by Mr Kelly, at £80 a year do not on an average amount to one half that sum yearly.

In reply to the letter of the Poor Law Commissioners of the 21st Inst N^o 10245 - ~~set~~ in reference to Dr Ronghan's report of his inspection of this Dispensary we beg to say in the first place with respect to my visiting persons without demanding tickets that in no instance

whatever has a ticket been refused to any applicant although there are a number of persons residing on these Islands well able to pay for medical attendance - The issuing of tickets under these circumstances where no distinction is made as to the means of the applicants has always appeared to me to be a matter of little or no import, and I have consequently long ceased to ask for them, but give attendance to all applicants alike - The cancelling of tickets to my mind is little better for the Law requires that the Medical Officer shall do the work first and get the ticket cancelled afterwards a very different state of things to this prevails in the English Poor Law where the Medical Officer has a right to refuse his attendance in the case where the ticket or order has been illegally issued i.e. where the applicant is not a pauper nor entitled to be pauperized -

I quite agree in opinion with Dr. Rouphan that a Relieving Officer who would make himself thoroughly acquainted with the circumstances of each individual and act accordingly would be a great improvement on the system hitherto prevailing -




