SIR,

THE Commissioners for administering the Laws for the Relief of the Poor in Ireland, transmit to you herewith, in duplicate, a Form for a *Return of the progress of the Collection of Poor Rate in the Union*, for the month of July, and they request that, if possible, you will transmit this Return on or before Thursday, the 9th Instant, having first submitted the Return to the Guardians for their inspection.

You are particularly requested to fill up Column 2, of the Return, *after strict examination*, showing the date on which the time allowed in the Bond for the completion of the Collection expired or will expire.

The Amount of the Lodgments entered in Column 15 should correspond with the Amount of the Lodgments entered in the Summary of the Return of Liabilities and Expenses for the month of July.

If, however, the detailed Return cannot be furnished by the 9th Instant, you will have the goodness to send up, in advance thereof, on or before that day *without fail*, the particulars required by the annexed Form, which can be taken from the Treasurer's Book of Receipts and Payments.

Principal Day Room stated to be 125 feet in length by $16\frac{1}{2}$ in breadth can accommodate 340 inmates at dinner, nor do they think that 54 Tables can be placed in this apartment without much overcrowding.

The Commissioners are informed that the Cubic Contents of the 3 Dormitories for Children which are also their day rooms, are only 19,210 Cubic feet, which if three hundred Children were placed in the rooms, would only give an average of 64 feet for each - The Commissioners would

would therefore suggest that one of these dormitories namely No 4, should be used as a day room, and the other two, viz Nos 2 and 3 as sleeping apartments, in which one hundred children at most, may be accommodated.

The total space of the remaining fifteen sleeping rooms is sixty thousand one hundred and fifty six feet, which the Commissioners are of opinion would accommodate three hundred and fifty adult females, assuming that adequate Day room be provided

provided for them. As however
you do not make any
reference to day rooms with
the exception of N^o 1, which
is also proposed to be the
dining hall, the Commissioners
are led to assume that you
propose that all the Rooms
should be used as Dormitories.

I am to state that the
Commissioners cannot concur in
this view, and they would suggest
that one third of the fifteen
rooms should be used as
Day rooms and the remainder

would

would afford sleeping
accommodation for two hundred
and forty inmates.

I still am of opinion, that 900 persons, may be safely accommodated in the House, viz. 600 Adults and 300 children, - the majority of the latter being of the age from 2 to 9 years. - The number I have laid down, may to a party not thoroughly acquainted with the situation of the House appear excessive, but taking into consideration the very salubrious position,

th

The elevation, and other capabilities of the building, together with the excellent system of drainage, and sewerage which has been adopted; and likewise the most perfect and thorough ventilation which it enjoys, and which surpasses any similar building which I have as yet witnessed, I do consider it capable of accommodating more paupers, with safety to their health, than any other Workhouse of its size in Ireland. The Day Room is 125 feet long

long, by 16½ wide, and 11 feet high - it can readily accommodate 540 paupers at Dinner, there being 54 tables, and 10 persons at each table, though the number never can be at one time in the Day Room, as a great number of the Paupers (over 100) are scattered about the Building at various employments, in the Kitchen, Washhouse, Bakehouse and elsewhere.

It might be desirable in the summer time, to have some
Wooden

wooden sheds erected round the yard, where the paupers could sit and work during the day time, and so diminish the number in the regular day room. - The three rooms used by the children as Day Rooms, and sleeping Rooms, and from which the beds are entirely removed during the day, are dry, well ventilated, and well lit, and the strictest attention is paid to cleanliness. It certainly would be an advantage, if a school

Room

Room was constructed for the
use of the children, to be used
likewise as a Day Room, and
Dining Hall - this is all I
think, that is required, to make
the House perfect. - I would here
remark, that nothing can
exceed the good health of
the paupers, both adults and
children since their removal
to Bunnowen - they have been
there since the 29th of May, and
no case of illness of any
consequence has as yet occurred,
while the general appearance
of

of every patient has much
improved.

GENTLEMEN,

With reference to the several sums advanced during the month of July last, in the *Clifden* Union, towards the current expenses of providing for the Relief of the destitute Poor, the Commissioners for administering the Laws for Relief of the Poor in Ireland request that you will have the goodness to furnish, as soon as practicable, a detailed account of the manner in which such advances have been expended, made up from the usual vouchers, in the Forms enclosed for the purpose, in continuation of the account required down to the close of June last, in pursuance of the Commissioners' Circular of the 13th July, No. 451—M/49.

As the advances have been made to be applied exclusively towards the current expenses for the support of the Poor, the Commissioners request that the date of the receipt of each advance may be given—the amount of each advance—and the manner in which the same was expended; specifying the several items of payment—the date of each payment—the account on which each item was paid—the week or other period for the supplies of which each payment was made—and whether the proper voucher for each payment has been duly lodged in the Clerk's Office.

The Commissioners request that the account may be certified by the Temporary Poor Law Inspector of the Union, previously to being transmitted to this Office.

The Commissioners for administering the
Law for Relief of the Poor in Ireland
have had before them the returns relating to
the Relief afforded in the Clifden Union, during
the weeks ended the 28th July and 4th Instant
respectively, attached to Minutes of your
proceedings on the 7th Instant, from which
they observe that 126 persons quitted the
Workhouse during the previous week, and
that only 684 persons remain on the
out-door relief lists, under the Direction
of

of the Act 10 Vic Cap 21.-

The Commissioners have advised me to request that you will at once take the subject into your consideration, with a view to relief being afforded only in the Work House, to persons not coming under the 1st Section of the Irish Poor Relief Extension Act, - who may still be destitute.-

The Commissioners think that accommodation might be provided in the Work House for testing the destitution of the persons now on the out-door relief lists, in all doubtful cases, by discharging from the Work House some of the present inmates who are not now in a destitute condition, only affording some of the inmates relief out of the Work House.-

The Commissioners are further
of

of opinion that a considerable reduction of the numbers receiving relief under the 1st Section of that Act, should also be now made.

The Commissioners have given instructions for the renewal of the order authorizing you to afford out-door relief to classes of poor persons not coming under the 1st Section of the Act 10 Vic Cap 21. for one fortnight, but they request that you will be good enough to consider whether the order may not be modified considerably at the end of that time.-

The Commissioners request that you will furnish, from the Treasurer's Rate-in-Aid Cash Book, the required Abstract, with the least possible delay; and you will include in the Abstract the names of those Electoral Divisions only in which new Rates were made since the receipt by the Guardians of the Commissioners' Order of the 13th June, 1849, down to the 4th August, 1849, inclusive.

If no new Rates were made in any of the Electoral Divisions down to the 4th August, 1849, inclusive, you will be good enough to send up one of the Forms, stating the fact thereon.

SIR,

The Commissioners for administering the Laws for Relief of the Poor in Ireland forward herewith a Copy of the Act 12th and 13th Vic., cap. 104, passed on the 1st instant, to amend the Acts for the more effectual Relief of the Destitute Poor in Ireland.

They propose to forward additional Copies for the use of the Board of Guardians, when provided with them; and they will then direct the notice of the Guardians to the various clauses altering the Enactments hitherto in force, or containing additional provisions relating to the administration of Relief.

The Commissioners now desire more immediately to direct attention to the 21st Section of this Act, which requires,—

1. That before the making of every Rate, (that is, before the signatures requisite for its legal completion are affixed,) the Guardians shall leave the Rate Books open for the inspection of Rate-payers, during fourteen days, and shall give public notice thereof in the same manner as they are now required to give notice that a Rate is made.
2. That in all cases the names of Occupiers for whom their Immediate Lessor is primarily liable for payment of the Rate, shall be inserted in the Rate Books.

The Guardians will see that it is necessary to make all future Rates in conformity with these provisions; and in reference to the first, the Commissioners are about to prescribe a Form of Rate which may be more conveniently applicable than the present Form. With regard to Rates, however, already in preparation, the Commissioners recommend that the names of Occupiers, for whom their immediate Lessors are primarily liable, pursuant to Act 6 & 7 Vic., Cap. 92, be inserted in the *third* column of the present Form, headed, "Description of Property Rated," which will be a sufficient compliance with the Act, in each case placing the name of the Occupier under the description of the property held by him.

The *sixth* column, headed "Occupier," is only applicable to Occupiers on whom the Rate is made, and should not be used in any other case.

The Notice to be given when a Rate is prepared, may be in the Form annexed, and must be published by posting it on the principal door of every Church, Chapel, or other place of Public Worship, in each Electoral Division of the Union, and at the other usual places therein, for posting Public Notices. The Notice must also be published in one Newspaper circulating in the County, if any portion of the Rate shall be for repayment of the Temporary Relief Advances, under Act 10 Vic., Cap. 7, *but not otherwise*.

It is important to observe, that this Notice will not supersede the Notice to be given when the Rate is actually signed, which must still be given pursuant to the Act 1 & 2 Vic., Cap. 56, Section 70.

MINUTE.

POOR LAW COMMISSION OFFICE, DUBLIN,

21st August, 1849.

The Board took into consideration the following matters:—

1. The abundant employment likely soon to be afforded generally to the labouring class by the Harvest operations;
2. The Sealed Orders still outstanding under the 2nd Section of the Poor Relief Extension Act;
3. The debts of the Unions which are at present under the management of Vice-Guardians;
4. The Rates which are, or ought to be, in preparation in those Unions, for prompt collection after Harvest;
5. The Workhouses and buildings now used as additional Workhouses in those Unions;
6. The discontinuance of the services of Vice-Guardians, which will take place on the 1st November next:

and the Board directed the following statement of their views to be recorded on the Minutes:—

That, in the few Unions in which relief is now given to any class of able-bodied persons out of the Workhouse, such relief ought, if possible, to be discontinued from and after the 31st instant.

That, during the interval which may elapse before the discontinuance of the services of Vice-Guardians, they ought to avail themselves of the diminished pressure of distress, and take every practicable step for restoring the management of the Unions to their respective Boards of Guardians, in a condition favorable to the success of the future administration of relief, especially with the view of improving the state of the finances; and, secondly, of obviating, as far as may lie in their power, all necessity for resuming hereafter the practice of relieving able-bodied persons out of the Workhouse.

Keeping these points in view, it is the duty of the Vice-Guardians to make and collect, with all convenient despatch, such Rates as they may find necessary to meet the requirements of the several Electoral Divisions in the Union, and as they may consider there is a reasonable prospect of collecting promptly after Harvest.

They should likewise apply themselves to the consideration of the existing Workhouse arrangements, both as regards the main Workhouse and the Auxiliary buildings used as additional Workhouses. The disadvantages felt in reference to the latter have been their inappropriateness, generally, to the purposes of discipline and classification, and the expense of maintaining such establishments separately from the main Workhouse. It appears to the Commissioners, that the Vice-Guardians should apply themselves, at this season, to remedy these disadvantages as far as practicable. It is of essential importance on the one hand, that the Boards of Guardians should have at their disposal as much Workhouse accommodation as can be obtained without too great a sacrifice in Establishment charges; while at the same time it is clear, that the value of such accommodation will altogether depend on the character of the arrangements, and that if the latter are not such as to insure the preservation of order and discipline, the occupation of the buildings used as additional Workhouses will tend only to an increase of expenditure, and not to an efficient administration of relief.

It is further essential to the future success of the administration of the law, that the Workhouses should be restored to the management of the respective Boards of Guardians in such a state as will enable them to use the test of admission to the Workhouse without danger to the health of any class of recipients of relief; and with this view, the Vice-Guardians should take advantage of the present season to have every building in succession thoroughly cleansed and purified, the necessary whitewashing done, the cesspools emptied, and all the pumps, sewers, and drains placed in good working order.

Any defects still existing in the means of ventilation should likewise be remedied. Another important arrangement as a sanatory precaution, is the provision beforehand of sufficient stocks of bedding and clothing to meet any sudden pressure of applications for relief, and to obviate the practice sometimes caused by the want of such preparation, of permitting newly admitted inmates to remain for a time in their own clothing.

It is extremely desirable that any steps which may still be wanting to perfect the arrangements for the industrial employment of the several classes of inmates, should be taken before the Vice-Guardians leave office.

Ordered,—That a copy of the above Minute be sent to the Inspectors and Vice-Guardians of the Unions at present under the management of Vice-Guardians.

Sir,

1. The Commissioners for administering the Laws for Relief of the Poor in Ireland transmit herewith for the use of the ^{New} Guardians of ^{Cliffden} Cliffden Union, copies of the Act 12 and 13 Vic., c. 104, which received the Royal assent on the 1st August, 1849, to amend the Acts for the more effectual Relief of the Destitute Poor in Ireland; and the Commissioners desire to call attention to some of the provisions of this Act, which materially alter the present state of the law.

2. The first section of the Act lays down a new rule for determining the chargeability of persons making application for relief after the passing of the Act, and declares, that "for the purpose of charging the expense of relief to any Electoral Division, every person making application for Relief shall, after the passing of this Act, be deemed to have been resident in such Electoral Division in which, during the period of three years next immediately before his application for relief, he shall have been longest usually resident, whether by usually occupying any tenement situate, or by usually sleeping within, such district. Provided always, that where any such person shall not have occupied a tenement, or slept within any such Electoral Division for at least twelve months in the whole during the said period of three years, the expense of the relief of such person shall in such case be borne by, and charged against the whole Union in which he or she is relieved." This section further provides, that "where any person chargeable to any Electoral Division shall have received relief, and shall cease to be relieved, and shall thereafter, within the period of twelve months again begin to receive relief, such last mentioned relief shall be chargeable on the Electoral Division to which such person was in the first instance chargeable." It is also provided by the same section, that the cost of the relief of "destitute poor who shall not have resided in the Union where such relief is given, for the last three years next previous to receiving such relief," shall be charged, according to the Act 10 Vic., c. 31, § 12. The effect of this last proviso is to separate the persons relieved into two distinct classes, namely,—those who have resided for the three last years within the Union, and those who have not so resided; and the chargeability of the former class is regulated by the new rule of residence laid down in this section, while that of the latter will be according to the law as it stood before the passing of this Act.

3. It is provided by section 63 of 1st and 2nd Vic., c. 56, that certain hereditaments exclusively used for charitable or public purposes, should not be rateable, "except where any private profit or use shall be directly derived therefrom, in which case the person deriving such profit or use shall be liable to be rated as an occupier, according to the annual value of such profit or use." Doubts having arisen whether, under these provisions, persons in receipt of rent for such hereditaments are rateable in respect of the same, the 10th section of the present Act declares, that in any Rate made after the passing thereof, every person receiving rent in respect of any hereditament exempt from rating under 1 & 2 Vic., c. 56, shall be liable to be rated in respect of such rent to the extent of one-half the poundage of every Rate assessed upon the Electoral Division in which such hereditament is situate. And such Rate is recoverable from the person liable by the same means as Rates are recoverable directly from Immediate Lessors in respect of tenements valued under four pounds, pursuant to 6 & 7 Vic., c. 92, § 2. It is desirable that the Guardians should take immediate steps for ascertaining all the cases of this kind existing in each Electoral Division of the Union.

4. Sections 15, 17, and 18, contain provisions for more simple and effectual proceedings for the recovery of Rates in certain cases. Section 15 declares that any action or suit brought by Guardians in the Superior Courts in Dublin for the recovery of Rates, shall be an action of assumpsit or debt, and provides for the adoption of a short form of declaration. Under § 17, a Civil Bill Decree for Poor Rates may be filed as a judgment of any of the superior Courts of Law in Dublin, and be deemed a record of such Court, having the same force and effect as a judgment of the Court. Section 18 declares that decrees so filed and

any judgment obtained for Poor Rates in an action or suit in any of the superior Courts, shall, after registration, be a charge on the lands, and have priority as such over all other charges and incumbrances whatsoever, except Crown and Quit Rents, Tithe Rent Charge, and Charges, if any, already existing under the Drainage Act 5 & 6 Vic., c. 89, and the Land Improvement Act 10 & 11 Vic., c. 32.

5. Section 19 provides that no proceeding shall be taken for the recovery of arrears of Poor Rates against any person not primarily liable to pay the Rate, after the lapse of two years from the making of such Rate. This provision, however, applies only to Rates made after the passing of the Act, and does not extend to the recovery of Rates made before the passing of this Act, nor to the recovery of Rate from the person liable in the first instance to pay it, whether such Rate be made before or after the passing of the Act.

6. Section 30 gives power to proceed by Civil Bill against an Immediate Lessor for Rate to which he is primarily liable, before the Assistant Barristers for the County, and in the Division in which the tenements rated are situated, on serving him, or his known Agent, or the receiver of his rents, with fourteen days' notice of the proceeding about to be taken against him by service of process; and the service of process on the Immediate Lessor, or his known Agent, or receiver of his rents, at any place out of such Division and County, are declared to be as effectual as if made within such Division.

7. The 24th Section of the new Act requires that the Guardians of each Union should cause books containing the names of the persons relieved out of the Workhouse, arranged under the heads of the Townlands on which they are stated to have last resided, to be kept for the several Electoral Divisions and the Union at large; and such books are to be open to the inspection of Rate-payers from 10 to 4 o'clock on one day at least in each week. Section 25 requires that a statement should be prepared and posted on the door of the Workhouse on every Saturday, showing the number of persons relieved in the Union during the seven days next preceding, either in or out of the Workhouse, and the numbers chargeable against the respective Electoral Divisions, and the Union at large. The Commissioners will cause forms to be prepared and transmitted to you for these accounts, and it will rest with the Guardians to determine the day in each week on which the list of persons receiving relief will be open for inspection at the Workhouse.

The Commissioners request that the account may be certified by the Temporary Poor Law Inspector of the Union, previously to being transmitted to this Office.

I AM directed by the Commissioners for administering the Laws for Relief of the Poor in Ireland, to state that they have caused Forms of Books for entering the names of persons relieved and charged upon the several Electoral Divisions and the Union at large respectively, in pursuance of Section 24 of 12 & 13 Vic., c. 104, to be prepared; and such Books should be immediately procured in the usual manner.

A separate Book is required to be kept for each Electoral Division, and one for the paupers chargeable to the Union at large. The Form for the Books is annexed hereto. These Books are required by Section 24 of the above Act, to be left open to the inspection of all persons assessed to the Poor Rate within the Union, from ten in the forenoon till four in the afternoon, on one day at least in each week; and the Guardians should give public notice of the day which they may select for that purpose.

In the Book for the Union at large, one or more separate pages (according to the population and probable number of applicants for relief) should be reserved for each townland in the entire Union, and the names of all persons admitted to relief and charged to the Union at large, should be entered under the head of the townland in which they are stated to have last resided, a separate series of numbers (to be entered in the 1st Col. of Form I), being employed for each townland.

In the Book for each Electoral Division, one or more separate pages should, in the same manner, be reserved for each townland in that Electoral Division, and the names of all persons admitted to relief and charged to that Electoral Division, should be entered under the head of the townland in the Division in which they are stated to have last resided according to the Register.

The names of all persons previously in receipt of relief, who may be re-admitted to the Workhouse, or again allowed Out-relief, should be entered anew with a proper reference in the 7th Col. to the number in the 1st Col. corresponding to the previous entry of their names under the head of the same townland.

Annexed is also the Form for the statement of the numbers relieved in the Union, and chargeable against the several Electoral Divisions and the Union at large respectively, to be posted each week on the door of the Union Workhouse, in pursuance of Section 25 of the same Act. The Forms for this purpose should also be procured in the usual manner, without delay.

The Commissioners for administering the Laws for Relief of the Poor in Ireland request your attention to the provisions relating to non-resident Justices qualified to be Ex-officio Guardians, in the 7th section of the new Act, 12 & 13 Vic., c. 104, for the amendment of the Acts for Relief of the Destitute Poor.

This section provides, that in any Union in which the number of Justices qualified to be Ex-officio Guardians, according to the Acts previously in force, shall, on the 29th September, in any year, not be equal to the number of Elected Guardians, then every Justice acting for any County, and otherwise qualified to be an Ex-officio Guardian of any Union within such County, and who shall be seised, possessed, or entitled, for his own use and benefit, of or to any Lands or Hereditaments within such Union, or in the rents and profits thereof for any life or lives in being, or for any term of twenty-one years at the least, such Estate being of the yearly value of Fifty Pounds at the least, shall, for the year next following such 29th September, be an Ex-officio Guardian of such Union, although not resident therein.

You should accordingly, on the 29th September next, and in each subsequent year, ascertain whether the number of resident Justices qualified under the 23rd section of the Act 1 & 2 Vic., cap. 56,—that is, being a "Justice of the Peace residing in the Union, and acting for the County in which he so resides, and not being a Stipendiary Magistrate or Assistant Barrister, or a person in Holy Orders, or a regular Minister of any religious denomination,"—is less than the number of Elective Guardians. If it be, you should then ascertain whether any Justices resident out of the Union possess an Estate in the Union of the kind and value prescribed in that enactment. In ascertaining this, the Statements of Claims to Vote in the Election of Guardians, under section 4 of 1 & 2 Vic., c. 56, and section 24 of 6 & 7 Vic., c. 92, and the Registers thereof which are required to be kept, may assist you; and you should avail yourself of any other sources of information that may be open to you. Even where parties who may be qualified to be Ex-officio Guardians under the provisions above cited, do not claim or wish to act, they are, nevertheless, invested with the office; and it is important to ascertain precisely, at the 29th September in each year, what the entire number of Ex-officio Guardians may be, and what parties possess the privilege to act.

In case it be found that the number of non-resident Justices so qualified would, when added to those qualified under 1 & 2 Vic., c. 56, exceed the number of Elective Guardians, it is further provided, that of the highest rated of the non-resident Justices qualified under 12 & 13 Vic., c. 104, such only shall be entitled to act as will make the whole number of Ex-officio Guardians equal to that of the Elective Guardians; the highest rated Justices being in such case ascertained in manner provided in section 16 of 10 Vic. c. 31.

If the number of Justices qualified according to the original provisions in section 23 of 1 & 2 Vic., c. 56, exceed the number of Elective Guardians, you will, in like manner, proceed in accordance with the 16th section of 10 Vic., c. 31, as pointed out in the Commissioners' Circular of 16th September last.

1st I beg leave to state that on my return to this County the latter end of last March I visited the Letterpack Depot the day but one after my arrival when I immediately discovered that about 200^{lb} of meal had been that week misapplied, and also that this had been in the habit of occurring on previous weeks to a greater or less extent, on my informing Mr. Deane of this, he dismissed the person who had acted so, but I respectfully submit it was his duty by proper attention on his part, to prevent such things happening at all -

2nd On my next coming to this County the beginning of last month, on meeting Mr. Deane at the same depot of Letterpack

I mentioned to him that I understood that there were very great abuses going forward at the Tully depot, about four miles from this and quite unconnected with my district or property, and that Burke the Relieving Officer ^{there} was giving the most indiscriminate relief.

I can prove that pigs have been fattened in the town of Clifden on the relief stirabout, purchased at so low a rate, that ~~it~~ a butcher made in one fortnight a profit of £1.10.0 on two pigs fed on it. Mr Dopping the Resident Magistrate tells me this and can substantiate the fact - I can also prove that sporting dogs in the same town have been fed on it.

Must now be entered into to supply the Poor House with Coal from the town of Galway 40 Irish Miles off, in consequence of the able-bodied paupers having been employed in making flower beds within the precincts of the Poor House in place of cutting turf on a bog close to it. 

Adverting to the request contained in the Commissioners' circular letter of the 7th August, 1848, that the Guardians of the Union, should bind each Collector to collect the amount of Rate set forth in his Warrant, within such a term (to be specified in the Bond) as should at the time appear to be sufficient for the performance of the duty, and in no case to receive a Bond, allowing an unlimited time for the collection,—the Commissioners for administering the Laws for Relief of the Poor in Ireland desire further to suggest to the Guardians, that the object of the letter above referred to, viz., the impartial and speedy collection of the Rates, will be additionally secured by the Guardians requiring each Collector, at the expiration of the time allowed in his Bond for the collection of the Rates, to balance his accounts, and fill up a form which the Commissioners have prepared for the purpose, copies of which form are enclosed.

I. The Commissioners request therefore, that the Guardians will direct duplicate copies of the form to be supplied forthwith to such Collectors as may now be under Bond to collect rates within a limited period, (*not yet expired*), and that they will acquaint such Collectors that they are required to balance their accounts and fill up the form prepared for the purpose by the Commissioners, immediately after the period allowed in their Bond has expired, in order that such form may be submitted to the Guardians, and to the Commissioners, with a view to the consideration of the proceedings necessary to be taken on the Bond, in case any Collector shall have failed to close his collection within the time allowed, or at least to give a satisfactory explanation of the delay.

II. With respect to any Collector who may have been bound to collect within a limited term, which *has already expired*, the Commissioners request that the Guardians will direct such Collector forthwith to balance his accounts and fill up one of the forms prepared for the purpose.

III. With respect to Collectors who may at present be collecting under Bonds which do *not fix* a limited term for the collection, the Commissioners request that the Guardians will require these Collectors also to balance their accounts, and fill up the form prepared for the purpose by the Commissioners, within such a period, commencing from the present time, as shall appear to the Guardians to be sufficient to enable the Collectors to close their accounts by using proper exertions in the interval.

The Commissioners desire to be informed of the steps which the Guardians may take in this matter, in pursuance of the Commissioners' request, and they therefore enclose a form of Return relative to the Bonds of the Collectors, which you will have the goodness to fill up after the subject of this letter has been considered by the Guardians.

The Commissioners being of opinion, that the Guardians may be desirous to communicate to the several Collectors the wishes of the Commissioners on the subject, direct me to enclose printed copies of their letter.

Forms of Bonds, with Warrants annexed, for collecting within a limited time, have been prepared, and may be obtained in the usual way, which are applicable as securities for the collection of successive Rates.

During part of my attendance as
Medical Officer at one of the fever Hospitals
in this Union, namely the Ballinacorney Hospital,
fever Hospital, I was allowed but 5^s per day
by the Central Board of Health, in consequence
of the remuneration being so very small and as
it was (according to the written instructions
of the Board) no part of my duty to compound
the necessary medicines for the Hospital, the
then Relief Committee at one of their meetings
passed a resolution which was entered on their
minute book to the effect that I should
have 4^s per day for that particular

only I was paid that sum from the
Commencement of my attendance up to
1st November 1847 at which time the
Committee ceased to act, the Management
of the Establishment then passed from
them into the hands of the Board of
Guardians of the Union, four of whom were
Members of said Committee, during the
existence of the Board of Guardians the
funds at their disposal were so low
that I thought it perfectly useless to ask
for payment and therefore rec^d no remuneration
during their time for the duty already
referred to, the Vice Guardians succeeded
them, and the Union still remaining
embarrassed, I followed my claim to go
on

on for some time longer, at length when
I sent in my bill (the amt of which is £35/16/9
that is from Nov 47 to 28 of April 1848
at which period (28 April) by the particular
Order of the Board of Health, I went to
the Pallinure Electoral Division to reside
at an increased salary, the Vice Guardians sent
me a written reply to say that they had
no power to allow it it is so that
Gentlemen pretty evident that I ought to be
paid by the Union, as it is in my opinion
at all events a perfectly just and legal debt
for resolution as I said before was regularly
entered on the Minute-book, the
Management of the Hospital with
all
