Leabharlanna Connóae na Saillime

LITRIDEACT NA SAÉDILGE FÁ LÁTAIR.

Duine ar bíe a bfuil oréacta nó áobair leabhair aige aoir tá veir aige le n-a éir i gcló ó curpeaó Coirpe na leabhar ar bun i mDaile áca Cuat. D'féoir nac bfuil an Coirpe céatona raor ó éionta, ac, bíoó nó ná bíoó, ip móir ip ríú a leirve a veit ann.

Áobair ácair to gac ríor-Saéveal an t-árfár reo atá a' teact toon teangca, agus aicbeoócan é atá ina 'Lán veoil' as curó de ríoláirí léiginn agus lairne na nheorpa inoiu. Anurairó éis an rgarmanac ainmneamail rin, Thurneyren, cuairt ar an tír reo, agus, de baip a éirair, curpeaó Coirpíúin ar bun le Láirrgíbhne Saédilge a ríinníú agus a foillrú. Níl ac aon Imleabair amáin curca i gcló as an rCoirpíúin rin fóir, ac, mar rin féin, níl aon duine dáir léig an t-Imleabair rin nac n-abrócairó rir ionmólta an raotair atá ar bun aca.

Leir an toul ar aghair atá an teangca a déanann tá baramail Lárorir aghainn rir rgarir rir féoirí gac áobair a múnacó éirce san aon roóocaíal. Tis linn a ráó so bfuil túr curca ar rin féin as Colairce na hIolrsoite i nSaillim—so neartuigíó Dia leir.

In presenting this Report the Committee and Secretary desire once again to thank the School Managers, Teachers and others for their interest and co-operation in the work of the libraries. The information given in the Report shows that the labour is fruitful indeed and illustrates clearly how the libraries play a part in the sphere of true education: "the drawing out of the good powers of a citizen, chiefly of the mind, and particularly his powers of reaching truth and admiring beauty."

THE CARNEGIE TRUST AND LIBRARY BUILDING GRANTS.

Faced by the difficulties created by the high cost of building, and also by the fact that public bodies are naturally reluctant to erect buildings which will involve heavy recurrent cost in upkeep, the Trustees have tended more and more to support projects (chiefly in rural areas) of an educational or social character which do not require costly buildings or involve high maintenance expenditure. The Trustees fully realise that the development of Irish Library Services has led to the need for suitable Headquarters on a far more considerable scale than was required for the inception of the schemes in purely rural areas. Their difficulty, however, is that the maximum allocation which they could possibly put aside would be inadequate compared with the cost of a whole series of new Headquarter buildings. The Trust's policy will be defined in detail about October. The Chairman and the Secretary of the County Libraries Committee at a conference in Brighton discussed the question relative to Galway with the Chairman of the Trust's Library Committee and the Trust's Treasurer. It was suggested by the Trustee's representatives that the Secretary of the County Galway Committee should prepare a survey of County Library Headquarters in An Saorstát. This has now been done through the Irish Library Association. The survey and an appeal to the Trust for grants will be submitted to a Special Meeting of the Association at which the Trust's Secretary will be present. Considering the rapid development of the Irish Library Service and its serious economic difficulties with the absence of suitable Library buildings, one is very hopeful indeed that the Trust, which from the outset, fully realising Irish difficulties made special allowance and proportionate grants, may continue that far-seeing and equitable policy.

SCHOOLS AND LIBRARIES.

In some districts in the county special efforts are required to instil in adults a love of reading or a love of better reading than that to which they have been accustomed. It may be generally admitted that the habits of the grown-up are mostly

fixed but the influence, both social and cultural, of the rural teacher must play an important part in the development of reading generally. The main hope of progress, however, rests with the children and here principally the teacher can render an incalculable service to the County Library. "Without encroaching on the field of the educational expert, one may say with some confidence that a teacher has not fully fulfilled his function unless he has given his pupils "not only the power to read fluently, but also a desire to read constantly, and some appreciation of the superiority of good literature over bad literature. His pupils on leaving school should become the most constant clients of the Library, and while they are still at school the teacher has an opportunity of cultivating tastes which will develop after school days have ended. If the teacher exercises his opportunities, there is no reason why the reading of the future should consist predominantly of fiction; since even in school days there are many subjects which if properly presented are more attractive than fiction. In more practical ways the teacher can assist the librarian. He can instil into his pupils *the duty of taking care of books* and show them that *the disrespectful treatment of books, in the many ways in which such treatment is common, constitutes a sin against wisdom.*"

Another service a teacher can render to his pupils is to teach them how and where to find out facts for themselves. There is no greater aid to intelligence than to know where knowledge can be found, and the habit of independent investigation of facts if acquired in youth is seldom lost. Lastly, the school in a district is the readiest medium for distributing information and, if the teacher takes care that his pupils are acquainted with the books which are available and are informed of the nature of their contents, the information percolates to a great part of the population."

The library service by rendering assistance to the education service of the county in providing distinctive School Libraries, is having its resources severely taxed. It follows, therefore, that "*it should be reimbursed out of the Central Education Fund, and since this phase is an educational and not a library service, means should be found whereby the cost of that portion of its work should rank for a Central Fund grant in the same way as Agricultural and Technical Instruction.*"*

STAFF.

During the past year the staff has been depleted through the resignation of Mr. Henry Shee, and the vacancy has not yet been filled. There is no more vital question in connection with the working of the County Library service than that of the means to be taken to obtain an adequate staff for the several

phases of the work. The success of a library, especially during the period of establishment and growth (through which all the county libraries of Ireland are still passing) depends to a very great extent on the staff. *A mere collection of books, however large, cannot by itself perform more than a small portion of the service which a well-staffed library can render to the community.* Only a small minority of readers (and under this head we include students) have sufficient knowledge by themselves to turn a collection of books to good account. For the large majority of the population of the county the librarian and his staff are the guides who introduce them into the kingdom of knowledge. For such a service a depleted staff tends to become a disaster to the community. "It means that a potential mechanism of cultivation is running at less than its full power, and that the county is obtaining much less than full value for library expenditure."

We have no hesitation in saying that this is a state of affairs that tends to exist while the whole field of library endeavour fails to be covered adequately. In saying this we make no reflection (except an entirely honourable one) on the members of the Council. On the contrary, *we consider it highly creditable to the Council as a whole, and particularly to the Chairman, that the service has developed so rapidly.* In fact, the readers of the county are under a very deep debt of gratitude indeed to the chairman for his energetic efforts in ensuring the library's growth in the midst of an opinion which did not appreciate its possibilities.

It is absolutely necessary also for the county librarian both to make himself acquainted with the requirements of the county, and to keep in touch with the numerous bodies to which he looks for advice or which require assistance from him. For this purpose it is necessary that he should not be tied to an office but should be free to move about without any fear that the routine work of the county library will suffer by his absence from headquarters. This fear cannot be eliminated without an adequate staff consisting of, in addition to the County Librarian, an assistant and a clerk.

PUBLIC LECTURES.

With the object of reaching as many different classes as possible the Committee in its lecture policy has stressed (while aiming at securing a wide range of themes) such subjects as Irish history, music and folklore. Four objects have been kept in view: (1) to attract readers; (2) to help existing readers by introducing them to fresh interests; (3) to indicate a method of approach to a subject; and (4) (apart from books or libraries) to have a definite educational and an intrinsic recreational value. In all cases large audiences were attracted in Galway,

Tuam, Loughrea and Athenry, and it is the intention of the Committee to widen the sphere of activity by including other towns and the principal villages in the next session's itinerary. The course completed during the period under review was: (1) "The Story of Old Dublin" (an illustrated lecture), at Galway; (2) "Bealoideas" (Folklore in Ireland and Scandinavia), at Galway; (3) "Amhranaidheacht Gaedhilge" (an Irish folk-song recital), at Galway, Athenry and Tuam; (4) "Clonmacnois" (an illustrated lecture), at Galway; (5) "National Transport Problems," at Galway, Tuam and Loughrea.

CARNEGIE TRUST.

The supplementary grant of £300, spread over a period of three years, given by the Trust for the purchase of additional books has now been paid in full. The Committee's best thanks are due to the Trustees for this—the largest supplementary book purchase grant allocated to any Irish County Library.

CO-OPERATION WITH EDUCATIONAL SERVICES.

It is very pleasing to report on the co-ordination of the library service with local educational bodies. The itinerant classes of the County Committee of Technical Instruction have been responsible for the increased issues of books in Irish and of works on building construction, and manual work. The demand for books in Irish has necessitated the purchase and circulation of a collection of 2,000 volumes in the native language for the use of elementary and secondary schools.

The City of Galway Technical School has been supplied with a stationary collection of works, augmented from time to time by books on Commerce, Electrical Engineering, Wireless, Building Construction, Manual Work, Mathematics and English Literature. Every encouragement is given the students by the Principal to make full use of the library.

COLLECTION OF WORKS ON LOCAL HISTORY, ANTIQUITIES, ETC.

It is a prime duty of every Library Authority to collect locally printed books. "Primarily the words local collection are co-extensive with local bibliography. The 'lacunae' in our national bibliography have been lamentable in the past in regard to locally and privately printed books, owing to the lack of such collecting," and they are not likely to decrease if the public do not co-operate with the Committee.

The Committee again appeal to the public to assist in the work of building up a local collection of books, pamphlets and

news-cuttings, dealing with the history and antiquities of the City and County. The financial resources of the service are limited, and the Committee trust that readers and residents in the town and county will help by donations of works of this kind.

A very fine collection of works on Irish history, Galway history and antiquities has been secured from the sale of the library of the late Miss Redington at Kilcornan House, County Galway. The works are in constant demand not only by the student but also by the general reader and, the Committee cordially invite all readers interested in the history and archaeology of the county to make full use of the books.

DEMAND.

For the two years under review the output of books from the printing-presses has been substantial and nothing much of exceptional literary achievement has been produced. The inclusion in daily and provincial newspapers of book reviews has to a very great extent influenced the nature of demands of readers.

Works in Irish continue to enjoy a steady demand and it is worthy of note to record that there is a marked tendency towards producing fewer books of an ephemeral kind in the language.

Biography and Memoirs have more than held their own in public favour. Essays and the study and criticism of literature, with the exception of established works required by students, have declined in favour with an age which demands "canned" speech, "canned" music and transcontinental decadence generally. Unfortunately only a small number of our people realise the subtle and degrading influence of such a recreative medium which is steadily threatening, if not undermining, our culture, our social life and our moral outlook. As unexplored and undescribed lands have become fewer and fewer the demand for books on travel tends to lessen, but in the rural areas a comparatively steady desire still exists for the older works on general travel. Again, with the exception of students, poetry is not largely read. Of fiction—which represents more than half of the total issues, and which in the Galway Centre is substantially more—the greatest demand is for the works of older Irish writers, e.g., Eirmingham, De Blacam, Bodkin, Lynn Doyle, McCartan, Murphy, Standish O'Grady, Seumas O'Kelly, Canon Sheehan, Smithson and Tynan, and the translations of Padraic O'Conaire.

The selection which follows fairly represents the demand of the general readers rather than the student or specialist, whose demand is well illustrated by the figures showing the nature and numbers of books borrowed from the Central Library for Students. Many estimable works in constant demand must perforce be omitted.

706. Ministry of Local Government and Public Health:- letters from the Ministry of Local Government and Public Health:-

Noted - G. 91363/1930 - sanction for expenses in connection with the attendance of Councillors Lynch and the Secretary at the Annual Meeting of the Library Association of Ireland.

G. 91364/1930 - The Minister awaits the views of the County Council apropos the increase of £13 per annum granted to Miss K. Ronaldson by the Committee (minute no. 688); and asking what special reasons are connected with them.

position and services to warrant the further increase now contemplated.

G 91340/1930. Provided the County Council agree the Minister raises no objection to the payment of £2.13.4, to Thomas J. Kennedy for services rendered during the illness of Miss K. Ronaldson.

The Minister adds that as soon as a permanent appointment is made the employment of temporary help will not be permitted.

Resolved - That the Secretary be instructed to inform the Minister that the increase was granted Miss K. Ronaldson on her having obtained an additional certificate of the Library Association by passing the examination in Section 5 of the Association's Examinations - Library Organisation, Finance and Legislation.

Noted - G. 3633/1931 - Enquiring if the views of the Galway County Council have been obtained as to the proposed increase in the salary of Miss K. Ronaldson.

707. County Council :- The Secretary submitted Minute No. 4473 of a special meeting of the County Council held on the 13th day of December, 1930 :-
"That under the authority conferred on ^a the County Council by Section 38(4) of the Local Government Act, 1925, the Galway County Council hereby empowers the County Galway Libraries Committee to make such payments as the County Council itself could lawfully make in the exercise of its powers and duties as Library Authority for the County of Galway."

"That the Libraries Committee is hereby instructed to render to the County Council, as soon as possible,

after the close of each financial half year, the Half-yearly Abstract of Accounts of the Committee, duly certified by the Chairman and two other members of the Committee and the Librarian." - Passed.

The Secretary also submitted a letter from the Acting-Secretary to the County Council stating that :-

(a) Minute No. 688 of the Libraries Committee granting Miss K. Ronaldson an increase of salary of 5/- per week was confirmed.

(b) Minute No. 691 of the Libraries Committee granting Mr Thomas J. Kennedy £2.13.4 for temporary services was confirmed.

(c) Minute No. 680 of the Libraries Committee appointing Miss J. Tolan as clerk, was confirmed.

The Secretary reported that he had notified the Minister of the County Council's decisions relative to the Minutes Nos. 680, 688 and 691, respectively.

Resolved - That the Secretary be instructed to ask the Minister if the authority of the County Council is now required for
(a) increases of salary granted by the Committee;
(b) the acquisition of special collections of works;
(c) any other special expenditure.

708. Lectures :-

Resolved - That the Sub-Committee's arrangements with Mrs H. Sheehy Skeffington, Dublin, and J.T. O'Neill, Esq., University College, Dublin, for the delivery of lectures, be approved.

709. Offer to purchase old and surplus books:- Resolved - That subject to the sanction of the Minister, the offer of ten shillings received from Mr. Sean O'Dwyer, The Book Mart, Galway, be accepted.

710. The Library Association of Ireland:-

The Secretary informed the Committee that an Irish Advisory Board (the result of an agreement between the Library Association of Ireland and the Dublin Booksellers' Association and approved by the Publishers' Association of Great Britain and Ireland) of Booksellers and Librarians in the Irish Free State has not been established. This Board is only empowered to recommend the issue of licences to librarians as Book Agents empowering them to receive a commission on the purchase of books under the Book Trade Agreement, 1929.

The original discount terms remain, viz:-
5% commission where the aggregate purchases amount to £100 and not exceeding £500 per annum.
10% commission where the aggregate purchases exceed £500.

The sums allowed by way of commission shall not be in cash but shall be expended in the purchase of additional new books on which no commission be given.

Resolved - That the Secretary be instructed to protest, at the next meeting of the Executive Board of the Irish Library Association, against the Association becoming a party to such an arrangement which is of no value whatever to the majority of Irish Librarians and that the Secretary be also instructed to insist at

the meeting, on the Association's co-operation to try secure a flat rate of 10% commission in each irrespective of the amount of a library's annual purchases.

711. Local History:- The Secretary reported that he had received a request from the County Galway Branch of the Irish National Teachers' Organisation suggesting that the library staff compile articles on local history, from the books, journals etc., in the County Library Headquarters, to appear periodically in the local press.

Resolved - That the Secretary inform the County Galway Branch of the Irish National Teachers' Organisation that all books, journals, etc., dealing with local history, are at the disposal of any member of the Branch; and that the works may be consulted at the Depository during the official hours.
