I understand that the Woodquey Dispensory will be made available for use asa Co. Library Headour ters when the Medical Services pre transferred to the new Co. Health Clinic. I do not propose to go into details now but would suggest that this is not an opportune time for the introduction of " Mobile Library Service in County Golway. REPORT FOR THE YEARS 1953-1954 and 1954-1955

To:

The Chairman and Members of Galway County Libraries Committee and the County Manager.

I have much pleasure in presenting this report for the two year period ending 31st March, 1955.

The end of a financial year brings us an opportunity of critically examining the work done in the past, and as a result of this examination to decide on measures to improve, wherever possible, the Library Service to the public.

The history and development of the Galway County Libraries has been fully and adequately recorded in the reports of the late County Librarian Mr. S. J. Maguire, who was responsible for the organization and progress of the past 31 years, and who also planned the present programme for the development of Branch Libraries throughout the County.

My service with Galway County Council and as Acting County Librarian covers only the last month of the period under review, and realising this I can offer little more than figures to show in some measure the work accomplished by my predecessors.

The number of books borrowed by the public is still the only method of showing the quantatitive value of the Library Service. The number of books issued during the year 1953/54 was 276,503. Of this total 56,630 were non-fiction, 181,847 were fiction, and 38,026 were juvenile.

Book issues for the year 1954/55 were as follows : Non-Fiction 37,554, Fiction 162,850, and Juvenile 46,720, a total of 247,124.

You will observe that the total issues for the year 1954/55 show a decrease of 29,379 on the number of books issued during the previous year. This apparent drop in books borrowed may be explained by the fact that I have excluded figures for schools and village centres, a feature of previous reports, as no returns are available and estimated figures tend to produce a distorted picture.

The actual number of books sent from Headquarters to Centres and Schools during the years 1953/54 and 1954/55 were made up as follows :--

The total stock of books in the Library on 31st March, 1954. was 72.620 and on 31st March, 1955, the number was 79.289. **Headquarters** :

Previous reports have drawn attention to conditions at Headquarters, and the lack of adequate space. Until such time as separate accommodation is found for a Headquarters or separate Branch Library for Galway City, further development of the County Library Services can only be carried out with great difficulty and inconvenience to staff and readers.

The Headquarters staff are compelled to carry out all administrative and routine duties in two rooms and all books dispatched and received at Headquarters must pass through a room which serves the dual purpose of a book store for the County and a Lending Library for the city of Galway. Thus a city with a population of over 20,000 is almost completely deprived of the services which are an accepted part of a modern public library system. There are no facilities for reference or study, children are admitted on Friday afternoons only, and it is impossible to cater for the number of children who desire to use the library.

A city of the size and importance of Galway, deserves proper facilities for all who wish to make use of the library; and the County requires a Headquarters with sufficient space for books and proper accommodation for the staff to deal with all the administrative and routine work involved in providing an efficient Library Service.

Branch Libraries :

(a) In addition to Headquarters which serves Galway City. part time Branch Libraries under the supervision of paid branch librarians are in operation at :--

Abbevknockmov, Athenry, Ballinasloe, Ballygar, Carraroe, Clifden, Dunmore, Glenamaddy, Headford, Killimor, Loughrea, Moylough, Oughterard, Portumna, Spiddal, Tuam, Woodford.

The Branch Libraries at Ballinasloe, Loughrea, and Tuam are open to the public for twenty hours per week. The other Branch Libraries open for ten hours each week.

Many of the Branch Libraries require better heating and lighting arrangements and in some large branches notably Ballinasloe, Tuam, and Loughrea floor covering is required to prevent damage to books from dust. Several branches need extra shelving and re-arrangement of shelves in order to improve supervision.

(b) Branch Libraries for the following places have been sanctioned by the County Manager, but are not yet in operation :---

Creggs, Currandulla, Gort, Kilronan, Kinvara, Menlough, Miltown and New Inn.

(c) Provision has been made in next year's estimates for Branch Libraries at Ahascragh, Clonbur, Craughwell, Kilrickle, Lettermore, and Movcullen.

The policy of renting accommodation for Branch Libraries in privately owned premises does not, in my opinion, tend to produce the best results and I would suggest that future policy should aim at acquiring accommodation in public buildings whenever such accommodation is available.

Co-operation with Neighbouring Counties :

In many instances Galway County has provided Branch Libraries in places such as Ballinasloe, Headford, Portumna which border on neighbouring counties, and it would appear that a considerable saving would result from co-operation between the counties of Galway, Mayo, Roscommon, Tipperary and Clare if reciprocal arrangements for use of Branch Libraries could be made. School Libraries :

It is not necessary for me to make a case for the provision of school libraries. The Library Association of Ireland which represents the views of Librarians all over Ireland presented a memorandum to the Minister for Education in 1954 asking him to subsidise the development of this very important aspect of the public library service. County Cork at present serves over 50% of its national schools and Limerick County serves about 50 of its 150 national schools.

In County Galway there are at present 19 Centres in Schools which are exclusively for the use of the pupils. The organization of a school library service would require the services of a trained children's librarian.

Transport :

The efficiency of any County Library Service may be measured by its success in " placing an adequate supply of books in all parts of the County where they invite use," and also by its ability to keep books in constant circulation throughout the County area.

I respectfully submit that distribution of books in boxes by hired transport is no longer sufficient if we are to attain the degree of efficiency demanded of a modern public Library Service.

Transport needs to be speedy and flexible, and should provide a personal link between the Headquarters and Branch Libraries, and where necessary between the Library and the individual reader.

The committee at its meeting in March requested me to submit a report on the possibility of providing a Mobile Library Service to certain areas of the County. The initial cost of providing a mobile library would be in the region of $f_{1,500}$ and the annual running costs would be approximately £1,000 per annum for wages, petrol, maintenance. etc.

I do not propose to go into details now but would suggest that this is not an opportune time for the introduction of a mobile library service in County Galway. I think consideration of this idea should be deferred until new Headquarters are occupied and the present programme relating to Branch Libraries has been carried out. When all the proposed Branch Libraries have been established we will be in a much better position to arrange a mobile library service to the remaining areas of scattered population.

I am of the opinion, however, that the County Library should possess its own system of transport in order to effect regular exchanges of books at Branches and Centres and to avoid book stocks becoming stagnant. A small van would be adequate for present purposes but keeping in mind that in future it will be necessary to provide direct service to certain areas by travelling library, and the fact that a considerable development in school libraries must take place, I would recommend that serious consideration be given to the purchase of a large van so designed as to permit of use for the following purposes :—

- (a) Exhibition van for exchanges at Branches, Centres and Schools.
- (b) Transport of furniture, fittings, etc.

(c) Travelling Library for direct service to the public. Stocktaking 1954-1955:

The annual Stocktaking at Headquarters was carried out on 29th, 30th, and 31st March, 1955, and the Headquarters branch was closed for this purpose.

Stocktaking of the 17 Branches was carried out by the Acting County Librarian and another member of the Headquarters staff, and at the same time deliveries of supplies receipt books, stationery, tickets, etc., for use in 1955/56 were made. Combining these deliveries with stocktaking visits resulted in a saving of staff time at Headquarters, and costs of carriage and postage on supplies.

The results of the stocktaking for the year 1953/54 showed that 2,036 books were missing at Headquarters and in 1954/55 Headquarters showed a deficiency of 1,963. It would appear that 73 books, not charged out to readers, were returned during the year 1954/55. Perhaps this is a good omen and I would make a particular appeal to all residents of the city and county to return any library books in their possession to the County Library Headquarters or their nearest branch library.

Cataloguing of Book Stock :

Arrangements have been made for cataloguing all non-fiction books added to stock from the 1st April, 1955, and for this purpose a large number of standard catalogue cards have been ordered. The form of catalogue to be used will be an Author and Classified Catalogue.

The ordinary stock card in use at present could by re-arrangement (alphabetical instead of by number) be made to serve as a catalogue for books of fiction and would, therefore, lighten con siderably the great task of providing a complete catalogue of books in the County Library.

The work of catalogaing the very excellent reference and local collection at Headquarters is a task which requires special training in cataloguing and however desirable and essential this work is, it must be deferred until more trained personnel are available.

Binding and Worn out Books :

Towards the end of the last financial year some 5,000 books were examined and a decision made on their suitability for rebinding. Three thousand books were earmarked for withdrawal from stock and two thousand were prepared for dispatch to binders. At least another 5,000 books remain to be dealt with in a similar manner.

Statistical Abstracts :

The statistical tables at the end of this report are self explanatory, and I do not think any useful purpose would be served by dwelling on them at length in this part of the report. The abstract has been compiled on similar lines as in previous reports, with the addition of some financial and general statistics which may prove of some value to other library authorities as well as our own. Comparisons, however, should be made with caution, as for instance in the case of registered readers I have discontinued the practice of carrying forward figures from one year to the next.

I believe that some comment is necessary on the general question of presentation of statistics in the Annual Reports of Irish Libraries. The variety of methods in use in presenting Library Statistics instead of being useful to other Local Authorities and helpful to fellow librarians, tend to cause confusion if any attempt is made to compare results in one county with those in another. Our obvious need is an agreed statistics blank on the lines of that recommended by the Library Association (British).

Conclusion :

In concluding this report I should like to express my thanks to the members of the Libraries Committee for their advice and guidance and their kindly toleration at my first committee meeting. I wish to thank the County Manager, the County Secretary, and the County Accountant, and all the other officials who helped me over the hurdles. Finally, my best thanks to the staff of the County Library for their willing co-operation which made my task lighter, coming to Galway as I did at the close of a financial year.

The total number of readers now using the Headquarters Branch Library is 2,050 and the figures for juvenile readers already show an increase of 30% ever the total figure for last year. The number of children registered to date is 414 (increase of 106).

In the Annual Report for 1954/55 reference was made to arrangements for enteloguing all non-fiction books added to stock since 1st April, 1955. This work has been carried out and the catalogue which is an Author and Classified Card Catelogue is being compiled in accordance with the best modern practices. This catalogue will enable us to provide classified lists of books on various subjects contained in the County Library. I am happy to report that the work of classifying and re-arranging the entire book stock at the headquarters branch has now been completed. In order to undertake this work it was necessary in the first place to relieve pressure on shelf space at headquarters. This was achieved by withdrawing over 3,000 worn out books from circulation and by increasing the stocks of several branch libraries. The committee will appreciate the magnitude of this task when it is understood that every book required individual examination and the entire book stock required to be moved and re-arranged.

The new branches at Gort and Kinvara have been provided with a wide range of literature; both libraries are completely classified and the Gort branch has been provided with a classified catalogue. The work carried out recently at Headquarters has enabled us to make a comprehensive selection of books for the new branches and the charging system adopted will ensure that no duplication of stock will take place in future.

The total number of books sent to branches for the period 1st April, '55 to 30th November, 1955 was 13,447. 29 feb 1956 was BALLINASLOE BRANCH

The fire which destroyed the greater part of the Workhouse Building at Ballinesloe on 2nd inst., was prevented from reaching the room occupied by the branch library. The books were removed to the Boys School by voluntary workers during the fire, but a large number of books have been badly damaged by water. The Library has since been transferred to a room in the Courthouse at Ballinasloe, and the books are being sorted and examined in order to estimate the damage. It will be necessary to find proper accommodation for the branch library at Ballinasloe, and I suggest that the problem would best be solved by adding an additional room to the new fire station to be erected there.

PROGRESS REPORT

HEADQUARTERS

Since the last meeting the hours of opening at the Headquarters branch have been extended on two evenings each week, Mondays and Fridays, from 7 D.m. to 9 p.m. The results of this extension are most gratifying and there is a steady improvement in book issues seconding as this evening opening becomes more widely known. The numbers now using the Library between 7 - 9 p.m. on Fridays is approximately 80 persons, and total issues for Fridays, when the children's section is open have reached the figure of 850 books.

The actual number of books withdrawn from stock was 3260. Books sent for re-binding 1780. New books edded to stock totalled 5915.

BRANCH LIBRARIES

There are now 20 branches in operation in various parts of the County. Two new branches were opened since the last meeting of the Committee, one at Kinvara on 7th November, 1955 and the other at Gort on 12th November, 1955. Three new Centres have been opened in schools at Crumlin Girld N.S., Ballyglunin, Garbally N.S., Menlough, Ballineslde, and Kilssolan N.S., Castleblakeney. The branch at Creggs will be opened as soon as the County Engineer supplies the necessary shelving and fittings.
