Miss Jane Murphy asked how often books were changed in branch libraries and on the mobile. The Co. Librarian stated that books at branches were exchanged four times every year, that worn-out books on the mobile were replaced continually and new books added to its ock.

In answer to Clr. Morgan's query about the proposed branch library for Portumna, the Co. Librarian stated that the Committee had agreed to build the library and that An Chomhairle Leabharlanna would pay 50% of the loan charges on the capital expenditure involved. It was originally decided to combine the branch library and the fire station but this proposal was rejected by An Chomhairle Leabharlanna.

Clr. Morgan enquired if the people of Gort were adequately catered for pending the renovation of the Church building. Minutes of the Estimates Meeting of the Galway County Libraries' Committee held in the Council Chamber, County Buildings, on Friday, 1st August, 1975, at 4.00 p.m.

PRESENT:

At the outset, the Chairman informed the meeting that the minutes of the meeting held on the 9th May, 1975, would be altered to include Mr. J. Burke among attendance. The minutes of that meeting, as circularised to members, were taken as read. On the proposal of Clr. Melvin, seconded by Clr. Morgan, they were adopted and signed.

The Minutes of the Meeting of 25th July, 1975, as circularised to members, were taken as read. On the proposal of Clr. U. Burke and seconded by Clr. Ryan, they were adopted and signed.

The Co. Librarian informed the meeting in respect of Branch Libraries as follows:-

CLIFDEN: Sanction to the loan had been received. The documents had been sent to the County Solicitor and he is to arrange for the completion of the contract and the bond.

PORTUMNA: The Council has asked the Department of Local Government for approval to revised plans consequent on the recommendations of An Chomhairle Leabharlanna.

GORT: The final contract documents have been received and are being checked by the Council's engineers.

MERVUE: A poster has been placed on the notice board in the Church in Mervue. It is too soon yet to forecast any improvement in the use being made of the Branch. Clr. Morgan asked if this poster in Mervue would be renewed from time to time.

SCHOOLS LIBRARIES SCHEME:

The Co. Librarian informed the meeting that he had written to the Dept. of Education on 12th June, 1975, requesting them to inform him of the amount of grant payable by the Department towards the schools library scheme in the present financial year. He sent a reminder on the 23rd June, 1975, and received a reply on 1st July, 1975, which said that no provision had been made for the grant in the Departments estimate for 1975. Mr. Sharkey added that when the Department drew up these estimates they did not inform the Co. Council that the grant towards schools libraries was being withdrawn.

The Chairman asked who was responsible for omitting the grant in the estimate. Mr. Sharkey replied that the Department for Education was and added he had written to the Library Association informing them of this matter. Mr. John Howlett said that the grant was first given in 1969 subject to review after five years. It now appeared that they had decided to discontinue it. He added that the Library Association would take the matter up with the Department of Education. Clr. Morgan asked the amount of last year's grant. Mr. Howlett replied that it was £6,470. Clr. Morgan proposed that the Co. Council provide the amount in question for a year or two. Mr. Sharkey stated that he had made provision for that in this year's estimate. Clr. M. O'Morain asked if there had been any indication that the Dept. of Education grant for last year was going to be the final one. The Assistant Co. Manager told him there was no indication from the Department that they intended to discontinue the grant. Clr. M. O'Morain proposed a formal resolution that the meeting deplore the Minister's action and ask him to reconsider the position. This proposal was seconded by Clr. H. Melvin. Clr. F. Fahey asked what effect this cutback would have on the school library service. Mr. Sharkey replied that it would not effect the service if the estimate was adopted, but it would cost the Council an extra lp. in £. Clr. F. Fahey said that he did not agree with putting the cost of the grant on the rates. Clr. Haverty deplored the fact that the ratepayers would have to make up the deficit and suggested that a strong protest be made to the Department. The Chairman stated that a proposal to this effect had been made by Clr. O'Morain and seconded by Clr. H. Melvin. Mr. J. Howlett said that the schools library service was set up in 1964 and that in 1969 they received a letter from the Department of Education saying that they were willing to contribute to this service, at the rate of 2/= per head for books and 3d. per head administrative costs. This grant was subject to review in five years. The grant was increased last year and no indication was given that this was not to continue. It would be very difficult for the Co. Council to dismember this service. Clr. O'Morain asked if it was the primary school scheme that was under discussion. Mr. Sharkey said a grant was never provided for post primary schools and that the Library Association had approached the Department on this matter on a number of occasions. Clr. M. Kitt, T.D., said that all agreed about the importance of the library service in education. Mr. Townley suggested that it might be a good idea when making a submission to the Department to write to the Library Council asking their aid in recovering the grant. The Chairman suggested that Deputy Kitt & Senator Mannion make representations on this matter to the Department. ESTIMATE 1976. The estimate for the year 1976 was discussed by the Committee. The total gross estimated expenditure amounted to £170,000, whilst receipts were estimated at £17,400. The estimated nett expenditure was £152,600. This amounted to a rate of 21.81p. in the pound or £1.02p. per head of population. The amount provided for new books in the estimate amounted to £50,000.

Mr. John Howlett said certain factors must be considered when examining this years estimate

- (1) the change in the financial year, this is the first complete year to work from January to December.
 (2) the increases caused by inflation.
- (3) provision for new Branches.
- (4) increases in wages & salaries.
- (5) increased contribution to Library Council.

Mr. Sharkey said that the most vulnerable part of the estimate was the bookfund.

Mrs. Croffy remarked that a good library service should be provided for retarded readers, she said this was of special interest to her and she proposed that no cutback occur on remedial reading material. This proposal was seconded by Clr. M. Kitt.

Clr. O'Morain asked about Galway Corporation contribution of £200, which he considered rather small. Mr. J. Howlett explained that this was a nominal sum paid by the corporation but that they paid their full share through the County demand.

The estimate was adopted on the proposal of Senator J. Mannion seconded by Clr. M1. Ryan.

ANY OTHER BUSINESS:

The Chairman congratulated Mrs. O'Brien on being presented with a papal medal.

ARISING FROM THE MINUTES:

BRANCH LIBRARIES:

The Chairman then asked Mr. Howlett if the Clifden project could go ahead and Mr. Howlett replied that the only problem was the securing of a contractor. The Chairmain then asked if there would be a fire station connected with the Clifden Branch to which Mr. Howlett replied no but that there would be offices upstairs and repeated that there was nothing to stop the project at the moment if a contractor could be appointed.

On Gort Mr. Howlett, replying to the Chairman, said that the contract documents were nearly ready but that there was no sanction

ELECTION OF CHAIRMAN & VICE-CHAIRMAN, 1976:

The Acting Chairman, Clr. S. O'Domhnallain, said that the Co. Libraries' Committee was a very important committee as it involved the whole county. Many branches and a mobile service needed the members attention.

Sen. M. Killilea proposed Clr. O'Domhnallain as Chairman and was seconded by Clr. N. Morgan. After his unanimous election as Chairman Clr. O'Domhnallain thanked the members for accepting him and asked them for their co-operation. Clr. O'Domhnallain also said that he would accept the office for one year and would like to see the chair rotate amongst the members.

Clr. Morgan proposed Clr. Holland as Vice-Chairman. Clr. Holland withdrew and proposed Mr. Jarlath Burke. Clr. Ryan seconded Mr. Burke.

Sen. M. Killilea proposed Mrs. J. Beatty but she withdrew in favour of Mr. Burke. Mr. J. Burke was then elected Vice-Chairman and returned thanks to the members.

SCHOOLS LIBRARY SCHEME:

The Co. Librarian told the meeting that he understood that the Dept. of Education was going to restore the grant which was withdrawn in 1975. He said that the Council would have to formally agree to spend the money, ifit came, but added that it would not add to the rates. Mr. Sharkey thought that this was good news especially as VAT on books would increase to 10% in March 1976.

Deputy Kitt then asked if the money would be forthcoming for Galway. The Co. Librarian replied that he had read that the grant was being restored but that the Dept. would have to state what the amount would be. Deputy Kitt then said that he had correspondence from the Department but that there was a confused ending to the letter in that the Department said it would give careful consideration to Galway's request. He added that he had a question in the Dail for Tuesday 17th February, 1976, about the school grant. The Co. Librarian said he would like to know how much would be allocated to Galway.

Clr. Morgan asked how would the grant affect the situation. The Co. Librarian said he hoped for at least £5,000 for books.

Clr. O'Morain then proposed that if the money arrived it be spent. Deputy Kitt seconded this proposal.

Clr. Morgan then asked what the money would be spent on. Mr. Howlett said the grant was specifically for libraries in primary schools.

NOMINATION OF DELEGATES TO LIBRARY CONFERENCE:

Clr. O'Morain proposed Clr. Hugh Melvin as a delegate to the Joint Conference of the Library Association of Ireland and the Northern Ireland Branch, the Library Association in the Old Ground Hotel, Ennis, Co. Clare, from Thursday, 20th to Sunday, 23rd May, 1976. Deputy Kitt seconded. Clr. Raftery then proposed Mrs. O'Brien and she was seconded by Mrs. Beatty. Both delegates were unanimously nominated and they returned thanks to the members for being selected to represent the Committee at the conference.

ANY OTHER BUSINESS:

The Chairman congratulated Mrs. Jane Beatty on her recent marriage. Sen. Killilea added his congratulations to Mrs. Beatty on behalf of the members and the Librarian, Mr. Sharkey, also added his congratulations on behalf of the staff.

Mrs. O'Brien a ked if there was any cut-back in the remedial reading expenditure. The Co. Librarian assured her that there was not.

Clr. Morgan then suggested that the next meeting of the County Libraries' Committee chould include a tour of the County Library and the University College Library. The Co. Librarian agreed to arrange a visit to the Co. Library for anyone who wished to go and added that the Committee members were welcome to visit the library at any time. He said however that a visit to the U.C.G. Library would have to be arranged with the Librarian, Mr. C. Townley.

Clr. O'Morain then asked if there was any improvement in the Connemara service particularly in Gaeltacht areas since it was last discussed at a meeting.

The Co. Librarian replied that there were no improvements as such and said there were branches in Spiddal, Oughterard, Clifden & Roundstone; press centres in Leenane, Tully Renvyle, Kilkerrin, Clonbur, Cornamona, Cashel & Eeragh Lighthouse; a Mobile service once every four weeks, with stopping points at Barna, Inverin, Minna, Rossaveal, Carraroe, Rosmuc & Moycullen. He also said that there was a library in every school in Connemara. Mr. Sharkey added that more press centres could be established if premises became available and a suitable person appointed to look after them.

The Chairman asked if there were many Irish books on the Gaeltacht route. The Co. Librarian replied that there were not many, but Irish books, when published, were purchased.

As regards the Mobile service Mr. Sharkey said that there was only one mobile for the whole county and its time schedule did not suit everybody as it had to move from place to place. Clr. Morgan asked if it was possible to provide microfilm readers for places like Portumna, Loughrea & Ballinasloe. The Co. Librarian replied that it would be very costly to buy new microfilm readers and to duplicate microfilms. Clr. Morgan asked it it was possible to get an actual copy of material and the Co. Librarian said that the stock of microfilms was 13p. per sheet. The Co. Librarian said that the stock of microfilms was continually being built up and that microfilms of the Connacht Tribune were on order. Clr. Morgan asked if any Loughrea Newspapers were available. The Co. Librarian replied that the Loughrea Nationalist was included.

Mrs. Beatty stated that the committee should be trying to put libraries into places like Mountbellew. Clr. Morgan said that there should be libraries every place that needed them and microfilm readers. The Co. Librarian said that for extra microfilm readers extra copies of microfilms would be needed. Another problem he said was that the Branch Libraries only had part-time staff and that supervision is needed for microfilm readers.

Clr. Frank Fahey said complaints were brought to his notice about restocking of Branches in that the same type of books were returning all the time. He also said that the Gort Branch needed repairs to its floor. Mr. Howlett assured Clr. Fahey that the Council were looking after this.

Mrs. Beatty said she also had complaints about the mobile service in that the same books were returning all the time. The Co. Librarian thought this complaint was exaggerated as the library rarely purchased multiple titles.

The Chairman asked whether it was possible to get a particular book and Mr. Sharkey replied that it was, if requested.

Clr. Morgan asked if there were libraries in schools even if there was a Branch Library nearby. The Co. Librarian replied that there were.

The Co. Librarian told the meeting that he had received regrets for inability to attend the meeting from Clr. J.F.King and Mr. P. O'Grady.

GORT: Mr. Doyle said that the final contract documents for the new branch library in Gort were with the Department of Local Government since the 4th May, 1976. He also informed the committee that a loan of £32,000 had been sought for the Gort Branch Library.

PORTUMNA: Mr. Doyle said that the original site of the proposed branch library had been changed. It was now planned to build the branch library, and an office for the local engineer in the Fairgreen, he said revised sketch plans had been received.

ARISING FROM THE MINUTES:

BRANCH LIBRARIES:

Mr. Doyle informed the meeting that little progress had been made in respect of Clifden, Gort and Portumna Branch Libraries.

GLIFDEN: Mr. Doyle said that a new tender had been sent to the Department of Local Government last May and sanction to the loan had been sought. The sanction had not, as yet, been granted.

SCHOOL LIBRARY SCHEME:

Mr. Sharkey informed the meeting that he had written to the Department of Education on four occasions about the grant for the provision of books in primary schools. He then read the reply he received from the Department of Education on 9th July, 1976, "The Question of payment of the grant for 1976 is at present under consideration and the Department is in touch with the Department of Finance on the matter. A further communication on the matter will be issued in due course. I should add that payment of the grant was suspended for 1975." Mr. Sharkey said that he did not know, as yet, if this money would be forthcoming or the amount of the grant. The Chairman remarked that the position was the same as at the last meeting. Clr. M. F. Kitt T.D. asked how the grant from the Dept. of Education was determined. Mr. Sharkey replied that the money was reckoned on a capitation basis.

Clr. M. O'Morain asked if it would be feasible to have a second Mobile Library service. Mr. K. Doyle said that an overall study of the Library service was being undertaken. In relation to a second mobile unit, extra staff and the feasibility of evening mobile stops were been considered. Clr. O'Morain asked if this study would be completed before the next Library Committee Meeting. Mr. Doyle replied that it was a very detailed study of the service, and he undertook to enquire into the matter.

Mrs. Beatty asked what became of worn out books. Mr. Sharkey replied that most were destroyed but that some were given to charitable organisations. Mrs. Beatty asked if some of the worn out books could be given to school libraries. Mr. Sharkey stated he had no objection to such books being given to schools if care was taken to keep them completely separate from current stock. Clr. Ryan asked if any national school could apply for worn out books. Mr. Sharkey replied in the affirmative.

STATISTICAL REPORT 1973.

The statistical report for 1975 was considered by the Committee. Mr. Sharkey stated that it was difficult to draw a comparison with the previous report which was for a nine month period. Mr. Sharkey made reference to the drop in issues in the Athenry branch library. He had expected a drop as the branch was opened in November 1973, and usually issues levelled off after a new branch was open for about a year. The largest drop was in issues to juvenile readers. He noted that although Portumna branch was smaller in size and less attractive its total issues were greater than those in Athenry. He pointed out that apart from Galway City and Athenry branches, issues increased in eleven branches and decreased in sixteen. Issues from the Mobile Library increased by 12% on 1974. He also stated that the total number of registered readers was increasing although less books were being read. The Chairman asked Mr. Sharkey if he was pleased with the increase in the number of readers. Mr. Sharkey said that he was, but was disappointed with the drop in issues in Galway City. Clr. O'Morain proposed that an effort be made to have the study of the provision of a second mobile library service completed this year.
