ASSISTANT LIBRARIAN - GALWAY CITY BRANCH

I wish to present to the Manager and the County Libraries
Committee the following case in support of creating an additional
appointment to the grade of Assistant Librarian to be responsible
under the County Librarian's direction for the day-to-day operation
of the Galway City Branch Library.

I am convinced that this post is justified on the grounds of the increasing importance of the work carried out by the Branch, the present volume of work, the need for greater supervision, and the necessity of creating a higher standard of service for the public. POPULATION SERVED: The Branch serves a population of approximately 30,000, or 20% of the total population of the County.

PRESENT STAFF: It is staffed at present by three Library Assistants on a salary scale of £350 - £650. This scale is £130 on maximum above that of Clerk-Typist and £200 on maximum below that of Clerical Officer. The staffing, therefore, represents on the maximum of the scale a total of 3.7 Clerk-typists, or 2.3 Clerical officers.

The three members of the Branch Staff are on the same grade and there is no senior grade directly responsible to the County Library for the day-to-day operation of the Branch. Approval to the creation of the senior grade of Assistant Librarian is sought, the salary scale for which is £650 - £850, the maximum being the same as that for general service Clorical Officer.

OPENING HOURS: The hours of duty at the Branch are 10 a.m.- 1 p.m. and 2.30 p.m. - 8.30 p.m. from Monday to Friday, and 10 a.m.- 1 p.m. and 2.30 p.m. - 5.50 p.m. on Saturday. This is a total of 51 hours per week. Number of staff = 3, each working 33 hours per week = 99 working hours per week. This represents an average of less than two staff on duty at any one time to deal with all of the following duties at the one time:

- (a) Issue and receipt of books. (b) Registration of readers.
- (c) Writing of overdue notices. (d) Dealing with borrowers written application for special books.
- (e) Dealing with verbal enquiries and requests for information.
 - (f) General supervision of the Branch.

- (g) Withdrawal of wornout book, and books for rebinding from shelves.
- (h) Displays of book jackets.
- (i) Affixing plastic jackets to books assigned to Branch.
- (j) Collecting of fines on overdue books.
- (k) Keeping of records, including cash receipts and lodgments.

BOOK ISSUES: The number of books issued to the public at the Branch over the past number of years have shown a considerable increase.

This represents an increase of approximately 60% over six years, or an average increase of 10% per year. The number of books issued and returned each year is the greatest single quantitive analysis of the volume of work carried out at the Branch.

REGISTRATION: The number of registered readers for the year ended 31st March, 1962 was 3,501 or 11.5% of total population in the area served. For each member registered a form has to be checked and filed; the out-of-date form for previous year withdrawn; three tickets written in the case of an adult and two in the case of a junior reader; a charge of 2/- collected from an adult reader and a Receipt written for same.

OVERDUE BOOKS: The Branch Staff must make every effort to ensure that each of the 180 to 190 thousand books issued is subsequently returned. To do so a considerable number of overdue notices must be written daily. The following notices are sent in respect of overdue books:-

- First application when book is approximately five weeks in the hands of a city reader, and six to seven weeks in the hands of a resident from outside the city area.
- 2. Second application 14 to 21 days later.
- 3. A notice to the borrowers guarantor where the borrower himself is not a ratepayer, or a further notice to the borrower himself where he is his own guarantor 14 to 21 days later.

4. A final circular to the borrower demanding payment for the book - 3 months from date of issue.

The sending of these notices within the proper time and order, and the checking involved in respect of - right person, right address, and right guarantor, takes a considerable amount of time and effort. The number of such notices sent within the twelve months ended 30th November, 1962, was 9,009.

The tendency for people to request that a SPECIAL REQUESTS: particular book be provided has been growing over the years. Books requested are sometimes in stock and other times not in stock. Again they may be new books just published, or reviewed, or not even published, they may be old and out of print books, expensive books, or mere light fiction, they may have their origin in the United States and not capable of being traced here, the flimsiest of details may be given or as happens very frequently, the author or title requested may bear no relation to authors correct name, or the To trace these requests, first whether the book is in stock, whether it can be purchased or worth purchasing, whether it ought to be obtained through the Central Library, if in stock where is it and who has it, requires considerable time, effort and an advanced knowledge of old books, new books and bibliographical When the book requested has finally come into the hands of the Branch Staff the borrower has to be notified to collect it, and in some cases the book must be returned later to its original location whether this is a Branch throughout the county, the Central Library, or the Special Collection.

A total of 1,498 books were supplied to individual readers who made specific requests during the year ended March, 1962, at the Galway City Branch.

The total for the twelve months ended 30th November, 1962, was 1,516. Approximately 90% of books for which requests are accepted are supplied.

VERBAL ENQUIRIES: Desk staff battling with a queue of borrowers entering the Library are expected to answer a continuous stream of enquiries such as, "who wrote what", "where can I find such and such a book", "What's the class. number for Trade Unions, "how do I look up a book in the Catalogue", "I lost my tickets, I lent my tickets, lost or mislaid my books, what do I do", "Have I any other books out" if so "what are they and when did I get them", "When am I going to get that book I requested", etc. etc.

SUPERVISION: Branch staff must endeavour to ensure that books are not taken unofficially from the Library. Borrowers are not now allowed to take shopping bags into the Branch, and the desk assistant must ensure that all books are presented for stamping by those leaving the Library.

OTHER DUTIES: Other duties in connection with the operation of the Galway City Branch include, the withdrawal of wornout books and books for rebinding, periodically from the shelves, weekly displays of book jackets, the affixing of plastic jackets to new books assigned to the Branch, the calculating of the amount of fines due on books and the collection and receipt of such money, the keeping of records such as daily records of issues, receipts, monies received, registration figures, etc. and the lodgment of cash received once per week.

Each days issue of books must be arranged in numerical and classified order to provide for the clearing of tickets when books are returned.

At peak periods a member of the staff must take control of the Childrens Library.

LIBRARY PORTER: The Library Porter is required to spend approximately half his time at the Galway City Branch and is responsible during this time for replacing the accumulated books returned in their proper places on the shelves and is also responsible for re-arranging all shelves in Childrens Library, Adult Section and Reference Section daily. Generally, he must seek help from the Branch Staff in doing this, and when not present Branch Staff must replace books themselves.

It must be borne in mind in relation to all the foregoing duties as stated under the heading of "Opening hours" the average number of staff on duty at any one time is less than two. The maximum salary for the grade involved being a little higher than that for Clerk-Typist but £200 below that for General Service Clerical Officer.

It should be clearly evident from the foregoing that the Branch staff is lacking both in number and the permanent attention of a supervisory officer and that the creation of an additional post between that of junior Library Assistant and County Librarian to be responsible to the County Librarian for the day-to-day operation of the Galway City Branch is warranted, and I recommend the creation of the post of Assistant Librarian on the salary scale £650 - £850.

- LIBRARY DEVELOPMENT SCHEME: A Scheme for the Improvement and 9/63 Development of the County Library Service was circulated to members during December 1963, and was before the Meeting for consideration. The Scheme had been considered by An Comhairle Leabharlanna at a Meeting of that body on 10th January, 1964, and Mr. Foley, Director of the Council, had visited Galway for three days from the 15th to 17th January to make a survey of the existing Library Service and to study the recommendations embodied in the Scheme. The Librarian read the letter from the Library Council giving general approval to the Scheme. Mr. Foley then spoke on the Scheme and on the standard of the present County Library Service, and pointed out that he had been impressed by the improvement which had taken place over the previous ten years particularly in the bookstock. The Librarian outlined the principal recommendations in the ten year plan of development.

Mr. Foley explained the difference between the Department of Education's School Library Scheme and the County Library Scheme. The Assistant County Manager spoke on the Municipal Centre for Galway with which it was proposed to incorporate the new City Library and Headquarters. Members asked questions on various

aspects of the Scheme including cost of implementation, book transport, building of Branches, guidance to readers and service of schools. After a long discussion it was proposed by Clr. Michael Kitt seconded by Clr. P.J. Galvin and agreed unanimously that the Committee adopt the Scheme as submitted and that it be recommended to the County Council for sanction.

10/63 CO. LIBRARY ESTIMATE 1964/65: Details of the Estimates Expenditure and receipts for the County Library Service for the year 1964/65 as circulated to members were before the Meeting. The Librarian explained that the estimate presented was based on the second year of the ten-year scheme of development and that an increase of ld. in the £1. was being sought. Members pointed out that since the Scheme had already been adopted that the estimate based on it should also be adopted. The estimated expenditure shown was £27,585, Estimated receipts were £3,745 leaving a net expenditure of £23,840 or an increase of £2,605 on estimated expenditure for 1963/64. It was proposed by Clr. T. King seconded by Mr. T. Murphy and agreed unanimously that the estimates as presented be adopted and recommended to the County Council for sanction at the Amual Estimates Meeting. The Assistant Co. Manager pointed out that it might be necessary to amend the Estimate to provide for salary increases under the Ninth Round etc.

To a question from Clr. Hynes, regarding the proposed new Branch Library at Ballinasloe, the Assistant Co. Manager explained that all delays had now been cleared up at local level and that the plans would be with the Library Council within a fortnight.

The Chairman welcomed Clr. Michael Carty back after his illness, thanked Mr. Foley for attending the meeting and congratulated Miss M. Kavanagh on her promotion to the grade of Assistant Librarian.
