Minutes of the Annual Meeting of the County Libraries' Committee, held on Thursday 14th August, 1969, at 4 p.m., in the Council Chamber, County Buildings.

Mr. Howlett presided until the election of a chairman had taken place.

ELECTION OF CHAIRMAN & VICE-CHAIRMAN: Clr. M. F. Kitt proposed the re-election of the Venerable Archdeacon Glynn, as Chairman for the coming year. Clr. T. Clarke seconded the proposal which was passed unanimously. Ven Archdeacon Glynn then took the chair. He thanked the committee for his re-election and congratulated Clr. John Geoghegan on being appointed Parliamentary Secretary to the Minister for Social Welfare. Deputy M. F. Kitt was proposed as Vice Chairman by Clr. T. Boyle, seconded by Clr. S. Donnellan and was unanimously re-elected.

MINUTES OF PREVIOUS MEETING: The minutes of the previous meeting, as circulated to each member, were taken as read and it was agreed that they be signed.

# MATTERS ARISING FROM THE MINUTES:

SPIDDAL BRANCH: Mr. T. Sharkey stated that work on Spiddal Branch Library was going ahead satisfactorily and would be completed in a short time.

BALLINASLOE BRANCH: The contract for the new Branch Library at Ballinasloe has been granted to Ml. Kenny & Sons. The documents are at present with the County Solicitor.

The New Mobile Van is at present under construction.

The New School's Van will be delivered in September.

APPOINTMENT OF COUNTY LIBRARIAN: Ven. Archdeacon Glynn and Deputy M. F. Kitt congratulated Mr. T. Sharkey on his appointment as County Librarian. Mr. C. Townley joined in the congratulations.

He said that U. C. G. was about to erect a 2,000 seater library and called for continued co-operation between the County Library and the University Library.

Mr. Sharkey thanked the Ven. Chairman and members for their good wishes.

STATISTICAL REPORT: Mr. Sharkey commented on the Statistical report for the year 1968-1969. He pointed out that expenditure had increased and that 20,853 new books were added to stock compared with 14,873 the previous year. The number of registered readers showed a slight overall increase. Some branch libraries showed a drop in book issues and others recorded an increase. There was an overall increase of 1,927 in books issued at County Branches. An increase of 3,818 book issues was recorded at Galway City. Issues on the Mobile Library dropped by 6,814. This was because many schoolchildren formerly using the mobile library were now being catered for by the School's Library service and also because the mobile was unable to travel on a number of occassions due to mechanical defects. There was a big increase in the number of books issued at schools during the year.

The Librarian's report was adopted.

#### SCHOOLS' LIBRARIES:

Mr. T. Sharkey stated that a grant of £3,035 had been received from the Dept. of Education towards schools' libraries. This amount was calculated at 2/3d. per pupil in primary schools - 2/- for books and 3d. for administration. The grant will be available for the next five years, and will then be reviewed and probably increased. He also stated that an additional library Assistant would be needed to deal with the extra work involved and pointed out that the grant towards administration from the Department of Education would pay the new assistant's salary in the current financial year. The County Council would have to pay approximately £180 towards the new appointee's salary next year. A library assistant with long service was shortly leaving the Galway service on promotion and would be replaced by a library assistant on the minimum of the scale. He did not therefore anticipate that the Council would have to pay more in salaries next year even if the new appointment was made.

Deputy M. F. Kitt proposed that the appointment be made and the proposal was seconded by Clr. Mrs. Croffy.

The County Librarian was instructed to convey the Committee's thanks for the grant to the Department of Education.

#### LOSSES OF BOOKS:

Mr. T. Sharkey stated that there was a loss of 3,338 books during the three-year period 1966-1969. He had decided to place a box outside the library during the holiday period, for the return of books, taken illegally from the library.

#### STAFF CHANGES:

Mr. Sharkey informed the Committee that Miss Marie Crowe formally of Limerick City Library had taken up duty as Assistant County Librarian in June and that a library Assistant, Miss Margaret Foy, would be leaving for Cork City Library in September on her promotion to the grade of Assistant Librarian.

Mr. Sharkey, on behalf of the staff, congratulated Deputy S. Geoghegan on his promotion.

The Committee, on the proposal of Clr. P. Joyce seconded by Clr. M. Ryan, congratulated Senator John Mannion on his election to An Seanad.

#### VOTE OF SYMPATHY:

Clr. Holland proposed a vote of sympathy with Seamas Uasal Mac Domhnaill, C.E.O. on the death of his brother.

All members stood as a mark of respect.

The meeting then ended.
