REPORT.

In accordance with the instruction of the Council that "before any appointment is made either to a new position or to fill a vacancy an enquiry should be held by the Finance Committee as to :-

- (a) Whether such appointment is necessary,
- (b) The salary to be paid,
- (c) The duties to be discharged,
- (d) Whether pensionable or not,

and a report submitted to the Council on these points before any advertisement is issued."

The Finance Committee hereby report to the Council that they have had before them a statement of the Salaries and Emoluments of the late Secretary as follows :-

1. Salary as Secretary to the Council	... £800 per annum.
2. Salary as Clerk to Local Authority under Diseases of Animals Acts	... £150 per annum.
3. Salary as Clerk to Old Age Pensions Committee	£ 10 per annum.
4. Fees on Certificates of Valuation (say)	... £ 10 per annum.
5. Remuneration under Registration of Voters' Acts, variable, paid in 1924.	... £949
6. Remuneration under Jurors' Acts, variable, amount paid in 1924.	... £466
Total,	£2,385

Of this total £2,365 was paid by the County Council, items 3 and 4 being paid from other sources. The Scale for No. 5 the Committee find has been reduced from £1 per hundred, to 16/8 per hundred names, and with regard to No. 6, Secretaries or Rate Collectors appointed after November 1923, are not entitled to any Fees for Jurors' Lists.

Mr. Fogarty applies to the Council through the Committee for promotion to the Secretaryship. The Committee recommend Mr. Fogarty to the Council for promotion, and attach a copy of his application. The Committee accordingly report to the Council.

- (a) That it is necessary to appoint a Secretary.
- (b) The Committee recommend the Council to adopt the principle of promotion, and they recommend the Accountant for promotion to the Secretaryship on the following terms :-
A Salary equal to his present salary as Accountant (£240) plus £500. All fees over £500 to go to credit of the County Council.
The Committee further recommend that Mr. P. Crowe, be promoted to the Accountantship with such increase of salary as the Council may think fit.
- (c) The Secretary to be responsible to the County Council for all its work.
- (d) Office to be pensionable.

GENTLEMEN,

I beg respectfully to apply, through the Finance Committee, to the County Council for promotion to the Office of Secretary, now vacant. I was the first official directly appointed by the Council in 1899, and was largely responsible for the organising work of bringing the first Local Government Act into operation in County Galway.

I have been responsible directly to the County Council for the Accountancy work for which I receive a salary of £240 per annum. This is the lowest salary for this office in Ireland. I have not sought to have it increased owing to the fact that, by arrangement with the late Mr. Seymour, I became responsible to him for the general supervision of his Secretarial, Statistical and Registration work in return for which services he divided with me the fees for Registration work, paying me in this way yearly sums equal to between £450 and £500 per annum nett.

The special Departments of County Council work organised and started by me include the Insurance Society, the Sanatorium Committee, the Insurance Committee, the Union Amalgamation Committee, and the Board of Health. For all of these county activities I acted as first Secretary, and might indeed as I was requested to do have retained some of these offices with their salaries, but I relinquished them in turn as soon as they were organised and working smoothly, as I considered that my first duty was to the County Council, and consequently all this arduous organising work has not resulted in any increase in my pensionable salary.

The records of the Council show, and many members know of the wearying, protracted, and, in the end successful struggle I carried out, as their representative on behalf of the Loughrea and Attymon Railway guaranteeing ratepayers, recovering nearly £5,000 for which I never asked for any remuneration.

Now a vacancy has arisen upon which I most respectfully submit I have a prior claim. The best part of my life has been spent in the service of the Council, and I am no longer a young man. To refuse me this promotion would be to inflict on me the hardship of suffering a reduction of £500 a year in my income, as well as the humiliation of being passed over in favour of somebody junior in age and experience. The Council will, I earnestly trust, consider me worthy of better treatment.

I respectfully suggest to the Committee that by promoting me to the Secretaryship, and promoting a senior clerk to the Accountantship with a suitable increase of salary :-

- (a) The cost to the Ratepayers will be less than can be secured by any other arrangement; and
- (b) The adoption of the principle of promotion will maintain and increase the efficiency of Local Government service.

If Banks or other public Institutions were to go outside the ranks of their own staffs when managerships fall vacant, the type of entrants to their service would quickly deteriorate, and less of efficiency would inevitably result. Do not close the way to the top, if you want the right type of youth to put his foot on the bottom rung of the ladder.

My interest however in the matter is frankly personal. I have worked hard for promotion, and I respectfully ask it at the hands of the Council as a reward for faithful service.



I am directed by the County Council to again draw your attention to the fact that essential County services are in serious danger of being brought to a stand still for want of funds. There is no reason why this should be so if the Collectors of Poor Rate set diligently to work and carry out the duty for which they were appointed.

The County Council will insist on the prompt collection of Rates, and have directed the Finance Committee to take drastic steps with any Collector who does not make regular and substantial lodgments. The Finance Committee, being a Committee of the Whole House, has been authorised to use all the powers of the County Council in dealing with Collectors and Ratepayers.

Every assistance that the law can give and that the Council can secure will be placed at the disposal of Collectors in the discharge of their important duties.

THE MONEY MUST BE GOT IN, AND GOT IN QUICKLY.

The Mental Hospital, the Sanatorium Committee, the services administered by the Board of Health, and the Public Works, and Agriculture and Education Departments are all calling for money, and the Council cannot meet these claims unless the Ratepayers meet their Rate liabilities promptly.


