Scope and Content

The collection consists of two volumes of minutes of county Galway's National Monuments Advisory Committee meetings. The National Monuments Act, 1930 stipulated that every Local Advisory Committee should consist of not less than three nor more than five members, however as time passed the number of full members permitted grew.

The Committee gave advice on the care, protection and maintenance of national monuments in County Galway, and submitted proposals for vesting monuments in the Council.

Membership was made up of full and honorary members. Initial members for instance included Rev. Fr Crehan, Rev. Monsignor Hynes, Fr Egan (Chairman for many years), Lord Killanin, Dr T.B. Costello, Professor M Duignan, P Fahey, and H.P McGlory. Members in the early 1970s included for instance Rev. Egan, Cllrs J Donelan, and P Fahey, Fr Coen, D. J. Murphy (+1990), Martin Joyce, N.T. (+1991), M. J. Molloy (playwright, + 1994), Etienne Rynne (UCG) (+2012). In the 1980s membership also included P. Holland, Tom Fanning (UCG) (+1993), Dr A Claffey and Paul Gosling (UCG), James Joyce (Chairman 1991, appointed to National Heritage Council & the National

Wildlife Advisory Council in 1992), and in the 1990s also included Mrs Anna McHugh (Caherlistrane), Michael Mullens, Pierce Joyce, Erin Gibbons (Clifden), and Evelyn Varley. From the 1980s onward membership was made up of 10 members, together with at least 15 honorary members.

Volumes of minutes of meetings, generally held four times a year, on typed sheets pasted or sellotaped into volumes, recording details of attendance and business transacted by the Committee, relating to advise given on the care, protection and maintenance of national monuments in County Galway, proposals for vesting monuments in the Council, details of correspondence, such as from Bord Fáilte, received and dealt with.

Monuments receiving ongoing attention from the Committee included the Belleview Gates in Laurencetown, Athenry Town Walls, Clonfert Cathedral, Clontuskert Abbey, and Ross Errilly (Headford).

Includes:-

- 'It was decided that a report be obtained from the County Engineer on the condition of the monuments which are at present vested in the Council and that consideration of what further monuments should be so vested be placed on the Agenda for next meeting' (12 Mar 1947).
- 'That the Committee whole heartedly endorses the County Manager's recent suggestions to the County Library Committee for a new Civic Centre, including a Museum and Art Gallery' (19 Jun 1947).
- 'A letter dated 30 June from the Irish Tourist Board was read and considered. In the
 Committee's view the substance of the letter was to the effect that National Monuments
 were of no interest to tourists. With this view the Committee strongly disagreed. The Hon.
 Secretary was instructed to write to the Irish Tourist Board inviting the Board to reconsider
 the matter' (26 Aug 1947).
- <u>'Kiltiernan Church</u>: Prof Duigan pointed out that the task of conserving Kiltiernan Church was too big for the committee since any repairs should only be carried out in conjunction with scientific excavation of the entire site. He informed the Committee that, in consequence of recent appointment of Dr Benu to a professorship of archaeology in the Royal Irish Academy at the insistence of An Taoiseach, state funds were now once more available for such excavation; that he had been informed that a due proportion of such funds would be allocated to work in the West....' (26 Aug 1947).
 - 'The 'Spanish Arch', Galway: The County Manager drew the attention of the Committee to the question of ownership of the Spanish Arch. The adjacent premises had been purchased by Miss Claire Sheridan who claims thereby ownership of the Arch. The Arch was not vested in the County Council. The Harbour Board disclaimed ownership. Miss Sheridan has expressed orally her intention of preserving the Arch...' (26 Aug 1947).
- <u>'Portumna Castle & Dominican Friary</u>: Lord Killanian drew the Committee's attention to the announcement that the Harewood estate Portumna was to be sold and drew attention to the importance of the Clanricarde Castle and the Dominican Friary there. The Chairman under



took to raise the matter at the forthcoming meeting of the National Monuments Advisory Council...' (26 Aug 1947).

- <u>'High Cross & St. Jarlath's Church</u> Tuam: The Hon. Sec drew the Committee's attention to the "Journal of the Galway Archaeological & Historical Society" II, 1902, p125 from which it appears that the County Council has assumed the custody of these monuments about 1901/02, and had carried out repairs to them at that time. He also drew attention to the bad condition of the Cross today....' (1 Jun 1948).
- <u>'Gateway at Belleview, Laurencetown</u>: Fr Egan proposed and it was agreed that this historic Gateway, with an inscription commemorating Irish Parliamentary Independence, 1783, should be preserved. The County Manager to be requested to have necessary inspection carried out and estimate submitted' (9 Feb 1950).
- 'CLAREGALWAY CASTLE: Dr Costello stated that ivy is threatening to damage the Castle. The Hon. Secretary pointed out that Claregalway Castle is a private residence and that it was a matter for informal personal representations to the owners' (9 October 1951).
- 'CLONTUSKERT ABBEY, ETC. BALLINASLOE: Prof Duignan reported that Clontuskert Abbey is remarkable for a number of interesting rare architectural features, that he believed the work of repairing it is beyond the technical and financial resources of the County Council, and recommended to the County Manager be requested to address an urgent plea to the Office of Public Works inviting them to assume responsibility for the repair and maintenance of this monument, and pointing out to them that the monument is in urgent need of attention...' (6 May 1952).
- <u>'SPANISH ARCH, GALWAY</u>: The Committee considered a verbal report to the effect that Mrs Claire Sheridan had sold the Spanish Arch and that the purchaser proposed to set up a "Spanish Tea Garden" thereon. The Secretary was instructed to write to the Mayor and Corporation to urge that everything possible de done to preserve the Monument and to safeguard it from inappropriate utilization' (16 Sept 1952).
 - 'LETTER FROM AN BORD FÁILTE: The Hon. Secretary reported that for the adequate discharge of its functions, An Bord Fáilte had appointed an Archaeological Officer, Mr Hartnett, The National Museum; that he, the Secretary, had recently been invited to a Conference with Mr Hartnett and other persons concerned, but owing to absence in England had been unable to do so. He had since received a communication from Mr Hartnett outlining the sort of steps which the Board had under consideration with a view to improving attractions and facilities of national monuments from the point of view of the Tourist trade. The Bord is anxious to make the fullest possible use of its powers under the 1952 Act and drew attention to the fact that the Bord is empowered to undertaken the repair and conservation of ancient monuments...' (2 Mar 1953).
- <u>'Spanish Arch, Galway</u>: A report dated 2253 from the Borough Surveyor, Galway, who stated that the estimated cost of putting this structure into a good state of preservation would be

- £200, was read. This estimate was conveyed to An Bord Fáilte on 4/12/53 and a reply is awaited' (9 Dec 1953).
- 'Clontuskert Abbey: It was reported that the County Manager had made an Order authorising the expenditure of a sum of £680, as per County Engineer's estimate of 3/12/1953, on repair work to this Abbey and such work on the access road as may be agreed on with An Bord Fáilte which has undertaken to pay the cost...' (2 Mar 1954).
- Aughnaure Castle: The preservation of this national monument which is in State care was taken up with An Bord Fáilte who are going to spend a certain amount of money on cleaning up same and fencing it in. The Acting Hon. Secretary reported that Mr Le Clere, together with Mr Harbison (Archaeological Officer, Bord Fáilte) of An Bord Fáilte, inspected the monument on the 27th February and a report is still awaited' (2 Mar 1954).
- Tempull Beag na Naomh and St Brecan's Church, Killanin: The Acting Hon. Secretary reported that the County Manager had made an Order authorising the carrying out of work on Tempull Beag na Naomh at an expenditure of £25 and on St. Brecan's Church at a cost of £20...' (2 Mar 1954).
- Athenry Town Walls (2 Mar 1954).
- <u>'Bellevue Gate</u>: Fr Egan reported that this gate was to be taken over by the State as a National Monument' (6 Dec 1954).
- <u>'Folklore Museum:</u>...."That the County Manager be asked to consult with the Corporation, County Council, National Monuments Advisory Council to the Board of Works, the Irish Folklore Commission, An Bord Fáilte, the Galway Archaeological Society and this Committee, with a view to the immediate establishment of a folklore museum in County Galway' (6 Dec 1954).
- <u>'Addergoole Cross</u>: This cross has not yet been found. It was decided to ask Lord Killanin if he has been able to find out anything about it' (12 Jun 1956, see also 12 Aug 1960 & 16 Nov 1960).
- <u>'Dunsandle</u>: Professor Duignan stated that the National Monuments Advisory Council have made exhaustive efforts to get a new owner and have set up a sub-committee to investigate the whole problem including taxation, maintenance, etc...' (12 Jun 1956).
 - 'GRAVEYARD AT ROSSERRILLY: Mr Murphy stated that tombs had been broken into some years ago through vandalism, and that they were now in a very dilapidated condition. It was decided to write to the Commissioners of Public Works drawing their attention to this fact' (12 Aug 1960).
- 'ABBEYNOCKMOY CHURCH: Mr Murphy said he was informed that the stone taken to Dublin from the east window of the church at this Abbey in 1853 was not back in Ballyglunin...' (12 Aug 1960).

<u>'LION'S TOWER, GALWAY</u>: Motion received from Professor Hayes McCoy was read. It was agreed by the members that this monument was primarily of interest to Galway and to the people of Galway, and that if they want it preserved they should be prepared to help to pay for it.

Professor Hayes-McCoy's motion was amended slightly, and the following motion was carried unanimously, on the suggestion of Mr Joyce:

"That the Committee deplores the threatened destruction of the Lion's Tower bastion in Eglinton Street, Galway, built in 1646, and trusts that steps will be taken by the Corporation and citizens of Galway to preserve this historic memorial' (12 Aug 1960).

- <u>'YEAT'S CASTLE, BALLYLEA</u>: Mr Dolan told the meeting of the vandalism which has been the cause of continued deterioration of this castle, and it was decided to write to Mr Yeats asking him if he would have any objection to the Committee's approaching the Commissioners of Public Works to take over the Castle...' (12 Aug 1960).
- <u>'CONGRATULATIONS</u>: Mr Joyce congratulated Fr Egan on the publication of his book on the *History of Ballinasloe*, and said he was honoured to have been associated with Fr Egan. The vote of congratulations was enthusiastically endorsed by all the members' (12 Aug 1960).
- <u>'MILE-STONES, ETC:</u> Mr Murphy said that many of the old mile-stones were destroyed during the course of road works, and it was decided to write to the County Secretary requesting that road workers be informed that these mile-stones should be preserved...' (16 Nov 1960).
- <u>'LYNCH WINDOW, GALWAY:</u> A letter from Bord Fáilte was read recommending that something should be done about this monument. Bord Fáilte stated that the Committee should get in touch with Mr Wilfrid Cantwell, Architect, who would give advice on the Lynch Window. The Committee decided to explain to Bord Fáilte that it had no connection with the Galway Corporation and that it was not responsible for the ancient monuments in Galway City which are under the authority of the Corporation. The Committee recommended that Bord Fáilte should write to the Corporation on the matter' (10 Dec 1962).

'ADDERGOOLE CROSS: Mr Murphy stated that the old church at Addergoole had recently been demolished and that His Grace, the Archbishop of Tuam, had protested about its demolition to the County Council. The proposal now is that the cross should be removed from its present position (in a field adjacent to the Cemetery) and erected in the cemetery itself. The Committee approved of this arrangement...' (26 Mar 1963).

- <u>'TUROE STONE</u>: The way of access to this monument was discussed. Lord Killanin stated that he had visited there recently and that the driveway was in good condition. There was discussion as to whether the stone was the property of the Office of Public Works or not...' (26 Mar 1963).
- <u>'KILCORNAN</u>: Prof Duignan reported that this ruin is of a simple rectangular church of the 14th-15th century, with a partly restored East window. He considered it worth preserving, but for County Council preservation the object would have to be made over to them. The Secretary



was instructed to write to the Superior of the Brothers of Charity there and explain how simple it would be to keep it in repair, and that Prof. Duignan would be prepared to go out and advise on it by appointment' (13 Sept 1965).

- 'CORRESPONDENCE: The Secretary read a letter from the National Monuments Branch, Office
 of Public Works to the Secretary of Galway County Council informing him that Clontuskert
 Abbey had been placed in the guardianship of the Commissioners of Public Works for
 preservation as a National Monument' (14 Mar 1966).
- 'MONUMENTS IN ARAN: Deputy Molloy stated that the Council were neglecting the
 monuments in Aran. Dun Aengus and the Seven Chapels in particular. They also suggested
 that the existing paths to Dun Aengus be improved and better signposting be provided. Fr
 Egan to write to County Council and Bord Fáilte regarding this' (16 Oct 1967).
- <u>'Protestant Church in Gort</u>: Father Coen said the difficulty here is that there is a Catholic graveyard on one side and a Protestant graveyard on the other. The Protestant Rector would be willing to have it used as a cultural centre. The Committee thought it did not come under their terms of reference' (8 Jun 1971).
- <u>'Kilmacduagh</u>: Fr Coen referred to projected renovation by local effort. Mr Rynne said the road making would be in order but the ruin is a National Monument and may not be interfered with. Secretary to write to parish priest and County Council' (14 Dec 1971).
- <u>'Galway Town Wall in Corbett's Yard</u>: Suggestion that National Monuments Inspector be asked to excavate on both sides of it' (13 Jun 1972).
- 'Architectural Heritage Year, 1975: It was suggested that the Committee advise the County Council to do something and members were asked to have proposals for next meeting' (8 May 1974).
- <u>Athenry Town Walls:</u> Mr Rynne stated that the National Monuments Council has recommended that the Commissioners of Public Works put the walls in repair. This being so, the Secretary is to recommend to the County Council that it forego any rights it may have in parts of the walls in favour of the Commissioners' (12 Mar 1975).
- County Archaeologist: Councillor Ryan said that the matter was being considered by the
 County Manager. He and Councillor Morgan agreed to try and get even a limited sum made available, say £1,000 for a trial period of four months' (12 Sept 1975).
- <u>'Lydican Castle</u>: This is vested in the County Council. The Secretary to request that the protection wall which a farmer knocked to let this cattle in be replaced' (12 Mar 1976).
- <u>'Monument at Monivea</u>: Mr Rynne said it is a National Monument and the finest mausoleum in Ireland. Secretary to write to National Monuments Council requesting that it be recognised as a National Monument and included in this list of National Monument' (12 Dec 1975).

- <u>'Appointment of Co. Archaeological Officer</u>: Mr Rynne reported that Co. Manager was satisfied to sponsor a baronial survey carried out by students of Dept. of Archaeology, U.C.G. (14 Apr 1978).
- <u>'Terryland</u>: Secretary instructed to write to Mr G Lee, B.E., U.C.G., and to President, U.C.G. asking that consideration be given to preservation and if not possible, to have its historical significance recorded' (16 Jun 1978).
- <u>'Athenry Walls</u>: Secretary, Councillor Ryan and Fr Coen met County Manager before Meeting. Mr Joyce made the case for consultation with National Monuments Advisory Committee where planning permission was sought in proximity to historic and archaeological sites....' (12 Jan 1979).
- <u>'Athenry Walls</u>: Fr Fanning reported a change of Office of Public Works Policy in regards to National Monuments. They were now prepared to grant money for "rescue-operations" (12 Feb 1981).
- <u>'Inscribed Stone and Cross Head (Tuam)</u>: Dr Claffey said this was a subject of dispute. Stone and Cross Head were in possession of Member of Old Tuam Society. Diplomacy required. Undertook to have mater solved locally' (11 Feb 1982).
- <u>'Bellview Gate</u>: Profession Rynne submitted report which stressed the architectural, historical and touristic value of Bellview. Secretary asked to send (copy) copies of report to County Council and Bord Fáilte asking that they give the matter special attention as this (1982) is bicentennial year of its erection...' (24 Apr 1982).
- <u>'Clonfert Cathedral'</u> Agreed to offer advisory help to Bishop Empey re restoration of Clonfert Cathedral' (12 Jul 1984).
- <u>'BALLINDOOLEY CASTLE:</u> A letter was received from the County Secretary, stating the position as regards Ballindooley Castle. In January, 1986, the Council was notified by the OPW that the building had been listed pursuant to Section 8 of the National Monuments (Amendment) Act 1954. Prior to this the Co. Co. had taken proceedings against the owner who was fined but had appealed to the Circuit Court. ...' (10 April 1986).
- 'Clonfert Cathedral: Chairman informed the meeting that Mr T Fanning had told him that he and Mr Maurice Craig were trying to have Clonfert Cathedral declared a national monument thus become eligible for an E.E.C. grant' (11 Feb 1988).


Archaeological Report had not received sufficient attention as regards notice beforehand of

- '...case involving the Gardai, where a medieval Castle at Cahernamuck West, near Loughrea, was blown up by its owners, using legally held explosives. It appeared that the permit issued in respect of the explosives was for the demolition of "an old house", but that the actual permit was not in the possession of the Gardai who attended on the demolition work. Thus, they were unaware of the discrepancy between the licence and the actual character of the remains....' (5 Nov 1991).
- **Lighthouse at Ballycurran**: Cllr Varley said that the Lighthouse at Ballycurran, Headford was in bad condition, and it was agreed to contact the Lough Corrib Navigation Trustees in relation to this matter' (11 Dec 1991).
- Correspondence: The Secretary reported that two further submissions had been received for inclusion on the proposed list of estate gateways in Co. Galway. These were from Mr Kilcummins, and from a Mr Cronin listing examples in north-east Galway (no address given).
 Mrs McHugh states that a list of submissions was being compiled by Mr J Higgins¹, and would be forwarded to the Secretary' (8 Dec 1992).
- 'The situation with regard to Tyrone House was discussed and it was stated that stones were being taken from the buildings on the site. It was proposed by An t-Uasal Breathnach, and seconded by Mrs McDonagh, that a letter be written to the OPW, asking that Tyrone House be listed for preservation as a National Monument or that it be listed for protection' (27 Apr 1993).
- 'Other Business: The Chairman referred to letters he had received from the Minister, Mr Ml. D. Higgins, and the Minister of State Mr Noel Dempsey, regarding Inchagoill. Both stated that the developments taking place are on land owned by Coillte, and are a matter for Coillte, but that the developments do not pose a threat to the National Monument whose conservation and protection are matter for the OPW. The large tree overhanding (sp) the 12th century church was a unique evergreen oak which was preserved by Coillte...' (3 May 1994).
- 'Mrs McHugh gave a brief outline of the events planned worldwide in connection with the Famine Commemoration which will be held from December 1995 to 1997. She also mentioned that GCC failed to pay a contribution of £100 to the Famine committee...' (7 Jun 1994).

NATIONAL MONUMENTS ADVISORY COMMITTEE

Minutes of Meeting held at the County Buildings, Galway, on 12th March, 1947.

Present: Right Reverend Monsignor Hynes, Lord Killanin, Dr. T. B. Costello, Professor M. Duignan and Mr. H. P. McGlory.

Apologies for inability to attend were received from Rev. Fr. Crehan and Mr. P. Fahy.

It was proposed by Dr. Costello, seconded by Professor Duignan and unanimously Resolved:-

"That Monsignor Hynes be appointed Chairman of the Committee."

Professor Duignan proposed, Lord Killanin seconded and it was unanimously Resolved:-

"That an Honorary Secretary to the Committee be appointed."

Mr. McGlory proposed, Lord Killanin seconded and it was unanimously Resolved:-

"That Professor Duignan be appointed Honorary Secretary."

The County Manager informed the Committee that premises for holding meetings would be available in the County Buildings and that the services of a Shorthand-Typist would also be available when required.

The County Manager read list of monuments which are vested in the State and also list of monuments which are vested in the Council.

It was decided that a report be obtained from the County Engineer on the condition of the monuments which are at present vested in the Council and that consideration of what further monuments should, be so vested be placed on the Agenda for next meeting.

The County Manager suggested that the Irish Tourist Board should be requested to erect sign posts on the roads adjacent to the more important monuments, and to make available locally printed pamphlets giving the history, etc., of such monuments.

Dr. Costello requested that the following monuments be vested in the Council:-

- (1) Inscribed slab taken from the old wall at Galway at present in possession of Mr. Kerins, Cregg.
- (2) The Lally monument 11 miles north of Tuam.

Mr. Fahy wrote requesting that something be done to preserve the old Church at Kiltiernan.

Professor Duignan stated that the preservation of this Church was already considered by the Office of Public Works.

It was arranged that the next meeting of the Committee would be held as soon as possible after the County Engineer had submitted his report on the condition of the monuments at present vested in the Council.

NATIONAL MONUMENTS ADVISORY COMMITTEE.

MINUTES of Meeting held at the County Buildings, Galway, on 19th June, 1947, at 4.30.p.m.

Present: Very Reverend Canen Crehan, P.P., Dr. T.B. Costelle, Lord Killanin and Professor Duignan.

In the unaveidable absence of the Chairman Lord Killanin proposed, Canon Crehan seconded, and it was agreed that Dr. Costello should take the chair.

MINUTES: The Minutes of the previous Meeting were read and signed.

It was then decided to consider the reports received from the County

CORRESPONDENCE: Messages of apology for inability to attend were received from Right Reverend Monsigner J. Hynes, Chairman, and Mr. Padraig O'Fhathaigh. Mr. O'Fathaigh once more drew attention to the importance of the early monastic remains at Kiltiernan.

COUNTY ENGINEER'S REPORTS: Reports from the County Engineer's Staff; on the condition of the monuments already vested in the County Council were then considered:-

- (1) "Giants' Grave". Grannagh: It was agreed that there was no immediate danger to the menument but that it should be kept under observation in view of possible encreachment by the adjacent gravel-pit.
- (2) Cist at Annaghkeen, Headford: It was agreed to request the County Manager to have the Engineer's proposals carried out, viz., to remove briars and bushes, to re-creet entrance style, and to clear up the site generally at an estimated cost of £12.
- (3) Stone Gresses and Hely Well, Ballingarry: The Engineer was unable to locate these menuments. It was agreed to ask Mr. Padraig O'Fhathaigh if he could help.
- (4) Castle and Town Walls, Athenry: Prefessor Duignan pointed out that these remains were in State charge, that repairs had been carried out in recent years and that further repairs were contemplated. It was agreed that the question of ownership should not be raised and that the only action taken should be to call the attention of the Inspector of National Monuments to the present condition of the monuments in question.

- (5) Lydican Castle, Ardrahan: The Committee agreed (i) that the eastle should be cleaned out and a barrier erected so as to keep live-stock from fouling the interior;
 (ii) that the question of further expenditure be deferred.
- (6) Glinsk Castle, Ballymee: The Engineer reported that no work is required.

Very Reverend Canen Glynn pointed out that the Castle was fouled and begged by livestock, that a gate should be erected so as to prevent this, and that the tops of the walls required treatment.

Dr. Costelle stated that at his suggestion the Castle had been taken ever by the State about five years age.

Prefesser Duignam peinted out that the Council's records were incomplete.

It was agreed that an inquiry as to ewnership should be addressed to the Inspector of National Monuments, and that if it is not vested in the State an effort should be made to find out if it had ever actually been vested in the County Council.

(7) Church and Menuments, Ballynakill, Glinsk: It was agreed that steps be taken to confirm the County Council's ewnership of these remains, and that if they are vested in the Council, the repairs, etc. proposed by the County Engineer at an estimated cost of £20 should be undertaken at once.

Matters arising out of Minutes: The Hon. Secretary reported that he had interviewed the County Manager and put forward the views of the Committee: -

(1) To request the provision of a Shorthand-Typist who would attend meetings, enter the Minutes in the Minute Book and send a copy to the County Manager.

(2) To request the attendance of the County Engineer or his representative at meetings for the purpose of advising the Committee.

The County Manager expressed his approval & these proposals.

(3) With regard to the appointment of a representative of the Corporation, the County Manager was of opinion that the question would best be met by applying to the Corporation for ad hoc assistance according as questions relating to the city presented

(4) The Committee's views with regard to the nomination of a successor to the late Monsignor J. Hynes were conveyed to the County Manager.

The County Manager expressed the opinion that he should be kept informed by the Office of Public Works when monuments were taken into State custody or care or when Preservation Orders were issued. The Hon. Secretary reported that he had interviewed the Inspector of National Monuments in this regard and hopes that the situation will be better in future.

Mr. Martyn, Assistant County Engineer, drew the Committee's attention to a letter dated the 20th June, 1949, received from Mr. H. Finnegan, B.E., stating that the landowner at Glinsk, Ballymoe, had recently offered to sell him the stones of the Castle. The Hon. Secretary was instructed to inform the Inspector of National Monuments at once.

The Committee's Previous Recommendations to the County Manager:

Ballynakill or Glinsk Church and Monument: An estimate has already been received from the County Engineer. The Hon. Secretary directed

attention to the fact that the Inspector of National Monuments finds. by experience, that the use of cement in repair work can prove disasterous to certain types of stone, particularly sand-stone and certain types of free stone. He recommends - (i) that gauged mortar, not containing more than 10% cement, is the ideal mixture. They have found also, by experience, that iron straps or ties should never be used -(ii) where necessary bronze should be used. The Committee recommend that these points be brought to the notice of the Engineering staff. Mr. Martyn stated that work on the Abbey would commence week beginning the 28th June, 1949, under the supervision of the local engineer -Mr. H. Finnegan.

Cist at Annaghkeen. Headford: Mr. Martyn reported that the work herein was carried out about a year ago.

Lally Monument: Mr. Martyn reported that the local Engineer was in consultation with Dr. Costello on the matter.

Lydican Castle, Ardrahan: Mr. Martyn reported that the repair of the Castle was carried out about eighteen months ago at an expenditure of £60 and that further work at an estimated cost of £38 was recommended. The Committee recommended that the question of further work at Lydican be deferred.

Correspondence: A letter from Professor Mrs. M.D.O'Sullivan, forwarded by the County Manager, was received relative to Renvyle Castle. Lord Killanin reported that the castle was in very bad condition and devoid of architectural interest. Dr. Costello recommended that we call the attention of the National Monuments Council to it as its repair is beyond the means of the Local Committee.

Ballynakill or Glinsk Church and Monument: Mr. Collins reported that so far nothing had been done in this matter. He promised to ask the County Manager to sanction expenditure involved.

Lally Monument: Dr. Costello reported that the necessary repairs have been completed.

Teampall Beag na Naomh, Killanin, and St. Berchan's Church, Roscahill E: Lord Killanin reported that these ruins appear to be deteriorating. He proposed and it was agreed that immediate steps be taken in the matter.

Athenry Town Walls: Mr. Collins reported that this work had commenced - in fact, that a sum of £200 had already been expended on it.

Ruins of Temple Jarlath, Tuam: Dr. Costello read a letter from the Old Tuam Society intimating that they had exhausted their funds on the maintenance of this monument and asking the County Council to repair top of walls and remove growths. Professor Duignan reminded the Committee that County Council had taken over this Monument 1901/1902 (Minutes of Meeting 1st June, 1948). It was agreed to ask the County Manager to have the monument inspected and an estimate submitted.

Leacht in Fahy's Land, Monument Park, Tuam: Dr. Costello reported that Mr. Fahy had re-built the Leacht, but that now it has fallen down and the inscribed slabs are in danger of being broken. Mr. Fahy is willing to have repairs done by County Council. It was agreed to request the County Manager for a report and estimate.

Gateway at Belleview, Laurencetown: Fr. Egan proposed and it was agreed that this historic Gateway, with an inscription commemorating Irish Parliamentary Independence, 1783, should be preserved; the County Manager to be requested to have necessary inspection carried out and estimate submitted.

Clontuskert Abbey & The Teampaillin, Ballinasloe: Fr. Egan drew attention to these. It was agreed to ask the County Manager for a report by the County Engineer and to bring the matter to the attention of the National Monuments Council.

Portumna Castle: Lord Killanin mentioned that rumour has it that access to the Castle is not now allowed, and recommended that the matter be referred to the Inspector of National Monuments for investigation.

Matters Arising Out of Minutes:

Ballynakill Church: The County Manager wrote on the 30th March, 1950, to the Inspector of National Monuments requesting confirmation of the County Council's responsibility - no reply since received.

Glinsk Castle, Ballymoe: The County Manager wrote to the Inspector of National Monuments on the 30th March, 1950, for confirmation of the report that the Castle has been taken over by the State. No reply, as yet, received.

Lally Monument. The County Manager wrote on the 30th March, 1950, to Dr. Costello asking him to help in the completion of the necessary form of consent by the owner no reply since received. No reply received from Dr. Costello.

Teampull Beag na Naomh Killanin & St. Brecan's Church, Rosscahill East: The County Manager wrote on the 30th March, 1950, to Rev. Fr. Mullins, P.P., Rosscahill, asking for his assistance in the completion of the necessary forms of consent by the owners. No reply received.

Temple Jarlath: (Tuam) - The County Manager has instructed the County Engineer to have the ruins inspected and to submit an estimate of the cost of maintenance. Mr. Collins reported that the repairs, etc., will cost about £42 approximately. The Committee agreed to request the County Manager to take the necessary steps.

Leacht on Fahy's Land: The County Manager wrote to Dr. Costello on the 30th March. 1950, asking for information as to the historical value of the Leacht and for assistance in securing the owner's consent to its transfer to the County Council. No

Gateway at Belle View, Laurencetown: The County Manager wrote to the County Engineer on the 30/3/50 asking him to have it inspected by one of his Engineers and to submit an estimate of the cost involved. Mr. Collins reported that the owner is a Mr. John Grady who lives in a dwelling-house of which the Gateway forms part. He estimated the cost of the necessary repairs at £25/£30. The Committee agreed to request the County Manager to do everything possible to have the Gateway put in repair. The Committee also recommended that the Office of Public Works be notified to issue a Preservation Order.

Clontuskert Abbey & The Teampaillin, Ballinasloe: The Hon. Secretary reported that the matter had been submitted to the Inspector of National Monuments and is under consideration. On the recommendation of An t-Athair E. Mac Finn it was agreed to request the Inspector of National Monuments to include a nearby "Station Cross" with ClonPortumna Castle: The Hon. Secretary reported that the Inspector of National Monuments confirms Lord Killanin's statement in this matter, and that the Inspector has promised to consult with the Forestry Department.

Proposed Visit of Royal Society of Antiquarians of Ireland: The Hon. Secretary reported that the Committee's instructions had been carried out.

Correspondence: Aughnanure Castle, County Galway: The Office of Public Works has informed the County Council that a Preservation Order has been issued for Aughnanure Castle and requesting the County Council's co-operation. The matter has been drawn to the attention of the County Engineer by the County Secretary.

Rev. Fr. Egan wrote to say that His Lordship, the Bishop of Clonfert, has given permission to submit all church ruins under diocesan control to the National Monuments Advisory Committee for the purpose of their preservation or to have them declared National Monuments if so desired. He feels that it is the only effective way of dealing with them as their condition is rapidly becoming worse. Consideration of the matter was deferred to the next meeting.

Membership of the Committee: The Hon. Secretary reported that an inquiry had come from the National Monuments Council, Dublin, asking for particulars of the Committee's membership and activities, etc. This had drawn attention to Section 22 (2) of the National Monuments Act, 1930, according to which every Local Advisory Committee shall consist of not less than three nor more than five members. MINUTES OF MEETING WITH OFFICIALS OF AN BORD FAILTE ON TUESDAY, 22nd September, 1953, at 4.p.m.

IN THE CHAIR: Dr. Costello

PRESENT: Lord Killanin, Rev. Fr. Egan, An t-Athair Eiric Mac Fhinn and Mr. H. McGlory.

IN ATTENDANCE: County Manager, County Engineer, Mr. Hartnett and Mr. Harbison of An Bord Failte.

Mr. Hartnett addressed the meeting and said that it was the object of An Bord Failte to protect and maintain sites of historical importance, but with regard to monuments vested in the Commissioners for Public Works, there is very little they can do on the fabric of the building - as they are only concerned with certain improvements in the amenities, such as, the clearing up of sites and access to them.

MATTERS FOR ATTENTION OF AN BORD FAILTE.

SIGN-POSTS TO NATIONAL MONUMENTS: In this respect, said Mr. Hartnett, it was noted that the County Council had already submitted their requirements. The matter is under way, and the Galway signs will be ready early next year; sign-posting will be bilingual giving name of monument and location.

Mr. Hartnett informed the meeting that An Bord contemplate having a descriptive plaque in bronze or plastic erected near such historic ruins - such plaque to give a brief history of the place or monument - those connected with it - and date of foundation; also a plan of the building to be inscribed thereon.

PRINTING OF PAMPHLETS: The Committee were also informed that An Bord is considering the printing of pamphlets - (An Fogra Failte being the Advertising Branch of An Bord Failte) - said pamphlets to give in detail the history of such historic ruins and monuments throughout the country. It was suggested that where there is a Caretaker, a supply of these pamphlets could be left with him for distribution to persons interested in the particular ruin or monument - a small charge of ld. or 2de being made for such pamphlet, if necessary. The Committee submitted the following places of historic interest as those requiring pamphlets:-

(1) Kilmacduagh;

(2) Claregalway Friary;

3) Kilconnell

(4) The Carmelite Friary, Loughrea.

CLONTUSKERT ABBEY: Rev. Fr. Egan, being familiar with this historic ruin, gave an cutline of the repairs necessary to prevent it from deteriorating further. It was decided that before any funds can be advanced by An Bord for its further preservation, the County Engineer is to have the Abbey inspected, and a full report, giving estimated cost, submitted to An Bord Failte.

KILCONNELL: Mr. Hartnett informed the meeting that this ruin is kept in a tidy condition by the Caretaker who is engaged by the Board of Works. The question of regional supervision of national monuments arose, and Mr. Harbison of An Bord Failte stated that this matter of regional supervision and maintenance is being gone into and that nothing definite has been arrived at yet.

PORTUMNA: Mr. Harbison informed the meeting that this matter had already been raised with the Inspector of National Monuments - and they hope to have something done at an early date. The old Dominican Friary ruin is on Forestry lands and this Department object to people trespassing on their property.

AUGHNANURE CASTLE: (scheduled in 1950). This is an important historic ruin being on the main tourist road from Galway to Clifden. It was agreed that Lord Killanin and the two officials of An Bord Failte would inspect same and see what could be done by way of preservation.

SPANISH ARCH, GALWAY: The County Manager gave a brief outline of the developments in this matter - the question of ownership being the only difficulty arising here. Messrs. Hartnett and Harbison took note of this and requested the County Manager to submit an estimate of the cost of any necessary work so that consideration might be given to the making of a grant by An Bord Failte to the Galway Corporation to cover the cost.

GATE-WAY AT BELLE VIEW: An Bord Failte were asked to do something about financing the cutting of trees on top of this Gateway. The owner, a Mr. John Grady, will do nothing in this respect. The estimated cost of repairing this Gateway in 1950 was £25 to £30. It was agreed by the two officials of An Bord Failte that this Gateway is worthy of preservation.

Clontuskert Ahbey: Rev. Fr. Egan informed the Committee that he had inspected this monument with Mr. O'Connor, Assistant County Engineer, on the 15th October, 1953 - from whom a report is still awaited. The Committee requested that this matter be again brought to the notice of the County Manager. Portumna: In addition to reports made by Mr. H artnett, the Acting Hon. Secretary

reported that he had written to the Inspector of National Monuments, who replied stating that some satisfactory arrangement will be made with Department of Lands

Aughnanure: This monument was visited by Mr. H artnett in company with Lord Killanin - who stated that he had been informed, unofficially, that work will commence on this structure in February. The Inspector of National Monuments is to inspect same before work commences. The Committee recommended that the work be done, by contract, by the County Council for An Bord Failte. Spanish Arch, Galway: A report dated 2/12/53 from the Borough Surveyor, Galway, who stated that the estimated cost of putting this structure into a good state of

preservation would be £200, was read. This estimate was conveyed to An Bord Failte on 4/12/53 and a reply is awaited.

Gateway at Belle View: On 27/11/53 County Manager wrote to Inspector of National Monuments regarding necessity of having a Preservation Order made in respect of this Gateway. A reply was received in which Mr. Le Clere stated that as they are now working in Portumna, they will have an early opportunity of inspection, when they will be in a position to formulate any actual intentions. The Acting Hon. Secretary informed the Committee that he visited the owner - a Mr. O'Grady - who wants very much to have the Gateway preserved - but feels that it is worth something and would like some monetary contribution for same. The Committee recommended that steps be taken to got Mr. O'Grady to vest said Gateway and that he might bo appointed Caretaker following Mr. Le Clere's visit.

2. CORRESPONDENCE:

Teampull Beag na Naomh & St. Brecan's Church, Killanin: The Acting Hon. Secretary reported that the consent of the owners for vesting of these monuments in the Council had at last been obtained. Breac-Chluain (Near Clonfert Crossroads): This matter was raised by An t-Athair Eiric Mac Uhinn who requested that as the owner may demolish it owing to the fact that it is dangerous to children - that something should be done for its preservation. House at Dunsandle: Reference was made to the proposed sale of this house, and it was recommended by the Committee that a letter be sent to the Irish Land Commission asking that all necessary steps be taken to ensure that the building itself is not demolished.

MINUTES OF MEETING HELD AT THE COUNTY BUILDINGS, GALWAY, ON TUESDAY, 2nd March, 1954.

IN THE CHAIR: Lord Killanin.

Clr. O'Dowd and Mr. J. Sweeney. PRESENT:

IN ATTENDANCE; County Manager.

The Minutes of the last meeting were read and signed by the Chairman. MINUTES:

- The Chairman had been informed that Clr. O'Dowd and Mr. J. Sweeney had been added as additional members, without voting powers, to the National Monuments Advisory Committee, and welcomed them on their first visit.
- Apologies for inability to attend, owing to inclement weather, were received from An t-Athair Eiric Mac Fhinn and Rev. Fr. Egan.

MATTERS ARISING OUT OF MINUTES:

- (a) Sign-Posting: The Acting Hon. Secretary reported that no further news had been received from An Bord Failte and requested that the matter be again raised with Mr. Hartnett in this respect - and also in regard to the question of
- (b) Clontuskert Abbey: It was reported that the County Manager had made an Order authorising the expenditure of a sum of £680, as per County Engineer's estimate of 3/12/1953, on repair work to this Abbey and such work on the access road as may be agreed on with An Bord Failte - which has undertaken to pay the cost. A report dated 2/3/1954 from the Co. Engineer was received stating that the work had not yet been commenced owing to bad weather conditions.
- (c) Aughnanure Castle: The preservation of this national monument which is in State care was taken up with An Bord Failte who are going to spend a certain amount of money on cleaning up same and fencing it in. The Acting Hon. Secretary reported that Mr. Le Clere, together with Mr. Harbison of An Bord Failte, inspected the monument on the 27th February and a report is still
- (d) Spanish Arch, Galway: The County Manager informed the Committee that the sum of £200 had been made available by An Bord Failte for the restoration and future preservation of this monument. Letter, dated 25/2/1954, from Borough Surveyor was read stating that work had already commenced on this structure.
- (e) Gateway at Belle View: The Acting Hon. Secretary informed the Committee that a report is awaited from the Inspector of National Monuments as to whether or not this Gateway should be taken over by the State or the County Council. Clr. O'Dowd drew attention to the coat of arms which

is visible on the house - once the home of the Laurences - and requested that same should be inspected and, if thought fit, reported to the National

Monuments Council. (f) Teampull Beag na Naomh and St. Brecan's Church, Killanin; The Acting Hon. Secretary reported that the County Manager had made an Order authorising the carrying out of work on Teampull Beag na Naomh at an expenditure of £25 and on St. Brecan's Church at a cost of 220. The County Engineer's report indicates that work on same will commence in a fortnight's time.

(g) Breac-Chluain: The Acting Hon. Secretary drew attention to this monument and requested that the County Engineer be asked to report on its condition giving details of the work necessary to make it safe.

MISCELLANEOUS:

(a) Athenry Town Walls: A discussion took place re the preservation of these walls and, finally, it was decided that the views of Mr. R.W. Powell, Assistant County Engineer, Athenry, as well as those of the Inspector of National Monuments, be obtained.

Mr. Sweeney informed the Committee that the issue of a pamphlet, giving the history of the Town Walls and other monuments of historic

interest in Athenry, is desirable. The Acting Hon. Secretary is to take this matter up with Mr. Hartnett. Mr. Sweeney informed the Committee that the sign-posts had arrived in Athenry, but had not yet been erected - as they are awaiting

authentic information in regard to some of the monuments. (b) Lady's Holy Well: Attention was drawn to this Holy Well, which is frequented yearly by pilgrims. The Committee requested that this matter be raised with An Bord Failte - and recommended that something be done to preserve it.

(c) St. Mary's Collegiate Church: Mr. Sweeney was informed that the preservation of this appears to be a matter for the Representative Church Body.

(d) Parson's Fairgreen: Mr. Sweeney informed the Committee that there is the base of a Cross left in a field from olden days - and the County Manager stated that a plaque could be put up giving the history of this Cross. The Acting Hon. Secretary requested Mr. Sweeney to let him have a list of the various monuments and old ruins in Athenry, when he will pursue the matter with Mr. Le Cle re.
