# MINUTES OF THE MEETING OF THE NATIONAL MONUMENTS COMMITTEE OF GALWAY COUNTY COUNCIL HELD IN THE COUNCIL CHAMBER

## Item No. 1. - Congratulations.

The Chairman, on behalf of the Committee, congratulated Senator McDonagh on his election to the Senate.

Senator McDonagh thanked the members for their good wishes and said that if there was any way in which he could assist the work of the Committee through his membership of the Senate, he would be most willing to do so.

On the proposition of Senator McDonagh, seconded by the Chairman, the Committee extended its congratulations to Mr. Paul Gosling and to his wife on the birth of their baby.

## Item No. 2. - Minutes.

On the proposition of An t-Uasal Breathnach, seconded by Mr. McLoughlin, the Committee approved the Minutes of the Meeting held on the 2nd February, 1993, copies of which had been circulated to each member.

Item No. 3. - Matters arising from the Minutes.



Reference was made to the difficulties which had arisen in relation to access to Dun Aonghus and to St. Ruth's Bush at Aughrim, and the possibility that the Government might introduce legislation exempting local landowners from public liability claims in such cases was referred to.

The survey of estate gates and follies was referred to and it was suggested that the list of such items for preservation should be submitted to the County Council's Planning Office, before September, 1993, in order to ensure that these were included in the Development Plan arising from the review which was currently underway.

The situation with regard to Tyrone House was discussed and it was stated that stones were being taken from the buildings on the site. It was proposed by An t-Uasal Breathnach, and seconded by Mrs. McDonagh, that a letter be written to the Office of Public Works, asking that Tyrone House be listed for preservation as a National Monument or that it be listed for protection.

Mr. McLoughlin referred to the Castle at River Street, Ballinasloe, which he stated was a listed monument, but is in a neglected state. The Chairman suggested that he should bring the matter to the notice of the Town Clerk of Ballinasloe Urban District Council.

### Item No. 4. - Bellevue Gate, Laurencetown, Ballinasloe.

The Committee discussed the status of the gate which it is stated is of tremendous historical significance. It was agreed that the Office of Public Works should be written to and asked to take over the Gate as a National Monument.

### Item No. 5. - Clonfert Cathedral.

The Chairman said that the Graveyard at this location is multi-denominational, but the land is owned by the Representative Church Body. He said that some headstones and tombs are in a precarious position and a number of trees in the graveyard are so located that they would cause considerable damage if they fell. He said there is also local concern over the Cathedral itself and it is believed that the unroofed transept is in danger of collapse. He suggested that Mr. Paul Gosling might carry out an inspection and prepare a report on the situation. He also asked if the County Council would pay Mr. Gosling's expenses in this respect.

Mrs. McDonagh stated that it would be necessary to obtain the permission of the Church of Ireland Authorities for the proposed examination of the situation and it was noted that the Rector of Clonfert Cathedral lives in Banagher.

It was agreed that the matter be put on the Agenda for the

# Item No. 6. - Teampaillin at Ballinasloe.

Councillor Finnerty said that this matter had been discussed at a Meeting of Ballinasloe Urban District Council, and the Members said that it was a matter for the National Monuments Committee of the County Council. He said that the local Heritage Society wishes to have the Teampaillin preserved, and also St. Grellan's Church, which dates from the 5th or 6th Century.

After some discussion, it was agreed that this matter be left on the Agenda of the Committee's Meetings, with a view to obtaining Mr. Paul Gosling's views thereon.

# Item No. 7. - Any Other Business.

The problem of access to Clontuskert Abbey was discussed and it was noted that legal difficulties have arised in the matter. It was proposed by Mr. McLoughlin, seconded by An t-Uasal Breathnach, and agreed that the Chairman would discuss the matter with the landowner concerned.

The Chairman referred to a document which he had circulated to each of the members present, regarding Inchagoill. He outlined the history of the Island, which was purchased by the Irish Government in 1939 from the State of Sir Benjamin Lee Guinness. He said that the graveyard and churches on the Island are National Monuments and the oldest church dates from the 5th Century. He said that local people were concerned about possible damage to the monuments from lack of maintenance and supervision. He had brought the matter to the notice of the National Heritage Council, which had passed it on to their Archaeological Sub-Committee in order to have a report drafted. He said that a planned approach to the preservation and enhancement of the monuments is necessary.

It was agreed that the matter be placed on the Agenda for the next Meeting of the Committee.

Councillor Cunningham referred to renovation works, which had been carried out at Tullira Castle and said that the owners of the property, who had spent a lot of money on the renovations, were to be congratulated on the quality of the work carried out. He said that works on the main house had now been completed and the stables were currently being renovated.

On the proposition of Senator McDonagh, the Committee agreed that the County Council be asked to erect a sign indicating the location of a trampoline at Corrandrum, County Galway, which had been restored by the Corrandrum Community Group.

It was agreed that the next Meeting of the Committee would be held in the Council Chamber, County Buildings, on the 8th June, 1993.

#### Apologies

The Chairman informed the Members that apologies had been received from Mr. Paul Gosling who was unable to attend the Meeting.

#### Item No. 1 - Minutes

On the proposition of Cllr. M. Cunningham, seconded by Mr. Mac Lochlainn, the Committee adopted the Minutes of the Meeting held on the 27th April, 1993, subject to the following corrections:

- It was noted that the heading on the Minutes (a) as circulated should have read "Tuesday, 27th April, 1993", and not "Thursday".
- It was noted that the trees referred to under (b) Item No. 5 - Clonfert Cathedral, were located near the graveyard and not in the graveyard as stated in the Minutes.
- It was noted that Senator McDonagh's (C) proposition recorded under Item No. 7 of the

next Meeting.

# Item No. 3 - Clonfert Cathedral

The Chairman informed the Members that the Heritage Council had discussed this matter and had agreed to write to the Dean of Clonfert Cathedral and to Bishop Darling of Limerick, expressing concern about the possibility of damage to the doorway of the Cathedral due to weathering, and also expressing concern about the transcept and the condition of the graveyard.

Item No. 4 - Inchagoill

The Chairman stated that he had raised this matter at a Meeting of the Heritage Council and they had decided to write to the Office of Public Works in the matter. He suggested that Councillors from the area might visit the Island to see the situation for themselves. He expressed the view that the Island should be declared a Heritage Island.

It was decided that this matter should also be put on the Agenda for the next Meeting of the Committee.

# Item No. 5 - Annual Meeting of the Committee

It was agreed that the Annual Meeting of the Committee would be held at Oughterard on Tuesday, 6th July, 1993, and that the Committee would visit the nearby Aughnanure Castle in conjunction with the Meeting. The Meeting room in Oughterard Golf Club was suggested as a possible venue for the Meeting and Mr. Barrett informed the Members that he would contact the Golf Club to see if they would make their Meeting Room available.

On the proposition of the Chairman, seconded by Mr. Mac Lochlainn, it was agreed that the Minister for Arts, Culture and the Gaeltacht be invited to attend the Meeting on the 6th July and that the matter would be referred for the agreement of the County Council at the County Council meeting to be held on the 11th June, 1993.

# Item No. 6 - Any other Business

On the proposition of the Chairman, the Committee extended its congratulations to the County Vocational Education Committee on the opening of the second stage of the Clonbur Outdoor Pursuits Centre. The Chairman said that the Vic hopes to restore the house as the next stage of development of the Centre.

Mr. Mac Lochlainn raised the matter of waste plastics, which he said were causing an extensive litter problem and were a hazard to animals in rural areas. He suggested that Central Government should legislate to restrict the use of plastic carrier bags and that the County Council, as part of its Waste Management Policy, should have these burned rather than dumped at landfill sites.

He also referred to the damage caused by ivy to trees and monuments in the Country and said that the problem of ivy should be tackled nationally.

The Chairman informed the Members that Mr. Maurice Craig and his son were carrying out a survey of mausoleums with a view to publishing a book on the subject. He asked that any Members who had, or could obtain, information in the matter would give such information at the next Meeting of the Committee. The following mausoleums were mentioned in the course of the discussion - Laurencetown, the McEgan Tomb and the Bermingham's Tomb at Clonberne/Kilkerrin, two mausoleums at Monivea (Daly's and O'Farrell's) and two mausoleums on the Ballinasloe road from Loughrea near Kilmeen Cross.

On the proposition of Councillor Varley, it was agreed that the Office of Public Works be asked to preserve Ballinduff Castle, Headford, Co. Galway. It was stated that the castle is located near Lough Corrib and some wooden floors in the castle are still intact.

On the proposition of Councillor Varley, it was agreed that Mayo County Council be asked to erect a signpost, giving directions to Ross Errily Abbey, at Moyne/Kilroe Crossroads. Councillor Finnerty stated that the local heritage group were seeking a site for the erection of the Eyrecourt Estate Gates and the Chairman suggested that he should approach the County Council in the matter.

Mrs. McHugh referred to the Dunmore Heritage Symposium, which was taking place at the Emerald, Dunmore, over the weekend from Friday, 13th July, to Sunday, 1st August, 1993, the theme of which is "from Bronze Age Warships to Medieval Warships". Mrs. McHugh said that the organisers of the Symposium hoped that as many people as possible would attend.

# APOLOGIES:

The Chairman informed the Members that apologies had been received from Rev. Fr. Egan and from Councillor Michael Mullins who were unable the attend the Committee Meeting.

# MINUTES:

On the proposition of the Councillor O'Sullivan, seconded by An t-Uasal Breathnach, the Committee adopted the Minutes of the Meeting held in the County Buildings, Galway, on the 8th June, 1993.

## MATTERS ARISING FROM THE MINUTES

Mr. McLoughlin referred to the discussion which had taken place at the previous meeting regarding problems caused by ivy. He said that this is a serious matter, and that when he had raised it at the previous meeting, he had hoped that the Committee might take some action relating to it. In the discussion which followed, a number of members made the point that the Committee could only concern itself with the affects of ivy on monuments and structures of that nature and that its affect on trees would not be strictly within the Committees brief. The point was also made that ivy on trees and in hedge rows provided a habitat for birds and that large scale removal of ivy in such circumstances might have adverse environmental affects.

On the proposition of Senator McDonagh, seconded by Mrs. McHugh, it was agreed that the County Engineer should be asked to advise on the affects of ivy on monuments and structures and to consider the question of control of the spread of ivy.

The discussion at the previous meeting regarding mausoleums was also referred to, and in this context, Mrs. McHugh referred to the French mausoleum in Monivea. She said that the door of the mausoleum had been damaged and left open with the result that rainwater was penetrating the tomb and causing internal damage. A discussion followed as to where responsibility lies for securing the mausoleum which is one of the finest in the country. It was noted that the mausoleum is located in woodlands, and it was suggested that perhaps Coillte may have some responsibility in the matter.

On the proposition of the Chairman, it was agreed that the County Council's Solicitor be asked to advise if the County Council had any responsibility in the matter, and if not, who is likely to be responsible.

## INVITATION TO THE MINISTER FOR ARTS, CULTURE AND THE GAELTACHT:

It was noted that items numbered 1-5 inclusive on the Agenda for the Meeting all related to matters which the Committee had wished to discuss with the Minister. The matter of access to heritage sites and monuments was discussed briefly and it was noted that the Government had received a report in the matter from a study group set up to consider the problem.

The Chairman informed that Members that a letter had been received from the Minister indicating that he would not be in a position to attend the meeting to which he had been invited. He read the letter received from the Minister's Private Secretary dated 30th June, 1993.

The provision of toilets at Ross Erilly Abbey was discussed, and it was noted that there had been correspondence between the County Council and the Office of Public Works in the matter. It was stated that the absence of a water scheme in the area was put forward as a reason why toilets could not be provided by the Office of Public Works. It was also stated that a site for the provision of the toilets could be made available by a local landowner. It was agreed that a letter be written to the Office of Public Works asking again that a public toilet be provided and also that an information plaque be erected on site and that a Guide be employed.

It was agreed that consideration of the other matters, which the Committee wished to discuss with the Minister be deferred to a future date.

On the proposition of An t-Uasal Breathnach, it was agreed that the Minister be asked to attend a future meeting of the Committee.

# CLONFERT CATHEDRAL:

The Chairman informed the Members that a local group had done some tidying up work in the graveyard and had found an interesting grave stone which had been carefully put aside in the Cathedral.

# TEAMPAILLIN AT BALLINASLOE:

It was decided to defer discussion on this matter to the next Meeting of the Committee.

# ANY OTHER BUSINESS:

The Chairman referred to the Dunmore Heritage Symposium "From Bronze Age Warships to Medieval Water Power" which was due to take place in The Emerald, Dunmore, from Friday, 30th July, 1993, until Sunday, 1st August, 1993. congratulated the organisers on the programme which they had arranged and on the quality of the speakers listed in their programme.

Mrs. McHugh said that the quality of the speakers at the Symposium is such that is of national conference standard. She said that the objective of the local heritage committee is to confirm Dunmore as a heritage town. She said that there would be no admission charge and that the organisers would like to have as many people as possible attend the symposium. The matter of grass cutting in cemeteries was raised by Senator McDonagh. He said that the County Council has no funds for this purpose and he suggested that the rules applying to FAS schemes should be amended to provide for the inclusion of such grass cutting. proposition of Senator McDonagh, seconded by Councillor Varley, it was agreed that a letter should be written to FAS

and to the Minister for Labour requesting that the rules for FAS schemes be amended to permit the inclusion of grass cutting in cemeteries.

On the proposition of the Chairman, seconded by Senator McDonagh, the Committee adopted a vote of thanks to Oughterard Golf Club for making their facilities available for the Committee's Meeting.

On the proposition of Senator McDonagh, it was agreed that the next meeting of the Committee would be held at Aughrim on the 7th September, 1993.

The Chairman thanked the staff of the Aughrim Interpretative Centre for the tour and presentation received by the Members prior to the Meeting.

#### ELECTION OF CHAIRMAN.

It was proposed by Councillor M. Cunningham, seconded by Councillor P. O'Sullivan and unanimously agreed that, Mr. James Joyce be re-appointed as Chairman of the National The Chairman of the Monuments Advisory Committee. Committee thanked the Members for his appointment and informed the Meeting that he looked forward to a productive year.

#### ELECITON OF VICE CHAIRMAN.

It was proposed by Councillor M. Cunningham, seconded by Mr. E. Kennedy and agreed, that Senator Jarlath McDonagh be re-appointed as the Vice-Chairman of the National Monuments Advisory Committee.

#### DUNMORE HERITAGE SYMPOSIUM.

Mr. Bermingham informed the Meeting that the Dunmore Heritage Symposium had been very successful and enjoyed by a large number of people. Mr. Bermingham stated that the lectures and seminars were of the highest standard and most informative. It was unanomously agreed that a vote of congratulations be extended to the Organisers of the Symposium and the Chairman of the Committee stated that he wished to be particularly associated with this Vote of Congratulations.

## Matters arising from the Minutes.

The issues of Ivy was raised, and the Acting County Secretary informed the Meeting that Ivy can be a problem as it can break walls apart, but Archaeologists may not always agree with removing Ivy as this process may cause further damage. The situation can be improved by cutting the main growth low down, and this has been done on a number of Social Employment Schemes. The Meeting was also informed that any particular cases which are causing concern can be examined with a view to initiating Social Employment Schemes.

In relation to the French Mausoleum, the Committee was informed that the Mausoleum would not seem to be in the charge of the County Council, and as the French Family have not requested the Council to carry out works or given permission for the Council to enter and examine the mausoleum, it would not be appropriate for the Council to take action. The positon regarding Bullies Acre, Ballinasloe was discussed and it was agreed that the area should be preserved.

The Meeting was informed that the O.P.W. had been requested to provide a public toilet at Ross Errily Abbey, Headford and a response is awaited.

#### COUNTY AND CITY ARCHAEOLOGIST

The Chairman said that there is a grave need for a City and County Archaeologist. While the city had had the services of an Archaeologist for a time, this was no longer the case, and they had to seek advice from U.C.G. when necessary. He said that a favourable view would be taken by the O.P.W. if proposals were submitted to them for funding towards the cost of an Archaeologist. He therefore proposed that the Council appoint a County and City Archaeologist. This was seconded by Mrs. McDonagh and agreed.

#### INCHAGOILL

The Chairman also referred to Inchagoill which he said was owned by Coillte, but the ruins on the island were the responsibility of the O.P.W. Trees on the island were now mature, and he expressed concern that damage may be caused to historic artifacts in felling the trees, and also that damage could be caused to the 12th century Church by a big overhanging tree. He said that he would send a report to the relevant Authorities.

#### OTHER BUSINESS

The Chairman accepted with regret the resignation, owing to ill health of Fr. Martin Coen. A vote of thanks to Fr. Coen was proposed by Mr. Kennedy, and seconded by Mr. Breathnach. Mr. Kennedy said that Fr. Coen had been a stalwart member of the committee for over forty years and had rendered great service. Other members joined in paying tribute to Fr. Coen.

The Chairman read a copy of a letter from Mr. Noel Treacy to the Minister of State at the O.P.W., Mr. Noel Dempsey, concerning an approach made to him by the Loughrea Heritage Society regarding the preservation of Dalystown House. Mr. Ml. agreed on behalf of the committee to check out the position regarding Dalystown House, before the next meeting.

In relation to Heritage Houses in general, the chairman said that the Minister was preparing, for the government, a list of houses to be preserved. He would endeavour to obtain a copy of the list.

Sen. Jarlath McDonagh welcomed a grant of £100,000 to the V.E.C. for Peterburg House. The chairman referred to letters he had received from the Minister., Mr. Ml. D. Higgins, and the Minister of State, Mr. Noel Dempsey, regarding Inchagoill. Both stated that the developments taking place are on land owned by Coillte, and are a matter for Coillte, but that the developments do not pose a threat to the National Monuments whose conservation and protection are a matter for the O.P.W. The large tree overhanding the 12th century church was a unique evergreen oak which has to be preserved by Coillte. The chairman also said that the Heritage Council will be meeting with Coillte to discuss afforest ation and tree cutting and the potential danger to historic monuments. Mrs. McDonagh commented on the monuments on Inish Mor which were being very well kept and preserved.

Cllr. Mullins expressed grave concern over the demolition of the workhouse in Ballinasloe which should have been preserved. He suggested that members of the Committee be on the alert for historic buildings that may be designated as Derelict sites by the Council. Public notice should be given of any proposal to demolish a building.

Mr. Owen Kennedy spoke on the matter of the acquisition of rights of access to National Monuments sites by the Office of Public Works or County Councils. The Minister replied that rights of access will form part of the legislation. Regarding the work of the Law Reform Commission, the IFA wants consultation but action is hopefully expected before the end of the year. Farmers liability for visitors safety will be gone. In some cases a compulsory Purchase Order may be required. The budget available for the years 1994 - 1999 is f26 million.

In reply to Senator Jarlath McDonagh's query regarding the availability of funds to allow access to Ross Errily be established and to provide facilities for visitors at this nationally important site, the Minister said that an on going scheme of conservation was being proceeded with there. The site will be "made safe" within one year. The Minister would welcome suggestions regarding visitor facilities at Ross Errily.

Mr. Michael Fahy requested the Minister to provide short-time financial assistance to help catalogue and conserve heritage material country-wide. Mr Fahy told the Minister that an important case in point was the preservation of the collection of treasures held in the small museum at Loughrea Cathedral. Mr Fahy pointed out the urgency of this particular matter.

In his reply the Minister said that with regard to financial assistance for Heritage Groups, the aim was "Autonomy with Responsibility". The Heritage Council had made a study of thatched cottages. The Minister suggested that the Chairman, Councillor James Joyce, should write to Noel Lynch regarding help to places as they come up. The Minister announced that

The Heritage Council will be put in touch with the Dept. of the Environment regarding thatched cottages.

Senator Jarlath Mc Donagh brought up the matter of the refurbishment of thatched cottages which up to now have had to be allowed to become derglict when a family built a new house nearby. Senator McDonagh said grants to re-thatch would be welcome in these cases. In answer the Minister said that the Heritage Council Bill will become law early in 1995.
