Burke and Michael O'Neill at the Council Meeting on 'the 23rd October, 1992, in the course of discussing a Section 4 motion dealing with Council offices. I have been advised not to allow the next; Council meeting pass without dealing with matters which amount to serious misrepresentations. Clrs. Burke's statements were quoted extensively in the Tuam Herald.

1 - Clr. . Burke stated that the Council were told that for £1.4m/it was getting a magnificent building, with all facilities except a library headquarters on a self-financing basis. 0 01 920001.13

I wish to confirm that a statement along the foregoing lines was not made to Galway County Council. The reference to "all facilities" is not understood. A statement to the effect that the purchase was on a self-financing basis was never made. Minutes of the

Council Meetings dealing with this matter confirm my position in the matter.

2 - Clr. Burke stated that Cluain Mhuire would cost f4m or f8m including interest.

The cost of acquisition and refurbishment is approx. £4m. Clr. Burke is well aware that the nett estimated outlay by the Council after re-sale of the County Buildings is approx. £2.25m. There is no reference to £8m in any report placed before the Council. The plans and detailed costs were presented to the Council when they became available in Sept. 1991.

- 3 Clr. Burke stated that if the Council had been aware that Cluain Mhuire would cost £4m, the original decision would not have been made.
- I confirm that the Council were made aware, at all times, that there would be a refurbishment cost and when this was determined it was placed before the Members.
- 4 Clr, Burke stated that during the last 2 years expert advice to the Council was absent.
- Clr. Burke is aware that the refurbishment plans for Cluain Mhuire were prepared by Consultants on behalf of the Council. The team of Consultants included an Architect, a Structural Engineer, a Mechanical and Electrical expert, and a Quantity Surveyor.
- 5,-Clr. Burke stated that there was no fire report on Cluain Mhuire, or a report under the Safety, Health and Welfare at Work Act.
- Clr. Burke was not in a position to state that there was no fire report on Cluain Mhuire. The refurbishment plans incorporate the requirements of the Chief Fire Officer for fire safety. The plans present no problem in relation to safety, health and welfare at work.
- 6 Clr. Burke stated that many people questioned the fugure of £2.25m as adequate.

In making this statement Clr. Burke choses to reject the expert advice of the consultants who compiled the estimate.

7 - Clr. Burke stated that the County Manager used a legal implement, and this was grossly unfair and illegal. He also said it was grossly unjust for the Manager to do this.

This is a most serious charge which is totally without foundation. It is also a reckless charge and is defamatory of me as regards the discharge of my duties

as County Manager. This charge was made, despite the fact that Section 16 of the County and City Management (Amendment) Act, 1955 was read to the Council at its meeting of the 28th Sept. 1992. It also ignores the fact that Mr. O Donoghue, County Solicitor, gave full and proper legal advice to Councillors and answered questions for approx. one hour.

- 8 Clr. Burke stated that there was an unexplained delay in putting the loan proposal before the Council and that the matter was badly handled.
- Clr. Burke is well aware of the delays in bringing the matter to finality. He is well aware of the number of Council Meetings at which it was discussed and deferred by Council Members. To suggest that the matter was badly handled by me is a deliberate reflection of my discharge of my duties as Manager and is totally without foundation.
- 9 Clr. Burke referred to use of the Material Contravention provisions of the Planning Act " to rezone Cluain Mhuire ".

This reference is open to the interpretation that the planning application was not property handled by me and the Corporation. The statement is unjustified, incorrect and damaging to my reputation. In fact, the Material Contravention provisions of the Act were not utilised. The site was not re-zoned for the purposes of the applications, and these facts are a matter of public knowledge.

- 10 Clr. Burke stated that the Council was wrongly refused independent legal advice.
- Clr. Burke is aware that I arranged for the attendance of the Co. Solicitor at the meeting of the 28th Sept. 1992. He is aware that the Co. Solicitor is the person whose responsibility it is to advise the Council and that full and proper legal advise was provided at the meeting.
- 11 Clr. Burke stated that the Council was improperly advised.

This is a most serious charge. It is incorrect and unjustified.

1 - Clr. Ml. O'Neill referred to the vote at the previous meeting and said that he found it unsatisfactory and it raised a question of democracy and freedom. He said it was distasteful and he felt

The case of the disco

These remarks could be interpreted as meaning that there was something unsatisfactory about the manner in which I, as County Manager, discharged my duties in relation to the giving of a Statutory warning. This statement was made after Clr. O'Neill had the benefit of

- (a) the terms of Section 16 etc. being read out to him, and
- (b) after having heard the Co. Solicitor's advice.

To suggest that there was something "distasteful" seems to suggest that it was in some way improper to have advised the Council in line with my statutory obligations. I regard this statement as particularly offensive. To say that hearfelt intimidated is entirely without justification in the light of the advice which he had received.

3 - Clr. O'Neill stated that he should not have to vote under threat.

If it is suggested that he was put under threat by me such a suggestion is without foundation. It is also offensive and defamatory."

Councillor J. Burke said that if he cast any slur on the County Manager, he was totally withdrawing it. He said he regarded the County Manager as honest and full of integrity. Councillor Burke said that having said that, she did not need the County Manager to tell him what he was well aware of. Councillor Burke said that he would have the County Manager's statement studied by his legal adviser, and asked that he be given brime to do this, and give the reply in writing to each Councillor. Councillor Burke said that he want the County Manager is integrity and and not want the County Manager to question his either. He said that what the County Manager had said was basicly tuntrue and that he (Councillor J. Burke) would not be intimidated. He said he had the right to represent the people.

The Chairman said that he would not allow any further discussion on the matter at this meeting.

The making of the Plan for the Scheduled Town of was previously considered at Council Meeting on 27th April, 1992. At that Meeting, the submissions/objections received from the following were considered:

(a) Richard Joyce, The Grange, Gort.
(b) Dr. Patrick Joyce, Kilderry Lodge, Gort.

(c) National Monuments Advisory Committee for County Galway.

The comments of the Planning Officer on the submissions/objections were also considered together with the revised standards for septic tanks, S.R. 6: 1991 which would have to be included in the Appendices to the Plan. However, the making of the Plan was deferred until such time as Council Officials attend a Public Meeting in Gort to explain the proposed road reservation for a By-Pass.

Councillor Cunningham thanked Mr. Gilmone and TMr. Timmins for attending the Meeting in Gort. Heavsaid he was prepared to propose the adoption of othe Plan but asked the Council if something could be done bwith the two bottlenecks in the town, one at Crowe Street, and the other at the other end of the town. He also said that in the event of a By-Pass being provided, the owners of Filling Stations would suffer most and he suggested that they might be given priority if development was allowed on the new route. Councillor Fahy also thanked the Engineers for attending the Meeting in Gort and supported Councillor Cunningham in relation to the two bottlenecks. Councillor Byrne said that while he agreed with the need for a By-Pass in the long term, there was need to improve the infrastructure in Gort, i.e., water, footpaths, carparking, etc. In reply to Councillor Loughnane, the County Engineer said that the proposed By-Pass was not on any priority list at present.

The Plan consists of the written statement and the relevant maps as amended at this meeting."

DEPUTATION FROM CASTLEGAR CONCERNED COMMUNITY:

The Chairman proposed that Item 7 be taken at this point and this was agreed.

 - c) the International Union of Local Authorities (IULA) and the Union's European regional section the Council of European Municipalities and Regions (CEMR)
- (iii) providing, or arranging for the provision of, an adequate EC intelligence and information service to it's constituent Councils focusing on developments at EC level, particularly in relation to EC programmes with funding potential for local authority projects from the community's existing Structural and proposed Cohesion Funds.
- (iv) co-ordinating the international Twinning activities of it's constituent Councils and administering the allocation of EC Commission twinning grants in Ireland.
