ARAN WATER:

c expre-Councillor O'Neachtain expressed his concern at the serious situation which has occurred on Inishmore where water supplies have run out. He pointed out that while the recent drought would have led to a problem with availability of water, that this was aggravated because of a leak which had occurred at the main reservoir and which had not been detected for some time. It was pointed out that whilst every measure to alleviate the problem had been taken by the Council and approval had been received from the Department of the Environment for the provision of an overground pipeline to carry water from the pier to the reservoir, that the provision of adequate permanent storage facilities on the island is a priority to ensure that this situation. does not re-occur.

The County Engineer pointed out that there has been shortages of water on Aran for the past 10 years, and in 1984; bit had been necessary to ship out tankers of water . Two additional reservoirs had been built but there is still inadequate storage on the island. The Department of the Environment had insisted by that a Preliminary Report be carried out to determine the required solution and this had now been completed and forwarded to the Department. Permission to proceed with the preparation of Contract Documents is awaited. The reservoirs on the island had been full in May, and thereafter, excessive demand indicated that a leak existed. Sections of pipeline were isolated and examined, and the leak, when found, was fixed. Drinking water is being brought to the island by boat for the past number of weeks and the bulk transport of water to augment the reservoir will commence in the coming week and will continue for a period of approximately 10 days. Councillor O'Cuiv thanked the Officials of the Council for the diligent manner in which the problem had been attended to. He expressed the hope that there would be an equitable distribution of water to all areas of the island. " The Deputy County Manager indicated that the ultimate solution to the problem is the provision of additional storage and pointed out that the Department of the Environment will be asked to allow this solution to be processed further. The resolution set out on the Agenda was proposed by Deputy Connaughton and seconded by Senator Hussey.

Deputy Connaughton said that the town of Ballygar had suffered badly from the closure of the Butteknit Factory and the peat briquette factory at Ballyforan. He said that the only hope of some progress was to try and create an environment in Ballygar that would encourage people to live there even though not working there. He said that some years ago, a builder got planning permission for a small estate of houses near The Square but when all the development costs were worked out, the scheme fell through because of the cost of infrastructure, etc. This left a very high demand for sites in Ballygar. Deputy Connaughton said that the three sites, the subject of the Section 4 Resolutions were strategically placed and that they were in fact closing off a gap that existed on that road. He said that while the road has a National Secondary Road status, there was a big difference

between the volume of traffic on that road and other National Secondary Roads in the County. He said he understood that in the last review of the County Development Plan, sympathy was expressed for places like Ballygar. He said that all three applicants did have a housing need. Mr. Nestor had just sold his present house and the only site he has is the site the subject of the application.

The Chairman advised the Members to confine their discussion to the resolution relating to Planning Application number 66135 - applicant: Tom Nestor. Senator Hussey said that he had attended many meetings in Ballygar and was told each time that the town was not being allowed to develop and expand. He said there were now three individuals prepared to build three houses and he strongly supported the granting of permission. He said that an extension of the speed limit had been proposed but this had not happened. Senator Hussey said that the infrastructure and services were available and that it seemed to be easier to get Planning Permission on the same road only a short distance away in County Roscommon. He appealed to the County, Engineer to look at the applications sympathetically.

Councillor Finnegan said he was confident that the three applications would have the unanimous support of the Council. He said that the three applicants were claiming a housing need even though the Planning Officer's reports did not say so. He said that an important point to be considered was the fact that the three houses would be using the one exit. He said there was also a prosposal to extend the speed limit. Councillor Quinn also supported the three applications and asked the County Engineer and the County Manager to consider them sympathetically. She said it was nice to see people coming back to reside locally. Councillor Walsh also supported the granting of the three Permissions. He said that Ballygar qwas somewhat different to other towns in that there were few suitable areas for building. He said the people of Ballygar felt that the Planning Regulations were loaded against them and it would be nice to show some willingness on the Council's part to allow them

Councillor Ryan said that he supported all three applications. He said that he attended a meeting of the Community Council in Ballygar together with other Members, and they were asked questions which they could not answer. He said that people looked at the County Development Plan and how it affected the development of their towns, and it appeared that other towns like Mountbellew seemed to get better treatment. He said that new houses were under construction on the Galway Road outside Mountbellew which was a busier road. Councillor Ryan said that 7 new houses were

REPORT BY THE INSTITUTE OF FISCAL STUDIES ON RATE GRANT DISTRIBUTION:

A copy of the report document, together with a copy of the Finance Officer's Report dated 8th June, 1992, had been circulated to each Member since the previous meeting. During the discussion, which followed, the following points were made by the Members:

- (a) That the Council was loosing between £1M and £3M per annum depending on which option is used.
- (b) That there could be difficulty in getting the report implemented because some Counties would suffer a reduction if a re-distribution of existing resources only was involved.
- (c) That Galway County Council had suffered a grave injustice and had lost out to the tune of £20M over the years to the benefit of local authorities like Dublin Corporation. The Council should unite as a Body and use all its influence to get the report adopted for 1993.

- (e) That the report related only to one element of a total review of local government and that tother aspects such as a regional tier and a sub-county tier of local government should not be lost sight
- (f) The fact that some local authorities such as Dublin Corporation could operate without service charges was a grave injustice to local authorities who were being under funded such as Galway County Council.
- (g) That the Minister should be put on notice that the Council will not pass next year's Estimate unless a realistic attempt is make to have the report implemented.
- (h) That, having commissioned the report, the Minister has no option but to implement it in the

Applicant has been refused planning permission on two previous occasions by the Planning Authority and on appeal to retain the entrance (i.e. Ref. 57999 and 62135). Applicant has two alternative means of access to his dwellinghouse - he can continue to use his family home access adjoining his site or alternatively from the same field in which the present unauthorised entrance is located onto the County Road to the North subject to a planning application. This option has been put to the applicant in writing but he has not responded to

It is important to note that the original proposal which involved use of his family dwellinghouse entrance was a proposal put forward by the applicant at the time of his planning application and was not imposed against his will by the Planning Authority.

In conclusion, therefore, applicant has an alternative means of access to his site and a possible second and therefore has no case for retention of this unauthorised access directly onto a restricted National Secondary Road.

RECOMMENDATION:

The development would be likely to give rise to a traffic hazard as the entrance is located on a National Secondary Route at a point where the

maximum speed limit applies and the traffic movements generated by the development would be likely to interfere with the safety and free flow of traffic on the said road. Also, an alternative means of access onto a County Road exists in this case based on which planning permission ref. no. 48852 was originally granted for chalet."

The County Engineer said that the application was complicated by the fact that the adjoining landowner, Mr. Mulkerrins had widened his own entrance and both were now using an unauthorised entrance onto the National Secondary Road at the same point. The County Engineer said he explained at the last meeting how he had difficulty exiting from the site because of the insufficient sight distance. He said that an alternative exit could be provided onto the County Road. He said the road was a very busy one being the main road to Clifden and west and there had a number of fatalities, one only a few hundred yards from the site. The County Engineer recommended that the application be refused.

Deputy McCormack said that there was no alternative entrance onto the side road as this was now blocked by a 6 foot wall. Referring to the objection because of the heavy traffic, Deputy McCormack said that he had examples of Permissions granted in similar circumstances and mentioned one at Drimcong. He said he could not understand why Permission would not be given.

Councillor Gavin said that he lived only a couple of hundred yards from the site in question. He said the applicant had a serious problem as he had no entrance except onto the National Secondary Road. He said the applicant had four young children, all under the age of 4 years, who cross the road every day to their grandparent's house. He said that Ross Castle was now developing as a significant castle and there were six houses on that road and Permissions for others. He said that the applicant could not afford to buy any land off Mr. Mulkerrins and that he was in a very difficult position and something would have to be

Councillor Joe Burke said that while the County Engineer recommended refusal on road safety grounds, Deputy McCormack said that other Permissions had been granted on the same road. Councillor Burke also referred to the fact that the County Engineer said there was an alternative access while Councillor Gavin said there was in. The County Engineer replied that the Planning Staff had made suggestions about alternatives but had got no response. He said the applicant proposed an access onto the County Road in his original application. Councillor Gavin said that

the situation had changed over the years. The applicant was now married with four children and his financial position had also changed. Deputy McCormack repeated that the applicant has no access onto the County Road and mentioned some planning reference numbers where Permissions had been given, and also mentioned the Drimcong entrance. Mr. L. Kavanagh, Planning Officer, gave a full history of the Drimcong entrance situation. Councillor Brennan said that while he sympathised with the applicant, there was a danger involved according to the County Engineer. Deputy McCormack proposed that the resolution be put to the Meeting. A vote taken for or against the resolution resulted as follows:
