Councillor McDonagh informed the Meeting their is no septic tank or effluent problem with this site, the development will not create a traffic hazard, the proposed development will enhance the environment, the applicant proposes to build a home for his son, and that the site which is the subject of the Section 4 is the last site which the landowner has available. Councillor McDonagh also informed the meeting that Planning Ref. no. 62035 had been refused by the Council on the basis of septic tank and ribbon development, but on appeal to An Bord Pleanala, the application was refused only on the basis of ribbon development. He also informed the Meeting that Planning Ref. 66110 was refused by the County Council on the basis of density, and that there was no reference to septic tank in the refusal. Councillor McDonagh stated that the only problem with this application is that the County Council will not allow more than two houses in a line.

Councillor Michael Ryan informed the Meeting that he understood that the application referred to development on a County Road, and that it could not, therefore, be considered to be ribbon development. Councillor Ryan stated that existing policy will probably be changed in the Review of the Development Plan, and that this application should be granted. Councillor Ryan stated that the Council should try to facilitate people who wish to live in a particular area.

The County Engiener read the following report which had been circulated to each Member prior to the Meeting.

### "LOCATION:

The site is located in the townland of Cregboy and on the roadway linking the Galway/Claregalway road and the Claregalway/Oranmore road approximately a half mile from its junction with the Galway/Claregalway Road.

### PLANNING HISTORY:

PR 62935 - Outline Planning Permission was refused by the Planning Authority on essentially the same site on grounds of an excessive density and concentration of houses and septic tanks. The C.M.O.'s Office deemed the site unsuitable for the treatment of septic tank effluent because the site had been filled with unsuitable dauby

material. The application was refused by An Bord Pleanala on grounds of ribbonization (Applicant: L. Carr).

PR 66110 - Permission refused by the Planning Authority because of an excessive density and concentration of non-essential housing in the rural area in the Environs of Galway City. (Applicant: Mr. Danien Carrick).

### PLANNING CONSIDERATIONS:

The site is located within the Urban Environs of Galway City as indicated on Map No. 7A of the County Development Plan. It is the policy of the Planning Authority as set out in Chapter 7.2.6 to strictly control development in this area. It is also the policy of the Planning Authority as set out in Chapter 7.2.8(i) to prohibit the growth of groups of housing in rural areas and this policy is reinforced as a development objective at Chapter 7.1. (vi).

There are 2 no. existing dwellinghouses and 1 no. permitted dwellinghouse immediately adjacent to the site in question. In addition, there are approximately 20 no. dwellinghouses within a quarter of a mile of the site.

Development of this site has already been refused on two occasions by the Planning Authority and once on appeal by An Bord Pleanala.

### **RECOMMENDATIONS:**

following grounds:

1. The proposed development would, together with adjacent existing and permitted development, constitute an excessive density and concentration of non-essential housing in this rural area in the Environs of Galway City and would, if permitted, be contrary to the proper planning and development of the area and would be in conflict with Sections 7.1. (vi), 7.2.6 and 7.2.8 of the County Development Plan which restricts groups of houses in rural areas."

The County Engineer informed the Meeting that the proposed development is on a minor road which links the N.17 with the N.64, and that there is an inordinately large number of houses built along this narrow County Road. With refereence to Planning Ref. 62935, the County Engineer stated that there had a difficulty with ground conditions and that trial holes had failed a suitability test. Mr. Flood informed the Meeting that the application was refused by An

Bord Pleanala on the basis of ribbonization, as it is difficult to justify further development along this road. The County Engineer stated that it is the Council's policy to restrict control in this area, and to prohibit groups of houses, particularly for non-essential housing need, as such ribbonization is contrary to the proper planning and development of the area.

Councillor J. McClearn stated that if the Development Plan had been in operation for the last 200 years, villages would not exist. As there is no problem with the septic tank in relation to this application, Councilor McClearn considered it to be unfair to refuse this applicant having regard to the fact that applications had already been granted in the area. Deputy Connaughton informed the Meeting that there will always be a need for housing at Cregmore and that it is unfair that this application be refused on the basis of ribbonization. Councillor J. Brennan stated that, having regard to the fact that 20 houses already exist at Cregmore, the proposed development will constitute infill and would possibly enhance the area. Councillor Brennan noted that granting such applications may result in pressure for the widening of roads and the provision of sewerage schemes. Councillor T. Byrne considered the application to constitute infill of a vacant site in a residential area, and stated that he would support the application.

The County Engineer informed the Meeting that Permissions had been granted by stealth over a number of years, that it is inevitable that pressure will be exerted to widen the road and that further applications for development will be submitted. The County Engineer also informed the Members that An Bord Pleanala had already made a decision that this application be refused on the basis of ribbonization. A vote taken for or against the resolution as set out on the Agenda resulted as follows:

### C.A.P. REFORM:

A number of problematic elements of the C.A.P. Reform Package were discussed by the Members of the Council. It was proposed by Deputy Connaughton and agreed that the following resolutions be sent to the Minister for Agriculture:

"To ask the Minister for Agriculture to ensure that small farmers get an Ordnance Map for headage purposes costing not more than £20 per holding."

"To ask the Minister for Agriculture to give a sheep quota to farmers who traditionally supply breeding hoggets, but who did not have a sheep quota for 1991."

"To ask the Minister to give priority for beef cow quota purposes to farmers who have had T.B. or Brucellosis in their lands in 1992."

"To request the Minister to ensure the EC do not implement the recent decision to reduce the carcass weight to 340 kgs for intervention purposes."

"To ask the Minister for Agriculture to resist the EC demand to have Fresian cows in beef cow herds replaced by beef breeds."

### LOUGH DERG:

It was proposed by Councillor McClearn that the Council approve initiating contact with SFADCO to discuss the implementation of the South Galway Tourism Plan. In seconding this proposal, Councillor W. Burke stated that Lough Derg should be developed and promoted on a joint basis with the County Council in control. The Deputy Manager informed the Meeting that further discussion of the implications of this proposal would be required and it was agreed that this matter would be discussed at a future meeting of the Council.

### SIGNPOSTS:

Senator J. McDonagh was informed that a sign will be erected at Loughgeorge to indicate "Lackagh". Councillor Cunningham was informed that flashing lights for Lough Cutra School will be considered on notification of the 1993 Road allocations.

# HOUSING:

The Deputy County Manager informed the Members that the Council has been notified of an allocation of 70 new housing units for 1993. Mr. Gavin stated that this is a substantial improvement on 1992, and that it is proposed to construct 33 rural houses. The balance of 37 units will be constructed as town/village schemes throughout the County. The Chairman and Members of the Council welcomed the increased allocation and the proposed development in villages. It was agreed that the Minister for the Environment be requested to increase the £10,000 limit for Improvement Works in lieu of Local Authority Housing, and to increase the income limit for Shared Ownership.

In reply to questions, the Deputy County Manager informed the Meeting that it is proposed to improve the design of local authority housing during the current year, that the possibility of acquiring derelict sites for housing purposes is being investigated, and that the Council is seeking land in various locations throughout the County.

Mr. Gavin also informed the Meeting that he considered there should be no financial ceiling in respect of improvement works in lieu of housing, that all qualified persons have been notified of the Shared Ownership Scheme, and that rural housing will be provided on the basis of need. The Deputy Managers also informed the Meeting that it is proposed to provide housing for two particular families in Portumna, and referred to a recent television report regarding housing applicants. Mr. Gavin confirmed that the applicants in question had received every assistance from the Council, and had already been adequately dealt with prior to the television report.
