The Chairman indicated that it was his intention totake Item No. 3 on the Agenda first.

Councillor Matt Loughnane proposed a Vote of Congratulations to Kilconieron Hurling Team. This was unanimously agreed.

PRIOR NOTICE - CLR. SEAN O'NEACHTAIN - PLANNING REF. NO. 69100 - APPLICANT - HENRY WHITE.

Councillor O'Neachtain indicated that the Council had passed a Section 4 Motion concerning this particular Planning Application. It was refused by the County Manager. He asked what basis that the application was turned down. He indicated that the applicant had no way of getting any more frontage. He had made a submission to the Council willing to freeze the remaining 18 acres of his land for agricultural purposes. He felt that decision was harsh in planning terms. He wished to make the point also that it was on a by-road.

The County Manager indicated that after receiving legal advice it was considered that the decision by the Council was not in accordance with the proper planning and development of the area, and that the

matters considered by the Council were not fully planning matters. Deputy McCormack asked whether in future it would be safer just to propose and second Section 4's on the basis that they believed that they were in accordance with the proper planning and development of the area. The County Manager indicated that it was not his advice and that it would be unwise of the Council to follow this course of action. The Councillors should address the matter before them and deliberate on same, and it was up to them to decide then whether it was felt that the development was in accordance with the proper planning and development of the area and the Development Plan. Deputy O Cuiv indicated that there were unusual circumstances in this particular instance. He would have no sympathy if the applicant had sold road frontage previously. He felt that the road frontage rule was to stop backlands and high density development. He asked would the County Manager reconsider in the light of the unusual circumstances. Councillors Matt Loughnane and John Mannion asked whether the Material Contravention procedure would be the way to proceed in this particular instance. The County Manager indicated that they must have regard to the Plan, but that there was the Material Contravention option that could be considered.

HOUSING.

The County Manager indicated that in an effort to encourage rural redevelopment and to have a broad base for the 1994 Housing Programme that it was his intention to advertise for lands in the following areas for housing, Carraroe, Clifden, Lettermore, Ballyconneely, Athenry. For Halting Sites - the Portumna Area, Tuam Area, Oranmore Area.

The County Manager indicated that he would examine any area where there was a housing need should land be required, and confirmed that the Council had started their 70 houses in the 1993 Programme, and informed the Council that the Department had laid down guidelines with regard to the number of houses that were to be built in any location. He also informed the meeting that Deputy Stagg had indicated to each Council that they would be required to provide a specific portion of their 1994 Housing Programme for Traveller Families. He stated that over the past number of years, Galway County Council had provided 100 houses plus 4 Halting Sites and Galway Corporation had provided 70 plus 4 Halting Sites for members of the Travelling Community.

The County Manager indicated that the Council must provide accommodation for those deemed to be in need of housing and that, while the County Council provide Halting Sites and Houses, it is not Council Policy to provide caravans.

The Council unanimously agreed to send the following Councillors to a Conference which was held in Wexford on Incineration - Councillor J. Mannion, Senator J.McDonagh, Councillor J. McClearn.

FINGER POST SIGNS.

199

The Members discussed the problems associated with Finger Post Signs. Deputy O Cuiv indicated that the restriction to one sign could bring problems in certain locations, and queried the necessity for planning permission as a result of seeking permission for a sign for Bed and Breakfast. Councillor Walsh indicated that Kilkerrin Environmental Group were asking permission to erect Wooden Signs and that a sample of the signs could be given to the Council. Councillor Gavin indicated that the stonework signs that were being placed in many locations were an attractive feature and this should be encouraged. Senator McDonagh referred to his Submission No. 4 with regard to Finger Post Signs, and asked whether planning permission was needed for the stone signs, and stated that same should be used in every Village. Councillor O'Neachtain indicated that he had misgivings in relation to the spelling and meaning of signs in Gaeltacht Areas, and felt that planning permission should be required given the shanty town image that was being portrayed in some areas by unauthorised signs. Councillor Byrne referring to the Development Plan indicated that there was no reference to Finger Post Signs, and asked that the Members submit proposals. Councillor Ni Fhatharta indicated that the Council had to set out a policy in this area.

The County Manager indicated that the matter was dealt with quite reasonably in the County Development Plan on Pages 134 to 136 Paragraghs 13(i) and 13(ii). The Manager read the relevant portion of the Plan to the Councillors. He indicated that he would circulate this portion of the Development Plan to the Councillors. The County Manager indicated that with regard to the need to look for planning permission that it was not possible to give planning permission for a Finger Post Sign to unauthorised developments. He further clarified this by indicating that he did not see any problem with regard to Finger Post Signs being erected for small B & B's who operated during the Summer and stated that this matter would be examined by the Council staff, but the main problem was to get rid of illegal signs. The County Manager indicated that the Stone Signs that were being put in place by local communities were an excellent idea and that the Council had to achieve the balance to ensure people knew where they were going while at the same time restricting unauthorised signs.

Councillor Fahy indicated that these signs should be at the entrance and exits to each town and that also information as to what services are available in the town should be displayed on the sign. The County Manager indicated that this was an excellent idea, that Kilronan was an example of this where an information sign indicated the services being provided and stated that with regard to small scale B. & B's it would not be necessary to apply for planning permission. He pointed out that the Council could not take any action with regard to operations that were in existence for 4 and 5 years.

FLOODING AT KNOCKNACARRA.

Councillor O'Neachtain enquired whether the flooding at Knocknacarra was the responsibilty of the County Council or the Corporation. He was informed by Deputy McCormack that it was a Corporation matter and that he would be taking up same.

The need to attract tourist accommodation had to be catered for. Councillor Neachtain indicated that he was not in favour of deletion of this portion of the Plan. Councillor O Tuathail indicated that there needed to be some change, the Section seemed to be a carte blanche for development. Councillor McHugh indicated that he was not in favour of deleting same, he said that it might be more beneficial to free up the amenity areas as listed in the Development Plan. Deputy O Cuiv asked whether all planning permissions in these areas could be brought before the Council. Deputy McCormack clarified the reasons for his submission indicating that the if the Ballyconneely application had become before the Council, it was unlikely that same would have been passed. If the Members felt that the development was beneficial to the locality the matter could be considered by means of a Material Contravention of the Development Plan. The Chairman in summing up asked Deputy O Cuiv to submit a motion to the Council indicating that it would be written into the Plan that certain large scale proposals would need to be approved by the Council before being passed.

Submission No. 3 - Councillor S. O'Neachtain.

Councillor O'Neachtain proposed his submission.

He indicated that the present blanket restriction was too restrictive. He indicated that this was a very important section of the plan which had to be written to encourage development while at the same time preserve the natural amenities of particular areas. The Chairman indicated that in Submission No. 6 that he had asked the Council to define High Amenity. Some of the Members indicated that there were other areas in the County, for example, in South Galway which could also be examined with regard to their potential as High Amenity Areas. The Members also asked that the need to address what is the family farm and to cater for emigrants returning home be also reconsidered.

VOTE OF CONGRATULATIONS.

The Members agreed to write to the E.S.B. and the Lifeboat Emergency Services with regard to the work which they had done during the recent storm. Councillors also proposed a vote of congratulations to Mr. Declan Varley, Journalist on his recent publication "Elephants Graveyard". Deputy O Cuiv

The Opening Prayer was recited.

ESTIMATES 1994:

Deputy P. Connaughton called for a reduction in the proposed increase in Rates, an increase in funding for Essential Repair Grants and Disabled Persons Grants, an increase in funding for County Roads, referred to the high cost of housing repairs, and stated that the Council should have a more developmental role which would be relevant to local groups.

Councillor M. Fahy proposed a special allocation of funding for the provision of housing to deal with the backlog of approved applicants, and stated that the Council should not be responsible for maintenance of Courthouses. Councillor O'Neachtain stated that provision should be made for road safety outside schools, welcomed funding for new lights, and suggested that community groups provide and maintain

public lighting. Councillor O'Neachtain also requested that provision be made for the Spiddal Sewerage Scheme.

Councillor McClearn expressed concern due to the fact that low income families may not be able to avail of discounts for water charges, requested information regarding the contribution to the Aughrim Interpretative Centre, proposed that new lights should be provided in villages on a programme basis, and requested that Portumna Sewerage be treated as a top priority by the Department of the Environment.

Councillor Gavin emphasised the need to improve collection levels, referred to the fact that additional responsibilities are being imposed by Central Government and the E.C. without corresponding funding, and agreed with the proposal to increase amenity grants to £30,000. Councillor Gavin also expressed concern at the high cost of the Fire Service.

Councillor Brennan suggested that a discount scheme be introduced for Rates, requested information on the repaving contract at Oranmore/Craughwell, Health and Safety, the possible use of Social Employment Schemes for housing maintenance and the adequacy of staff numbers.

Councillor Loughnane welcomed the inclusion of the Loughrea By-Pass in the National Plan, but expressed concern at the fact that Loughrea Sewerage Scheme is not mentioned in the Estimates, recommended an extended period for revisions of valuations, that funds be made available for local tenants who wish to carry out repairs, and stated that, as Athenry does not have a 24 hour water supply, residents should not be requested to pay full charges for a partial supply.

Councillor O'Tuathail stated that the Council has no impact on housing, water and sewerage, or roads, that there is no option for private rented accommodation in the Connemara area, that roads funding should be on a per mile basis as far as possible, that Capital funding be spent on villages, that the Council should take over group schemes, that pipes should be replaced rather than repaired, expressed concern due to the fact that the Preliminary Report for Carraroe Sewerage had not been prepared, and expressed concern at the rates increase due to the fact that small rural businesses cannot compete with those in the City. Councillor O'Tuathail also stated that the

position in relation to burial grounds is unacceptable. Deputy McCormack stated that the increase in the Rate Support Grant is too low, that National Primary Routes are being improved at the expense of local roads, expressed concern at the Oranmore/Craughwell Road Development, and stated that Gaeltacht Grants are too low having regard to the cost of mobilisation of employees and plant.

Councillor Ni Fhatharta stated that £20,000 provision for new lights is too low, requested information on the Costello Regional Water Supply Scheme, stated that the Waiver Schemes should be publicised, expressed disappointment at the number of rural houses being built in Connemara, and informed the Council of the need for new Burial Grounds and improved maintenance. Councillor McHugh referred to the fact that the cost of the Library Service is very high, emphasised the need to promote the Library Service, and proposed that £3,000 of the funds available to the County Librarian be used to promote the service. This proposal was seconded by Councillor Mullins. Councillor O'Neill referred to the fact that the system of Local Government is too centralised, the need for the provision of facilities in rural areas, and suggested that the Council examine the possibility of introducing charges for Sewerage Schemes in the light of the high cost of maintenance.

Councillor Byrne welcomed the increase in the Rate Support Grant, suggested an increase of £10,000 for Amenity Grants, and that the Council increase the number of Social Employment Schemes. Councillor Cunningham requested further information on the design of the Gort By-Pass, the Gort Regional Water Supply Scheme, and thanked the Manager and the Staff for dealing with the recent traveller problem at Gort. Councillor Varley suggested that the Council acquire derelict buildings in the centre of Headford, informed the Meeting of the need to address the decline of rural areas, and requested increased maintenance for Burial Grounds.

Councillor O'Sullivan told the Meeting of the need to upgrade public lighting, requested information as to the use of Motor Tax Receipts, and stated that Rate Support Grants are not equally distributed having regard to the fact that some local authorities have not imposed Service Charges. Councillor Callanan informed the Meeting of the need for increased funding for disabled persons grants, requested information on planning charges, and stated the

Social Employment Schemes have been of great benefit to the County. Councillor Michael Finnerty referred to Persse Park Group Water Scheme and requested that this scheme be charged at a lower rate.

Deputy O Cuiv referred to the need to have the Fiscal Studies Report implimented as soon as possible, requested further information on the Waiver Scheme and Planning Fees, requested that special attention be given to the repair and replacement of ranges, asked that the County Council be flexible in relation to selection of sites for serviced demountable dwellings, stated that charges for Group Water Schemes are high and suggested that the Trustees of Group Schemes collect charges. Councillor Ryan informed the Meeting that a proposed 5% increase in rates is too high, welcomed the discount scheme for water charges, stated that the condition of roads is generally unacceptable and that extra provision should be made for lights and burial grounds.

TRAVELLERS

The County Manager informed the Meeting that the Council had physically moved travellers in Gort and that it is the policy of the Council to enforce the law fairly in relation to travellers and the settled community alike. The Manager also stated that the Council has commenced construciton of a house for a Handicapped Traveller at Bridge Road, Portumna, and that the Official Opening of the Halting Site at Craughwell would be held on the 3rd December, to which the Members of the Council and the Traveller Settlement Committee would be invited.

The County Manager also informed the Meeting that the Council's efforts to commence construction of a house at Caherlistrane had been frustrated by protesters, that the Solicitor representing the protesters had been informed that the Council intends to seek an Injunction, that the site had been fully examined by the Council and was considered suitable on all grounds, that outline planning permission had been granted in 1986 for a house on the site, that the Council had given assurances that no scrap would be allowed on the roadside, and that the Council has a right to construct a house on that site and must ensure that that right is not enfringed. The Manager emphasised that the traveller family are entitled to housing and appealed to the people of Caherlistrane to allow the house to proceed. In reply to Councillor McHugh, the County Manager stated that an alternative specific site had been examined
