ESTIMATES

The County Manager referred to the Book of Estimates and Report which had been circulated to the Members of the Council. It was proposed by Councillor Hussey, seconded by Councillor Mannion and agreed that the Council request the Minister for the Environment to impliment the Fiscal Studies Report on a phased basis over a five year period, and that 1/5 th of the shortfall to Galway County Council be paid in the current year with the balance being paid in subsequent years. Deputy Connaughton requested that further funding be allocated from the Department for County Roads and the Rate Support Grant. Councillor Willie Burke requested increased provision for public lighting, for pumps in Athenry, for the Moyvilla Road, and for the Portumna Sewerage Scheme. Councillor Finnerty requested that discounts be given to Group Water Schemes similar to those proposed for connections from Council mains.

The County Manager stated that there is provision in the National Plan for funding for County Roads but this money has not yet been allocated, that there is no indication of any further increase in Rate Support Grant for 1994, and that the proposed discounts apply to all connections.

Councillor Callinan requested the provision of £100,000 for Essential Repair Grants, Councillor Finnegan requested that the Council impliment more safety measures due to the fact that roads are not being improved, Councillor O'Neachtain requested an increased provision for public lighting and safety on Regional Roads, Councillor Ryan requested improvements to the Monairmore Springs and asked that the money due to the Ballyedmond Group Scheme be paid, Councillor Quinn requested an increase in the provision for public lighting, and Councillor O'Sullivan requested information on the Clontuskert Group Water Scheme.

The County Manager informed the Members of the need to increase income or reduce expenditure if extra provision is to be made for expenditure items in the Estimates. The Manager also stated that the payment to the Ballyedmond Group Scheme had been approved.

VISIT BY THE MINISTER FOR THE ENVIRONMENT.

The Chairman welcomed Mr. Micahel Smith T.D., Minister for the Environment to the Meeting, and proposed that a number of Members of the Council address the Minister.

Councillor W. Burke, informed the Minister that the Report of the Institute of Fiscal Studies had identified that Galway County Council Council should receive a minimum of fl.4 M extra per annum, and that as a result, the services in the County are deteriorating due to lack of funds and increasing needs. Councillor Burke proposed a compromise whereby the Urban District Council's would be excluded from the calculations, grants to authorities which are presently overfunded should be frozen, and the grants to other authorities should be adjusted to

provide funding in accordance with Model 4 of the report. Councillor Burke estimated that this would cost the Exchequer £7 M in 1994 and £3.50 M in 1995.

Councillor Gavin informed the Minister that the Council is of the opinion that there is too much emphasis on National Roads at the expense of County Roads, that the proportion of funding for non-national roads is decreasing, that the Council requires £2.50 M per annum over 10 years instead of £0.4 M as was allocated in the current year, and that re-alignment and pavement works are urgently required. Councillor Gavin referred to specific roads in the County which urgently require remedial action. Councillor Gavin stated that employment in the Council has dropped by 60% over the last ten years, and requested that more funding be available for Local Improvement Schemes with a specific allocation for Islands.

Councillor P. McHugh welcomed the increase in housing starts for 1993, and requested that at least 100 starts per annum be allocated to Galway County Council on the basis of a three year plan. Councillor McHugh informed the Minister that a House Improvement Grant, administered by Local Authorities is required to deal with essential improvements, and recommended that this scheme be means tested. Councillor McHugh also requested that the floor area limits for New House Grants be extended, that a grant of £200,000 be allocated in the current year for the provision of water and sewerage facilities to demountable dwellings, that a special grant of £200,000 be made available for the refurbishment of group housing schemes for travellers, and that a once off allocation be granted to Galway County Council to clear the backlog of applications for Disable Persons Grants. Councillor McHugh also stated that powers should be devolved to Housing Authorities, particularly in the area of New House Grants and Design Approvals.

Councillor M. Mullins informed the Minister that the Council has, for some time, been requesting a transfer of funds from the Department of Social Welfare to the Department of the Environment so that people can be employed by Local Authorities to do work which is badly needed. Councillor Mullins stated that this scheme would reduce unemployment levels and have consequent social and economic benefits, would increase overall productivity, would allow for roadworks and amenity works to be

undertaken, and would possibly generate income tax revenue to the State. Councillor Mullins stated that the Council considers that a fundamental re-appraisal of policies is necessary to deal with the unemployment problem which is restricting the development of County Galway. Councillor Mullins also stated that the Council should seek to restore the level of outdoor staff to previous levels.

Councillor Sean O'Neachtain informed that Minister that there are a large number of small towns and villages in the County which require sewerage disposal systems, and while funding is being provided for a number of major water and sewerage schemes, the Council is requesting that special funding be provided for small schemes to enable such schemes to proceed in parallel with the major schemes. Councillor O'Neachtain also informed the Minister that the Council faces a major problem in the funding of annual maintenance costs of new major sanitary services schemes, and that the cost of planning new major schemes is placing a severe restriction on the finances of the Council. Councillor O'Neachtain stated that there is an urgent need for the improvement of the water supply systems on the three Aran Islands, and asked that the Minister give special consideration to proposals which the Council has put forward for these Islands. Councillor O'Neachtain also requested the Minster to consider a number of specific schemes throughout the County.

The Minister for the Environment informed the Council that he is anxious to build a partnership between local authorities and the Department of the Environment to determine priorities at local level, that limited resources are available to meet demands, and that services must, therefore, be delivered as efficiently as possible. The Minister referred to the lack of positive publicity about local authority achievements, and the need for local authorities to express a positive attitude in relation to developments and services. The Minister stated that £180,000 is being made available for refurbishment of Gilmartin Road, and that group sewerage schemes will be introduced with revised local contribution levels.

The Minister stated that it is clear from the report of the Institute of Fiscal Studies that Galway County Council should benefit from a revised system of grant equalisation, and that the observations received from local authorities are being considered at present. The Minister also stated that there is substantial

provision in the National Plan for the funding of County Roads, but this would be expended on the provision of new roads rather than maintenance. The Minister did not consider that local authorities will, in future, be able to maintain roads if they are also responsible for hedges, drains, etc. The Minister pointed out that County Roads are owned by the local community and that the local communities should maintain the roads either on their own or in conjunction with the local authorities. The Minister stated that there must be a radical re-appraisal, not just of County Roads, but for other services, and that the public should only seek services which can be afforded.

The Minister informed the Meeting that there is no scope for increrasing permanent employement in the public sector, and that Trade Unions should co-operate with local authorities for the promotion of FAS and Social Employment Schemes, particularly in the light of the increase of funding available by way of Structural Funds.

The Minister stated that powers are being devolved to local authorities, and that this process will continue. Mr. Smith pointed out that a large number of housing applicants are single and lone parents and stated that the needs of these applicants will not be met solely by the provision of houses. The Minsiter paid tribute to Galway County Council for the progress achieved on the Improvements in Lieu Scheme, stated that small developments are required rather than large scrawling estates, and informed the Meeting that all the schemes in the Plan for Social Housing must be used and integrated. The Minister confirmed that a New Housing Grant Scheme will be considered, but it is not envisaged increasing the floor area for New House Grants. The Minister also confirmed that the problem relating to the servicing of demountable dwellings will be considered and Disabled Persons Grants, Water and Sewerage Schemes and Roads, referred to by the Members will be considered in the context of the 1994 Estimates.

In relation to employment, the Minister stated that studies carried out to date indicate that a Scheme as proposed by Councillor Mullins would be very expensive due to the difference between the rates of Social Welfare and the average Industrial Wage, but this scheme would be further examined.

The Minister informed the Meeting that the public must hear the real facts, i.e. that taxes have to be raised to fund increasing services. The Minister stated that local authorities should be positive about the work which is being undertaken, and that the public should be made aware of the benfefits being produced. The Minister also informed the Members that, with the resources available from the EC, there is now an opportunity to improve infrastructure and to promote community development.

The Chairman thanked the Minister for attending the Meeting and addressing the Members of the Council.

That money be provided for renovation and freeing of the under road drains at the house of Mr. Eddie Booth - serious flooding occurs causing road to be closed quite often. This problem should be examined. I would like a report on this as it may be a bit problem.

That the Public Refuse Dump at Kilronan be closed down as the present location adjacent to the Public Water Storage is not suitable. The closure should involve sealing and capping or removal of entire amount of rubbish to a new landfill refuse dump to be extablished at a mroe suitable location where proper management procedures would be enforced on a daily basis.

Councillor S. Gavin, Senator J. McDonagh and Deputy E. O'Cuiv requested that this application be reviewed. The County Manager informed the Meeting that, if submissions are made with a view to resolving existing problems on the ground, the matter can be considered.

ADVANCE NOTICE - 68487

1838

Deputy McCormack informed the Meeting that this proposed development is causing concern in the Ballyconneely area, that a decision has yet to be made on a Discharge Licence, that the development cannot be assimilated into the surrounding area, that the elected members were not given an opportunity to express their views on the application, and that natives of the area have been refused planning permissiion for single houses. Councillors O'Neill and O'Neachtain raised similar queries.

The County Manager stated that Outline Planning Permission was granted for this development in 1992 and that no objections were lodged. The County Manager informed the Meeting that it was the policy of the County Council that where there is essential housing need, this need takes precedence over all other matters. The County Manager also informed the Members that he would examine any individual cases raised by the Members, and that the elected members sought in the last plan to include the provision for development of this nature in tourist areas. The development is within the natural growth area of the Village, is specifically for holiday use and, therefore, is in keeping with activities in the area, and that approval has been granted for this development.

Deputy O Cuiv stated that development of this type should be considered in the context of the Review of the Development Plan, and that, where essential housing need is accepted, the applicant should be invited to discuss the application with Planning Officials.

A Deputation from the Ballyconneely area addressed the Meeting.

EFFLUENT FROM MEAT FACTORIES.

The County Manager, in response to issues raised by Deputy Connaughton, stated that where planning applications are lodged for slaughter houses, the Council can deal with the disposal of effluent by way of conditions. The Manager also stated that part of the problem is due to the fact that effluent is

coming from other counties, that the only way to dispose of blood is by controlled land spreading, and that such control could be implemented by the introduction of by-laws. The Manager informed the Meeting that the Department of the Environment is carrying out an in depth investigation into waste disposal and that a central location may be proposed for dealing with this waste. The Manager also stated that the Council is monitoring ground water on an ongoing basis.

Councillor Walsh requested that the Council ask Teagasc to initiate a publicity campaign to deal with the concerns about slurry tanks, and the Manager confirmed that this would be done.

CONFERENCES.

It was agreed that the Council approve the attendance of Councillor J. Mannion at the A.M.A.I., Conference in Wexford on 21st/23rd September, 1993, and that Councillor T. Walsh replace Councillor T. Byrne at the Housing Conference in Brighton.

LAW AND ORDER.

The Council unanimously denounced the recent attack on four members of a Hurling Team in Galway City and requested the Minister for Justice to provide more Gardai for Galway. It was agreed that an Official Invitation issue to the Minister for Justice to address a Meeting of Galway County Council/
