RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955 - PLANNING APPLICATION NO. 68683 - APPLICANT - ANN LAHEEN.

The Resolution as set out on the Agenda was proposed by Deputy Connaughton, and seconded by Councillor Hussey.

The County Engineer read the following report which had been circulated to each Member prior to the Meeting.

LOCATION:

The site is located on the N63, i.e. the National Secondary Route, three and a half miles approximately west of the village of Moylough and within 200 yards of Brierfield National School.

PLANNING HISTORY:

There was one previous planning application on this site.

PR. 64398 - Planning permission was granted by Galway County Council to Ann Laheen because of a second family claim on this restricted route. Condition No. 2(ii) restricted the use of brickwork to the surrounds of the windows only and, that the front elevation should be plastered grey in colour or finished in such other finish as shall be agreed in writing with the Planning Authority.

The applicant Ann Laheen appealed this condition to An Bord Pleanala and the Bord upheld Galway County Council's decision so that Condition No. 2(ii) was inserted as above.

PLANNING CONSIDERATIONS:

The site is located on the National Secondary Route just 200 yards from Brierfield School and approximately three and a half miles west of Moylough village, an area of limestone landscape. The proposed development would be contrary to the proper planning and development of the area because it would provide for an extensive wall finish which would be incongruous in its setting and out of character with existing and traditional house facades in this rural area.

The use of brick for building purposes is more tradition to the east coast of Ireland especially Dublin City and is used to a lesser extent in other urban areas.

The development as proposed would be contrary to the present County Development Plan, Appendix A where it states that materials prevalent to the area should be used for the external elements of a house where there are extensive guidelines for house designs for Rural areas.

The proposed development would contravene materially

a condition attached to a previous existing permission for development on this site and would not be in accordance with the proper planning and development of the area.

RECOMMENDATION:

Refusal is recommended as follows:

- 1. The proposed development would be contrary to the proper planning and development of the area because it would provide for an extensive wall finish which would be incongruous in its setting and out of character with existing and traditional house facades in this rural area.
- 2. The development would contravene materially a condition attached to an existing permission for development and would not be in accordance with the proper planning and development of the area.

Deputy Connaughton informed the Meeting that the question at issue in this case was whether an applicant was entitled to use red brick. Deputy the Public are divided on the issue, and contended that when a young couple procure a substantial loan, they should have some discretion as to the not out of character with the area. Deputy built without red brick and subsequently painted with red oxide.

The County Engineer referred to the report circulated to the Members and pointed out that the planning family home on a National Secondary Road, that he Connaughton, but one difficulty was that the Bord Pleanala and the Bord had upheld the Council's not traditional in this area and that the County area should be used.

Councillor Finnegan spoke in favour of the motion, and Councillor Brennan paid tribute to the applicants for not ignoring the conditions of planning permission.

The resolution as set out on the Agenda was proposed by Councillor Walsh and seconded by Deputy

Councillor Walsh informed the Meeting that Mr. McHugh is a building contractor who employs 12 people in the area, that he keeps his building equipment in an area adjacent to the roadway, and that there were no complaints until he took steps to enhance the area. The applicant purchased land at the back of his house with the intention of removing his van and machinery to the land to enhance the appearance of the area for himself and his neighbours. In order to improve access, the applicant removed ground cover, put in

top soil and gravel, and considered that he was entitled to make a road to his land. Clr. Walsh stated that the applicant was surprised when required to stop the development, when planning permission was refused, and when the permission was refused on appeal. Clr. Walsh stated that, having visited the site on two occasions and discussed the matter with the applicant, he believes the objections were the reason for refusal. Clr. Walsh considered the objections to be inaccurate, and questioned whether it would be preferable if the applicant parked his equipment at the front of his house. Clr. Walsh also stated that it was the concern for his neighbours that made Mr. McHugh undertake the development, that there is very solid support from Mr. McHugh's neighbours with the exception of one family, that Mr. McHugh is a substantial employer, that the development is not of immense proportions as stated by the objectors, that Mr. McHugh is satisfied to allow a grass area between the laneway and the objectors land, that the number of vehicles using the laneway have been grossly exaggerated by the objectors, and that this a genuine effort by Mr. McHugh to improve the situation.

The County Engineer informed the Meeting that a second objection had been received, and that this objection was conditional on the road being widened. The County Engineer read the following report which had been circulated to the Members prior to the Meeting.

LOCATION: The site is located at Kilcloghans, approximately 1 mile north of Tuam Town centre, on a County Road which joins the Tuam Milltown Road 400 metres to the east.

PLANNING HISTORY:

Ref. No. 31756 - Permission granted for dwellinghouse on site in July 1979 - applicant Mr. T. McHugh. Ref. No. 67741 - Permission refused by the Planning Authority and An Bord Pleanala for retention and completion of access road and builders storage area - applicant Mr. T. McHugh. A Warning notice and an Enforcement notice have issued in relation to the unauthorised development on site.

The site is located within the Tuam Town Environs

Planning area in the agricultural zone designated in the Town Plan. The applicant has developed a small compound to the rear of his house on eleven acres of land which he purchased in recent times. The compound is for the storage of machinery and material relating to his business as a building contractor. Access is by means of a roadway which he has developed between his own house and his neighbours immediately to the west. The neighbour is objecting to the development. There is also a second objector in the area.

The development immediately adjoins the curtilage of the objectors house and is within 100 metres of a number of other houses some of which have given written support to Mr. McHugh. It is considered that an activity of this nature should not be located in such close proximity to residences because of the noise and other nuisance which would be generated by operation.

The Development Plan states that commercial and industrial development are not normally permitted on lands zoned agricultural.

RECOMMENDATION:

Refusal is recommended as follows;

Having regard to the location of the site adjacent to and adjoining a number of residential properties, it is considered that the development would seriously and would be contrary to the property in the vicinity development of the area.

CONSULTATION: The applicant attended the Planning Office with Councillor T. Walsh and discussed the application.

Councillor W. Burke informed the Meeting that he would oppose the proposed development as the objectors family had borrowed money to make a family home, that the area for the proposed development is a residential area, that it would be unfair to develop a builder's yard at the back of the objector's house, employed people, alternative arrangements should be made for the yard. Councillor Burke also stated that

the objectors have put their house on the market, and that they have young children who could wander onto the site. Councillor Burke stated that, as the application has been rejected twice by the County Council and as An Bord Pleanala have also rejected it, the Council cannot set precedence and should abide by the Development Plan.

Councillor Brennan questioned whether a Section 4 could be granted after a refusal by An Bord Pleanala and whether that decision could then be appealed to An Bord Pleanala. The County Manager informed Deputy Brennan in the affirmative, and the County Engineer stated that there could be legal problems if circumstances have not changed. Councillor Finnerty pointed out that the objectors contended that 12/14 people congregate at Mr. McHugh's house at 7.30 a.m. each morning, and pointed out that, if refused Mr. McHugh could still park his equipment in his Driveway. Deputy Connaughton stated that he did not consider the development to constitute an industrial site, and that there should be some compromise. The County Engineer, in response to Deputy McCormack, stated that there are no substantial differences between this application and the previous application, but Councillor Walsh contended that the current application is different in a number of

Councillor Finnegan stated that the Section 4 Notice had been signed by himself and Councillor Hussey to have the matter on the Agenda for the Meeting, that Section 4's are not designed to settle disputes, and that the County council has a judicial function to listen to the evidence and make a decision. Councillor Hussey stated that he would not support the Section 4 Motion and expressed the hope that both parties would come to a compromise.

The site is in an Area of Outstanding Scenic Amenity, as designated in the County Development Plan, which stretches along the Galway Bay Coastline from Parkmore westwards to Auglunish on the County Clare Border and southwards to include that part of the Burren which is in County Galway. It is on a green boreen approximately 600 metres from the public road where there is no existing building development and which is removed from the E.S.B. and Telecom services.

There are panoramic views of the Burren from the public road southwards across the site and Auglunish Bay. A building situated on this site would be a serious intrusion on the outstanding views available and would seriously diminish their quality. It would also serve as a precedent from further housing along this road, which apart from the building themselves, would result in the extension of E.S.B. lines and most probably Telecom lines across an unspoilt landscape.

The existing family house adjoins the public roadway and there would be no objections to locating the proposed house south of it where it would adjoin other houses and cause least damage to visual amenity.

RECOMMENDATION:

The following difficulties would arise in relation to this application;

1. The proposed development would be located in the foreground of extensive scenic views of the Burren in an area presently free of development, and it would be an intrusive feature on the landscape and would interfere with a view of special amenity value which it is necessary to preserve.

The County Engineer stated that the Council has informed to the applicant that sympathetic consideration would be given to an alternative site. The County Engineer disagreed with Councillor Byrne in that development along this Boreen would be in an isolated area, and stated that the poles for Telecom, Engineer contended that the house would be visible from the County Road, and that a compromise would be possible if the development was to take place along the County Road.

The County Manager pointed out that the applicant had

Senator McDonagh stated that this development does not exit onto the National Primary or National Secondary Road as it will exit onto to a County Road. Senator McDonagh also informed the Meeting that the proposed developer has 10 acres of land and that there is a genuine housing need. As there is no traffic hazard, and as the application does not constitute backlands development due to other houses having been recently granted planning permission, Senator McDonagh did not see the necessity for a Section 4 in this case.

Councillor O'Neachtain stated that this is a straight forward case of housing need, that the Applicant owns the land, and that the proposed development does not constitute backlands development as planning permission was granted on adjacent sites.

The County Engineer read the following report which had been circulated to each Member prior to the Meeting:

LOCATION:

The site is located in the townland of Cregboy on the County Road linking the N17 Galway - Claregalway road and the N64 Claregalway - Oranmore Road. The site is located approximately 300 yards from the junction with the N17 National Primary Route.

PLANNING HISTORY:

PR. 66955 - A similar application by the same applicant was refused by the Planning Authority on grounds of undesirable development of backlands and inadequate site size having regard to the requirements of the County Development Plan.

Subsequent to this refusal, the applicant developed the access way to the site without the benefit of planning permission. A Warning Notice has issued in relation to this unauthorised development.

PR. 67663 - A similar application was again refused by the Planning Authority on the same grounds as previously refused.

PLANNING CONSIDERATIONS:

The proposed site has no direct frontage on to the public road but is accessed by a right of way approximately 8m wide and is located approximately 110m from the public roadway.

Mr. Forde also indicates areas of the public roadway as being part of the right of way and parking areas.

There is no evidence to support this contention and in fact one neighbour has objected to part of his garden being indicated as a right of way and has also objected to the proposed development. There is a hand-printed note purporting to be from the second neighbour allowing Mr. Forde the use of his parking area but this note is unsigned.

It is a development objective of the County Development Plan, as set out in Chapter 7.1 (vi) to control backlands development.

The site is also located within the urban environs of Galway city where it is the policy of the Planning Authority as set out in Chapter 7.2.6 of the County Development Plan to exercise strict development control. The minimum site frontage required onto a public road is 30m. It is also the policy of the Planning Authority within this area to prohibit backlands development, as contained in Chapter 7.2.8 (ii) of the County Development Plan.

The applicants response to the question of housing need indicates that a housing need does not exist.

RECOMMENDATION:

It is proposed to refuse the application on the following grounds: -

- 1. The proposed development, without any direct access onto a public roadway would constitute undesirable development of backlands which would be contrary to a development objective of the County Development Plan as indicated at Chapter 7.1 (vi) and would be contrary to the provisions of Chapter 7.2.6 and 7.2.8 of the County Development Plan which seek to prohibit such development.
- 2. The proposed development would contravene Chapter 7, Table 7A of the County Development Plan which requires a minimum site frontage of 30m onto a public road, because the site proposed to be developed has no frontage onto a public road.

Councillor Brennan stated that he was amazed that a Section 4 had been submitted in this case as objections had been received and the Application had been refused twice in the past.

The Chairman informed Councillor Walsh that the Manager would consider this matter.

Deputy McCormack referred to a Section 4 Motion recently dealt with in the name of Alan Griffin. Deputy McCormack stated that, as Councillors make a genuine case for Planning Applications at Council Meetings, Officials should inform the Members early in the Meeting as to whether or not it is likely that permission will be granted.

It was agreed that all items to be dealt with under the heading "Advance Notice" are to be submitted 7 days prior to the relevant meeting, and that the planning reference and the name of the Councillor raising the item will appear on the Agenda in future.

Deputy O Cuiv requested that, where a conditions is attached to planning permission that a particular item is required to be done subject to approval or agreement of the planning Authority, that this

It was agreed that the September Meeting of the Council be held on the 27th September, 1993.

CONFERENCES

1760

It was proposed by Councillor McDonagh, and agreed that Councillors Mullins and Mannion attend the Seminar on "The Creation of Employment" to be held in Greystones, Co. Wicklow on the 8th/10th October, 1993. It was proposed by Councillor Hussey and agreed, that Councillor Cunningham also attend.

It was proposed by Councillor Mullins, and agreed that Senator McDonagh and Councillor Ryan attend the "Housing and the Euorpean Community Conference" to be held in Derry on the 21st/24th September, 1993. It was proposed by Councillor Hussey, and agreed that Councillor Fahy also attend.

WILLIAMSTOWN SEWERAGE SCHEME.

1761

Councillor Finnegan referred to the proposal that householders in Williamstown would be required to pay for connection to the proposed Williamstown Sewerage Scheme and requested confirmation that the Council is fully committed to the Scheme. Deputy Connaughton, Councillor Hussey, Councillor Walsh, Councillor Quinn and Councillor J. Burke requested that the Scheme proceed as a matter of urgency, and referred to the fact that some householders may not be in a financial position to meet the charges.

Mr. Kavanagh informed the Meeting that the sewer will be laid to the property boundary and that the householder would be required to connect to the sewer at his/her own cost. A preliminary estimate had indicated that these costs would be approximately £200 to £1,000. Mr. Kavanagh also stated that the Department have requested confirmation that all residents will connect to the scheme when completed, and that there is no indication from the Department of the Environment as to when the Scheme will be approved. Mr. Kavanagh undertook to have information

made available to assist householders in determining the estimated cost of connection.

In reply to Councillor Gavin and Deputy McCormack, Mr. Kavanagh stated that the recent problem of algae bloom in Ballyquirke Lake is being investigated.

ORANMORE SEWERAGE SCHEME

1762

It was proposed by Deputy McCormack, seconded by Councillor Cunningham, and agreed that Galway County Council enter into an Agreement with Galway Corporation, in accordance with Section 59 of the Local Government Act, 1955 whereby Galway Corporation will perform the function of the construction of the Sewerage Rising Main and Ancillary Works within the Corporation Area and preliminary requirements associated therewith, all being part of the Oranmore Sewerage Scheme.

Councillor O'Neachtain requested that plans be prepared for sewerage requirements West of the City, and was informed by the County Manager that the Council already has a substantial programme of sanitary service schemes in planning.

VISIT BY THE MINISTER FOR THE ENVIRONMENT.

It was agreed that the visit by the Minister for the Environment will take place on the 29th October, 1993 at 2.30 p.m. and that the Committee to determine the Agenda for the Minister's visit will meet before the October Planning Meeting.

It was agreed that Mr. M. Killilea, M.E.P., be invited to the October Monthly Meeting of the Council and that this Meeting be held on the 22nd October, 1993.

BEEF PRICES

1764

It was proposed by Councillor Fahy and agreed that the Minister for Agriculture be requested to take urgent action to stop meat factories discriminating against the farming community by trying to reduce beef prices.

TRAVELLERS

1765

Councillor Fahy proposed that the Council take action to remove travellers from Crowe Street, Gort. The County Manager informed the Meeting that the Council has a responsibility to accommodate travellers by Halting Sites, Houses, or Group Houses, that temporary facilities can be provided on Council lands at Gort, and that in this way Councillor Fahy's proposal can be complied with.

Councillor Cunningham informed the Manager that there are objections to the settlement of travellers on

land at Kinincha, and that he had suggested an alternative site. Members of the Council expressed concern at the existing conditions at Crowe Street.

The Chairman stated that travellers should acknowledge that they have responsibilities to the settled community. The County Manager informed the Members that the travellers in question have indicated that they require a Halting Site, that the proposal to build a Halting Site at Kinincha has the support of Traveller Settlement Committee, and that the alternative site is not available and is adjacent to the dump. The Manager confirmed that the Council will immediately examine the possibility of accommodating the travellers on a temporary basis at Kinincha. Councillor Cunningham reiterated his objection to a permanent Halting Site at Kinincha.

WORK EXPERIENCE.

It was proposed by Councillor O'Sullivan, seconded by Councillor Mullins and agreed, that the Council facilitate students who require Work Experience. The Manager confirmed that the Council would co-operate in this matter.

REVIEW OF THE DEVELOPMENT PLAN.

It was proposed by Deputy McCormack, seconded by Councillor O'Nechtain, and agreed that the County Secretary request each Member of the Council to prepare submissions to be considred in the context of the review of the Development Plan, and that three weeks be allowed for such submissions. It was agreed that the Council set a date to consider the Review of the Development Plan at the next Monthly Meeting of the Council.

DUMPS.

In response to Councillor Varley, the County Manager informed the Meeting that the Council is examining the overall strategy for Waste Disposal, and that Kilronan will be examined in that context. In response to Councillor Quinn, the Manager stated that provision will be made for remedial works at Ballygar Dump in the 1994 Estimates.

PEOPLE OF THE YEAR AWARDS.

It was proposed by Councillor Gavin and agreed that Dr. Padraic O'Conghaile be nominated for the People of the Year Awards in recognition of his work for the Galway Hospice. It was proposed by Councillor Fahy, seconded by Councillor Quinn, and agreed that Mr. Jarlath Cloonan also be nominated in recognition of his work with the Galway Senior Hurling Team.
