by Councillor Sean O'Neachtain, seconded by Councillor Connie Ni Fhatharta.

Councillor O'Neachtain indicated that this was a small development which was used as a builders depot. It has been there for many years and it was Mr. Conroy's only means of livelihood. He felt it would be restrictive zoning if this application was turned down. He felt that the development did not fit into industrial category. The agricultural zoning in this area was meaningless given the agricultural worth of the land. He felt that the use was notdisruptive to the residential zoning in this area. With regard to the second reason for refusal, he could not agree that there was a traffic hazard at this location. The road at this location was rather wide and was only used by the applicant to supply local people. It was a small operation and he stressed it is was his only means of a living. He indicated that there was no local objections and felt that there was the flexbility in the Development Plan to allow this type of development.

The County Engineer referred to the report circulated to the Members and as set out hereunder indicated that the development was not in accordance with the proper planning and development of the area.

LOCATION:

The site is located at Forramoyle West, west of Barna in Barna Plan Area in an area zoned agricultural but with a fairly large spread of residential development.

PLANNING HISTORY:

Planning ref. No. 68266 - Planning permission refused in April, 1993 for the same development. Applicant: Michael Conroy.

PLANNING CONSIDERATIONS:

This development for which there is no planning permission consists of a paved yard which is in use as a builders depot in which the applicant stores concrete blocks and sand which he sells to people doing small building jobs in the Barna area.

The site is located in an area zoned "Agricultural" in the Barna Plan and adjoining the area zoned "Residential". The development control objectives as

set out in Chapter 11 of the County Development Plan requires development to conform with the uses set out in Table 11B and lists the type of uses which are not normally permitted in agricultural zones. Such uses include Industrial Development. Consequently, the proposal would not be in compliance with the Development Plan for the area.

The operation will also be within 100 metres radius of seven other houses and this would be regarded as too close a proximity to them to allow for acceptable standards of residential amenity, free from disturbance by noise, dust or traffic or unsociable hours of operation. It would also set a precedent for other industrial or commercial uses which require location close to dwellinghouses in similar areas.

RECOMMENDATION:

Refusal is recommended as follows:

- 1. The development is located in an agriculturally zoned area in the Barna Plan Area of the County Development Plan. It is the policy of the County Development Plan not to permit industrial development in such areas and the proposal would thus be in conflict with the said Development Plan.
- 2. The development would endanger public safety by reason of a traffic hazard which the development would create because the development is located on a narrow county road unsuitable for commercial/industrial vehicular use.
- 3. The development would be seriously injurious to the amenities of this agriculturally zoned rural area because the development is out of character with this rural area.

The County Engineer indicated that it was an industrial use and it was an unauthorised development accordingly. Councillor Brennan asked if there was a sandpit there why was it zoned agricutural. The County Engineer indicated that the blocks were not being made on site. The Chairman asked why the application was now being submitted on the basis that the development had been ongoing for a considerable amount of time. The County Engineer indicated that it was to regularise the development. Deputy Connaughton asked how many people were employed in the operation. Councillor O'Neachtain said that there was one person employed - the applicant. The

In a wide ranging discussion to which many Members contributed ther was unanimous agreement that the representatives of the County Council on the Structural Review Group make every effort to stress the need to ensure that an adequate proportion of the Structural and Cohesion funds be allocated to the West of Ireland.

ADOPTION OF HIGHER EDUCATION GRANTS SCHEME 1993.

On the proposal of Councillor Brennan, seconded by Councillor Quinn it was unanimously resolved that the Higher Education Grants Scheme as circulated be adopted by Galway County Council.

On the proposal of Councillor Brennan the Members agreed that the Department of Education be requested to increase the income levels in all categories to provide for these figures to be treated as Net Income Figures in future years.

Deputy O'Cuiv indicated that there were two anomolies in this scheme as far as he was concerned.

- For the Self Employed there was no provision for depreciation, lease costs etc. being included.
- 2. With regard to land inheritance this was taken as income in the year of inheritance while no cash may be received by the person in that year. He felt that only cash inheritance should be included in the assessment.

Councillor T. Byrne felt there was some confusion with regard to whether people should apply to the Council or to the Vocational Education Committee for Grants. Ms. Ann Hanley, Acting S.S.O., indicated that one application would suffice. Councillor Callinan asked whether the Council accepts the accounts presented by Farmers that have been verified by the Revenue Commissioners. The Deputy County Manager indicated the Council had to make their own decision with regard to any Grant application. He pointed out that they were agents for the Department and that they had no option but to follow the quidelines laid down. Councillor Naughton indicated that he felt there should be loan facilities available for students. Councillor McClearn in accepting that they could not change this Plan he noted that there was no increase in the Maintenance Allowance in 1993. He felt that in future schemes should provide for an annual increase in the Maintenance Allowance. Councillor O'Sullivan indicated that there was some inequities in the system and that the Higher Education Grant Committee should formulate a policy and present the case to the Department of Education with regard to having same reviewed. On the proposal of Councillor Callanan,

seconded by Councillor Connaughton, it was unanimously agreed that Galway County Council write to the Minister for Education requesting that accounts verified by the Revenue Commissioners be accepted by the County Council when consideration was being given to a grant application received from a member of the farming/business community.

ADOPTION OF SHEEP DIPPING REGULATIONS 1993.

On the proposal of Councillor Fahy, seconded by Councillor Callinan, the Members unanimously agreed to adopt the Regulations for Sheep Dipping for 1993. The Members agreed to suspend Standing Orders to allow Mr. Pat Donnellan, Galway I.F.A. to address the Meeting concerning the abolition of Dipping Charges. Councillor Callinan asked that the Members be circulated with the details of the I.F.A.'s case with regard to their opposition to the Sheep Dipping Regulations. The Chairman asked the representative of the I.F.A. to submit a list to the Secretary so that same could be circulated to the Members. Councillor Mullins proposed that Meeting of the Sheep Dipping Committee be held early in October to allow consideration be given with regard to the possible loss of income arising out of the abolition of the Sheep Dipping Charges so that same could be available to the Council before the Estimates Meeting. This was seconded by Deputy Connaughton and agreed.

CONTRIBUTION TO GLENAMADDY TOWN TWINNING COMMITTEE.

On the proposal of Councillor Walsh, seconded by Councillor Hussey, it was unanimously agreed by Galway County Council to pay a contribution of £500 to Glenamaddy Town Twinning Committee.

TENANT PURCHASE SCHEME.

Councillor Gavin indicated that he welcomed the Tenant Purchase Scheme, that it gave people an opportunity to buy out their homes, however, when he compared the two schemes - the current scheme to be adopted and the 1988 Tenant Purchase Scheme he felt that there were quite a lot of inadequacies in the current scheme. He had a number of principal areas of concern as follows:-

 The Scheme did not give any recognition to people who spent money on maintaining their own house. In actual fact, it would mean that they would now PAGE NO. 8

have to pay more to buy their house than someone who has not maintained same.

- He felt that the procedure involved in valuations where there is an appeal to the Valuation Office could actually hold up someone wishing to proceed with the purchase of their home.
- 3. He was a bit dubious with regard to the requirement that people who wished to purchase their homes had to deal with banks and building societies.
- 4. He noticed also that the loans that were being made available were at variable rates and this could cause problems in the future for prospective tenant purchasers.
- 5. He indicated that in some instances where Galway County Council have repairs listed to be carried out that if someone wished to proceed to go and purchase, they could, in effect loose out on having those repairs carried out.
- 6. He was also apprehensive in relation to the fact that people cannot sell their house and there were certain problems with regard to tax relief etc.
- 7. He also quoted that in the example given in the case of a house being purchased for £20,000 that the repayments would be approximately £170 per month. He could not see tenants of local authority houses being in a position to repay these amounts of money.
- 8. He was also concerned that the Council had to cover the legal costs associated with the purchase. While in most cases these would be of small amounts it could leave the Local Authority open to a loss of income.

Councillor Toddie Byrne indicated that he was totally dissatisfied with the manner of valuing houses i.e. Market Value. He preferred to retain the valuation method used in the last scheme - i.e. updated cost.

The Chairman allowed Councillor Regan, at that point, to raise an issue concerning Loughrea Development Plan. Councillor Regan indicated that he wished to

amend the Plan so that back gardens in the Town Environs would be changed from the requirement of 11 metres to 3 metres. The Chairman indicated that the Plan had only been adopted and if Councillor Regan wished to have same amended he should make a submission to the County Secretary and let the matter be processed in the normal way.

Deputy Connaughton asked that perhaps the Officials could give an indication to him with regard to what the sale price of a house - the market value £10,000 would be. The Deputy County Manager explained the difference between the Old and New Scheme with regard to a house having a purchase price of £10,000. The Deputy County Manager outlined some of the other aspects of the Scheme at that point as follows:

- (i) It was agreed that the scheme was not as favourable as the previous Tenant Purchase Scheme.
- (ii) There was no Closing Date for the Scheme.
- (iii) Once the Scheme had been approved, there was no need to bring individual sales details before the Council.
- (iv) The total purchase price of the house which would be affected by loan would be payable at the outset. Monies received in this way would be credited to the Housing Capital Account to be used for the Housing Construction Programme.

Councillor Finnerty indicated at this juncture that it would be appropriate that given the matters raised by the Members concerning the new Tenant Purchase Scheme that same be placed on the Agenda for the visit of the Minister for the Environment.

Continuing, the Deputy County Manager indicated that ${\mbox{-}}$

- (v) the method of valuation would be by way of the Council's own technical staff with an appeal to the Valuations Office.
- (vi) the cost of all legal matters will be borne by the Council. People could not avail of the Shared Ownership Scheme with regard to the Tenant Purchase Scheme.

Councillor Toddie Byrne proposed that the Scheme be rejected. This was seconded by Councillor Finnerty. Deputy O Cuiv indicated that the applicant owned the land in this instance. The lands adjacent to the site were owned by the family. The main point in this instance was visibility of the house which it was claimed would be obtrusive on the landscape. He disputed this. Deputy O Cuiv indicated it would not be visible except for a half mile along the County Road that was not used extensively.

The County Engineer read the following report which had been circulated to the Members prior to the Meeting.

LOCATION:

The site is located in the townland of Truska on the Bunowen to Doonloughan road approximately 1 mile east of Connemara Golf Club.

PLANNING CONSIDERATIONS:

The site is in an area zoned "High Scenic Amenity" in the County Development Plan. It is a subdivision of a field which the deceased owner left to her two sons. The present applicant lives in a house in Spiddal and does not have a housing need.

While the County Development Plan does not impose the severe restriction on housing development which applies in the area of "Outstanding Scenic Amenity" it nonetheless states that the policy is "to control and restrict development which would detract from scenic views or would be otherwise out of character with the area".

The site is an elevated ridge of ground which looks northwards onto the sand dunes of Truska and Manninbeg. There is extensive outcropping bedrock with very shallow soil cover in places. Trial holes encountered rock at a depth of 1 foot and the applicant proposes to bring drainage materials onto the site so as to comply with the requirements of S.R.6 1991. This will in turn require the house to be on the high ground contours in order to drain to the septic tank system. Such a location will result in a very obtrusive development on the landscape when viewed from the approach road to the South East or from the sand dunes to the North West. It would not seem possible to implement an effective planting scheme to assimilate the development because of the outcropping rock.

RECOMMENDATION:

The following difficulties would arise in relation to this application.

- 1. The proposed development would be seriously injurious to the visual amenity of this Area of High Scenic Amenity because the site is elevated and exposed and any development thereon would be a strident feature incapable of being assimilated into the landscape.
- 2. It is the policy of the Planning Authority as stated in the County Development Plan 9.2.1(ii) (c) to control and restrict development in Areas of High Scenic Amenity which would detract from scenic views or would otherwise be out of character with the area. The proposed development would contravene the said policy.

The County Engineer referring to the above report indicated that what was really wrong in this particular instance was the fact that the applicant chose the highest point to place the house. If the applicant moved to low ground in the area the County Council would look favourably on the possibility of granting permission for same. The County Engineer indicated that the applicant lived in Spiddal and as such had no housing need. The development would be out of character and would be visible from the sand dunes and approach road. He reiterated that the County Council would be most sympathetic if an alternative location was proposed for the dwellinghouse.

Councillor O'Neachtain indicated that he felt that the development could be incorporated into the landscape. The level of the house could be lowered. The fact that the land was family owned was the main reason for this application. He pointed out that there were other houses in this area. The County Engineer clarified the matter with regard to this point indicating that he wished to have the house located to another site. He felt that if the house was dug into this particular area it would spoil the view also. Deputy O Cuiv enquired whether the Council had requested additional information in this case. The County Engineer indicated in the affirmative. Deputy O Cuiv asked was one of the questions to the applicant an enquiry with regard to the total lands owned by the applicant in that area. The County Engineer read the additional information requested from the applicant.

Deputy O Cuiv indicated that the problem in this particular instance was that there was no time to consider a further location. The application had to be decided on the 16th August, 1993. They did not know if an alternative site would come up with the problem of complying with S.R. 6. He felt that there was a breakdown in communication between the applicant and the planning staff. The applicant was not requested to look at the possiblity of an alternative site. He reiterated his point that the site was not visible from the Golf Club Road which

was the road that was more heavily trafficked in this area. The County Engineer also indicated to Councillor Brennan that there was no consultation with the Planners with regard to this planning application. Councillor Brennan indicated that he could not support this Section 4. There were other refusals in this area. He believed that there should be no Section 4's unless there was consultation between the Council Planners and the applicants. The Chairman called for a Vote on the Section 4 as before the Council.

RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955, - PLANNING APPLICATION NUMBER 68587 - APPLICANT: ALAN GRIFFIN

The resolution as set out on the Agenda was proposed by Deputy McCormack and seconded by Councillor Seamus Gavin.

Deputy McCormack indicated that in his opinion the erection of a dwelling house and septic tank at this location was in accordance with the proper planning and development of the area. He felt that the two reasons for refusal as recommended were not valid in this particular case. He indicated there were three other houses at this location. The Council's requirement with regard to access to minor roads was being complied with fully in this instance rather than having access onto National Primary routes. The applicant owns other land in the area, has an essential housing need, and as such meets the criteria set down in the Development Plan.

The County Engineer referred to the planning history and the following report which had been circulated to the Members prior to the Meeting.

LOCATION:

The site is located on a non-public road which is off the main Galway-Tuam Road (National) Primary Route

N17 on the Galway side of Claregalway village. The site is outside the development boundary of Claregalway village and this part of the National Primary Route is outside the 40 m.p.h. speed limit zone. The access road serving the site is approximately 140 metres long and there are already 2 dwellinghouses built along this access road.

PLANNING HISTORY:

Ref. No. 64358 - Outline permission refused in August 1991 for dwellinghouse on the same site on grounds of traffic hazard - Applicant Ms. Mary Jennings.

65027 - Outline permission refused in March, 1992 for dwellinghouse on a site which included part of current site. Applicant Alan Griffin. A Section 4 Motion was withdrawn in this instance.

68196 - Permission refused in April, 1993 for dwellinghouse and septic tank on the same site as current application. Applicant Alan Griffin.

PLANNING CONSIDERATIONS:

The proposed development would take access onto the N17 at a point where the maximum speed limit applies and along a stretch of road that is already grossly overdeveloped with at least 20 houses developed along an 800 yard stretch of road. On the opposite side of the road, there is another county road junction with approximately 9 new houses having been built just off the N17 over recent years. This demonstrates an excessive level of development along and adjacent to a National Primary Route. The proposed development would add to this level of development and exacerbate the traffic hazard along this stretch of National Primary Route.

The applicant claims that the proposed dwellinghouse is an additional dwellinghouse on the family farm. However the entire land-holding is only 7.5 acres which could not reasonably be considered as a viable farm unit. In any case the remainder of the field appears to be in use for horse-training and there is a large commercial horse training building in the adjoining field. The proposed dwellinghouse could not therefore be described as a 2nd family dwellinghouse on the family farm as defined in the County Development Plan "essential housing need" category.

RECOMMENDATION:

Refusal is recommended for the reasons set out hereunder.

1. The proposed development would endanger public safety by reason of a traffic hazard because the site takes its access onto a heavily trafficked section of the National PAGE NO. 7 MINUTES OF SPECIAL MEETING HELD ON 13/8/93

Primary Road where the maximum speed limit applies and the traffic movements generated by the development would interfere with the safety and free flow of traffic on the road. In addition, the development would militate against the objectives of the Planning authority to:

- (a) preserve the level of service and carrying capacity of the road so that it can fulfil its function as a through road for heavy traffic.
- (b) protect the public investment in the National road network.
- 2. The proposed development would contravene the County Development Plan (Chapter 8, Table 8A) which limits development along this road to those where essential family housing need exists, a category of development which does not apply in this case.

The County Engineer indicated that there were two houses with access on to the laneway. The laneway was quite narrow and would only accommodate one vehicle. There would be a problem with cars turning right into the laneway and having to stall on the National Primary Road waiting for the entrance to clear. The proposed development would endanger public safety by reason of a traffic hazard, because the site takes its access on to a heavily trafficked section of the National Primary Road. The traffic movements generated by the development would interfere with the safety and free flow of traffic on the road.

The County Engineer indicated that 41% of accidents occur on National Primary Routes which account for less than 10% of the road network and this was a frightening statistic. These routes should not be used as development routes. The County Engineer indicated that this was not a County Road and was a private avenue. The A.A.D.T. of this section of the roadway, established in 1990, was set at 10,088 vehicles plus 20% for current figures, 9% represented heavy goods. These were clear reasons for refusal of the application currently before the Council. The County Engineer pointed out that it was hoped that eventually there would be a dual carriageway along this section of road as far as Laghtgeorge. Councillor Seamus Gavin indicated that the County Council were not being consistent. He took issue with regard to the indication in the report that on the opposite side of the road, there was a County Road junction with approximately nine new houses having been built just off the N.17 over recent years. This was further away and was not opposite the laneway to which the current application refers. Councillor Gavin said the applicant seems to be left to suffer because of the overdeveloped road The whole question of the viable family farm had to be addressed in any review of the County Development

Plan. He believed that 7.5 acres can be a viable unit. It depends on the type of farming - extensive farming could be done on less. He also indicated that other developments had taken place in this area. Councillor Ryan, on a point of information to the County Engineer, enquired with regard to the width of County Road, and pointed out that in his area, County Roads were no wider than the one in question. This should not be an objection in this case. The County Engineer made the point that in those instances, you would not have a similar situation that pertains on a National Primary Road. Councillor Ryan indicated that you would have milk lorries waiting to turn off into these also. Councillor Varley indicated that she would question too the fact when a farm is viable or not viable. Councillor Varley knew a farmer who had lost the free fuel allowance over the question of redundant land which was considerably less than seven and a half acres. Therefore, she had to question the rule as to what was a viable farm. Senator McDonagh indicated that the whole kernel of the problem in this instance was what is a viable farm? If it is accepted as viable, the permission should be granted as it was a second family dwellinghouse. Councillor Brennan indicated that he had a certain sympathy with this particular case and wondered about the viability of farm sizes. Deputy McCormack indicated that he would not argue with the County Engineer as it would achieve no good. He supported the idea of a dual carriageway at this

With regard to the current application:-

- (1) It was on a side road.
- (2) It was on the applicant's own lands.

Deputy McCormack indicated that the intention of the Development Plan was to allow an applicant an opportunity to build on his own lands. It is quite obvious that there is a very wide road at this location, and there is also nothing to stop the road being widened further. He could quote others that have been granted permission in these circumstances.

The County Engineer, responding to Councillor Gavin's point, indicated that he had not specified the other developments in this area. Three of these were, as a result of Section 4 resolutions. Others were at least twenty years constructed. There were no recent decisions given by the County Council in this area with regard to planning approvals. It was unfair to make generalisations. He pointed out, also, that there was a refusal to Mary Jennings on this site in 1991. Councillor Gavin indicated that he would be only quite willing to clarify the other developments in this area. He felt it was unfair to victimise one person because of the other development in the area.

NOMINATION OF MEMBERS FROM EACH GROUP TO MEET WITH THE COUNTY SECRETARY AND COUNTY MANAGER TO DISCUSS PROPOSED AGENDA FOR MEETING WITH THE MINISTER FOR THE ENVIRONMENT.

Councillor Mannion indicated that it was agreed at the July Meeting that 6 Members of the Council would be nominated together with the Chairman to meet with the County Secretary and the County Manager to discuss the proposed Agenda for a Meeting with the Minister for the Environment. Councillor Mannion seconded by Councillor McDonagh proposed Councillor Michael Ryan and Councillor Michael Mullins. Councillor Fahy, seconded by Councillor Paddy McHugh proposed that the full Council meet In-Committee to decide on an Agenda for the Meeting with the Minister. The same meeting could also incorporate the Development Plan review. Councillor Gavin indicated that this was a time wasting exercise. It would be better if each group nominated people so that an Agenda could be decided. Deputy Connaughton agreed that the selection of members from each group was the most positive way to proceed with this matter. Councillor Finnegan indicated that it was important that every one have their say in this particular matter. Councillor McHugh indicated his support to the opinion expressed by Councillor Finnegan. Councillor Willie Burke indicated that at the previous meeting of the Council a group session was agreed. It was not possible to rescind this decision. Deputy County Manager, Mr. T. Kavanagha indicated that there was plenty of time to deal with the matter now. He did not feel that there was any necessity to have another meeting to discuss same. CONSIDER MAKING OF CONTRIBUTION TO CONNEMARA/ 1697

On the proposals of Deputy O Cuiv, seconded by Councillor O Neachtain, it was unanimously agreed that a contribution of £2,500 be paid to Connemara/Vlaanderen. The Deputy County Manager, Mr. Kavanagh outlined the background to this proposal for the benefit of the Members.

BUSINESS SUBMITTED BY THE CHAIRMAN.

Deputy McCormack welcomed An Bord Pleanala's Decision with regard to the Barna Golf Club Appeal. This was seconded by Councillor Seamus Gavin. Deputy McCormack indicated that there should be a penalty for frivolous objections. Deputy O Cuiv indicated that he felt there was place in the planning systems for objections on solid planning grounds. The Deputy County Manager indicated An Bord Pleanala had power to deal with frivolous objections.

Councillor Gavin enquired whether there is any change in the exempted regulations requirements as a result of the decision on the Barna Golf Club case. The Deputy County Manager indicated that there was no change in the exempted regulations. Each case would have to be examined with regard to the proposals and the exempted development regulations.

In response to Deputy O Cuiv, the Chairman indicated that the matter of Finger Post Signs would be dealt with on an Agenda at a later date.

On the proposal of Deputy Connaughton, seconded by Senator McDonagh it was unanimously approved that Mr. Frank Rushe, Mountbellew, Ballinasloe replace Mrs. Mary Conway, Mountbellew on the Libraries Committee.

On the proposal of Deputy Connaughton, seconded by Senator McDonagh it was agreed that an Item be placed on the Agenda for the Monthly Meeting of the County Council with regard to the allocation of the Eight Billion Pounds Structural and Cohesion Funds.

Senator McDonagh expressed his concern with regard to the influx of New Age Travellers to the Galway area. They were creating traffic hazards in a number of locations. Their animals were a hazard to traffic and property. Fires also could be a problem. He felt that the legislation was ineffective in this area. He felt that the influx of travellers, particularly from England, was as a result of new laws being implemented in that Country to control indiscriminate parking. Senator McDonagh proposed that the Council write to the Minister for the Environment and the General Council of County Councils with regard to this problem seeking more

Councillor Gavin asked whether Galway County Council had had any imput into the provision of the Galway Sewage Treatment proposal. The Deputy Manager indicated that this was a matter for Galway Corporation.

Councillor Fahy reminded the County Engineer with regard to the requirements to have some hedge cutting carried out in South Galway.
