#### ITEM NO. 5 ON AGENDA.

#### CONNEMARA - VLAANDEREN

For a number of years there has been a linkage between Connemara and West Flanders and exchange visits have taken place including representatives of Galway County Council. A structure has been set up in Flanders to expand this relationship. Now other areas of Flanders (total population 6.5 million) have got involved and are asking that all of Flanders co-operate with a region of similar size in Western Ireland. These proposals are set out in attached memorandum dated 31 Bealtaine, 1993.

The proposal, including the setting up of a fulltime office in Galway was discussed at a Meeting in County Buildings on 11th June, 1993 by representatives of the Counties involved. While all favoured the idea, they saw great difficulty in coming up with funding to the tune of £10,000.

At this point in time, a funding commitment is required from all the local authorities involved in order that a decision can be made to go ahead with the proposal or abandon the idea. I recommend that the Council agree to a commitment of £2,500.

This letter is a brief introduction to Conamara Vlaanderen and an invitation to attend a meeting to be held at the County Buildings Galway on Friday 11 June at 11.30 a.m. at which the participation of your county in this inititive can be discussed.

Originally the idea of linkage between Western Ireland and Western Belgium was concieved by a group of graduates of the Masters in Rural Development course at University College Galway and in 1988 an organisation called Fiontar Flanders was set up to investigate the feasibility of bottom up inspired cooperation between the Gaeltacht region of Ireland and the province of "West Flanders". Though this proved to be highly successful Flemish people from other provinces who wanted to assist in the effort felt excluded and accordingly Interleuven in the province of Brabent have proposed a linkage between themselves and Galway County Council. Furthermore, the Flemish Prime Ministers Office took a strong interest in this inititive also and they intimated their preference that all of Flanders should be linked to a region of similar size in Western Ireland.

Our proposal now is that Flemish Conamara as in "Conamara Vlaanderen" should consist of the counties Galway, Mayo, Monaghan and Clare as well as all of the Gaeltacht region of Ireland and that they should twin with their Flemish counterparts as follows:-

- The Gaeltacht Region of Ireland and the Province of West Flanders.
- 2. County Clare and the Province of East Flanders
- 3. County Mayo and the Province of Limburg
- County Galway and the Province of Brabent (which includes Interleuven)
- 5. County Monaghan and the Province of Antwerpen (Monaghan has already developed close links with the town of Geel in this province due to St. Dymphna.

In the first year we propose that a representative of each of these participating regions as well as the five founding members of Fiontar Flanders should form the board of directors of Conamara Vlaanderen Teo. Our sister organisation in Flanders Conamara Vlaanderen VZW should also have a nominee on the Board.

In the future as ordinary membership is developed in each of the Counties we forsee that they should also be able to nominate the chairperson of their branch to the board.

The intensive cooperation which the Prime Minister of Flanders Mr. Luc Van de Brande speaks about in his letter of May 24 should begin on September 1st. with the opening of a fulltime office by Conamara Vlaanderen Teo. To finance this operation a minimum budget of £50,000 will have to be provided by the partners to the inititive. We are delighted that the Minister for the Arts, Culture and the Gaeltacht, Mr. Michael D. Higgins has decided to give the lead in this regard by already sanctioning a grant of £10,000 in respect of the Gaeltacht region. We hope that your council will see fit to do likewise as we are convinced that this investment will yield a handsome return in terms of trade, tourism, investment, jobs and cultural enrichment for your county.

We look forward to meeting you all in Galway on June the 11th.

#### PLANNING HISTORY:

There were six planning applications made to Galway County Council in relation to this site and are summarised as follows: -

Ref. No. 23683 - Application was made for outline permission for 4 No. houses by Mrs. B. Kelly on a frontage of 280' along this road. Three were granted and the fourth was refused on a site which included this present site, so that access to backlands would be preserved.

Ref. No. 34418 - Permission was granted to Mr. Gabriel Kelly for a dwellinghouse on the adjacent site north of the present site.

Ref. No. 42888 - An application for outline permission was made by Mrs. Brigid Kelly for 2 No. dwellings, one on the present site and a second on a site over 100' north of this site. One house was granted on the site to the north and the second was refused on this present site as "The proposed development would be contrary to the proper planning and development of the area as it would cut off access to the backlands of the area from the main Loughrea/Bullaun Road and would thus deny adjoining sites of the choice to develop".

Ref. No. 55504 - Application for the erection of a store and utility outhouse on lands which includes this site by Martin G. Kelly was granted by the County Council.

Ref. No. 66585 - Permission was refused by the County Council to erect a dwellinghouse on this present site on the 25th June, 1992. The applicant was Mr. Gabriel Kelly. Reasons for refusal were as follows:

- 1. The proposed development would result in an excessive density of housing development in a suburban location and would be contrary to the provisions of the Development Plan with regard to minimum site area requirements in residential areas. The proposal would be seriously injurious to the general residential amenity of the area and would be contrary to the proper planning and development of the area.
- 2. The proposed development would compromise the future development of the lands to the rear of the site for residential development as it would cut off

the only remaining access to same from public road. The proposal would therefore be contrary to the proper planning and development of the area.

#### PLANNING CONSIDERATIONS:

- (a) The proposed development is located on a site which has a road frontage of 53' but only a depth of 70' approximately. The building line along this road is 20' so that the house must be contained within the remaining 50'. The house which is L-shaped has a depth of 43' 6" on one side which only leaves 6'6" to the rear boundary wall. The Development Plan requires a rear garden space of not less than 11 metres (36' approx.).
- (b) This site forms part of a site for which permission was granted for a store so that if the existing proposal was permitted, it would cause an excessive density on this confined site.
- (c) This is now the only remaining suitable gap that would allow an access road to service approximately 10 acres of the lands to the rear which are zoned residential and adjoin drainage services along this stretch of the Loughrea/Bullaun Road. Consequently if the proposal is permitted, this land will be land locked and it would not be feasible to develop it for housing purposes without encroaching other lands which are zoned agricultural in the Loughrea Town Plan and would be contrary to the proper planning and development of the area.

#### RECOMMENDATION:

- 1. The proposed development would result in an excessive density of housing development in a suburban location and would be contrary to the provisions of the Loughrea Plan with regard to minimum site area requirements in residential areas. The proposal would be seriously injurious to the general residential amenity of the area and would be contrary to the proper planning and development of the area.
- 2. The proposed development would compromise the future development of the lands to the rear of the site for residential development as it would cut off the only remaining access to same from the public road. The proposal would therefore be contrary to the proper planning and development of the area.

Councillor Regan stated that he could not understand

why this application was being refused as the person

who owns the site also owns the derelict site which is adjacent. In reply to Deputy McCormack, Mr. Kavanagh informed the meeting that the site is served by the public sewerage scheme. Councillor McClearn stated that the site is within the environs of town and that development should be allowed on the outskirts of towns. He also stated that, if a person owns backlands which are used and zoned for agricultural use, it should be a matter for the land owner to arrange access to the backlands to facilitate future development. Councillor McClearn also accepted that the site is restricted.

The County Manager stated that there are two major planning issues to be considered - that there are 10 acres in the backlands for which there will be no access unless an access is now provided, and that the planning authority must consider the overall planning of the area, that the normal requirement for a back garden is 36' whereas this application allows for a back garden of 6' which would be totally inconsistent with proper planning and development.

Councillor Regan pointed out that he was aware of a development in Loughrea where planning permission had been granted for a housing development with a provision of 8' at the rear. Mr. Kavanagh stated that the Kelly Family were previously granted permissions in this area, and that the Council was acting reasonably by granting such permissions. There are a number of owners of the backlands, and as the area is zoned residential, the development of these lands must be provided for. Mr. Kavanagh also stated that, where there was a pattern of long gardens in suburbs, this pattern should be maintained. In reply to Councillor Loughnane, Mr. Kavanagh confirmed that all the allotments in the area have been zoned for housing, and an area of 3.428 acres has been zoned agricultural.
