

# **REVIEW OF COUNTY DEVELOPMENT PLAN**

Chapter 7 which deals with Rural Areas had been circulated to the members and Mr. Brian Callagy proceeded to read through the chapter and highlighted the changes which had been made to this revised edition. He stated that the development control area around Galway City had been reduced in size and was now in line with the Councillors requests. He also referred to the definition of essential housing need which had been amended. He then dealt with the new concept of clustered development which was part of this revised draft. Councillor Gavin requested to know how would enurement clauses apply to people who claimed an essential housing need. Mr. Callagy informed the Councillor that each application would be dealt with on its merits and would depend on seriousness of the situation. The Councillor stated that the implementation of enurement clauses was not being imposed uniformly and referred to a particular case where this occurred. Cllr. O'Neachtain stated that in relation to the area of special development. control, he requested an indication as to what changes had been made. He added that he wished to look at the definition of essential housing need and pointed to the terminology of a farm-holder. He stated that he wanted a native of an area to be allowed build in his own locality. He believes that the term farm-holder is not a correct title. Referring to Connemara in particular, he added that a farm-holder is not a technical word that conveys the needs of the areas and he would like to see this definition looked at.

Mr. Callagy informed the meeting that this chapter dealt only with the Environs of Galway City and did not cover the amenity areas. Cllr. Fahy requested to know if this chapter dealt with Clarinbridge and Moyveela where there had recently been a number of section 4 motions. He was informed that the Environs of Galway City did not go out as far as these townlands.

Mr. Callagy then spoke on the definition of ribbon development. He stated that the Planning Authority would deal with ribbon development by considering grants of permission solely for the development of single sites so that each application can be considered on its merits. He added that if the definition was removed altogether, then this would lead to planning applications being lodged for 6 or 7 houses in a row and added that it would be better to take each application singly and on its merits. Cllr. Callanan requested to know how this procedure would work and requested to know if an owner of land sold three sites to three different people, would permission be forthcoming. He added that it was not clear in the chapter. Mr. Callagy stated that the Council were trying to prevent housing estate type

development on a country road which in turn would lead to traffic and septic tank problems. Cllr. O'Neachtain stated that ribbon development had its faults but was there because people had to build on side roads and requested to know if there was an alternative to this type of development. He stated that he found it difficult to understand the alternative offered and he would like this topic to be discussed.

Cllr. Gavin stated that the Council members were looking at the present situation in a different perspective than the planners. They were looking at it from a representation point of view. He added that people were not in a position to pay £25,000 for a serviced site and as a result they want to build on County Roads. He requested to know how ribbon development policy can be explained to the ordinary person in such cases and added that it is money that matters to people and not planning. He stated he was trying to point out the problems in planning and referred to page 29 on the research document. He was only trying to change the plan because the feeling was that the last plan did not work.

Mr. Callagy stated that the majority of rural housing is second family dwellings and that each case is considered on its merits. Cllr. Gavin stated that he was just pointing out the problems that they had encountered. He stated that people liked living in the countryside and having the benefit of the City.

Cllr. O'Neachtain stated that he agreed that the County Development Plan cannot be an ideal plan. He added that the basic problem was that nothing had changed since 1963. He requested to know what was the interest of the common good as quoted in this particular legislation. He added that this Act is outdated and does not in fact consider the common interest. He does not agree that the national policy should come before local policy. He added that he could not see any solution to the problem of ribbon development other than creating a village format in a number of places. He stated that people want to live on their own holding.

Mr. Callagy then went through objective 3 which deals with backlands development. He stated that this type of development is undesirable and applies in the rural environs of Galway City. He added that it would depreciate the value of property. He then spoke on objective number 4 which deals with the capacity of the road system. He stated that most roads around Galway City are at capacity and if the level of development is allowed to continue, then there will be complaints as regards the capability of the road taking this extra burden.

Cllr. O'Neachtain referred to the damage which had occurred to roads. He stated the provision in this

chapter was a very positive one. He knows of roads which had been damaged by overweight trucks going and coming from building sites and added that the road in certain cases may be completely destroyed. He agrees with the proposal in the chapter to levy people responsible for damaging such roads.

The Chairman stated that in areas of high scenic amenity, the Council should try to identify areas which have been overdeveloped and release them to further development for instance allowing backlands development in such cases. In this way, this will take the pressure of other areas.

Cllr. Quinn required clarification on areas which are outside the development control area. The Councillor then stated that trees should be planted to improve the environment and that the construction of houses in a line should be discouraged. She stated that people cannot be taken out of rural areas and that it was important that houses were allowed in such areas. She stated that if young people were taken out of the country areas, this would lead to desolation of parts of the County.

She continued stating that people should be allowed build in rural areas and in this way to keep local facilities in place. -

Mr. Callagy informed the members that the only real restrictions on ribbon development are in the Environs of Galway City and stated that the problem is only around urban areas particularly the city of Galway. He added that ribbon development was not a problem in rural areas and generally did not arise.

Mr. Callagy then spoke on objective number 5 which deals with traffic hazard. Deputy Connaughton stated that the Council had no problem on density of houses on a County road but access onto the main road from a County road was a problem. The Deputy then referred to a particular case where the Council would grant planning permission provided the access was improved. Such improvements would cost thousands of pounds.

Mr. L. Kavanagh, S.E.E. was aware of this particular case and replied to the Deputy. He stated that the proposed house was fronting onto a non public road where three houses had already been permitted. The Council was aware that the junction was substandard at the initial granting of the first planning permission and were aware that further houses would make this situation worse. He added that in retrospect, permission should not have been granted for any house on this road. Deputy Connaughton stated that it was hard to argue with this statement but added that the cost of improving the junction was enormous to which Mr. Kavanagh stated there were standards set down for carrying out such improvement and minimum requirements required.

Deputy Connaughton stated that you would have to travel for miles to meet with these requirements. The Deputy added that using the criteria in this chapter one would hardly get a by-road up to the standard in the County. This criteria will apply to by-roads and will restrict development. He requested to know would there be a requirement for capital contribution to improve such junctions. Mr. Callagy stated that the Council must look at the public interest and not at the interest of one person. When dealing with a planning application, a planner must look at the public safety aspect when there is a problem with the junction. He added that the number of planning applications refused on traffic hazard reasons was quite small.

Deputy Connaughton stated that if access has to be brought up to such a standard, it will be too costly and will limit people building in certain areas. Mr. Callagy stated that you could not allow a bad situation to get worse and that each application will be looked at on their merits.

He then proceeded to go through objective 6 which deals with the assimilation of development. He stated that there was huge proliferation of badly designed development both domestic and commercial. The basic plan is that the houses should blend into the landscape and not the opposite. The design of buildings should reflect the character of the countryside it is situated in. Deputy Connaughton stated that people cannot understand why the use of red brick in building their houses and gable fronted houses are restricted.

Cllr. O'Neachtain then stated that an applicant had recently been refused planning permission for a thatched house to which the Chairman stated that there were other reasons for this particular refusal. One of the reasons relates to the location of the house adjacent to a lake. Mr. Callagy stated that there are principles set down on how buildings should blend into the landscape. There are provisions in the plan relating to the siting of houses and also the design guide-lines which are all available to the public.

Deputy Connaughton stated that he had no problem with landscaping but with this being a condition it is expensive and enquired if this condition could be complied with over a number of years. The applicants will comply with the condition but due to financial situations it would take a number of years. Mr. Callagy stated that the Council do not require it to be done immediately but a time scale should be set down in agreement with the Planning Authority.

Mr. Callagy then proceeded to go through objective number 7 which deals with signage. Senator McDonagh

referred to the present signage system and stated that where signs are needed for community projects, he proposed that such signs be allowed on National Routes particularly where such projects create employment. He then outlined a particular case relating to Lackagh Museum which had been refused permission for a sign. He proposed that the plan be changed for the operation of fingerpost signs to allow signage on National Routes which indicate community based projects and particularly where employment is created. This proposal was seconded by Cllr. Ryan. The Secretary stated that the Council cannot allow community projects favouritism. Senator McDonagh stated that the scheme should cater for this. Deputy Connaughton enquired if this objective related to layby advertising on the approach to towns. He added that people who invest heavily in businesses should be allowed one large sign on the road. Mr. Callagy stated that when talking about National Primary Routes, the traffic hazard element has to come into play. Deputy Connaughton stated that it was hard to look out for a fingerpost sign and that it was easier to see a large hoarding. Cllr. Regan enquired was it more dangerous to have a small sign rather than a large sign. Mr. Callagy stated that where one person was allowed a sign then everyone else would also require such a sign. Cllr. O'Neachtain stated that he took the opposite view and stated that the trail of advertising signs along our road network was visually obtrusive. He stated that international roadsigns were acceptable but you could not have signs for every village facility. The then referred to the language aspect in the signage and that the Gaeltacht areas should have signage in Irish. This provision should be incorporated into the plan. Cllr. Mullins stated that there were a lot of small businesses trying to eke out a living. He accepts that there are horrendous signs throughout the County both on buildings and shops. He felt that this was more important than road signs.

Cllr. Ni Fhatharta stated that there are no signs indicating that you are entering the largest Gaeltacht area in the Country. She stated that there are too many unauthorised signs and in this area certain guidelines need to be set down. All unauthorised signs should be removed. She welcomed the townland signage.

Clir. O'Neill stated that where a whole number of signs are put up, it becomes counter productive and leads to confusion. He also stated that it becomes very dangerous for someone trying to read those signs. He added that if proper directional signs. were put in place, then unauthorised signs, would be removed. Signs with international symbols would be of benefit. He added that when one gets to a village there should be directional signs in the village.

Cllr. Callanan stated that he supported Deputy

Connaughton on the provision of a communal sign hoarding adjacent to a town. He then added that he strongly objects to lights outside of houses and finds them a more serious hazard than signage.

Deputy Connaughton stated that he agrees that gaudy signs should be removed but if a premises is situated off the major route, they should be allowed a sign. He requested to know if communal notice boards could be incorporated into this chapter. Mr. Callagy stated that it could be put in as an objective but funds would have to be made available to erect such structures.

Mr. L. Kavanagh stated that there are guidelines for the erection of fingerpost signs for B & B's. These guidelines were brought in in 1985 under the previous plan. Prior to their implementation the Council had received complaints about the proliferation of signs. He stated that the Council had taken no action on the laybys which is an objective in the 1990 plan. He stated that instead of opening laybys, the Council were closing them down and that an alternative must be looked at. He added that there must be a fair and consistent policy in place to operate fingerpost signs. Where unauthorised signs have been erected the Council has taken legal proceedings and obtained prosecutions in certain cases. The fingerpost sign policy is in place to facilitate premises which are located off the major routes. He stated that now other projects were looking for exception on the major routes. He would be in agreement with towns and villages having an agreed signage system. With respect to Gaeltacht areas, the Council has specified that signs must be in Irish. Deputy Connaughton proposed that this section take note of communal notice boards. Senator McDonagh referring to page 12 of the document to which he wished to insert the following under paragraph 2 from top "at junction of National Roads". Cllr. Ryan seconded this proposal. Mr. Callagy stated that communal signboards would be included as an objective in Section 1 of the Plan. Cllr. O'Neachtain stated that advertising in the Gaeltacht areas should be in Irish with English subtitles and referred to the example of Wales in this case.

Mr. Callagy then went though objective number 8 which deals with environmental protection and objective number 9 on site requirements.

Cllr O'Neacthain spoke on the requirement of 100 ft. road frontage for development sites. He stated that there must be some flexibility in this requirement. He added that the problem arises in areas where land is scattered. The requirement of this minimum road frontage he agrees with in principle but there should be an allowance for exceptional cases and he asked that this be looked at. Mr. Callagy informed the Councillor that it has to go down to individual

cases. He stated that it would be impossible to regulate if you had exceptional cases and that there must be minimum requirements. Cllr. O'Neachtain spoke on frontage onto a public road. He requested to know why must it be a public road. He stated that permission should be granted in cases where the road is not public. He then referred to screening and set back requirements.

Cllr. Loughnane spoke on the requirements of road frontage and referred to a particular case. The stated that where planning permission was granted and a housing need existed, then the applicant should be allowed to renew the planning permission on the site.

Cllr. Callanan stated that there had been a lot of applications lodged for farm buildings and he wished to know if these applications could be dealt with as fast as possible. He then spoke on water test requirements and asked if these provisions could be included as a condition in a planning permission.

In the end the Spokesperson for the group stated that they were not interested in a bye-pass unless it included roundabouts. The Secretary said that was the up-to-date position.

Opening the debate Councillor McClearn said that no other issue had been the subject of so many meetings. Everyone accepted the need for a bye-pass but the problem was the shape of it. He said that considerable progress had been made and management and the Design Team had taken on board the wishes of the Elected Members. The Plan now on display was a vast improvement on previous plans, including two grade separated junctions and three over-bridges. Unfortunately there was not agreement on it. The business people of Loughrea wanted roundabouts at each end of the bye-pass. They were vital to the well-being of the town and they were entitled to have their wishes recognised. Councillor McClearn proposed that the bye-pass plan submitted already to the N.R.A. be amended to provide for three over-bridges and two roundabouts at each end with easements into them and the deletion of the two grade separated junctions.

Councillor Regan seconded Councillor McClearn's proposal. He said that the people of Loughrea were very reasonable and they were entitled to get the bye-pass they wanted. This proposal would cost less and he asked all the Councillors to accept it.

Councillor Loughnane supported the previous speakers and acknowledged that a lot of progress had been made since last December. He said there would have to be further changes with further discussion and local input. If there was disagreement at this stage there could be objections down the road.

Deputy Connaughton said that he too would be supporting the Loughrea Councillors. He said the people of Loughrea believed that their interests would be best served with 2 roundabouts. He said that he could not understand why the N.R.A. would not allow roundabouts in Loughrea when they work elsewhere.

Councillor Fahy agreed with the previous speakers. He said that the people of Loughrea were entitled to roundabouts and there would be no compromise on it. If necessary the Loughrea Councillors should meet with the N.R.A.

Deputy McCormack asked how the costs of the bye-pass compared when the roundabouts are included. He said a lot of people would welcome a proper bye-pass for Loughrea. He was not confident that a plan including roundabouts would be approved by the N.R.A. and he was fearful that the funding could be lost.

Councillor W. Burke agreed with the previous

speakers. He said the absence of roundabouts was the main problem and Members were not given statistics of the dangers of roundabouts. He said that the interests of local people would have to be considered and he asked that roundabouts be included.

Senator McDonagh said he understood the fears of the local people and it was regrettable that the project was so protracted. He had seen roundabouts in many other towns. Councillor Byrne said he was supporting the proposal to provide two roundabouts. He didn't understand why vehicles had to travel at record speeds and roundabouts would help to control speed. Councillor Brennan asked that the design features at both ends of the bye-pass be explained.

The County Manager said that the need for a bye-pass has been identified for a long number of years. Provision is made for it in the current Operational Programme for Transport and it is very high in the priority of the N.R.A. He said it was a very important project for the future development of the county, being on the N6 national route between Galway and Dublin. Loughrea was known to be a bad bottle-neck and most people experienced long delays there, and this had an obvious impact on the industrial sector. If the bye-pass had been provided years ago we would now have another project on stream and the delay was effecting the future investment in the infrastructure of the county. Most of the improvements and amendments proposed by the Councillors had been taken on board.

The County Manager said that the decision to be made at today's meeting was a very important one. He said that roundabouts would not be recommended by the Council's Technical Staff and would not have their support. Roundabouts were not the safest option on high speed roads and constituted an obstruction to traffic. Previous reports indicated why the proposed grade separated junctions were much safer. As County Manager he regarded safety as a top priority and he could not recommend roundabouts. He appealed to the Members to give the matter careful consideration. He said that whatever resolution was passed would be forwarded to the N.R.A. but he was fearful that the inclusion of roundabouts could result in the loss of the project.

Mr. Eising then gave details of the up-to-date plan as displayed. He explained that the two roundabouts at the western end had been replaced by one roundabout and the slip-road to Galway was along the existing N6. At the eastern end the slip-road from Ballinasloe was also along the N6. Over-bridges were also included along the Raruddy Road and Caheronaun Road. He said that the inclusion of roundabouts at each end of the bye-pass would mean that local traffic would have to mix with through traffic. The provision of grade separated junctions meant that

local traffic would be separated from through traffic travelling at high speeds. The safety of all road users whether pedestrians, cyclists or vehicular traffic was the Council's main concern.

Councillor Mannion proposed that the meeting adjourn for a short time. Councillor Hussey said that he was concerned about the Manager's statement in relation to the possible loss of the project. He suggested that no decision be taken pending consultation with the N.R.A. Councillor Walsh seconded Councillor Mannion's proposal to adjourn for a short period. The Chairman then declared the meeting adjourned until 4.45 p.m.

When the meeting resumed Councillor J. Burke said that he had to have regard to the Manager's statement and the safety aspect. He was concerned that if roundabouts were included, funding for the project could be lost and this would be a disaster for the whole county. He proposed the following amendment to Councillor McClearn's motion "that the bye-pass plan submitted by the Council to the N.R.A. following the Council Meeting on 19th December, 1994 be amended as follows: -

- that the grade separated junction at the 1. west of Loughrea be relocated to the western extremity of the bye-pass.
- That the grade separated junction at the 2. east of Loughrea be relocated from the Danesfort/Caheronaun Road to the vicinity of the Greeneenagh Road.
- The full access to and from Loughrea town be 3. provided at both grade separated junctions.
- That an over-bridge be provided for the 4. Caheronaun/Danesfort Road.
- That an over-bridge be provided for the 5. Raruddy Road.

Councillor Loughnane said that the Council had only received funds sufficient to allow a 55% of year 1 of the Five Year Roads Plan to be implemented. This was totally inadequate. Councillor Finnegan said that the Council couldn't accept the grants offered and he would have no hesitation in rejecting the scheme. Councillor Mannion asked the County Manager to comment on the situation.

The County Manager said that the preparatory work for the Roads Programme commences at Estimates time. The next stage is the notification of the Road Grants which were notified over a month ago. In order to avail of the good weather and get value for money it was necessary to start work immediately. He said that he wanted to start works earlier in the year than heretofore. This would allow road grants to be claimed which would help the cash-flow and would avoid doing such works during the winter period. He said that the Department was carrying out a study on non-national roads and to his knowledge no extra funding was available at present. He strongly recommended the adoption of the Road Works Scheme.

Councillor Ryan said that many meetings had been held to discuss the scheme. He proposed an amendment that the scheme be adopted subject to the transfer of the £30,000 Supplementary Grant to the Tuam Inner Relief Road and subject to the amendments circulated. relation to Speed Limit Revisions on national roads was submitted. Attached to the report was a schedule showing the Council's proposed speed limit revisions on national roads and the response of the N.R.A. thereto. The Secretary stated that the N.R.A. had only approved extending the 30 mile limit in a small number of cases. Instead it recommended a 40 mile per hour limit in many cases and most of the Council's recommendations for 40 miles per hour speed limits were approved for shorter distances. The Secretary also read letter dated 4th April, 1995 from and the N.R.A. in relation to the speed limits.

During the debate which followed Members were very critical of the N.R.A.'s response... Members unanimously proposed that the recommendations of the N.R.A. be rejected. They said that the revisions proposed by the Council were expertly drawn up. They had been drawn up in consultation with the Gardai, Council Engineers and Councillors using proper criteria. Several accidents had occurred at locations proposed for revision and the N.R.A.'s recommendations did not make sense. It was finally agreed that an official from the N.R.A. be asked to address a Council Meeting to explain why the Council's proposals were not approved.

#### URBAN AND VILLAGE RENEWAL GRANTS SCHEME

Report of County Secretary dated 20th April, 1995 on the Urban and Village Renewal Scheme was submitted. The County Manager said that the proposed scheme would give the Council an opportunity over the next five years to improve the physical appearance of towns and villages. The programme provides for a scheme of grants through the Department of the Environment to assist with environmental improvement measures and will operate mainly through the local authorities. There must be an economic focus to help the local economy. The grants would be subject to local funding being provided. The Council would have to prepare an action plan for the whole county and Ms. Mary Flynn, Executive Planner had been assigned full-time to the job. Details of the scheme would be given at the forthcoming Community Seminar in Loughrea on 27th April and at a seminar to be arranged at Maam Cross. He said that the action plan had to be prepared urgently and hopefully it would be ready for the May Meeting. ## **ROAD WORKS SCHEME FOR 1995**

The debate which had taken place at the meeting in-committee continued. Mr. Killeen explained the origin of the Supplementary Improvement Grant. He said that it came out of a special fund of £5m which was divided between approximately 16 counties with bad roads. He said that the Connemara roads were a major factor in helping Galway receive a portion of the grant and it was expected by the Department of the Environment that the grant would be spent on reasonably large projects. This was the first time that part of the grant was taken for spending elsewhere and if any more was taken the Clifden, Oughterard and Costelloe areas would suffer.

Councillor Joe Brennan said that all areas had suffered from the bad weather and the Supplementary Grant should be allocated to all areas. He said the roads in the Caltra area were extremely bad. Councillor Finnegan said that a further £50,000.00 should be found for the Tuam Inner Relief Road in

order that it could be opened for traffic. He said that roads in the Gurteen area and Dunmore were very bad. Councillor Gavin said that the Council was being left seriously short of funding and a case would have to be made for additional monies. He said that the Council had only 26% of the funds required. Councillor McHugh said that he supported the proposal to transfer £75,000.00 from the Supplementary Grant for the Tuam Inner Relief Road. He said that the Council grants were down f1.2m on last year and he supported the idea of a deputation to the Minister. He said that the cycle of surface dressing and strengthening were getting seriously out of line and would have huge implications in the years ahead. He said that no funds had been made available for the Galway/Headford road or the road at Lydican.

Deputy Connaughton said that the Council had never received adequate funds for roads. He said that last year a sum of £10m from the Tax Amnesty was available for distribution but no such sum was available this year. He said that a major job needed to be done on the roads in the county and he suggested that a surcharge on petrol be considered specifically for county roads. Councillor Ni Fhatharta said that the storms and flooding had caused serious road damage in Connemara. She said that the county roads were very important in Connemara but these had been allowed to deteriorate over the years. It was because of the bad roads in Connemara that the Council received the Supplementary Grant and she objected to using it elsewhere.

Councillor O'Sullivan proposed that the Supplementary Grant be divided equally between the 11 engineering areas. This was seconded by Councillor Callanan. Deputy McCormack questioned whether the Council was getting good value for money through direct labour works and said the public tender method would have to be seriously considered. Councillor Fahy said that he was very unhappy with the grant allocations. The people in South Galway had suffered great hardship because of the flooding and now the roads were in a deplorable state. He said that there should be a special allocation for South Galway.

Councillor Hussey said that the reduced road grant was the cause of the problem. He then proposed the notice on the agenda that the Minister for the Environment be asked to approve the borrowing of additional money to enable the Council to carry out the complete 1995 Programme of Works as outlined in the Council's Road Development Plan 1995 - 1999. This was seconded by Councillor Finnegan. Senator McDonagh said that the General Council of County Councils had looked for extra money for county roads. He proposed an amendment to Council Hussey's motion that the Council seek an urgent meeting with the Minister for the Environment with a view to sourcing funds to allow the Council proceed with its Five Year

Roads Plan. This was seconded by Councillor Varley who outlined the urgency of carrying out improvements to the Curraghline Road and the need to maintain an adequate work-force in all the areas.

Councillor Joe Burke said that he would not support Councillor Hussey's borrowing motion. He said there was subsidence at the road at Kilclooney Burial Ground and it needed to be looked at urgently. He said the Councillors agreed last year that Tuam would get a fair allocation but there would not be enough money to purchase materials based on the scheme as proposed. He said that Deputy Connaughton's proposal regarding a petrol tax was worth considering and seconded the motion. Deputy O'Cuiv said that the N.R.A. had forgotten their responsibility for national secondary roads as the Curraghline Road was a disgrace. He said that the N.R.A. would have to be asked to produce a roads plan with a reasonable allocation for national secondary roads. He also mentioned the Clifden to Westport Road. He supported Councillors Hussey's motion saying that the Five Year Roads Plan was minimal. He said that the Minister should be asked to allow the Council proceed with the Five Year Plan and reimburse the Council in 1996. He said that he would oppose any proposal for a tax on petrol. Councillor O'Neachtain said that the basic problem was under-funding for roads. He said that too much money was going to the Dublin area which strictly was not an objective one area. Councillor O'Neill said that prior to 1993 the road funds were allocated having regard to the number of employees and this had always left a short-fall in the Connemara area. He said that Councillor O'Sullivan's proposal would have serious implications for the Connemara area and he proposed that the Supplementary Grant be adopted as circulated in the Road Works Scheme. Councillor Byrne said that he would not agree with Councillor Hussey's motion as any money borrowed would have to be repaid with interest and he said that it was reasonable to ask the Minister for extra funding.

Councillor Mullins said that he was against borrowing money for roads but would support the sending of a deputation to the Minister requesting funds to allow the Council proceed with its Five Year Roads Plan. Councillor Walsh said that he was not satisfied that the Tuam area was getting a fair allocation or if the Supplementary Grant was being distributed according to the greatest need. He said that the proposal for petrol tax would need greater study. Councillor McClearn said that the Members should be aware of the consequences of borrowing money. He said that he was not happy with the way the Supplementary Grant was being distributed and said that the problem on national secondary roads would have to be seriously addressed and gave Hearnsbrook as an example.

Councillor Mannion said that the east of the county

was getting two thirds of the E.U. Grants for non national roads and one third of the Supplementary Grant. He said that the poor condition of the roads in Connemara was responsible for the Council getting the Supplementary Grant. He proposed that a decision be deferred for two weeks to the Monthly Meeting, the meeting to commence at 3.00 p.m.

The County Manager said that there were 6,500 km of road in the county and it was important that they be properly maintained. He read an extract from the Dail Debates of the 9th March, 1995 which stated that the Government was undertaking a comprehensive review of non-national roads. Referring to the Council's Five Year Roads Plan, he said that the Council was well armed to go on a deputation to the Minister and the N.R.A. He said he would not recommend borrowing for road works.

Councillor Hussey seconded Councillor Mannion's proposal and the meeting then ended.
