Mr. Killeen also explained that a problem had arisen with Flannery Bridge on the way to Carna and that it probably would have to be replaced. A temporary bridge would have to be constructed for which funds would be required immediately. Accordingly the Bridge Works Programme shown at appendix F would have to be revised and works on some other bridges would have to be deferred.

Councillor Brennan said that the Ballinasloe Area Committee had proposed that £82,000.00 be taken from the Supplementary Improvement Grant as follows: -

£50,000.00 for the flooding in the Gort area where expenditure in excess of £90,000.00 had been incurred.

Councillor O'Neachtain said that he was totally dissatisfied about the response in relation to storm damage and that an approach should be made to the Department. Much repair work needed to be carried out in the Spiddal area. He said that he was disappointed about the way he received the information in relation to Flannery Bridge. Deputy O'Cuiv said that the Connemara Area Committee would have to approve the final proposals for that area. Councillor Walsh said that other areas in the county were flooded apart from South Galway such as Williamstown and Kilbeg where roads needed to be raised. Councillor Hussey supported. Councillor Joe Burke said that the Tuam area was badly treated last year and the same was happening in 1995. The said that £50,000.00 was allocated for the Tuam Inner Relief Road, but a further £75,000.00 was required in order to open the road. He wanted to know how the Tuam Road Staff would be affected.

Mr. Killeen said that he now had the Labour Analysis for all the areas, although two roads had yet to be decided by the National Roads Authority. He said that the labour element was getting very high and was reaching a stage where it would be unacceptable. He said that employment in all areas would be difficult but particularly so in Tuam and Ballinasloe. He said that the overall problem was the lack of sufficient funding but the schemes put forward made the best use of available resources.

Councillor O'Neill said that many roads in Connemara were impassable and he objected to diverting the Supplementary Grant from West Galway, The Chairman pointed out that a lot of storm damage had been caused in Connemara and no grant was forthcoming yet. Councillor O'Sullivan said that the Supplementary Grant should be divided between the eleven engineering areas.

At this point Deputy McCormack proposed that the meeting in-committee end. This was seconded by Councillor O'Sullivan and agreed.

The Meeting in-committee then ended.

PLAN RELATING TO APPLICATION FOR PERMISSION TO

CONSTRUCT 20 HOUSES IN THE TOWNLAND OF HEADFORD

APPLICANT - MR. P. JOYCE - PLANNING REF. NO. 71365

Mr. Liam Kavanagh, Senior Executive Engineer went through the following report which had been circulated to the members:

"DESCRIPTION: The proposal is for the construction of twenty houses with services and an advertisement hoarding.

LOCATION: The site is located on the N.84 Galway/Headford road at the Southern edge of Headford

Town

PLANNING HISTORY: There have been no previous planning applications on this site.

ASSESSMENT: The proposal relates to the construction of 20 houses and an advertisement hoarding on a site which has an area of 2.59 hectares. The house types are hip-roofed dormer bungalows with some single storey variations of same.

Effluent from the development will be piped to the Headford Town sewage treatment plant, and the necessary wayleaves have been obtained from the owners of intervening properties. Surface water disposal is to a drain adjoining the mart. The Sanitary Services Department of the County Council have no objections to the proposal subject to the imposition of a charge to meet the cost of carrying out improvement works to the treatment plant to cater for the extra loading.

The estate road proposes to join the National Secondary Road 50 metres approximately outside the existing 30 m.p.h. speed limit. The granting of such a permission contravenes materially the County Development Plan and the County Council must comply with the procedure set down in the Local Government (Planning & Development) Act 1963, as amended, whereby public notice is given of the Council's intention and a formal resolution must be passed by the elected members in favour of the proposal if permission is to be given.

There is one objector to the proposal who claims that his right of way to the "main road" will be removed. This is regarded as a legal matter between the parties involved. It is not clear to the Planning Authority that there is a specific right-of-way over the site to the "main road" as there is no gate entrance along the "main road" frontage of this site. Even if there is a legal right of way as stated, it may be possible to continue across through the site via the estate road as proposed.

The merits of the development lie with the County Council's policy of encouraging private housing development in towns and villages. This is set out in 2.1.1. and 5.1.3 of the County Development Plan. The site is an attractive one on the outskirts of the town and has good scenic views Southwards over rolling farmland which constitutes the eastern hinterland of Lough Corrib. There has been very little growth in housing development in Headford Town in recent years and it is considered that the proposal will help to optimise existing community facilities and add to the housing stock in the Town.

It would not be advisable to permit the required advertising hoarding other than for a limited period

STATUTORY CONSIDERATION: A decision to grant permission cannot be made unless a resolution is passed by the members, requiring that such a decision be made in accordance with Section 26(3) of the 1963 Planning Act as substituted by Section 39(d) of the 1976 Planning Act, as amended by Section 45 of the Local Government Act 1991.

Public notice of the Council's intention to consider deciding to grant this permission was given on 24th February, 1995 and the notice invited members of the public to submit representations or objections if they so wished. The one objection lodged has been dealt with above.

If a resolution is passed requiring that a decision to grant permission be made, such a decision will issue, otherwise a decision to refuse permission must issue.

The latest date for a decision on this application is the 19th April, 1995.

Deputy McCormack proposed "that having considered the Planning Application made by Mr. P. Joyce for permission for erection of 20 no. houses with services and an advertisement hoarding in the townland of Headford, Planning Reference No. 71365, and having considered the report by the County Engineer on the matter, Galway County Council in accordance with the provisions of Section 26(3) of the Local Government (Planning and Development) Act, 1963, ⁶ as amended by Section 39.(d) of the Local Government (Planning and Development) Act, 1976, as amended by Section 45 of the Local Government Act, 1991, hereby require that a decision to grant permission be made in the case of this application." He stated that he was delighted to see the positive attitude of the Planning Department towards this development. However, he wished to highlight the delay which had occurred as a result of the National Roads Authority. This body affects the County Council and is taking the power away from the Local Authority. He stated that he would like the National Roads Authority to respond more quickly to the council's request to extend speed limits and stated that this body is holding up this county and other counties in the country.

Cllr. Varley seconded the proposal. She stated that Headford had been in decline and that the proposed development would create employment in the area. She added that she agreed with Deputy McCormack on the speed limits dilemma. She again reiterated that the proposed material contravention was a good development.

Deputy Connaughton stated that he would like to see

this type of development in every town and village in the County and supports this proposal. Referring to the speed limits issue, he stated that he was tired of the National Roads Authority. He had been told on several occasions that decisions would issue on the speed limits but nothing had happened. He stated that alot of work had gone into the speed limit plan and if the extension of speed limits is curtailed, then this in turn will limit planning permissions.

The County Secretary then informed the meeting that correspondence had been received from the National Roads Authority and it was currently been assessed.

Senator McDonagh welcomed the material contravention for the proposed development in Headford. He stated that this would add to the future development of Galway rural towns. He was glad to hear that the National Roads Authority had replied to the Council and added that he would like to see members of this body address the Council.

Cllr. O'Neachtain welcomed this development and feels that the material contravention system should be used more often. This would then alleviate problems which arise in the County Development Plan. He stated that he concurs with what was being said about the National Roads Authority. The role of the local authorities is continually being eroded, he added. He stated that the functions of local authorities are few when compared with similar bodies in Europe. The Council would end up being a pure meeting place for opinions and nothing else.

Cllr. Cunningham welcomed this type of development and stated that he would support the motion. He would like to see similar development in other towns and villages.

Cllr. McHugh stated that he wished to compliment the planners on their attitude towards this development. He added that towns like Headford need this type of development. He then requested the Secretary to state what was in the letter which was received from the National Roads Authority. He proposed that the 30. mile speed limit be extended beyond Joyce's Supermarket in Headford.

Cllr. Gavin welcomed this application which he stated goes along with the discussions which are currently being held on the review of the County Development Plan.

Cllr. Regan welcomed the development in Headford but expressed his concern at the delay which had occurred in dealing with this application and hoped that in future this would not arise in similar cases.

Cllr. Fahy welcomed the development for Headford and stated that this was a great encouragement to the

The Asst. County Manager gave a breakdown as follows of the 1995 Housing Capital Allocation. The allocation comprises;

£2,460,000 Local Authority Housing. 1.

£50,000 Remedial Works to existing Local 2. Authority dwellings.

- £50,000 for Residential caravan parks and new 3. Group Housing Scheme for Travellers.
- £140,000 Improvement works in lieu of Local 4. Authority Housing.

The Asst. County Manager indicated that the funding for the Local Authority Housing Programme was sufficient to allow the Council complete their 1994 Programme and to commence their 1995 Programme. £50,000 has been provided to allow the Council complete Phase 1 of the Gilmartin Road Refurbishment Scheme and, also, allows for the commencement of Phase 2; the £50,000 for Traveller accommodation was for two new houses at Clonlyon, Ballygar. The sum of £140,000 for improvement works in lieu of Local Authority Housing would allow the Council complete 14 such applications during 1995. The Council also received permission to bring forward from the 1994 allocation, schemes proposed for Carna and Rosmuc.

Plan for Social Housing

The Asst. County Manager indicated that it was anticipated that the Plan for Social Housing would be updated within the next month. The Council had approximately 455 housing applicants approved and to meet this housing need the Council would encourage increased activity using the various options under the Plan for Social Housing to complement the Council building programme.

Improvement works in lieu

The Asst. County Manager indicated that the Council had completed 24 improvement works in lieu; 18 were in progress, 11 were approved and ready to start. There were currently 58 applications on hand. The Council were successful in receiving an extra allocation in 1994 of £201,000 under this heading.

Shared Ownership

The Asst. County Manager indicated that activity under this heading had resulted in 276 applications being received, of which 87 were approved. The applications that did not proceed or were refused were mainly as a result of people's inability to pay, no available sites or unfit houses being proposed for purchase.

Disabled Persons Grants

The Asst. County Manager indicated that expenditure under this heading in 1994 amounted to £224,000. The current years estimates provision of £110,000 was insufficient to allow the Council complete the applications on hand. The Asst. County Manager pointed that there were 27 approved applications under this heading. A further 133 applications are at various stages of preparation. The number of applications would require additional funding in the sum of £572,000. This was noted by the members.

Asst. County Manager, also, indicated that he was currently seeking to streamline the Housing Maintenance Programme with a view to ensuring that the Council achieve full value for money for the £400,000 provided in the estimate of expenses for 1995.

Cllr. Michael Fahy indicated that not enough money would be made available to allow the Council provide bathroom facilities for demountable dwellings. He felt, also, that the Housing Section should deal with the Emergency Housing Fund administered by the Western Health Board. He proposed that a deputation be sent to the Minister to seek more funding for Disabled Person's Grants and, also, that the Council provide more rurals to meet the needs in this area.

Deputy Paul Connaughton welcomed the increased allocation for housing. He felt that the housing technical staff needed to be increased to allow for the findreased workload in the housing area? He indicated that the increased availability of funds for the Voluntary Sector should allow the Council to promote further schemes in this area.

Cllr. Toddy Byrne welcomed the numbers of rural houses in the 1995/96 programme. He felt that the improvements in lieu and the Shared Ownership schemes were very worthwhile. He felt there should be more money made available under the Disabled Persons Grant heading. The, also, asked that the Council urgently look at the matter of repairs and every effort be made to speed up same.

Cllr. Gavin welcomed the Housing Programmes and the initiatives being taken by the Asst. County Manager. He, also, stressed the need to speed up the response to repair request which meant an awful lot to people.

Cllr. Joe Callanan welcomed the provision of rurals which were a real help towards the stabilisation of the rural population. The new rural house design reflected well on the County Council design team. He complimented the Asst. County Manager and the Housing Staff on their approach to their work. He welcomed the approach being taken to provide subsidised sites and, also, to encourage the Shared Ownership Scheme. He earnestly felt that at least another £200,000 was needed under the Disabled Persons Grant heading.

Cllr: Pat O'Sullivan indicated that the Housing Section was the caring face of the Council. He stressed that the Council should endeavour to commence their building programme earlier in the year, and, if possible, a five year plan should be put in place. He welcomed the Manager's initiative in this area. He, also, asked that consideration be given by the Council to purchase rural houses. He, also, proposed that the Council write to the Minister for the Environment suggesting that a Housing Repair PAGE NO. 10 MINUTES OF SPECIAL MEETING HELD ON 07/04/95

Grant be introduced.

Cllr. Finnerty welcomed the comprehensive report of the Asst. County Manager. He pointed out that housing needs were changing and the Council would have to adapt its policy in line with same. He seconded the proposal by Cllr. O'Sullivan that the Minister for the Environment be asked to introduce a Housing Repair Grant.

Cllr. Cunningham welcomed the presentation and urged further action in the area of purchasing of sites in towns and villages. He, also, raised the issue of the problems caused by the flooding in South County Galway and asked that the Government would move in this area as quickly as possible.

Cllr. Finnegan expressed his regret that the Department had not allowed any provision for extensions to Council houses. He felt that further efforts would have to be made within estates to control traffic and, also, the illegal parking of caravans. He highlighted the demand that there was for housing repairs. He welcomed the ten two-bedroom houses proposed for Tuam. He indicated that the improvement in lieu scheme was not sufficiently funded.

Cllr. Michael O'Neill complimented the quality of the rural house currently being built by the Council. He questioned the matter of priority between applicants residing in mobile homes and applicants who had reasonably good accommodation available to them. He welcomed the idea of localising repair response and, also, the question of using tenants to carry out minor repairs. He supported Cllr. O'Sullivan and his request to the Minister for the Environment for the introduction of a Housing Repair Grant.

Cllr. Kathleen Quinn welcomed the number of rural houses. She felt that the improvement in lieu of Local Authority Housing Scheme needed additional funding to make it more successful. She stressed the need to introduce a Grant scheme.

Cllr. Ni Fhatharta welcomed the Programme and, in particular, she welcomed the provision of housing in Carraroe where she understood there were approximately 23 housing applicants. While she welcomed the provision of rural houses, she felt that the Council needed to achieve more in this area and extra finance should be sought from the Dept. of the Environment. She, also, supported the Improvement in Lieu Scheme and felt that more funds were needed in this area. She indicated that repairs were a problem area for tenants and welcomed the initiative that tenants would be allowed to carry out some repairs for themselves.

Cllr. O'Neachtain welcomed the Programme and the

Policy Statement. He stressed the need to house Irish speakers in Gaeltacht areas. The introduction of cluster housing will have to be dealt with sensibly. He urged that the Council make available land from their Landbank to facilitate site purchase.

Cllr. Paddy McHugh asked that the Disabled Persons Grant allocation be increased because of the number of applications on hand, and the fact that the number of people applying for such grants were among the most vulnerable in society. He suggested that the Council make an application to the Dept. the of Environment for once-off funding in this area. He supported the idea of the introduction of a Housing Repair Grant.

Cllr. Brennan felt that the Council should continue their policy of trying to get people to move from demountables to villages. The possible provision of one-bedroom houses should be considered. He suggested that the Council provide built-in wardrobes in their schemes. There was a problem regarding the length of time that single men or women had to wait on the housing list before being accommodated. With regard to the involvement of the Western Health Board, he felt that only one agency should be involved in the provision of housing. He felt that there was quite a lot of money paid on rent allowance which was unproductive and this money could be used instead to provide extra Council accommodation.

Cllr, Mullins supported the Programme and thanked the Asst. County Manager for his presentation. The Council needed more funding to help reduce the problems that were being encountered with people living in demountable dwellings. He urged the Council to purchase more houses in villages in an effort to house people in their own areas. He welcomed the low cost maintenance features that were being used in new schemes. He felt that if people maintain their own house satisfactorily, that a reduction of rent should be forthcoming. He welcomed the statistic that the Council provided accommodation for 73% of Traveller families. He highlighted the example of Craughwell Halting Site which was a credit to the County Council and its staff.

Cllr. Varley supported Cllr. O'Sullivan with regard to the introduction of Housing Repair Grant which she suggested should be means tested.

Cllr. Ryan welcomed the fact that the Housing Allocation provided for more housing starts and more funds and he proposed the adoption of same.

The Asst. County Manager, in response, indicated that all Local Authority Houses in the County had bathrooms. He pointed out that the Improvement in Lieu of Local Authority Housing Scheme was to facilitate people in need of rehousing and it was not

a substitute for a Repair Grant. He indicated that the Council would actively encourage activity under the Voluntary Housing element of the Plan for Social Housing. He stressed that it was his priority to ensure that a value for money return was achieved in the area of Housing Maintenance. He, also, highlighted the fact that it would be the intention of the Council to phase out the 270 occupied demountable dwellings as far as possible over the coming years. He indicated that he was currently looking at the overall staffing arrangements of the Engineering Housing Section. He pointed out that the Department of Environment paid 50% of the costs of the Disabled Persons Grants and this matter would be put under review. He indicated that the Council were adopting a Five Year Plan with regard to Land Acquisition in areas where the Council have no available land for building. This would coincide with the provision of subsidised sites to suitable tenants. He indicated that he was aware of the changing profile of housing needs, however, it would be better value to build two-bedroom houses. He pointed out that the Council had made an application to the Department of Environment for funding for extensions. The Council had also asked that funding be made available to allow the Council manage the Traveller population in the County, which was proving to be a very time consuming effort. He indicated with regard to priority of applicants in houses as against applicants in mobile homes, that there was no set rule and that each case was looked at on its own merits. He noted the point with regard to housing Irish speakers in Gaeltacht areas. He pointed out that the Scheme for Special Housing for the Elderly was in place and that the Western Health Board operated same, there was unlikely to be any change. With regard to rural resettlement, he indicated that the County Council had contact with the Organisation monitoring same. The Council were looking at derelict sites in villages and towns. The Council would use the Compulsory Purchase Procedures under the Derelict Sites Act to help control dereliction throughout the County and, also, to avail of these sites to provide housing for people in their own areas.

Cllr. Callanan felt that the Council must provide funds for Disabled Persons Grants, and asked that a report be available for the next meeting of the Council concerning same. The County Manager, Mr. D. O'Donoghue, indicated that finance was scarce, but he would look at the position.

Cllr. Paddy McHugh stressed that the Council should not let the Department of the Environment off the hook in this regard.

On the proposal of Cllr. Michael Ryan, seconded by Cllr. Finnegan, the 1995 Housing Programme was approved and adopted unanimously. On the proposal of

Cllr. Finnegan, seconded by Cllr. Ryan, the Policy Statement on the Management of Local Authority Housing was approved and unanimously adopted.

It was agreed that this matter would be put on the agenda for the next Council meeting.



WASTE MANAGEMENT PLAN

A copy of the Waste Management Strategy Discussion Document had been circulated for the December 1994 Meeting of the Council. The County Manager said that waste disposal was becoming an urgent matter in the county and it was time for the Council to consider a proposed strategy. He said that the total annual waste to be disposed of by Galway County Council and Corporation was 110,000 tonnes, 50,000 tonnes of which was generated in the county area. It was estimated that the total annual waste by the year 2015 would be 250,000 tonnes. The dumps still in operation in the county were Clifden, Tuam, Ballinasloe, Portumna, Inishmore and Carrowbrowne. The dumps at Clifden, Tuam and Portumna had only about one years capacity left. He said that the strategy put forward in the document involved a joint approach by Galway County Council and Galway Corporation for the development of one land-fill site to serve both areas. The dumps at Clifden, Tuam and Portumna would be replaced by Transfer Stations in combination with civic amenity sites. In accordance with E.U. policy, waste management must include waste minimisation, re-use, recycling and final disposal. The strategy aims at directing 20% of combined house-hold and commercial waste away from land-fill to recycling by 1999. The County Manager referred to the huge estimated costs as outlined in the document and the need to apply the "polluter pays" principle. He said that if the Council adopted the report in principle, it would allow further planning to proceed and the Department of the Environment to be advised of the strategy and the need for subsidy.

Councillor Byrne said that Members should be informed in advance of proposals to develop land-fill sites or transfer stations. Councillor Callanan referred to the increased dump charges and said" that it would make it difficult for the Private Operators and the consumers. Councillor Joe Burke said that he had reservations about the strategy and the closure of Tuam Dump without the provision of a transfer station would be unacceptable. Councillor O'Sullivan said that it was the most serious document to come before

the Council for some years, the costs would result in a huge imposition and it needed very serious consideration. Councillor Finnegan said that there was a strong reaction to the increased charges but the provision of a transfer station in Tuam was a good idea. Councillor McClearn said that people were dumping indiscriminately even though there was free access to dumps and he was concerned what would happen when charges are introduced.

Councillor McHugh welcomed the document. The said a start should be made with one or two transfer stations where dumps have closed recently such as Headford. Deputy O'Cuiv said he accepted the trust of the document but that people's attitude to waste disposal would have to change. He said that he would only agree to the adoption of the document in principle at this stage and that subsidy 'from the Government for recycling was required. Councillor Loughnane said that as regards dumps that are closed, the Council should consider selling the sites back to the original owners. He complained about indiscriminate dumping around the county and urged the appointment of Litter Wardens. Councillor Ryan requested that transfer stations be provided in north Galway where a number of dumps had been closed. He said that many people had no refuse service. Councillor O'Neachtain said that the document was well researched and it showed that waste disposal was one of the major tasks facing the Council in the future. He said that it was vital that there be co-operation between the city and county. Councillor Cunningham said that some rural areas had no refuse collection service and he wanted this investigated. Councillor Walsh complained about the Widespread indiscriminate dumping and said that the Council would have to take action and should seek the assistance of voluntary groups to tackle it. Councillor Fahy said that the best way to deal with indiscriminate dumping was through education. Councillor Varley also complained about the indiscriminate dumping particularly in the area of Carrowbrowne dump and asked that the Corporation be requested to have Carrowbrowne Dump adequately screened.

E.U. LIFE PROJECT: TOURISM ECO-LABELLING

A brief report on this project was circulated to each Member. Mr. Denis O'Connor, Acting Executive Engineer gave an over-view of the project using an over-head projector. It is being developed as part of the E.U. Life Programme and it is proposed to develop an Eco-labelling system which will be recognised by the E.U. and which will transfer into a marketable economic asset. The organising group of the project are Galway County Council in partnership with Udaras na Gaeltachta, U.C.G., Donegal, Mayo and Kerry County Councils and Galway Corporation. The aim of the pilot project is to define and develop an area based environmental quality mark that would give an indication that the area maintains certain standards in environmental management. The Eco-Label would be used as a marketing tool to develop tourism and would also serve as a mechanism to encourage local residents and developers to become more aware of environmental protection. The project is to be based in four areas along the west coast: Connemara and Galway City, West Donegal, West Mayo and the Brandon area of County Kerry as shown on the map circulated. The over-all cost of the project is £703,000 for which the E.U. has approved 50% aid. The balance of the cost is to be provided by way of a £50,000 contribution from each of the seven Irish partners. This contribution can be spread over the 3 year life of the project and may be provided in the

form of services rendered, staff time or cash payment.

The County Manager said that progress reports would be brought to the Council from time to time.

The meeting approved of the Council's participation in the project.

LOUGHREA BYE-PASS

Report of County Manager dated 24th March, 1995 in relation to Loughrea Bye-pass was circulated to each Member. The report described the scheme and the amendments carried out to it resulting from the discussion at the December Meeting of the Council. The County Manager gave the history of the scheme and said that it was now included in the Operational Programme for Transport 1994 - 1999 and it could be our last opportunity to press ahead with the scheme. He said that at the meeting with the N.R.A., it was made clear that time was of the essence in view of all the procedures that had to be gone through. He referred to the amendments which had been made in the plan which now allowed two access points into Loughrea from either direction. He said that safety had to be the major factor in designing the scheme and that the N.R.A. would not approve of roundabouts. He strongly recommended the adoption of the scheme as now 'amended.

During the discussion which followed all the Members of the Loughrea Electoral Area spoke together with other members. A bye-pass plan prepared on behalf of the community was handed in. The following points were made during the discussion:- 20578
