

HOUSES AT CARRARDE - LOCATION PLAN






CHAPTER 7

The meeting commenced with a discussion on Objective No. 7.2.4 which pertains to the capacity of the road system. Councillor Ni Fhatharta proposed that Deputy O'Cuiv's submission on the definition of Economic

Activity be amended to include the words "Industry and services". This proposal was agreed by the members. Objective No. 5 on traffic hazards was then discussed by the members. Councillor O'Neachtain stated that the Development Control Policy statement under this heading was not clearly defined. He referred to a recent planning application which was refused for a traffic hazard reason. Mr. Callagy stated that the Area Engineer initially comments on a proposed planning application. He cannot recommend permission where a traffic hazard exists. Councillor Neachtain stated that the interpretation of this paragraph could be very wide and would be used to restrict development along county roads. Deputy McCormack stated that he objected to this clause being included in the Plan. He added that reasonable development would be refused as a result of it and referred to a planning application lodged for a Pitch & Putt course in Roscahill. This application was refused, whereas in other neighbouring counties such applications would be granted. Councillor O'Neachtain requested that the definition of "traffic hazard" be defined. He stated that a traffic hazard on a county road cannot be of the same degree as that on a regional road. He added that it was very difficult for a person to be refused permission and then see holiday cottages being built on regional routes. Councillor Quinn stated that where a housing need exists and land is available on a county road, then permission should be granted. She requested clarification on the difference between a by-road and a county road. Mr. Callagy stated that where a traffic hazard exists, the Engineer must point it out. A traffic hazard reason is a planning consideration which must be assessed. Councillor O'Neachtain stated that the definition of a traffic hazard must be stated and it must be specific. The County Engineer replied that the Technical Guidance Document RT181 sets down the guidelines in relation to traffic. He added that 95% of all planning applications are granted on local roads. He added that if you decide to put restrictions on this statement then this will result in more planning applications being refused. The paragraph on traffic hazards 7.2.5 was then agreed. Mr. Callagy then discussed 7.2.6, Objective No. 6 on the assimilation of development. Deputy McCormack, referring to the provision in the present plan on Beneficial Tourism, stated that he could not understand how houses granted under this provision could be assimilated into the landscape and referred in particular to a development in Ballyconneely. Mr. Callagy stated that the objective was that buildings would blend into the landscape and that the design of a house would comply with the characteristic of the countryside. Councillor Brennan requested to know if there was a danger that someone would draw up an elaborate plan of a dwellinghouse and then be refused permission because it would not be assimilated into the landscape. Mr. Callagy stated that discussions should take place with the relevant planning officer prior to the application being lodged, also the application could be amended accordingly while it was being processed. Councillor Ryan stated that the Council should make it easier for people to get planning permission. He referred to Ballygar where permission was difficult to obtain. He stated that on the Roscommon side of the N63 permissions were being granted on either side of the road - this did not apply to the Galway side. He added that people were leaving rural areas. Councillor Callanan supported Councillor Ryan's statement. Councillor Quinn in supporting Councillor Ryan added that he would like to see people living in rural areas. Objective No. 7.2.6 was then agreed by the members. Objective No. 7.2.7 on signage was then discussed by the members. Councillor Ni Fhatharta stated that the Council must look at the proliferation of signage along roads. She stated that a lot more must be done in the control of the unauthorised signage and felt that the County Council were not strict enough. Councillor Loughnane stated that he agreed with the previous Councillor's statement. He added that people were experiencing difficulty in obtaining permission for signs and referred to one particular case. He stated that a distinction must be made between commercial signs and advance warning signs. Councillor Loughnane referred to Aughrim and the difficulty in obtaining permission for signage at this location - was there anything that could be done in this situation. Councillor O'Neachtain expressed his agreement with Councillor Ni Fhatharta in relation to signage. He stated that nothing was being done about signage and referred to a case in Spiddal where a sign had been tied to a pole in the village and had not been moved. He stated that the signs can be more obtrusive than a dwellinghouse and that the Council should operate a strict policy in this area. The Councillor then referred to Wales, whose signs reflect the ethos of particular areas. Councillor Byrne expressed his agreement that there was a glut of unauthorised signage in certain areas. He would like to see more control operated in the location of signs. He stated that it would be difficult for the Planning Authority to take action under the terms of 7.2.7 and added that this clause should be more specific against the hoardings which are causing the trouble. Deputy O'Cuiv stated that the biggest problem he had was with old signs which were pre-planning. Was there anything that the County Council could do about these particular signs he wished to know. Mr. Callagy stated that unauthorised signs was a matter for the development control area. A statement of policy requiring the removal of unauthorised signs can be included in this chapter. He added that signs which were in place for over 5 years cannot be removed. Councillor Hussey wished to know how the law applied in relation to unauthorised posting. He stated that the signs belonging to private individuals were on poles for months on end. The meeting then considered Objective No. 8 on Environmental Protection, the contents of which were read through by Mr. Callagy. Deputy O'Cuiv stated that the SR6 1991 document should

be available from the Planning Office and this proposal was agreed by members. Article 7.2.8 was then agreed. Objective No. 9 on site requirements was then considered by the members. Councillor Cunningham stated that he agreed with the 1/2 acre requirement, but requested that the minimum road frontage of 100 feet be reconsidered. Councillor Callanan expressed his agreement with Councillor Cunningham and added that there were sites which had planning permission with an area of less than 1/2 an acre which were now being refused for renewal of permission. 1 Councillor O'Neachtain stated that he had no difficulty with the acreage requirement, but was not in agreement with 100 foot road frontage. He stated that on non county roads a 100 foot road requirement 50 is creating ribbon development and that the 100 foot road frontage is a very severe requirement. He felt that reasonable applications would be refused because of this provision. He added that many sites do not lend to building parallel to the road. Where there is sparse population in an area the siting of a house should be to suit the site in question and not the criteria that it be parallel to the road. Senator McDonagh expressed his support for the last two speakers. He referred to an incidence where a person had 50 acres of land with only 200 feet road frontage in the entire holding. His 4 sons wished to build on the land, but under the present criteria of the County Plan, permission would only be granted for two sites. He wished to know if this particular case could be facilitated in the Development Plan. Councillor Loughnane referring to the renewal of derelict buildings stated that their restoration would have to be catered for in the County Development Plan and proposed that less restrictions apply in these instances. Mr. Callagy stated that it was impossible to allow for all exceptions. He stated that the basis for the 100 foot rule frontage requirement was of septic tank requirements. He then referred to item no. 3 under Development Control Policy which provides for exceptional cases which will be considered on the basis of their overall merits. Deputy O'Cuiv referred to his own site, stated that he has not got the required 100 foot road frontage and added his objection to this particular requirement. He stated that this requirement is causing ribbonisation. Councillor Cunningham proposed that the road frontage requirement be reduced. El Councillor Ni Fhatharta referring to the provision in the present plan which pertains to previous permissions and policy to renew these permissions requested that this be included in the draft. This proposal was seconded. Councillor Loughnane stated that there was no alternative but to delete the road frontage requirement. Councillor Joe Burke stated that where the 100 foot road frontage is not available could a larger site be required. The members then agreed to defer this section for further consideration at a later date.

Objective No. 10 on town by pass routes and major road alignment schemes was considered and agreed by the members. Deputy O'Cuiv stated that many people were unhappy about the definition of an essential housing need category and felt that it was too restrictive. Mr. Callagy stated that the Council cannot allow every county road to be built up. He referred to the change in the plan on cluster developments within a 1/2 mile of a National School. He was in favour of rural development and not urban living. He realised that this goes against professional planning. Councillor O'Neachtain stated that he could not see the reason against removing the word "farmholder" definition. A local person should not be prohibited from buying a site in his local area and suggested that farmholders be replaced with the word "land owner". This was seconded by Councillor Brennan. Mr. Callagy asked what was the definition of "land owner". Councillor Byrne then proposed that 7.2.1 on Urban sprawl be deleted from the draft plan. This proposal was seconded by Councillor Quinn. CHAPTER 8

Chapter 8 was then considered by the Council members. Mr. Callagy went through the document as circulated. Deputy O'Cuiv referring to point 8.0 on the definition stated that the speed limits should be changed to 40 m.p.h. in place of 30 m.p.h. This was agreed. 8.1 on Development Control objective was agreed. 8.2 on the Review was agreed. On 8.3, Development Control Policies, Deputy O'Cuiv proposed that people should be encouraged to build on county/local roads and encouraged off national routes for their own safety. This proposal was agreed. 8.3.3 referring to other land use types was agreed. 8.3.4 on Visual Amenity was agreed. 8.3,5(i) - Ribbon Development, Deputy O'Cuiv proposed the omission of the paragraph on top of page Councillor Callanan seconded this proposal. 8.3.5(ii), Road Alignment and (iii) Site Distances were agreed. (iv) Hazardous Junctions and National Routes -Deputy O'Cuiv stated that if putting a factory down a county road, will permission be refused for this structure as a result of the junction with the national roads. He stated that such cases should not arise. Mr. Callagy expressed his disagreement with this statement and stated that a major consideration is traffic hazard and protection of peoples lives. The County Engineer stated that the permission could be conditioned so that prior to development taking place, the junction could be improved. The following provisions were then agreed: 8.3.5(v) Off Road Parking, (vi) Surface Water Drainage, (vii) Side access road grading, (viii) Advertising signage, (ix) Minimum site requirements, and (x) Other planning requirements.

The County Manager referring to Councillor Callanan's enquiry as to the signs at Aughrim stated that this matter was being looked at in conjunction with the Interpretative Centre located at Aughrim. Councillor Callanan enquired as to the timescale in relation to the draft plan. Mr. O'Connell, Senior Staff Officer, advised the members of the procedure involved in the review of the County Development Plan and the timescale envisaged. An extension of time was granted until 31st March 1996. It was likely that a further extension of the period would be required from the Minister.

DAYS FOR NEXT MEETING FOR REVIEW OF PLAN

A general discussion took place on this matter during which it was proposed that money be provided in the Estimates specifically for hedge-cutting and that funds be set aside from the Regional and Local Roads Special Restoration Programme to fund hedge-cutting.

The Deputy County Manager in reply outlined the legal responsibilities of landowners in relation to hedge-cutting. He outlined the relevant sections of the 1993 Roads Act which places the responsibility for cutting of roadside hedges on the landowner and accordingly, the Council did not have any legal responsibilities in this regard. The County Engineer outlined the distinction between verge trimming and hedge-cutting. He indicated that the Council had a responsibility for the trimming of roadside verges. However, this responsibility did not extend to the trimming or cutting of hedges. He went on to indicate that the Council has limited resources and could not afford to undertake a hedge-cutting programme. He informed the Members that the Council would cut roadside verges where resources were sufficient to allow this. During the discussion which followed it was proposed that the Council carry out hedge-cutting. It was also pointed out that hedge-cutting was urgently required on some roads where the vegetation had grown to such an extent as to obstruct the free passage of traffic and resulted

in reduced visibility for road users. The discussion also focused on the proposal that each Engineering Area purchase hedge-cutting equipment for the 1996 season.

Consideration was also given to the involvement of the community in hedge-cutting activities. WILLIAMSTOWN SEWERAGE SCHEME

REPORT FOR COUNCIL UNDER LOCAL GOVERNMENT PLANNING AND DEVELOPMENT REGULATIONS 1994

This report on the above development covers the nature and extent of the development and the principal features thereof.

Background to the Scheme

This scheme forms part of the overall strategy of Galway County Council to provide sewage treatment facilities in all its towns and villages:

The principal purpose of the scheme is to remove a constraint on the development of Williamstown and also to eliminate a public health hazard and public nuisance being created by the existing inadequate provision.

Description of the present service provided

Williamstown is serviced by a selection of septic tanks and open sewers, a substantial proportion of the effluent discharged makes its way into an existing swallow hole and from there into the ground water system. However, before it does so it creates a substantial nuisance on the surface of the field and in a small water course leading into the swallow hole. The impact of this discharge is at total variance with our policy of improving and enhancing the environment.

Objectives

Our objective is to eliminate the present problem by collecting the effluent in a new collection system and then by disposing of the collected effluent in an environmentally efficient and cost effective manner.

Options

In pursuing these objectives we have examined 2 options

- 1. Get each individual household property to treat and dispose of its own effluent.
- 2. Provide a municipal collection and disposal system.

Having examined both options in detail we conclude that the provision of a municipal treatment system is the preferred option from an economic and environmental prospective.
