REVIEW OF COUNTY DEVELOPMENT PLAN

The Chairman introducing the topic stated that it was intended to proceed by going through the chapters one by one and omitting and adding additional material where necessary.

Mr. B. Callagy outlined the overall position as regards the contents of the County Development Plan. He stated that the plan was made up of two sections namely the development objective sections and the development control section. He then proceeded to commence at chapter 1. He referred to the main aims of the County Development Plan, the format, its legal basis under the Planning Acts, the scheduled towns, the planning research papers, the population overview and population settlement. Referring to the towns, he stated that most towns had remained static in population over the years.

Cllr. Gavin in referring to the village plans requested to know when they would be made available.

The County Manager stated that he placed very

important emphasis on forward planning and added that he had strengthened this particular division; once the County Plan was put in place and revised, action studies would be prepared for the relevant towns and villages extending out from satellite towns around Galway City. The relevant plans would then be brought to the members for adoption.

Cllr. Ryan stated that he was a rural Councillor and that there was concern that small towns and villages were not growing. He realised that Moycullen and Oranmore would eventually become part of Galway City. In referring to Ballygar he stated that out of 48 planning applications lodged, only 21 had been granted and he expressed his concern about this.

The Chairman then referring to chapter 1 requested the members to state if they were satisfied with page 1. This was agreed. Page 2 was then agreed.

On page 3 Deputy O'Cuiv had the following submissions. He stated that the statistics made it clear that Galway City was growing at an alarming rate compared with the County. He added that the growth of the City in relation to the province was becoming similar to that of Dublin. On looking at the statistics produced by NESC, urban growth in County Galway is very good but rural decline is of concern. With reference to the NESC report he stated that in 1966 47% of the population were in urban areas compared to 1991 where this had risen to 62%. In 1966 43% of population were in rural areas while in 1991 this had been reduced to 29%. He added that he did not agree with urbanisation. Referring to the figures quoted he stated that half of the population of Galway live within 10 miles of the City of Galway. Galway City was like a magnet attracting everything towards it and he requested that the statistics for rural areas from 1971 be shown. With regard to 1.8.1 of chapter 1, the Deputy stated that this section must highlight that rural parts of County Galway are in decline. On 1.8.2 he did not agree that urban growth is in a poor state in the County. Galway City had 52% of growth in 20 years. On 1.8.4 he added that decrease in population for the years 0-9 was of concern for schools in rural areas.

Mr. Callagy referred to a study that he had carried out in Ballinasloe and stated that the Environs population went up with the resulting loss in population in the town. He stated that the planning problem is where Environs increase in population, this results in the decline of the town. He added that a vibrant village is a compact unit which has all available services and referred to examples in the north of Ireland. Villages should be growing and not declining.

Cllr. Byrne stated that there had to be a recognition that members were in favour of rural areas and were concerned about such areas. He added that there was no statement on rural population decline in the plan and he would like to see included in the tables the population of the County as a whole, both rural and urban.

Cllr. J. Burke stated that he agreed with the previous members and added that the Council must address the decline of the rural population. This was of concern and he believed that the plan forces this decline. He added that rural people were entitled to live where they wanted to.

Cllr. Gavin stated that he agreed with Deputy O'Cuiv and Cllr. Byrne. He added that the whole trust of national planning is towards growth centres and this making existing centres larger. Referring to Moyculler village, he stated that land within the village was too expensive and this leads to people looking for sites outside of its boundaries.

Mr. Callagy stated that proper planning requires villages to be planned. He stated that there is a provision in the plan for people to build on their own family lands and that it is an objective of the plan to acquire land banks in towns where there is demand for such land. In addressing rural decline one must look at the rural economy. He added that it is a planning principle that the character of the countryside must be kept in place and added that around Galway City, County roads had been overdeveloped.

Deputy O'Cuiv stated that he had no difficulty with 1.2(i) referring to the heavy typing but he was not in favour of the light type which commenced with the planning input to this strategy etc. On 1.2(ii) he had no objection, however he was not in favour of 1.2(iii) and requested its removal.

Cllr. J. Burke stated that it was desirable that land banks be provided in certain areas such as Tuam.

The County Manager stated that it would be wrong to remove this paragraph (1.2(iii)). This was an important strategy for the Council to have and would be self financing.

Mr. Callagy stated that where there was demand for land, then this objective would exist to provide a land bank in such areas.

Cllr. Byrne referring to the last sentence under 1.2(iii) on the top of page 2 requested that it be removed. This was agreed.

The proposal from Deputy O'Cuiv to remove the light type on 1.2(i) was agreed also.

The Chairman then referred to the heading on economic development objectives. Referring to 2.1 on employment, this was agreed by the members, 2.2 on agriculture was also agreed. Referring to 2.3(iii) headed manufacturing industry, Cllr. O'Neachtain spoke on the topic of dispersed development and requested that the sentence referring to this type of development be removed. This sentence was too restrictive and would severely restrict Udaras na Gaeltachta. It was agreed that this item be removed.

Deputy O'Cuiv referring to 2.4 on service industry stated that he was not in agreement with the contents of this section. A lot of people were operating from their homes and there was no need for them to be in major centres. He also stressed that security was a major item. He did not like the negative connotations which he felt were portrayed under his heading.

Cllr. Loughnaie stated that many people worked from their homes and requested that the word "zone" be deleted from 2.4. This proposal was agreed. On 2.5 headed tourism, Cllr. Loughnane stated that the last plan did not have clour in relation to the protection of water sources. He stated that the most damage was being done by forestry developments on which the added that whole stretches of rivers had been ruined by forestry.

Cllr. Ni Fhatharta requested that the word "principal" be removed from 2.5(a). She stated that

the whole County depended on tourism and added that a lot of areas had been neglected.

Mr. Callagy stated that this paragraph was following Bord Failte's plan.

The members then agreed to remove the following from 2.5(a) "in principal tourism areas".

Deputy McCormack requested to know if 2.5 was purely aspirational.

The County Manager stated that the constraints were as set out on the bottom of page 2. He added that the general economic objective was to make the County more attractive and this was the vision they were following.

The members then dealt with item 2.6 on fishing. Cllr. O'Neachtain stated that it was very important to add a sentence on the improvement to the road access to Rossaveel as at present it did not have adequate access.

Mr. Callagy stated that this was a statement of policy.

It was agreed by the Members that 2.6(ii) include in its statement the improvement of the access roads to Rossaveel.

Under 2.7 on agriculture, Cllr. Ni Fhatharta requested that the improvement of slipways be included under 2.7(i). These slipways are required by fish farms.

Deputy O'Cuiv referring to 2.7(iii) stated that he would like to see the words "to minimise where practicable" added in to this section.

Deputy McCormack asked if there was any provision included to repair roads which were damaged by aquaculture and forestry developments and whether there was any provision to provide for a claw back of money spent on such works. He stated that the onus was on the developer to provide the access roads and the public should not be requested to cover the cost of infrastructure damaged as a result of such developments.

Deputy O'Cuiv opposed this provision. He stated that if we are getting sustainable development, then the infrastructure should be put in place.

Cllr. O'Neachtain stated that aquaculture should be enhanced and helped. The onus was on the Council to improve access roads and that it was important that jobs be kept in rural areas. Deputy McCormack stated that the forestry had no respect for the roads and that huge lorries were being brought in damaging

these roads. This was having a great affect on local people.

Cllr. Ni Fhatharta requested that slipways be included as well as piers and harbours.

Deputy O'Cuiv referring to afforestation under 2.8 stated that there were 2 major mills in the County which were worth f12 million and resulted in 95% profit for the local economy. This growth industry should not be destroyed. It provides employment in remote areas of the County. He had reservations about "adverse environmental aspects" contained in 2.8(i). He added that the roads were not a problem for the forestry but were a problem for the Road Authority.

Cllr. Quinn stated that she supported Deouty O'Cuiv. She added that forestry was a wonderful industry for Ireland and that Murray Timber Products located in the Ballygar area was a great employer. She stated that this firm allocated money where roads are damaged. She requested to know if Coillte do likewise.

Deputy McCormack stated that he could not support that the forestry operation had a right to destroy the road network and he wanted to know if Coillte gave money to the Council to repair road damage.

The County Manager stated that there must be a balanced approach to this development. He acknowledged Deputy O'Cuiv's submission but stated that the Council were getting a lot of complaints with regard to the standard of roads. He added they could not permit development irrespective of its consequence. The Council must ensure development is sustainable and that it did not damage the environment or the infrastructure. There was no point in having development and no road facilities. He added that he was not aware of the Council receiving funds for the repair of roads and bridges from Coillte.

Cllr. O'Neill stated that there needed to be some type of restriction on afforestation and he expressed his agreement with 2.8(i). He added that tourism is dependent on good roads and damaged roads destroy the landscape.

Mr. Callagy referring to 2.8(i) stated that "adverse environmental aspects" should be included in the proposal.

Cllr. Loughnane stated that he was guided by instances that he had come across. He referred to a house which had been surrounded by afforestation and as a result restricted its light and view together with being a fire hazard. He also referred to an

instance where a person had to leave their home as a result. He was in favour of leaving 2.8(i).

Cllr. Ryan stated that he was in agreement with Cllr. Loughnane and expressed the view that there should be some restriction of afforestation.

Deputy O'Cuiv referred to present forestry policy. He added that he had no difficulty with trees and finds them attractive and lead to a varied landscape.

Mr. Callagy stated that this item under afforestation was prepared and agreed by the members at a previous meeting. On 2.8(i) he stated that this was a general statement of protection and that it was the duty of the Planning Authority to make such statements.

The members then agreed to leave 2.8(i) as circulated.

Cllr. J. Burke suggested that the Council have discussions with Coillte with a view to lessening damage caused by afforestation.

Cllr. Byrne in referring to 2.8(ii) stated that he believed recent flooding in South Galway was contributed by forestry plantations on the Slieve Aughty mountains. He requested that the words "downstream drainage" be included in this paragraph. This proposal was agreed.

Cllr. Ryan asked if they were any controls on afforestation as certain planting had been taken right up to river banks.

Cllr. Loughnane then referred to a situation again where planting had been carried out up to the river bank. He stated that the Council should meet officials from Coillte to discuss the problem.

Deputy O'Cuiv stated that there must be a balance and he understood the fears expressed. He would be in agreement with leaving 2.8(i) and 2.8(ii) in place provided that they added the following clause "seek funding for the provision of necessary road infrastructure". This proposal was agreed by the members.

References 2.8(i) to (vi) were agreed by the members.

Cllr. Loughnane in reference to woodlands requested the preparation of a list of suitable trees for preservation.

Mr. Callagy then proceeded to discuss 3.0 on natural resource objectives.

Deputy O'Cuiv requested the insertion of a new section under 3.2 which would deal with the unsightly

state of disused quarries. He proposed to add the following "to develop a plan in consultation with owners to rehabilitate old quarries and where possible to find alternative uses for them".

The County Manager stated that the emphasis should be on the owner rather than the County Council to carry out this development. This was agreed and accepted by the members.

Section 3.2 in relation to peat was agreed by the members. On 3.3. which dealt with water Cllr. J. Burke referred to clean air and spoke on blood spreading which he would like included under this heading.

Mr. Callagy stated an objective would be included in the rewriting of this provision. He then proceeded to deal with 4.0 on infrastructure objectives and then dealt in turn with 4.1 on road, 4.2 water supply and 4.3 main drainage.

On housing and community facilities objectives under 5.0, Deputy O'Cuiv proposed the deletion of 5.1(ii) and the amendment of 5.1(iii). In this latter sentence he requested the replacement of "substantiated eligible need" with "demand". This proposal was supported by Cllr. Ni Fhatharta.

The County Manager stated that the Council did not want a situation where they could not build in towns and villages as a result of this deletion.

Deputy O'Cuiv stated that he wanted equality between rural and urban areas.

Mr. Callagy referring to Deputy O'Cuiv's submission under 5.1(iii) stated that this should be changed to housing need and not demand. It was agreed by the members that 5.1(ii) be deleted from the document.

Cllr. Fahy referring to 5.1(iv) requested that the traveling community be more clearly defined.

The Councillor was advised by the County Manager that as a Housing Authority, the Council must provide for people in need and this could not be qualified further.

Cllr. J. Burke suggested that provision be provided in this document whereby the Council would ensure that tenancy agreements be rigidly implemented.

He was advised by the Chairman that this was not a matter to be dealt with in the County Plan.

Cllr. W. Burke then spoke on the size of Council estates and stated that they were too large and this problem must be addressed.

The County Manager stated that draft guide-lines were issued in relation to this matter by the D.O.E. and a copy of same would be circulated to the members.

Cllr. Callanan stated that there should be a provision in the plan stating that the Council would provide water supplies.

Deputy O'Cuiv requested whether the objective outlined in the Department guide-lines would be incorporated into the development plan.

Section 5.2 which dealt with churches and burial grounds were then considered. Deputy O'Cuiv proposed that 5.2(iii) be amended with the insertion of the following "To locate new burial grounds in areas with adequate road access, parking facilities and visual screening preferably adjoining churches and where practicable to provide extra burial ground space as extensions to existing burial grounds". This proposal was agreed by the members.

On 5.3 dealing with education Deputy O'Cuiv proposed that 5.3(ii) be amended and that "in urban centres" be omitted. This proposal was agreed by the members.

The meeting then discussed 5.4 dealing with health and welfare. Deputy O'Cuiv proposed the replacement of 5.4(i) with the following "To locate community care facilities in the most convenient locations in communities taking into account usage of existing redundant buildings, availability of sites and community requirements". This proposal was accepted by the members.

On environmental services objectives 6.0, the County Manager stated that the implications of the cost of implementing the waste bill would be discussed at a further meeting by the members. The proposal under 6.1 on waste management had already been discussed by the members.

The fire services were considered under 6.2, the County Manager informed the meeting that the Council were in the process of preparing a 5 year plan for the fire services.

Cllr. J. Burke referring to the Glenamaddy fire service stated that it had been provided by the community. The Manager stated that the implications, cost wise and insurance, had to be looked at in such a case.

Cllr. Callanan stated that there may be inadequate fire cutting equipment in the Ballinasloe fire station. The Manager informed him that this matter would be looked at.

Heritage preservation and conservation objectives under 7.0 was agreed by the members.

Local Government Planning and Development Regulations 1994 Oranmore Sewerage Scheme

I set out hereunder report on the above development. The nature and extent of the proposed development and the principal features thereof.

Background to the Scheme

It forms part of the overall strategy of Galway County Council to provide sewerage treatment facilities in all its towns and villages.

It will remove a major constraint on the development of Oranmore and it will also facilitate our planning objective of providing serviced locations as an alternative to ribbon development.

Description of present services provided

The village is serviced by a selection of septic tanks, open sewers and private treatment works. Significant nuisance is being caused by these facilities and the public health risk is high. The impact of these discharges on the environment is at total variance with our policy of improving and enhancing the environment.

Objectives

- 1. Our objectives are to eliminate the present problems with the existing facilities.
- 2. To dispose of the collected effluent in an environmentally efficient and cost effective manner.
- 3. To provide sufficient capacity in the proposed services to meet the development needs of Oranmore for the immediate future.
