# PORTUMNA SEWERAGE SCHEME

# Report for Council under Local Government Planning and **Development Regulations**, 1994

This report on the above development covers the nature and the extent of the development and the principal features thereof:

# **Background** to the Scheme

Galway County Council has prepared, with 4 other Counties a proposal for the protection and improvement of the water quality in Lough Derg. This proposal has been submitted to the EU through the Department of the Environment for funding under the European Cohesion Fund. The provision of municipal waste water treatment plants is an important element within this overall project.

These waste water treatment plants will have phosphate nutrient removal facilities incorporated into them as part of the treatment process. This will help to reduce the rate of eutropication in Lough Derg.

The EU Cohesion Fund have approved an initial stage of the Lough Derg Catchment Protection Scheme under which Galway County Council have received approval to proceed with the preparation of the necessary planning documents for Portumna Municipal Waste Water Treatment Plant.

# Description of the present service provided in Portumna

Portumna has an existing collection system which discharges into a pumping station at Shannon Park and from there it is pumped into a treatment works at Rinnmaher. The Collection System and Treatment Works are old and significantly overloaded. They do not have phosphate removal facilities either.

# LA MARKS

The inadequacies in the system manifest themselves in an unacceptable rate of overflow at the Pumping Station in Shannon Park and the discharge of an untreated nutrient rich effluent into Lough Derg.

## **Objectives of the Proposed Scheme**

Our objectives are to eliminate the present problems by extending and upgrading the existing Collection System and by the provision of a new pumping station in close proximity to the existing station at Shannon Park. This effluent will be pumped to a new treatment works which is located in forestry land to the rear of the Green Isle Foods factory. Nutrient removal facilities will be included in the scheme and treated effluent will be discharged into Lough Derg.

Evaluate the likely implications of the proposed development with respect to the proper planning and development of the area in which the development will be situated.

The Planning Officer has indicated that the proposed development is in compliance with the proper planning and development of the area and complies with the County Development plan.

Issues arising with regard to planning and development on foot of submissions from persons or bodies or observations made in accordance with these regulations.

No submissions have been received from interested bodies or persons.

It is the Council's intention to proceed with the development as proposed.

The ESB intend to supply electricity to the three islands from the mainland. and with the investment of £5m, will bring several benefits to the islands. # HOUSING (REGISTRATION OF RENTED HOUSES) 3642 REGULATIONS 19996

The County Secretary stated that a new system of registration of privately rented houses came into operation on 1st May, 1996. Houses are registered with the Housing Authority. The Local Authority will draw up a register of rented accommodation which will be open for public inspection. A fee of £40.00 will be charged for each registration and this amount will be payable annually. Some types of rented houses are exempted, i.e. Holiday Homes, Lettings by a Minister of the Government, a Housing Authority, a Health Board or an approved Body, etc. Full details of the Regulations were circulated to each Member in a report issued by the County Secretary dated 11th April, 1996.

Deputy Connaughton stated that it must be made clear to the public that the new regulations are issued by the Department of the Environment and not the County Council. He stated that people feel that this is an invasion of privacy, and queried whether the information given will be forwarded to the Revenue Commissioners.

The County Secretary pointed out that the information available to public inspection is as follows:-

Address of Flat/property Description of same Date of receipt of Application/Registration

The public will not have access to the name and address of the landlord or the rent received. The register will be available for inspection in the Housing Department. There is no requirement to give the information to the Revenue Commissioner.

## Monthly Meeting - 22/04/1996

An Comhairleoir O'Neachtain requested that the items requested for registration should be clarified with the Minister. It was also stated that where flats become available, that it would be advisable to notify the Local Authority and this should be on the application form.

Councillor J. Burke welcomed the new regulations. However, where there is a large number of flats in one house, he suggested that a smaller fee be charged. Councillor O'Sullivan recommended that the exemption for Holiday Homes be withdrawn. Councillor McHugh queried as to how Galway County Council will police noncompliance of regulations, and implement the regulations without any increase in resources from the Department of the Environment.

Mr. Neslon, Assistant County Manager pointed out that this was another set of regulations being brought into force. He stated that the standards laid down for a Holiday Home do not compare with those laid down for a house. Holiday Homes are covered by other legislation and must be registered with Bord Failte. In regard to the policing of the regulations, the Council, upon receipt of complaints from tenant(s) will investigate same and take appropriate action. He also stated that all accommodation must be structurally sound and fit for occupation. Mr. Nelson stated that it was difficult to access the costs of implementing these regulations, which will be reviewed over a period of time, and a report will be issued in a few months time.

Councillor J. Burke proposed making a recommendation to the Minister that where there are multiple flats in one house, that a sliding scale should apply. This was seconded by Councillor O'Sullivan.

# ENVIRONMENTAL CAMPAIGN 1996

The Chairman and Members of the Council formally thanked Ms. C. Greene and Ms. C. Nevin in organising the 1996 Environmental Campaign. The Manager appealed to everyone to take part in the campaign "Clean Up Galway Week - 4th - 11th May, 1996".

Councillor Ryan stated that as the dumps in Glenamaddy, Dunmore and Ballygar are closed, that skips should be provided at different locations, especially for Clean Up Week. The Councillors raised the problem of indiscriminate dumping, and litter problems created outside certain shops and possible use of video for taking prosecutions against litter offenders.

The County Manager stated that skips would be provided during clean-up week 4th-11th May, 1996. However, due to financial constraints, cannot be provided on an ongoing basis. He also stated that the Minister for the Environment is introducing further legislation to deal with the problems of litter, with increased penalties etc. He thanked the Members for their comments and strongly urged everyone to take part in the 1996 Litter Campaign.

## **REFURBISHED CITY LIBRARY** 3644

On the proposal of Councillor Finnerty, seconded by Councillor Varley the Council agreed to invite the Minister for the Environment to open the refurbished City Library.

# Housing (Registration of Rented Houses) Regulations, 1996.

The above Regulations which introduce a new system of registration of privately rented houses come into operation on the 1st. May, 1996.

The Regulations require the landlord of a house which is let solely as a dwelling for rent or other valuable consideration to have the house registered by the local authority and to supply certain information to the authority. A "House" for the purpose of the regulations includes a house let in its entirety as a whole house, a self contained flat or apartment, a non self-contained flat, a single room or as the case may be.

The local authority is required by the Regulations to keep a register of such rented houses and to have the register available for public inspection at a designated office during office hours. Certified copies of entries in the register will be provided on request to members of the public on payment of a fee of £5.00.

# Landlords Obligations under the Regulations.

Where a house is already let on the 1st. May, 1996, the landlord is obliged to apply for registration within 2 months of that date and in the case of a house which is let after the 1st. May, 1996 application for registration must be made within one month of the date of letting.

A separate application for registration must be made in respect of each house on the prescribed application form and each application must be accompanied by a fee of £40.00 An annual fee of £40.00 is payable in respect of each house while it is registered.

The regulations do not apply to houses let as follows:-

- (e) Lettings made to certain relatives of the landlord as prescribed in the Regulations.
- (f) Lettings where the "house" is part of a building or within the curtilage of a house in which the landlord is normally resident and provided there are not more than two "houses" within the building and the curtilage of the building.
- (g) Letting of dwellings which are already the subject of Regulation under Part 2 of the Housing (Private Rented Dwellings) Act 1982.

Cllr. J. McClearn reiterated the case. He requested that the various bodies involved in the control and management of the lake establish a co-ordinated approach and put in place adequate resources to clean the lake and ensure the fish are disposed of properly. He stated that Mr. E. Cusack of the Shannon Regional Fisheries will make boats and man-power available to Galway County Council. Cllr. McClearn stated that the research centre at Abbotstown was not involved and wished to know why these facilities were not being utilised in this particular problem.

Mr. Declan Nelson, Assistant County Manager stated that it is acknowledged that there is a number of State Agencies involved in the management of Lough Derg. Galway County Council have been in contact with all the agencies concerned. He stated that the ESB owns all fishing rights, and control and management of the lake. Shannon Regional Fisheries Board is responsible for certain fishing aspects. Galway County Council has responsibility in relation to the Pollution Acts, licensing, sampling and the water quality used for drinking purposes. Mr. Nelson stated that the water quality at all in-take points is satisfactory.

Mr. Nelson pointed out that salmon and trout do not appear to be affected in this instance, which indicates that there isn't a pollution problem. He said that he would contact Mr. Cusack regarding his offer of boats and manpower, to help in the removal of dead fish. Mr. Nelson also pointed out that dead fish have also been reported at Terryglass and Scarriff lake and this problem is not just confined to the Galway County Council area.

Deputy Connaughton proposed that a deputation with representatives from the Loughrea Town Commissioners, Councillors and staff meet senior officials of the Department to discuss Loughrea Sewerage Scheme. Councillor Burke seconded this motion and the Council agreed to same.

On the proposal of Councillor Ryan, seconded by Councillor Finnegan, it was agreed that the next meeting of the Tuam Electoral Area will take place in the County Buildings on Monday, 22nd April, 1996, at 12.00 noon.

## **ROAD WORKS PROGRAMME 1995**

3626

The County Secretary advised that both the National Roadworks Programme and the Non-National Roadworks Programme were considered by the Area Committee's of the Council. The Non-National Roadworks Programme was approved by the various Committees subject to minor amendments in the Costelloe engineering area. In the case of National Roads, the programme was also approved with the exception of N59 Moycullen and N65 Portumna where members requested that a letter be sent to the National Roads Authority requesting the transfer of strengthening grants at those

locations to realignment works at N59 Woodstock, Moycullen and N65 Hearnsbrook respectively.

In the case of the N59 Woodstock, Moycullen, the County Engineer informed that it would cost approximately £1m. to make any useful impact, particularly in dealing with the bend at Corcullen. He also advised that sections of the pavement near Clydagh Junction was falling apart and that work was urgently required at this location in order to prevent serious difficulties arising later on in the year.

The County Engineer also said that the N.R.A. advised that the maximum National Secondary grant that the Council could expect to get over the next four to five years would be in the order of £1m. per annum and that the type of funding required for the carrying out of the above realignment works would not be available.

- In the case of the Bridge Road, Portumna he advised that a very serious situation
- permanent solution is now required. He strongly recommended that the grants for the N59 and N65 be spent at the locations as recommended in his Roadworks Programme.
- He also advised that it was hoped to commence the Transportation Study by
- September and that the situation at Moycullen would be examined under this Study. He further advised that road factors were not involved in fatal accident which
- occurred at this location.

Cllr. Gavin informed that there was tremendous anger locally over the way the road at Corcullen was left. He advised that loose stones are left on the side of the road since 1991 and he strongly felt that a start should be made stretching from Walshes to Sullivans. Land is available and many accidents have occurred in recent years. There is no margin and cars and vans are just inches apart when passing one another when going in opposite directions. He said that a start was required at Woodstock in the current year, otherwise the local people would lose confidence in the elected members.

Cllr. O'Neachtain agreed with Cllr. Gavin's comments and added that a fatal accident had occurred at this location since the last meeting. He stated that Corcullen has been mentioned at every meeting since 1991 and that any funds coming from the National Roads Authority should be directed towards Corcullen. He also stated that it was imperative that a design be put in place as otherwise there was no hope of getting the realignment works carried out.

Cllr. Gavin proposed and Cllr. O'Neachtain seconded a motion that a letter be sent to the N.R.A. seeking the transfer of the N59 East of Moycullen grant of £100,000 to realignment works at Woodstock and this was agreed unanimously.

Cllr. W. Burke strongly objected to the transfer of the £100,000 N65 Strengthening Grant for the Bridge Road, Portumna to design works at Hearnsbrook. He advised that the Chief Executive Officer of the N.R.A. gave a commitment that the above

exists on the section between Portumna and the Bridge and that emergency repairs have been carried out at this location over the last couple of years but that a more

funds would be spent at the Bridge Road and that Mr. Tobin visited the site along with the County Engineer during his recent visit to Galway. He said that the money was urgently required at this location where a serious accident was just waiting to happen if something wasn't done soon. He agreed that Hearnsbrook needs to be done but not at the expense of the Bridge Road and he strongly objected to a letter going forward to the N.R.A. requesting the transfer of funds.

Deputy Connaughton referred to a public meeting which was held in the hall in Killimor recently, where politicians were criticised for not making sure that funds became available for the carrying out of improvement works at Hearnsbrook. He said that it was imperative that a design would be carried out, as without the design there is no hope of funds coming forward for the carrying out of roadworks. He asked the County Engineer if design could be carried out by the present Design Team during the current year.

Clir. McClearn stated that funds were required for the Bridge Road, Portumna but as the proposed Portumna Sewerage Scheme would be going through this location, he was not willing to support the roads programme as this would result in the carrying out of works which would later have to be redone, thus resulting in a waste of public funds. He said that £100,000 was needed to design Hearnsbrook and that the Council would have no chance of attracting funds for the carrying out of roadworks without having a proper design in place.

Cllr. M. Cunningham, Cllr. M. Fahy and Cllr. M. Finnerty also stated that the carrying out of realignment at Hearnsbrook was urgently required.

Cllr. P. McHugh referred to the fact that many of the National Secondary roads were substandard. A notice of motion reply received by him some time back advised that it was impossible to provide a white line on a section of the N84 as the section in question was not wide enough which speaks for itself. He stated that, by and large, there were very little difficulties with National Primary roads with the exception of one or two black spots. However, this could not be said of the National Secondary routes and major funding was urgently required in order to bring them up to an acceptable standard. The Council had produced an excellent five year plan but it was of little use if adequate funding was not made available.

Cllr. McClearn said that proposals should be brought back to the next Loughrea Area Committee meeting regarding the redistribution of funds for Dominick Street and Shannon Road, Portumna. He also requested that Councillor's Notice of Motion funds be increased to £7,500 per Councillor.

Cllr. C. Ni Fhatharta informed that the total funding in the Connemara Electoral Area was down on last year mainly due to the loss of the supplementary grant. She welcomed the provision of school flashing lights at Tully School and asked whether this was coming out of the 1995 or 1996 Programme. She also requested that the 1996 Programme should be circulated to each member of the Council as soon as possible.

Cllr. C. Ni Fhatharta also asked what was the position regarding mobile weighpads and informed that a road which was recently repaired in the Rossaveal area was now being used by large lorries and that the road would be destroyed if something was not done to stop overladen lorries.

*Cllr. Cunningham welcomed the provision of a pedestrian crossing in Gort and also school flashing lights. He asked that a speed sign advising motorists to reduce speed be erected on a severe bend on the Galway road, Gort.* 

Cllr. Finnegan welcomed the inclusion of Kilnalag Junction in the Roadworks Programme. He asked when work was going to start at Kilclooney. He referred to the need to carry out realignment works on regional roads as some of these roads were now carrying very heavy traffic loads. He asked that the Council implement an environmental programme now to eliminate difficulties later on in the Summer, particularly in relation to ragworth, weeds, briers etc. He welcomed the provision of school flashing lights at Claregalway. Dunmore also requires school flashing lights.

Cllr. O'Sullivan wanted to know when work was due to commence at Cappataggle and whether it was going to be done by contract or direct labour.

He said that local improvement schemes were five years behind and something needs to be done urgently in order to address this serious situation. He wanted to know if road making materials were being supplied from one company and also referred to the need to bring the engineering areas into line with electoral areas. He felt that hedgecutting should be carried out as a service to the local Community.

Cllr. Varley welcomed the N84 grant of £300,000 and complimented the Council on the work carried out with the £110,000 which was provided in 1995. She stated that something needs to be done as a matter of urgency in order to advise the public not to be dumping plastic bags along the N84 as they were most unsightly.

Cllr. Callanan also referred to the five year backlog on Local Improvement Schemes and recommended that a once-off grant be sought from the Department in order to clear the backlog. He asked when work was proposed to commence at Cappataggle. He requested that the hedgecutting programme be resumed as in previous years.

Cllr. Fahy referred to a meeting with the I.F.A. recently at which he was informed that the I.F.A. made no deal with the D.O.E. regarding hedgecutting. They advised him that it was the responsibility of the County Council to cut grass and hedges as the County Council owns the lands and that farmers have no right to take grass without the Council's consent. He complimented the County Engineer on providing traffic route lighting at Ardrahan and also welcomed the provision of school flashing lights outside Kiltartan. School flashing lights were urgently required at Clarinbridge as motorists did not respect the speed limits. He informed that the National Secondary road between Kilcolgan and Kinvara was very narrow and was in urgent need of realignment. He welcomed the provision of the pedestrian crossing in Gort and wanted to know when works would commence.

Cllr. Quinn welcomed both the National and Non-National Roadworks Programmes. She asked when work, which commenced at Horseleap some years ago, would be completed and asked that the hedgecutting programme be resumed. She also advised that more funds needed to be provided for maintenance works.

Deputy O'Cuiv welcomed the increase in grants but advised that this was still far short of what was required. Regional roads required realignment and county roads needed increased funding. He stated that the five major cities were receiving approximately 40% of the total funds being allocated by the N.R.A. with only 10% of the road network. He referred to realignment works being carried out by Mayo County Council at Glencorrib and wondered why Galway County Council cannot do the same on the N84, particularly at Cloughanover. Similar works were also required between Corrandulla Cross and Headford as a number of accidents have occurred at this location and that a landowner cannot get out of her house due to inadequate sight distance and high speed of traffic.

Cllr. J. Burke requested that the hedgecutting programme be reintroduced as the Council was imposing charges and it was vital that something be given back to the public in exchange. He referred to the five year backlog on local improvement schemes and stated that funding is urgently required from the D.O.E. to clear the backlog. He welcomed all the funds being spent by Galway County Council in the Tuam area such as the Tuam Sewerage, the Inner Relief Road and the Outer Relief Road in particular. He stated that the above projects, when completed, will turn Tuam into an employment centre and will make Tuam a very attractive place for visitors.

Senator McDonagh requested that the hedgecutting programme be recommenced and that a deputation be sent to the Minister seeking a once-off payment to clear the backlog of local improvement schemes. He asked that road at Corbally to Cahernahona be included in the Roadworks Programme.

The County Engineer informed that the National Roads Grant was up £1.3m on 1995 and Non-National was up £1m. on 1995 and this was a welcome trend. He stated that the money available was not adequate to carry out all the works required but that it was vital that available money be spent usefully. He complimented the Minister on introducing the 10 Year Restoration Programme and looked forward to a substantial improvement by the end of the programme. Heretofore, the emphasis was to maintain road surfaces, now the emphasis is on reconstruction or restoration works together with surface dressing. Realignment work is a luxury we cannot afford as we are struggling to keep the present road structures in reasonable condition.

He said that the Urban Renewal Programme will contribute to the improvement of paths in the villages. The school flashing lights being provided at Scoil an Tulla was under the 1995 Programme and the 1996 Programme would issue shortly for the Non-National roads. Works will be carried out on the bridge at Ross Island in the current year and the remainder of the works will be completed in 1997.

He advised that the Council purchased mobile weighpads some years ago and due to a legal test case, the Gardai are no longer able to use them until such time as a concrete base is provided. The Council now proposes to provide platforms at strategic locations throughout the County. The County Engineer also advised that he would examine the situation regarding the bad bend at Galway Road, Gort to see if it can be included under low cost accident measures. Regarding hedgecutting, he advised that the I.F.A. were already aware that the responsibility for the cutting of hedges rests solely with landowners as a result of the Roads Act, 1993. However, where Area Engineers are maintaining verges, they will trim the face of the hedge. The E.S.B. and Telecom also carry out hedgecutting throughout the County.

Regarding the Cappataggle project, the Court

Regarding the Cappataggle project, the County Engineer advised that discussions have taken place with the N.R.A. The work will comprise mainly of the provision of hard shoulders and also the setting back of fences to improve sight distance where safe to do so and in accordance with good design practice. Some of the work will be done by direct labour and the remainder by contract.

Road materials are advertised each year and we deal with an excess of 30 suppliers. The price is based on mileages etc. and we purchase from the most advantageous tenderer.

Regarding Clontuskert/Kiltormer, the County Engineer advised that Mr. Martin, Senior Executive Engineer, would look at changes in the restructuring of the area. Regarding the Kiltartan/Kilcolgan road, the County Engineer advised that this was a National Secondary road and that the carrying out of realignment on such roads is dependent on funding being made available by the N.R.A. No such funds were made available in the current year.

The Council has carried out substantial bridge programme works in recent years. The majority of bridges were stone arch and were strengthened and are capable of taking very heavy loads. He was concerned for metal bridges as in the case of defects, the bridge might just collapse, unlike the stone work bridges.

Regarding the Galway Transportation Study, he advised that a notice has gone to the E.C. Journal this week and he expected that a contractor would be appointed by August/September at the latest. In the meantime, the Council will carry out traffic surveys themselves during August/September so that this information will be available to the eventual consultant.

Regarding the N84, the County Engineer advised that no funding was provided in the current year by the N.R.A for the carrying out of realignment works.

Cllr. C. Ni Fhatharta proposed that where local people are giving land free to remove bends, that additional allocations be provided to facilitate such projects and this was supported by Cllr. S. O'Neachtain.

Clir. McClearn proposed that a letter be sent to the N.R.A. requesting a transfer of £100,000 strengthening grant for the Bridge Road - Portumna for the carrying out of design on the N65 Hearnsbrook and this was seconded by Cllr. Mullins. Cllr. W. Burke proposed that no letter be sent to the N.R.A requesting the transfer of £100,000 strengthening grant for the Bridge Road, Portumna to the N65 Hearnsbrook and this was seconded by Cllr. J. Burke. Following a debate, it was agreed that the matter be referred back to the next Loughrea Area Committee for consideration.

- That the question of the transfer of the N65 strengthening grant of £100,000 2. for the Bridge Road Portumna to Hearnsbrook be referred back o the Loughrea Area Committee.
- Budgets already provided for Shannon Road and Dominick Street be :3. re-allocated.



The Acting Assistant County Manager stated that complaints had been received that representations had been made by Councillors on individual planning applications without being asked by the applicant to do so. The Protocol Committee expressed dissatisfaction with this practice and asked the County Manager to issue a letter to each Councillor on the matter.

# **COUNTY TRAVELLER ACCOMMODATION COMMITTEE**

On the proposal of Councillor J. Burke, seconded by Councillor Regan the recommendation of the Protocol Committee on the composition of the County Traveller Accommodation Committee was approved by the Members.

# **TELECOMMUNICATIONS ANTENNAE**

This matter was discussed at a previous meeting and the members asked that arrangements be made for an expert to address them on the subject. It was also agreed that a speaker representing the people of the Ballymoe district be allowed address the Council.

The Chairman introduced Professor Walton, UCG and Dr. Payne, Ballymoe to the members.

Dr. Payne addressed the Council. She stated that the proposed mast at Ballymoe was going ahead despite rumours that it wasn't. She represents the people of East Galway, where 95% of the community do not want the masts erected. They are concerned about the long-term effects of radiation levels which promote cancer. She then gave some technical information which in her opinion indicated that the guidelines used world-wide are false. She spoke on the IRPA Guidelines, which stated that unnecessary exposure should be minimised and gave an objective to protect human health. Serious effects have been found in animals. Every persons absorption is different. There is a lack of knowledge on environmental conditions, the possible effects on persons on medication and effects on the neuro system.

She said the responsibility for the protection of workers should be assigned to a Department or individual. There is no-one to measure non-ionising radiation. The siting and careful analysis of the health and environmental impact of the masts is necessary. The BANANA concept should be followed: - "Build Absolutely Nothing Anywhere Near Antennae", The school at Ballymoe has radon levels of 500. This is 3.5 times the accepted limit. No one came to test the radon level before Esat made their application. No ELS was carried out. Animals have been used to determine human safe levels. The IRPA Guidelines are without foundation. 95% are against the mast. Does this mean nothing in a so called democracy, she asked.

Professor Walton then addressed the Council.

He said there was a huge increase in the popularity of mobile phones. They are the victims of their own success. We are going to have to put up with masts if we want to use mobile phones.

The Esat system is a digital system. 150 masts are needed around the country. Currently, Eircell have more aerials but they are smaller (350 when complete). Esat operates at about 950 megahertz. The radiation levels between this and Chernobyl are very different. The ordinary T.V and Esat are almost at the same wavelength. Masts need to be 37.5m high in rural areas and 20m high in urban areas.

The IRPA is an international organisation made up of the worlds best experts on the subject who continually review and issue guidelines. These guidelines are adopted by most countries in the world. The IRPA recommend a limit of .46 miliwatts per square metre for the public. If 50 metres from the mast - it is .001 miliwatts per square metre. 1/460 of the limit set by the IRPA.

Cllr. Joe Burke could not understand how these two people could have different views on the same subject. He felt that where an EIS was required, the IRPA should see this. He mentioned that there is an existing mast in Tuam and felt that this should be used by Esat who intend siting another one 5 miles away in Belclare.

Cllr. T. Walsh stated that Dr. Payne's address outlined the anxiety of the people of the area. We need more debate and more understanding on the topic.

Cllr. Gavin welcomed both speakers. Dr. Payne's speech came from fears of a community she knows well. Professor Walton has taken an overall view. He asked Professor Walton if our fears can be allayed.

Cllr, O'Sullivan asked if one is subjected to the radiation levels from these masts over 25 - 30 years, is one more at risk. Is there anyway we can get definite information about this.

Deputy Connaughton wanted clarification on whether only animals were used for tests or both animals and humans. Is one likely to get as much radiation from a radio mast as from these masts.

Deputy O'Cuiv stated that the basic issues are risks, length of exposure and the strength of signal. Are these figures available of actual exposure to different frequencies. Can different signals interact with each other and cause harm or do they work on their own. Are people in urban areas more at risk than people in rural areas.

Professor Walton replied and said that the IRPA are continually reviewing the guidelines and don't make any changes unless they have to. The NRPD in Britain have reviewed their guidelines in the past two years and set the limit at 10 times higher than the IRPA. The limits set by the IRPA represent exposure year in year out, 24 hours a day. He said that a study carried out in respect of occupants of the US embassy in Moscow who were exposed to radiation levels which were 15 times the

maximum predicted by Esat, their health when compared to others in the US embassy's elsewhere, was no different.

The IRPA works closely with the WHO and both produce the guidelines. The radiation levels from a microwave oven is a lot more than from an Esat transmitter. A radio transmitter in the average house is comparable with Esat.

The risks from radon gas is serious and is known to cause lung cancer. There are no known risks from non-ionising electro magnetic radiation.

Cllr. Quinn proposed that an independent study be carried out to allay the fears of the people of Ballymoe. Dr. Payne's presentation should not be dismissed.

Clir: Hussey welcomed and congratulated both speakers. He said there appeared to be a conflict of interest and it was difficult to decide what course of action to take. He supports the views of the people of Ballymoe. There needs to be a lot more analysis into the health aspect of these masts.

Cllr. O'Neachtain said he could not understand why a body at national level has not been set up. He called on the Government to ensure that such an authority is established to give an assessment of the situation. As these masts are all over Europe, he doesn't think they will have any major effects.

Cllr. Callanan stated that there is no guarantee of no risks years down the road. By putting up another mast where there are three or four already must put people at higher risk.

Cllr. Brennan agreed that something should be done at National level. A lot of people are living in fear. Ones health takes precedent over a growing economy.

Cllr. Finnegan stated that he was opposed to dealing with the subject of masts when discussing the County Development Plan until the risks, if any, of such masts are clarified. He didn't think the matter was properly researched. A fully comprehensive study of the environment should be carried out where these are being erected. If the public make submissions that they don't want these masts, then that section of the Development Plan should be taken out.

Cllr. Mullins said that it was worrying that both speakers differ on the subject. This is a matter of great concern. He supports the idea that a Government appointed body or independent body carry out a study on these.

Dr. Payne was then allowed to address the Council to clarify a few points. She stated that just because England's accepted level of radiation is higher than here, does not mean that we're safer. These masts are not the same as T.V. signals because the masts are constantly repeating pulsing waves. We can reject the T.V., microwave, radio. We don't have to have them in our homes if we don't want them. The signals from the masts are around even if we don't want them. She read a letter she received from Padraig Flynn which stated that a research programme regarding radiation

levels and the effects on health was carried out and a blueprint would be available shortly.

Professor Walton asked why we needed an inquiry when the levels were lower than the safety standards. He felt that an authoritative body in Ireland would largely adopt the IRPA Regulations. He hoped that a few different masts would be sited together and doesn't see why they can't be. There is a huge amount of thought given to this at IRPA level. The television is pulsed as well as masts. Radiation levels from masts may be uninvited but so are levels by radio and T.V. which could be more dangerous.

The Chairman thanked both speakers for addressing the Council.
