TELECOMMUNICATIONS ANTENNAE

3583

The County Secretary referred to the Draft guidelines on telecommunications antennae and support structures which had already been circulated to the members. He stated that Forbairt would be in a position to speak to the Council on aspects relating to the structures. Deputy Connaughton welcomed this proposal. Cllr. Gavin referring to the guidelines circulated stated that this was an expanding industry and the companies involved would be competing so the requirement to group together the antennae structures may not always be possible. He stated that the lack of information in this area was causing problems. He added that minimum distances from dwellinghouses should be written into the County Development Plan and that grouping be encouraged in areas.

Cllr. Walsh stated that there was sincere and extreme worry about theses structures and in particular he referred to the Ballymoe area. He added that these fears must be allayed and continued, stating that there was a genuine feeling that a health risk existed. Cllr. Finnegan stated that the provision of telecommunications antennae should not be included in the draft plan. He added that there were fears that damage

would be done and he hoped that the Forbairt official could explain the matters to the council.

Cllr. McClearn informed the Council that the argument needed to be broadened out and requested to know if profit was being put before peoples, health and the environment. He wished to know were such large masts and in such quantities necessary and added that the risk to peoples health must be addressed.

Cllr. Hussey stated that it was desirable to have a high quality telecommunications system but not at the expense of peoples health particularly in the Ballymoe situation. He added that the County Council have to be careful in the type of policy it adopts. Cllr. Joe Burke stated that there was a genuine fear about these structures. He stated that they spoil the landscape and referred to the application at Belclare, Tuam. He stated that it was unfair to make decisions without the full knowledge. He added that there was a legitimate fear and the Council should recognise this.

Clir. Quinn stated that she had attended many meetings in Ballymoe and that people there expressed concern about the future for their children. She stated that the structures spoil the landscape but that health was the more important aspect. Deputy Connaughton stated that you cannot have the area dotted with masts and that it was important that the Council obtain professional input into this matter.

Cllr. Tiarnan Walsh requested that people from Ballymoe group be present at the next meeting. This proposal was seconded by Cllr. Joe Burke. The County Manager stated that the Council now have the guidelines and he stressed that it is national policy to have a modern telecommunication system. He added that the Council failed to get anyone from the various departments to address the Council on this issue. He continued stating that the Council had one meeting with the Regional Manager of Telecom on the aspect of co-locations. He will now address the other developers in this field. He stated that the difficulty existed that there were two systems of communication in operation which had different base systems.

The Council then addressed item no. 2 on the agenda - S. Cunniffe - Planning Ref. No. 95/1547.

Cllr. Fahy referred to this application which was a refusal for planning permission. He stated that planning permission should have been granted as the site was located close to Gort. He added that one entrance would be used to the proposed house and proposed that permission be granted in this case.

Cllr. Byrne seconded Cllr. Fahy's proposal. He stated that this type of application should be looked at in the context of the Draft County Development Plan.

Cllr. Cunningham stated that a housing need existed and that only one entrance was proposed. He felt that discrimination existed in this case. The County Manager informed the members that the planning decision had been issued and that the applicant did not avail of his right to appeal to An Bord Pleanala, an independent appeal board.

Clir. Fahy then spoke on Planning Ref. No. 95/1339. In this case, permission was granted but the Councillor stated that it was unfair to have an enurement clause attached as a condition. He added that there was not a question of speculation involved as no other house would be built on the farm. He proposed that the condition be deleted.

Cllr. Cunningham stated that he supported the Councillor and added that it was unfair to have this condition included.

The County Manager advised the Council that the planing application was dealt with in accordance with the proper planning and development of the area taking into account the County Development Plan. He added that the applicant had a right to appeal the condition to An Bord Pleanala which is an independent appeals body set up for this particular purpose. This avenue was not availed of by the applicant in this case.

On the proposal of Senator McDonagh, seconded by Councillor O'Tuathail, the Minutes of the Monthly Meeting held on 22nd January, 1996, were approved and signed by the Chairman.

The Report of the National Monuments Advisory Committee Meeting held on 9th January, 1996 was considered. It was adopted on the proposal of Councillor Cunningham, seconded by Councillor Ryan.

The Report of the Ballinasloe Electoral Area Committee Meeting held on 29th January, 1996 was considered. It was adopted on the proposal of Councillor O'Sullivan, seconded by Councillor Callanan.

The Report of the Loughrea Electoral Area Committee Meeting held on 30th January, 1996 was considered. It was adopted on the proposal of Councillor Ryan, seconded by Councillor Byrne.

The Report of the Connemara Electoral Area Committee Meeting held on 17th January, 1996 was considered. It was adopted on the proposal of An Comhairleoir Ni Fhatharta, seconded by An Comhairleoir O'Tuathail.

The Report of the Galway Electoral Area Committee Meeting held on 22nd January, 1996 was considered. It was adopted on the proposal of Deputy P. McCormack, seconded by Senator McDonagh.

The Report of the Tuam Electoral Area Committee Meeting held on 2nd February, 1996 was considered. It was adopted on the proposal of Councillor Finnegan, seconded by Deputy Connaughton.

MATTERS ARISING

FAMINE EXHIBITION

The Council complimented Galway Corporation on hosting the forthcoming Famine Exhibition in Leisureland during the Summer period.

A Conference commercrating the Famine will be held on 17th and 18th May, 1996 in Athenry. It is hoped that as many people as possible will attend this conference.

CAPPATAGGLE ROAD

The Cappataggle Road has been allocated £400,000 in the 1996 Road Grants allocation. The Members requested that the County Engineer draft proposals as to how this money will be spent, whether on hard shoulders etc.

The County Engineer stated that the road was surveyed in the past few months and the engineering team were looking at the best options available. He stated that £6-£8 million would be required for major improvements on the road. The sum of £400,000 would be spent effectively including proper design standards and sight distance to allow for over-taking to take place, and provision of hard-shoulders would be looked at. The Members urged that works should commence on this road as soon as possible and the various options be brought before the Council for consideration.

SPEED LIMITS

The Members expressed dissatisfaction with the N.R.A. over their refusal to approve speed limits for various areas in the County. The Council's proposals were supported by the Gardai Authorities. At the meeting held with the N.R.A. on 20th November, 1995, the Council were requested to submit justification for speed limit extensions. The Members wished the following also to be included:-

Ballygar - N63 - Speed limits to be re-submitted to N.R.A., and the Council to impress upon N.R.A. the need for funds for this road.

Kinvara - (a) 40 mile speed limit beyond Dunguaire Castle (b) 30 mile speed limit to Thatch Cottage

Gort - 30 m.p.h. limit to Lisk Factory and a further extension of 40 m.p.h.

N18 - Gort to Crusheen Road extension to 30 m.p.h. limit.

Abbeyknockmoy - Speed limit and 40 m.p.h. to Blackwater.

The County Secretary stated that the speed limits not approved were brought before the Area Committees. The decisions not agreed to by Area Committees will be resubmitted to the N.R.A. for review. At present, the Council are in the process of strengthening our case to justify this review. Any further comments or submissions from the Members to be forwarded to Mr. Colm Wallace, S.S.O. Engineering.

The Members asked when all the revised speed limits on County Roads will be erected, as there is growing dissatisfaction in various areas of the county, i.e. Moycullen.

Councillor McClearn asked that where there is no disagreement with N.R.A., can the speed limits on National Roads be erected. The County Secretary stated that bye-laws would have to be made for those speed limits. Councillor McClearn requested that this be considered. The County Secretary stated that he would re-examine the situation.

GORT ROAD/CRUSHEEN ROAD

Councillor Cunningham and Councillor Fahy on behalf of the small farmers in the Beagh/Tubber/Crusheen area asked that no further design work would take place on the Gort/Crusheen by-pass without consultation.

KILBEG/KNOCKFERRY BRIDGE

Deputy McCormack proposed the following motion:-

"In light of the study carried out by Harewood Associates and Sean Barrett on the Kilbeg/Knockferry Bridge Project that Galway County Council strongly recommend to the Department of the Environment to directly fund site investigation, environmental impact statement and cost benefit analysis applied for by Western Development Association Ltd., and a copy of the recommendation be given to all Members of Galway County Council, for the next meeting of the Council."

This was seconded by Councillor Varley. Councillor Gavin stated that the Bridge Committee are very angry with the response given to this project. He requested that the motion would be put to the meeting and for the document to be discussed prior to being submitted to the Taoiseach as there are a lot of factors to be taken into consideration. He also requested that the observations of the Bridge Committee be forwarded with the report.

The County Manager stated that there was no problem with the resolution proposed. He said that the Council would forward a copy of the updated report to the Department of the Taoiseach. He also stated that the Bridge Committee could make any observations on the report to the Taoiseach.

The Chairman declared the Motion carried.

PUBLIC LIGHTING PROGRAMME 1996

Senator McDonagh requested that the Public Lighting Programme for 1996 be implemented immediately.

On the proposal of Councillor Callanan, seconded by Councillor Byrne, the Council approved the sale of house at Moyode, Athenry to Joseph and Elizabeth Haugh, in accordance with Notice dated 16th January, 1996 under Section 83 of the Local Government Act, 1946, which had been circulated to each Member.

DECLARATION OF ROAD TO BE A PUBLIC ROAD

On the proposal of Deputy McCormack, seconded by Councillor O'Tuathail, the following road was declared a Public Road, the necessary statutory requirements having being complied with:-

Road commencing at junction with Co. Road 138 and extending north approximately for a distance of 71 metres in the Townland of Cloonboo.

REGULATIONS 1994 - CONSTRUCTION OF HOUSES UNDER THE 1995/96 HOUSING CONSTRUCTION PROGRAMME

A report on the proposed development dated 9th February, 1996 was circulated to each Member in accordance with the Local Government (Planning & Development) Regulations, 1994. On the proposal of Deputy McCormack, seconded by Councillor Ni Fhatharta, the Report was approved.

LOCAL GOVERNMENT ACT 1994

3550

The County Secretary referred to report dated 20th February, 1996 circulated to each Member. He stated that the Local Government Act 1994 (Commencement) (No. 4) Order which was made by the Minister on 21st December, 1995, brought Part VII of the Act into operation with effect from 1st January, 1996. Part VII of the Act enables Local Authorities to make bye-laws for or in relation to the use, operation, protection, regulation or management of any land, services or any other thing whatsoever provided by or under the control or management of the Local Authority. These provisions update the mechanisms provided under old legislation for the making of

bye-laws. In addition the Minister has made "Bye-law Regulations" providing for certain procedural matters relating to the making of bye-laws in addition to those set out in the Act. Generally, the Minister's sanction will not be required for the bye-laws.

LOCAL ELECTIONS

The County Secretary stated that Commencement Orders had also been made by the Minister bringing Sections 20, 22 and 23 of the 1994 Act into operation. These Sections deal with:-

Section 20 - Year of Election to all Local Authorities

An election of Members of every Local Authority shall be held in the year 1998 and every fifth year thereafter.

Section 22 - Provisions relating to the Conduct of Local Elections

In this respect the Minister has made new Local Election Regulations 1995. These replace the 1965 Regulations. Some of the changes are:-

- 1. Candidates Deposits increased from £5, £10 to £25, £50.
- 2. More flexibility in relation to times of the Count.
- 3. Minor changes in format of Ballot Paper.
- Increased penalties for Offences.
- 5. Deposit refunded when candidate's votes exceed 1/4 of quota.

Section 23 - Deals with the right to vote at Local Elections - restates the general provisions regarding the right to vote at Local Elections.

Part II of the 1994 Act, relating to Local Authority Membership will come into operation for the 1998 Elections. It updates and consolidates the law relating to eligibility for Local Authority Membership, disqualifications, term of office, casual vacancies etc.

Councillor Callanan stated that in accordance with the Regulations, disabled voters must renew their eligibility every year. He proposed and was seconded by Councillor O'Sullivan that a disabled person on the register who is over 80 years of age need not re-apply. It was agreed to forward this proposal to the Department of the Environment.

NATT

HOUSING

The Manager stated that the Council has been notified that a programme for the provision, by way of new building or acquisition, of 70 houses has been authorised for 1996. A detailed programme will be submitted to the Council for consideration.

ROADS

The Manager stated that details of the 1996 Grant Allocations for both National and Non-National Roads had been received. He said that the County Engineer is preparing the Road Works Scheme at present and the Area Chairpersons will call a meeting of the various Area Committees and details will be circulated to the Members as soon as possible.

COURTHOUSES

The Manager stated that a design team to undertake an initial comparative study has been appointed. A preliminary report is being prepared in relation to the Court facilities in Tuam and its findings will be brought before the Tuam Area Committee.

A preliminary report is also being prepared for a major refurbishment of Clifden Courthouse. Discussions are also taking place between Ireland West and the County

Council relating to the provision of a new Tourist Information Office and Council Office in Clifden.

The refurbishment to Ballinasloe Courthouse should be completed within the next two months. He said this item would be on the agenda for the next meeting in order to discuss the Official Opening.

The refurbishment work in Headford Courthouse should be completed in the next week or two.

At present 90% of the work on the roof is completed on the Portumna Courthouse and the Council will then re-assess the situation.

LOUGH DERG COHESION FUND SCHEME APPLICATION

The Manager stated that £600,000 has been allocated to commence detailed planning for Portumna Sewerage Scheme. A grant of £300,000 for up-grading of the Ballinasloe Sewerage Scheme has been allocated to Ballinasloe U.D.C.

The County Secretary stated that National Tree Week will take place from 3rd-9th March, 1996 and notice dated 19/2/1996 giving details of activities was circulated to the Members.

COSPOIR

A letter dated 1st February, 1996 from the Department of Education stated that on 7th November, 1995, Mr. Bernard Allen, T.D., Minister for Sport amounced the appointment of a working group to examine and make recommendations on the future role and structure of Cospoir, the National Sports Council, All submissions/recommendations to be received by 15th March, 1996.
