Councillor Gavin welcomed the Council's proposed development. He requested a report indicating the number of applicants on the Council's Housing List and the length of time applicants are on the list.

It was agreed that this matter would be referred to the next meeting of the Housing Services Strategic Policy Committee.

WASTE MANAGEMENT STRATEGY

5066

The Chairman welcomed Mr. P.J. Rudden, Mr. Larry O'Toole of M.C. O'Sullivan & Co. Ltd., Consulting Engineers and Mary Murphy, Public Relations Officer to the Meeting. He stated that it is vitally important that the public are fully informed on the Waste Management Programme for the City and County, and that a balanced debate is held on this issue.

Mr. P.J. Rudden informed the Members that Galway County Council and Galway Corporation commissioned M.C. O'Sullivan & Co. Ltd., and COWI Copenhagen to conduct a Waste Management Strategy Study for Galway City and County. The Strategy will have regard to all non-hazardous wastes generated within the functional areas of Galway Corporation and Galway County Council. The overall objective is to advise on the future waste management policy for the next twenty years in accordance with up-to-date Irish and E.U. legislation.

A copy of the Inception Report and Interim Progress Report had been circulated to the Members. Mr. Rudden outlined a brief summary of its contents and recommendations. The Study has adopted the following planning horizons:-

• Short Term Strategy 1998-1999

• Medium Term Strategy 1999-2004

• Long Term Strategy 2004-2014

A two strand strategy approach is currently being followed:-

- Diversion from landfill to recycling or thermal treatment
- Implementation of short term options to deal with the current crisis situation.

At present, most of the waste in Galway is disposed at landfill sites at Carrowbrowne, Tuam and Ballinasloe. The future for Waste Management is to remove a dependence on landfill sites and implement short-term options to deal with the current waste crisis.

The National and EU Recycling/Recovery targets are set-out hereunder:-

- National 20% of municipal waste by 1999
- EU Packaging Directive
 - Specified recycling targets for glass, paper, plastics, aluminium and steel packaging by 2001
- EU Draft Landfill Directive Specified diversion targets from landfill for biodegradable waste over the next 15 years

A two strand approach is being undertaken, namely Waste Minimisation and Waste Recycling and Recovery. The following are amongst the waste minimisation recommendations:-

- · Assessment of cleaner technology at industrial level
- Restrictions on landfills over next few months
- Employment of Environmental Education Officers.

In regard to waste recycling and recovery, a number of integrated scenarios are being assessed to determine the Best Practicable Environmental Option for Galway waste. The scenarios being studied are as follows:-

- Scenario 1 obligatory recycling, thermal treatment and landfill of residuals
- Scenario 2 Maximum realistic recycling and landfill of residuals
- Scenario 3 Maximum realistic recycling, thermal treatment and landfill of residuals

The scenarios outlined will be examined and modelled and the consequences for the waste stream and cost implications will be identified by the Consultants. With regard to recycling, this will be maximised by targeting priority waste streams such as construction and demolition waste, organic waste and packaging. A new community based recycling and composting scheme for the Aran Islands has been approved. This scheme is being grant-aided by the Department of the Environment & Local Government, Udarás na Gaeltachta, Roinn na Gaeltachta and Galway County Council. In order to meet the balance of funds required to operate the scheme, it is proposed to introduce an Environmental levy of £1 on all tourists visiting the Island. The proposed recycling depot is the subject of planning permission. Following the setting up of the new project, Kilronan landfill will close.

Proposals for new or enhanced waste recycling schemes for Galway City and Ballinasloe are being prepared in co-operation with Rehab Recycling Partnership, which will later be extended to other towns in the County. Advertisements have also been placed in the EU Journal for the Procurement of Transfer/Recycling Centres in Galway City.

It is proposed to close Tuam Landfill Site in September, 1998. It is recommended that new Waste Recycling Centres be established in Galway City, Ballinasloe, Athenry, Clifden and Tuam. Following the closure of Tuam Landfill Site, a new recycling centre and civic amenity site will be developed.

Mr. Rudden stated that the situation regarding Carrowbrowne Landfill is critical. An Bord Pleanala have placed strict restrictions on Galway County Council and Galway Corporation insofar as the landfill at Carrowbrowne will cease to operate from April 1999, or on reaching 150,000 tonnes of waste, whichever is the earlier. Based on current returns, approx. 12 weeks disposal capacity exists. The Local Authority has a legal responsibility in respect of domestic waste only. Accordingly, the collection of Commercial and Business waste will cease.

A licence application for the Ballinasloe Landfill Site has been submitted to the EPA. The licence application restricts the quantity of waste to be deposited to 40,000 tonnes per annum. In 1998, it is estimated that 25,473 tonnes of waste will be deposited in Ballinasloe, therefore 14,527 tonnes is the maximum waste acceptable from either Carrowbrowne/Tuam landfills under current operating conditions.

The Interim Report recommends that both Local Authorities increase the charges at Carrowbrowne and Ballinasloe landfill sites to £25 per tonne, effective immediately. These increased charges will provide a disincentive to private operators collecting waste outside Galway bringing waste to Galway and will provide the necessary capital to carry out the improvements needed at both landfill sites, and thus complying with the Polluter Pays Principle.

Mr. Rudden stated that existing landfills of Carrowbrowne, Tuam and Ballinasloe were examined with a view to servicing the short-term needs of the County. The survey revealed that Ballinasloe is the most suitable site for short-term expansion for the following reasons:-

- has suitable Hydrogeology
- has the space within existing boundary
- needs improved road access
- opportunity to leave upgraded landscape behind.

Details of the proposed Ballinasloe Landfill Plan and costs were outlined as included in Interim Report circulated to the Members. The costs associated with same are indicated hereunder:-

The long-term strategy of the Waste Management Strategy Study is to identify suitable location(s) for a new central landfill. The study is being carried out having regard to the County Development Plan, EU Proximity Principle, the EU Draft Landfill Directive and the EPA Draft Manual on Site Selection (1996). The process follows a sieving procedure whereby exclusionary areas such as airports, proposed N.H.A.'s etc., are excluded. A map indicating the areas suitable was circulated to the Members. Further surveys are being conducted in order to identify potentially suitable sites for selection later in 1998. The location of the site must be accessible to

either road or rail network. Mr. Rudden stated that the transportation of waste by rail is unlikely due to economic reasons.

The Chairman thanked Mr. Rudden for his presentation and the detailed Waste Management Strategy Study Reports which were issued to the Members.

Councillor Callanan thanked the Council for the opportunity to visit landfill sites in England. Councillor Callanan stated that landfills/dumps should be located in rural areas and far away from people's residences. He objected to the proposed plans for Ballinasloe on economic grounds stating that people wish to see public monies spent correctly. Councillor Callanan stated that should a suitable site for landfill be identified, he would give his support to same.

Deputy Connaughton stated that charges for the disposal of waste will increase approx. 300% over next few months, which will come as a great shock to domestic users. He expressed surprise that the collection of commercial and business waste will cease to be collected and queried what people will do with this waste. Deputy Connaughton stated that the location of new central landfill site may not be determined until 1999. He requested that a commitment be given to the people of Ballinasloe, by Galway County Council and Galway Corporation that the disposal of waste in Ballinasloe landfill site will cease in 2005. However, he noted that this cannot be given unless a site is being purchased and a legal agreement signed. Deputy Connaughton asked that legal advice be sought in relation to Carrowbrowne to determine whether its use can be extended until alternative arrangements are in place.

An Comhairleoir O'Neachtain stated that it is important to have liaison between both Local Authorities, i.e. Galway Corporation and Galway County Council. He welcomed the new initiatives for Inishmore, stating that the Island with its special amenity status will be an example for the rest of the country. He queried whether consideration has been given to improving roads infrastructure in areas around landfill site.

Councillor O'Sullivan agreed with sentiments expressed by Councillor Callanan and Deputy Connaughton. He stated that it is unfair to expect people of Ballinasloe to support an upgraded landfill site when no other sites have been identified.

Councillor McHugh stated that there is an onus on Officials and Members to solve this problem. He stated that he could not agree to locate a landfill site in urban/residential areas. It is more in keeping with the proper planning of the area to segregate the landfill from urban areas. Councillor McHugh stated that two of the proposed sites for transfer stations in Tuam are beside residential areas and wished to have his opposition to same recorded in the Minutes.

Councillor Hussey stated that it would help the Members if the site for central landfill is identified. Councillor Hussey said that every effort should be made to ensure that Carrowbrowne remains open for another two years.

Councillor Regan proposed that the Consultants come back to the Council with the proposed location of the new Central Landfill Site. Councillor Callanan seconded this proposal.

Councillor Ryan queried as to why Ballinasloe was the most suitable site.

Mr. Rudden replied to queries raised. He said there are three landfill sites in Galway. Based on current projections, Ballinasloe is the site with capacity to accept waste to year 2005. The landfill in Ballinasloe is adjacent to the forest, close to town, and as an existing site is working well. The costs of upgrading the site in line with EPA requirements will be in the region of £11m. In the medium term, the answers to Galway's waste problem is not a new landfill but to improve existing site at Ballinasloe. Mr. Rudden stated that according to the Department of the Environment, the Minister is to announce that existing landfill sites should be extended in preference to new sites.

In regard to Carrowbrowne Landfill, Mr. Rudden stated that there is a legal limit of 150,000 tonnes, and no guarantee that disposal of waste at this location will be permitted after 1st April, 1999. Remediation of this site must also be carried out. The EPA have stated that this site is unsuitable for various reasons, i.e. adjacent to water source. Mr. Rudden also confirmed that if an alternative site was selected today, it would not be operational by 1st April next. Mr. Rudden outlined briefly proposals for Ballinasloe landfill, and confirmed that roads infrastructure to and from site will be improved.

Mr. Rudden also confirmed that Commercial Operators are aware of the proposed waste restrictions and are making alternative arrangements.

In response to queries Mr. Rudden confirmed that Ballinasloe Urban District Council is the owner and occupier of the landfill site. The estimated costs of operating the upgraded site is approximately £500,000 per annum for seven years. The cost of remediation of the present site used by Ballinasloe UDC would be reflected in the cost of waste disposal of £62 per tonne as opposed to £13 per tonne if Galway County Council and Corporation availed of the site.

Mr. O'Donoghue, County Manager said that the document before the Members deals with the Short, Medium and Long term strategies for the County. Included in the document are important issues such as recycling, Bring Sites and the Appointment of Environmental Education Officers. The study was conducted in a strategic and professional manner. He stated that the process in acquiring a new landfill may take 5-6 years, taking into consideration the Planning Process, EPA Licensing, C.P.O. etc. In the interim, Ballinasloe Landfill Site is a suitable medium term solution. A well developed and maintained landfill is important to the infrastructure of the town. The revenue which Ballinasloe UDC would receive from the City and County would be of substantial benefit for the future development of the Town.

Mr. O'Donoghue indicated that the Consultants would proceed with selection of Central Landfill Site as quickly as possible.

Councillor Hussey proposed the adoption of the Waste Management Report subject to the approval of Ballinasloe Urban District Council in relation to the Poolboy Landfill Site. An Comhairleoir O'Neachtain seconded this proposal.

Deputy Connaughton stated that he wanted the Council and the Corporation to have identified the location for the new Central Landfill Site or at least have arranged for the purchase of same before a decision is made in relation to the upgrading of Ballinasloe Landfill Site.

Councillor Callanan proposed that the proposals in relation to Waste Recycling be proceeded with, and that the proposals regarding Ballinasloe Landfill Site be rejected. Councillor O'Sullivan seconded this proposal.

Councillor McHugh stated that he was opposed to two of the sites proposed as Transfer Stations for Tuam. Councillor Hussey requested that consultation with the public take place prior to agreeing locations.

Mr. Rudden confirmed that consultation would take place with the public regarding the location of Transfer Sites and their convenience to roads etc. He stated that the closure of Tuam Landfill will be advertised in the coming weeks.

Councillor W. Burke proposed an amendment to Councillor Hussey's proposal, in that the Waste Management Report be adopted with the exception of Section 2(10) relating to Ballinasloe Landfill. Councillor McHugh seconded this proposal.

A vote was taken on Councillor W. Burke's amendment which resulted as follows:-

Cllr. O'Sullivan queried whether the Draft Bye Laws apply only to owners of horses who were not kept under control and would not apply to owners of horses which were kept under control.

Mr. D. Barrett A.O. stated that the purpose of the Bye-Laws was to keep horses under effective control and that owners of horses who do not need a licence are not required to have a certificate to that effect. He stated that if the Draft Bye-Laws were adopted by the Members notice of adoption would be published. He also stated that copies of Bye-Laws would be available for inspection and copies may be obtained on request.

Cllr. O'Sullivan stated that he was not in favour of the Draft Bye-Laws and was against their adoption. On the proposal of Cllr. Mannion seconded by Cllr. Cunningham it was resolved that Galway County Council in accordance with Section 17 of the Control of Horses Act, 1996 hereby adopt the Control of Horses Bye Laws for the County of Galway and that the Control of Horses Bye Laws shall come into effect on the 1st October, 1998.

HOUSING (TRAVELLER ACCOMMODATION) ACT 1998

A report dated 7th August, 1998 on the Housing (Traveller Accommodation) Act 1998 had been circulated to Members.

The Acting County Secretary stated that the Act provides for the preparation and adoption of a Five Year Traveller Accommodation Programme. This programme will involve public consultation and assessment of accommodation needs and formal adoption of the Plan by the Elected Members of the Housing Authority. The Act also provides for the establishment of the National Traveller Accommodation Consultative Committee on a statutory basis. The committee's role will be to advise the Minister on general aspects of Traveller accommodation.

There is provision in the Act for the establishment of a Local Traveller Accommodation Consultative Committee to facilitate consultation with Travellers about the preparation and implementation of Traveller Accommodation Programmes. The Minister may give directions in relation to the composition of the committee, period of appointment, terms of reference and services and support to be provided by Housing Authorities to these committees is awaited.

Deputy McCormack welcomed the report and queried whether there would be traveller representation on the Local Traveller Accommodation Consultative Committee and whether the Council could make recommendation to the Minister that Travellers be represented on the Committee. He also questioned the powers of the Council under the Act in relation to temporary dwellings.

Cllr. Loughnane questioned the need for this Committee in light of the setting up of the Housing Services SPC and queried the position of Members in light of this proposal.

Cllr. Gavin stated that it was evident that other counties were not doing their share in the accommodation of Travellers while Galway had performed extraordinarily well in this area.

Cllr. O'Sullivan stated that a Traveller Committee had just been disbanded and that the Council were been told to re-form one. He proposed that the Council write to the Minister informing him that SPC's had been set up and that there was no need for another Committee while there was traveller representation on the Housing Services SPC. Cllr. J. Burke seconded Cllr. O'Sullivan's proposal and suggested that the Minister should be written to stating that any person in possession of a caravan should require a licence which would indicate their destination. He stated that there was a need to stop intimidation of communities where convoys of caravans arrived in their area.

Cllr. W. Burke stated that the proposed Committee was undermining the Housing Services SPC and questioned whether there would now be a whole plethora of committees.

The County Manager stated that the Council has a very good record in traveller accommodation. He stated that legislation requires the setting up of a Local Traveller Accommodation Consultative Committee and the Minister has to issue directions regarding the composition of this committee. He stated that the establishment of the

Local Traveller Accommodation Consultative Committee would be placed on the Agenda for a future Council meeting for consideration.

LOCAL GOVERNMENT ACT 1998

Rural Water Programme

The County Manager advised of an additional allocation of £637,000 from the Department of the Environment and Local Governments under the Rural Water Programme.

Councillor Gavin stated that the maximum grant of £1,600 for households connecting to a Group Scheme was insufficient as there are many schemes with a small number of connections to them where the contributions per unit would be in excess of £4,000 - £5,000.

Deputy McCormack asked if the level of grant available for construction of new Group Schemes is the same as applied by the Department of the Environment prior to the devolution of responsibility for Group Schemes to Local Authorities. He asked whether the Council could give a grant over and above the limits set down for households on new schemes. He added that the Department should be requested to increase the grant to a more realistic figure taking into account the current costs of Group Water Schemes.

Councillor O'Sullivan referred to the list of 37 schemes for 1997 and asked if a new list of schemes had been prepared.

Mr. Nelson, Assistant County Manager stated that he had several meetings with the Galway Federation of Group Water Schemes, where the major concern expressed was

that the £1,600 grant was insufficient. He stated that a submission had been made to the Department in this regard, but the Council had no discretion in the level of the grant provided. He stated that of the £637,000 additional allocation, £250,000 would go towards Mid-Galway Group Water Scheme; £200,000 towards new group schemes and the balance towards small public schemes.

Referring to the list of schemes in 1997, he stated that some of the schemes on the list would not be proceeded with and a decision had been taken to advance those group schemes that were ready to go ahead. He stated that the Council will spend £1m this year in upgrading and taking schemes in charge.

Councillor W. Burke stated that Councillors should be informed of new schemes going to construction.

The County Manager informed the Members that the County Engineer, John Colleran has been appointed to the National Rural Water Monitoring Committee. The Members were also advised that the County Manager had been appointed to the National Traveller Consultative Committee. The Members congratulated the County Manager and County Engineer on their appointments.

CHAIRMAN'S BUSINESS

Spiddal/Rossaveal Trunk Water Main

Deputy McCormack complimented the Council and Contractor for the quick and efficient works carried out on the Spiddal/Rossaveal Trunk Water Main and the way in which restoration work had been carried out. He queried whether Telecom lines were intended to be relocated underground as part of these works.

The County Manager confirmed that arrangements were in place to place the Telecom lines underground.

Clifden Town Plan

Councillor Mannion queried the position regarding the Clifden Town Plan. The County Manager advised that review of the Town Plan was being progressed by the Consultants.

Barna National School

Councillor Gavin stated that there was serious traffic congestion at Barna National School each school morning and requested that the Council consult with the School Authorities to see if a solution to the problem could be agreed upon.

Demountable Dwellings

Councillor Byrne stated that there were a number of unoccupied demountable dwellings lying idle in parts of the county and the landowners on whose land these are situated have expressed their concern regarding the potential for vandalism where they are left idle and vacant.
