The Mayor welcomed all to the Meeting. He then referred to the recent Tsunami disaster where 225,000 people had died and many were still missing. He referred to the generosity of the public and government, and suggested that Galway County Council do something tangible to support this effort. The Members were all in agreement that this was a very worthy cause and they complimented the Mayor on coming up with such a proposal. Mr. Gilmore explained to the Members that funding for Disabled Persons Grant and Essential Repair Grants was a mixture of Capital and Revenue Funds. He also stated that it was not anticipated that there would be any reduction in the level of service provided in the Disabled Persons Grants and Essential Repairs Grants in 2005

SUBMISSION Dd 4

Submitted by: Western Regional Fisheries Board

Issue: Protection of the water quality of the Rivers Clare and Nanny

Summary: New developments adjoining the Clare and Nanny Rivers pose a threat of pollution to water quality and fish life. They should be

connected to public sewers, surface waters should be treated so as to ensure that no pollutants enter surface or ground waters. Any public infrastructure projects should not be undertaken during

the fish spawning season, and surface water discharges from road should have silt and oil trapping interceptions fitted.

An amenity corridor should be provided along the River Clare and access rights for fishery owners be left unimpeded.

The policy on Tourism promotion should include the aquatic resource and the role of the Fisheries Board.

Response:

The additional areas zoned for development in the amended Draft are distant from the existing public drainage system and it may not be feasible or advisable for them to have individual connections to the public drains. They would have to combine and agree a drainage connection serving all of the sites, or, alternatively, the public drainage system would have to be extended to the sites by the County Council and the costs levied against the proposed development. The details would be a matter for consultation with the development control section before lodging a Planning Application.

In this regard it should be noted that one of the policies, as amended, in 3.4 Natural Heritage, requires consultation with the Regional Fisheries Board in relation to development proposals which may impact on the Rivers Clare and Nanny. This would also apply to public infrastructural proposals which would come before Council Members under part XI of the Planning and Development Act 2000.

The two remaining matters in the submission which deal with an amenity strip and Tourism policy do not relate to any amendment and do not require consideration.

Recommendation:

Insert a policy requiring, where feasible, that infrastructural developments be undertaken at times other than the salmonid spawning season.

On the proposal of Cllr McHugh, seconded by Cllr Canney, it was agreed to insert a policy requiring, where feasible, that infrastructural developments be undertaken at times other than the salmonid spawning season.

Issue:

Retail Policies in the Amended Draft.

Summary:

This submission is substantially the same as that which was submitted by Tesco to the Draft Plan and it makes this guite clear. The company seeks an opportunity to discuss "general retail matters" with members of the Planning Authority or its representatives in the future.

Response:

Members considered the Tesco submission before amending the Draft Plan. There were no alterations proposed to the policies on retail development as it was considered that adequate provision was available within the town centre and an additional commercial zoning at Blackacre and on the Galway Road.

Recommendation: No Change to Amended Draft.

On the proposal of Cllr Canney, seconded by Cllr McHugh, it was agreed not to change the amended draft

SUBMISSION Dd 6

Submitted by: Sarah and Alan Marrable Bracklagh

Issue:

Lands which were unzoned and outside the Draft Boundary to Residential within the amended Draft Boundary.

Summary:

Mr, Mrs Marrable live adjacent to the land owned by Archbishop Neary and are objecting to the proposed Residential zoning because housing development on the site would:

- (I). Contravene the current Tuam Plan.
- (II). Be out of character with established housing.
- (III). Impact on road safety
- (IV). In the absence of public drainage be detrimental to water quality
- (V). Exacerbate an already inadequate electricity supply.

Response:

As already advised at draft stage there are more than adequate lands zoned for Residential growth without extending the plan boundary into the rural environs of Tuam and encouraging patterns and intensities of development at variance with established one-off houses and remote from drainage services and safe pedestrian and

Recommendation: Maintain existing plan boundary on the Bermingham Road and leave the lands unzoned.

It was proposed by Cllr. McHugh, seconded by Cllr. Reilly to extend the Tuam Plan Boundary and zone the lands for residential as dealt with at the Draft Plan Stage. Cllr. Keavaney stated that he was opposing the zoning of these lands for development.

A vote was taken on the proposal and the result was as following,

SUBMISSION Dd 7

Submitted by: Department of the Environment, Heritage & local Government

They relate to a number of factors including Nature Conservation, Issue: Protection of Flood Plains, Archaeological Protection and

Residential Zoning.

Summary: The additional residential zoning in the amended draft should be consistent with the County Development Plan Framework and the

Regional Planning guidelines.

Any zoning adjoining the N17 by pass should not inhibit key

infrastructural proposals.

There is a welcome for the amended Natural Heritage section which contains additional policies for the protection of wildlife, but inadequate attention has been paid to flood plains and wetlands

which contain industrial and residential zoning.

The Natural Heritage section does not give adequate attention to the rural parts of the Plan Area and it should include objectives to identify wetlands and flood plains and to carry out a flood study to

guide future planning.

It is encouraging that an Area Action Plan is to be prepared for St Mary's and the Mall but Grehans Field should, in the meantime be zoned Recreation and Amenity.

Response:

The <u>Draft Plan</u> showed 180 Hectares of residential zoning. While this would be in excess of the requirements of the County Development Plan settlement framework it would allow a degree of flexibility in promoting development if some lands were not presented for development and it would cater for the growth to the target Hub Population by 2020.

The number of planning applications granted for residential units since the adoption of the County Development Plan is only marginally ahead of the framework allowance. However the Council directed an additional residential zoning of 50% in the Amended Draft, making the plan greatly exceed the settlement objectives of the County Development Plan. This would render the Local Area Plan, if adopted, in conflict with the County Development plan and therefore in conflict with 19(2) of the Planning and Development Act 2000. Since there have been indicators that the route of the N17 bypass may vary from that which was put on public display it has not been possible to show an up-to-date preferred route in the context of the Local Area Plan. There are no maps available of flood plains within the Plan Area. The ordnance survey sheets show areas that are "Liable to Flooding" but are outdated and imprecise. In the light of the predicted increase in water levels, inland and coastal, all development proposals which are adjoining areas which have a history of flooding or which can be described as "wetlands" will have to be examined as to their likely impact on water levels. This can only be done in the context of establishing up to date maps of flood plains so that flood impact assessments can be carried out and remedial measures applied if deemed necessary. A recent inspection showed an area of land zoned Residential in Curraghcreen under water. This would render it unsuitable for building without infilling and consequential disturbance of Flood Plains. Any proposed development in the area would have to be assessed in the context of protecting more widespread flooding of

Some of the industrial zonings mentioned in the submission are on marshy ground but have had its zoning for many years and are gradually being developed without any apparent adverse effect. The new additional industrial zoning adjoining the Bobby Burke Road is on dry agricultural land.

other areas.

It is not accepted that the "Rural" areas within the plan area have been overlooked. The majority of the policies in the Natural Heritage Section relate to the "Rural" surrounds. In particular the four objectives in the section commit the Council to extensive studies and works relating to protection to the environment of the total Plan Area. These projects have never been undertaken by the Council in the Tuam area up to now.

The concern about Archaeology in Grehans Field is well founded and the Council was advised at Draft stage to change the zoning from Commercial to Recreation and Amenity. The council decided not to amend the zoning.

Recommendation:

- (I). Reduce the extent of Residential zoning by reverting to the zonings as shown in the original Draft Plan.
- (II). Include an objective to establish the up-to-date flood plains of the Clare and Nanny Rivers within or adjoining the local Area Plan Boundary.
- (III). Include a policy to seek a flood impact statement in respect of development proposals on lands which are marshy or are subject to occasional flooding.

It was proposed by Cllr. McHugh, seconded by Cllr. Reilly not to accept the recommendation in the Manager's Report in relation to item (1) in Submission Dd7 A vote was taken on the proposal and the result was as following,

The Mayor declared the proposal carried.

On the proposal of Cllr. McHugh and seconded by Cllr. Reilly it was agreed to include an objective to establish the up-to-date flood plains of the Clare and Nanny Rivers within or adjoining the local Area Plan Boundary.

It was also agreed to include a policy to seek a flood impact statement in respect of development proposals on lands which are marshy or are subject to occasional flooding.

Mr Kavanagh stated that as previously agreed that there was to be a clear distance of 100m between the N17 Bypass and lands zoned residential at Killaloonty. (Re submission No MA11) but that this was not included in the script of the amended Tuam Plan.

On the proposal of Cllr. Canney and seconded by Cllr. Reilly it was agreed to include this in the Final Plan

Mr Kavanagh also stated that it had already been agreed at draft stage to insert the Architectural Conservation Area for Tuam in the amended Plan but the map defining this area was omitted from Appendix 6 in the amended draft. He recommended that this map be inserted in the final plan. On the proposal of Cllr. McHugh and seconded by Cllr. Canney it was agreed to have this map included in the final plan.

On the proposal of Cllr. McHugh, seconded by Cllr. Keaveney, it was agreed to make the Tuam Local Area Plan in accordance with Part 11 of the Planning and Development Act 2000 as amended by Part 111 of the Planning and Development (Amendment) Act 2002,(subject to the amendments above) and which comes into effect immediately.

Mr Ridge stated that an Irish version would be available as soon as possible.

GALWAY MAIN DRAINAGE STAGE 3 – PRESENTATION BY PATRICK J. TOBIN & CO. LTD., CONSULTING ENGINEERS. 291

The Mayor welcomed Mr. Paraic Fogarty of P.J. Tobin & Co. Ltd., who was going to make a brief presentation on the above. He also welcomed Mr. Tom Hernon, DOS, Water Services, Galway City Council and Mr. Ray Brennan, S.E.E., Water Services, Galway City Council. Mr. Fogarty briefly outlined the purpose of the scheme and gave a slide show to accompany the presentation.

The Mayor thanked Mr. Fogarty for the presentation.

Cllr. Joyce said he welcomed the presentation and said it set out clearly what was proposed. He said this was a good idea for the area it proposed to service, but stated that all of the County Council's and City Council's time, energy and funds was all going to be spent on promoting the City and environs. He said from his experience over the past 30 years his fear was that the peripheral areas of County Galway which were further away from the city would get less. He said he needed a guarantee that the same effort will be made for schemes for the peripheral areas as will be for this proposal. The Mayor said he understood how important it is for the City and Environs to get waste water facilities but not at the expense of the rural areas. Cllr. Cuddy asked what areas would be serviced in the Oranmore Area, would it cover Clarenbridge and Claregalway. Cllr. Keaveney said it was important that schemes in county areas get approval to proceed to enable development to occur. Cllr. Mullins welcomed the concise and detailed presentation and said he understood the importance of continued investment. He said he shared Cllr. Joyce's sentiments that the East of the County were only getting the crumbs from the table, and that Ballinasloe is taking all the hits. He said he wanted to see significant investment in infrastructure in the East of the County. Cllr. Feeney said while balanced developments has to be the cornerstone of planning and development strategy, he can't understand why we have to plan for a large population in Ardaun when they could be spread out in centres around the County and build a county that is sustainable.

Connaughton said while any investments in water services has to be welcomed, she feared the further from the City you go it seemed slower to get investment in water and sewerage services.

Mr. Gavin said he would like to assure Members that every effort would be made to ensure that Galway County gets infrastructure and development throughout the County. He said the Council would try to fulfil the objectives contained in the Water Services Investment Programme for 2004-2006. He said the Council will work with the Department of the Environment to try and advance schemes in towns and villages. He said Clarenbridge was covered within the Study Area. In relation to the area East of Galway City he said we need to plan for Athenry and Oranmore and the future likely expansion of these areas. He said there will be a Preliminary Report prepared in the next few months which will be brought back to the Council. The County Manager reiterated the Council's commitment to the Water Services Investment Programme 2004-2006 for the County.

RESOURCE RECOVERY PARKS – PRESENTATION BY DR. NIAMH CLUNE.

The Mayor introduced Dr. Niamh Clune, and apologised for the delay before she could give her presentation on Resource Recovery Parks and "Wealth from Waste".

Dr. Clune gave a very interesting talk and presentation on the above. She thanked the Council for allowing her this time. Cllr. Mullins proposed that the Director of Services examine this document and give feed back to the SPC. This was seconded by Cllr. Keaveney. The Mayor thanked Ms. Clune for the presentation and agreed that the SPC of the County Council should liase with the SPC in the City Council. Cllr. Joyce made the point that the Connacht Waste Management Plan officially stated that there was no money in recycling and he asked had that picture changed recently.

Mr. Gavin thanked Ms. Clune and informed the Members that this will be brought to the SPC and that he would prepare an issues paper for discussion at that Meeting.

MANAGER'S BUSINESS

Mr. Farrell informed the Members that a NASC Partnership E.U. Briefing is to be held in Brussells on the 2^{nd} and 3^{rd} March. He said that two Members could attend and it was agreed to nominate these at the Special Meeting on the 14^{th} February, 2005.

MAYOR'S BUSINESS

Cllr. Feeney referred to the forthcoming report on the Western Rail Corridor. He said he felt it would be beneficial if the Council reaffirmed its commitment to support the Western Rail Corridor. He proposed that the Council issue a letter of support to the Minister for Transport and the Western Inter County Railway Committee, this was seconded by Cllr. M. Connolly.

SPEED LIMIT SIGNS

The Mayor indicated that some Members wished to discuss the new speed limit signs which had been erected throughout the County.

Cllr. McDonough said he welcomed the new metrication of speed limits and said it was part of modern life, and this was agreed by all Members, but he said he had some issues with the speed limits that had been erected on Boreens and Cul-de-Sacs. He said there was a danger that signs on these roads could encourage people to drive too fast. He also referred to Speed Limits outside schools and asked that Bye Laws be introduced as soon as possible to regulate speed limits outside schools. Members pointed out that some schools were located on National Primary and National Secondary Roads and cars were speeding by. All Members were in agreement with the above and said there should be increased awareness now regarding speed.

Deir sé gur dhúirt urlabharaí ar son na Comhairle ar RnaG go bhféadfaí athbhreithniú a dhéanamh ar an scéal agus d'iarr an Comh. Ó Cuaig an bhféadfaí é seo a dhéanamh ag an gCPS.

Cllr. Joyce said that the driver of a vehicle is responsible for speed and that due care on the road is a basic requirement. Cllr. Fahy said that Flashing Lights had been erected outside of schools to slow down traffic. Now he said cars were speeding by when lights were flashing. Cllr. Cuddy said speed should be reduced at schools from 8.30 a.m. to 9.30 a.m. and from 1.30p.m. to 3.30p.m. during school hours, he also suggested that off street parking should be provided for the dropping off and picking up of children. This was supported by Cllr. Welby. Comh. O'Tuairsg said that a higher speed limit would be appropriate on certain stretches of the Cois Fharraige Road. Cllr. Connolly said that there had been a reduction in speed throughout the County, but that speed limits in Cul-de-Sacs, Boreens and narrow roads should be revisited and reviewed. Cllr. Hoade suggested writing to the N.R.A with regard to speed limits at a number of National Schools located on National Primary and National Secondary Roads she referred to the Coldwood School on the N6 in particular.

The County Manager commented that if debate in this Council, or nationally helped in changing driver behaviour, then that would be good. He stated that a speed limit is a

limit, not an instruction to drive at that speed, and that Galway County Council has been very proactive since the changeover. Staff had undertaken a huge programme of work and delivered on time. He said he was awaiting Regulations to allow the question of special speed limits to be addressed.

Mr Morgan informed the Members that the Act dealing with the metrication only became available on the 24th January, 2005. It converted all existing speed limits, but it did not provide for changes or for moving speed limits. The general speed limit no longer existed and that is why signs had to be erected in many areas including boreens, cul-desacs etc. He informed the members that permission would have to be got from the N.R.A. in relation to any signs on National Roads. He said that the Council will be examining the issues in relation to schools, and said he hoped this would happen quickly. He said the new legislation now provided for limits at specific times to facilitate school hours. He then referred to the situation on the Aran Islands and said that specific/special conditions may apply and that this would have to be examined. He informed the Members that a certain process has to be followed to enable the review of limits to occur e.g. consultation with Gardai etc. He said all of these matters would be brought before the Roads and Transportation SPC for discussion. The Mayor agreed that it would be appropriate to discuss all of these issues at the SPC Meeting and come back with proposals.
