CONFIRMATION OF MINUTES OF MEETINGS

1771

The Minutes of Annual Meeting held on the 16th June 2008 were approved by the Council and signed by the Mayor on the proposal of Cllr. Cuddy and seconded by Cllr. Regan.

The Minutes of Monthly Meeting held on the 23rd June 2008 were approved by the Council and signed by the Mayor on the proposal of Cllr. Kyne and seconded by Cllr. Conneely.

Arising from the minutes, the following issues were raised:

Cllr McDonagh said that he wished to put the Council on notice regarding a serious public health issue in the Carrick More Housing estate in Lackagh arising from raw sewage leaking from the percolation area of the estate. He said that the Council had a €57,000 bond from the builder and that this should be used to remedy the situation.

Mr. Ridge said that the Council was aware of this issue and in view of the implications of enforcement proceedings could not make any comment in this regard.

Cllr Kyne requested an update regarding the abandoning of a section of the N59 Galway Maigh Cuilinn road.

Mr. Gilmore said that the process of abandoning the road was ongoing. He confirmed that he had met with Galway City Council officials who informed him that all the travellers on the site were applicants for housing with Galway City Council. In response to Cllr. Kyne he further confirmed that the hardstand at Carrowbrowne is to be re-evaluated by Galway City Council.

Comh O'Cuaig stated that in relation to the resurfacing in Spiddal village, the Wallace family in the village had no parking space and there was water leaking into their house as a result of the works in the village. He said that they had employed their own engineer who had come up with a report on possible solutions.

Mr. Morgan said that that this was an ongoing issue and he requested that the Wallace's engineer liaise with the Council engineers in this regard.

In response to an enquiry by Cllr. O'Cuaig with regard to Carna/Cill Chiaráin Regional Water Supply Scheme and whether an additional lake could be added to supplement the existing source, Mr. Cullen said that a report had been received from the consulting engineers and clarification on that report was being sought. Cllr. O'Cuaig asked if priority would be given to it. Mr. Cullen said that once the feasibility of the proposal was established, it would be forwarded to the Department for consideration.

Cllr Cuddy said that as there was no funding available for the review of speed limits could the Council make an application to the NRA and to the Dept for same.

Mr. Morgan said that funds had been set aside from the Councils own resources but that there was still a shortfall of €1.5m which would have to come from the Roads Programme. He suggested that the Towns and Villages speed limits reviews be done first as they were a priority. He asked that the speed limit reviews done to date should now be sent to the Gardai without delay. This was proposed by Cllr Regan seconded by Cllr S Walsh and agreed.

REPORTS OF COMMITTEE MEETINGS FOR CONSIDERATION AND ADOPTION 1772

The Report of the Planning & Sustainable Development SPC Meeting held on 10th April 2008 was considered. It was adopted by the Council on the proposal of Cllr. Keaveney and seconded by Cllr. Hoade.

The Report of the Tuam Area Committee Meeting held on 21st May 2008 was considered. It was adopted by the Council on the proposal of Cllr. Keaveney and seconded by Cllr. Reilly.

Arising from the Report, Cllr. T Walsh said that he was concerned that there was a shortage of funding for the Disabled Persons and Essential Repairs Grants. He proposed that the Council look for an allocation for extra funding from the Department as, if there was no money available he could not see the point in approving applications. The Members expressed their concerns in relation to this matter. Cllr. Mullins proposed that the crisis in funding for the Disabled Persons and Essential Repairs Grants be placed as an item for discussion at the September 2008 meeting, this was seconded by Cllr. T. Walsh and agreed.

In response to Comh. O'Cuaig, Mr. Gilmore confirmed that applications were still being accepted by the HSE in relation to the Housing Aid for the Elderly Scheme.

The Report of the Loughrea Area Committee Meeting held on 7th July 2008 was considered. It was adopted by the Council on the proposal of Cllr. Burke and seconded by Cllr. Mullins.

Arising from the report Cllr. Burke said that he had put forward a proposal at that meeting which was seconded by Cllr. Regan but was not recorded in the report that negotiations should commence to purchase the site from the parish priest for car parking in Portumna.

The Report of the Corporate Policy Group Meeting held on 28th April 2008 was considered. It was adopted by the Council on the proposal of Cllr. D Connolly and seconded by Cllr. T Walshe.

Cllr. Joyce asked whether Ballinasloe Town Council had the right to introduce parking meters on roads in the town that were the responsibility of the County Council. He proposed that this matter would not be progressed until it came before a full meeting of the County Council. This was seconded by Cllr. Finnerty.

Cllr Mullins said that this matter should be brought before the Ballinasloe Electoral Area Committee meeting before a full Council meeting.

Mr. Kelly in response said that any legislative requirements would be met by the Council.

The Report of the Corporate Policy Group Meeting held on 12th May 2008 was considered. It was adopted by the Council on the proposal of Cllr. T Walshe and seconded by Cllr. D Connolly.

Cllr D Connolly said that there were fears being expressed about some issues on the N6 Galway to Ballinasloe construction project.

Mr. Morgan said that this matter was outside the control of the Council however, the Council would be meeting with the NRA in relation to the N6 Galway to Ballinasloe project to express reservations about some aspects of the construction project.

Road commencing at end of L11013 extending for a length of 950 metres westward ending at Paddy Mc Donagh's field gate, all in the townland at Derryherbert, Tullycross, Letterfrack.

On the proposal of Comh O Tuairisg, seconded by Comh O'Cuaig, the Council approved the declaration of the following road to be a public road, the statutory procedure having been complied with:-

A section of road in the townland of Cill Éinne on Inis Mór, Oileáin Árann extending from the road L52007 at Cill Rónáin Harbour towards and along Tra an Fhrancaigh for a length of 800metres in a northeast direction from Cill Ronain Harbour.

A section of road in the townland of Cill Muirbhí on Inis Mor, Oileáin Árainn, extending from the road L52006 westwards and northwards for a length of 990 metres to a junction with the road L5200.

A section of the road known as Bóthar na Leachta in the townland of Cill Éinne on Inis Mór, Oileáin Árainn, extending from the end of the road L 52003 at the National School eastwards to the junction with the Tran a Fhrancaigh Road for a length of 260 metres.

The road commences with the junction of the National Road with road number N17 in the townland of Killaloonty and extends North West for a distance of 163 metres in the townland of Killaloonty and terminates at the end of the said road in the townland of Killaloonty.

metres in the townland of Townparks (1st Division) and terminates at the entrance of Cois Na hAbhainn Estate in the townland of Townparks (1st Division)

Report dated 14th July, 2008 was already circulated to Each Member

Cllr. D Connolly proposed that the Casual Vacancy on the Regional Health Forum be filled by Cllr. Hynes and this was seconded by Cllr Willers and agreed.

FILLING OF CASUAL VACANCY ON THE FORUM (LETTEFRACK) 1779

The County Secretary informed the members that Cllr. S. Walsh had resigned his position on Forum Letterfrack. Cllr. Regan proposed that the Casual Vacancy on the Forum (Letterfrack) be filled by Cllr. Conneely and this was seconded by Cllr. Joyce and agreed. It was further agreed that when Cllr. Welby resigns from the Forum Letterfrack that Cllr. S. Walsh will take up the vacant position.

TO CONSIDER REPORT UNDER PART 8 OF THE PLANNING & DEVELOPMENT REGULATIONS 2001 – MOUNTCROSS (KINVARA) BURIAL GROUND 1780

Report dated the 14th July, 2008 was already circulated to Each Member.

On the proposal of Cllr. Willers, seconded by Cllr. Regan, the proposed Mount Cross (Kinvara) Burial Ground was approved.

TO CONSIDER REPORT UNDER PART 8 OF THE PLANNING & DEVELOPMENT REGULATIONS 2001 – BACKLAWN CARPARK, ATHENRY 1781

Report dated the 15th July, 2008 was already circulated to Each Member.

On the proposal of the Mayor, seconded by Cllr. Hynes, the proposed Backlawn, Car Park, Athenry was approved.

TO CONSIDER REPORT UNDER PART 8 OF THE PLANNING & DEVELOPMENT REGULATIONS 2001 – MILLTOWN SEWERAGE SCHEME 1782

Report dated the 15th July, 2008 was already circulated to Each Member.

On the proposal of Cllr McHugh, seconded by Cllr. Regan, the proposed Milltown Sewerage Scheme was approved.

TO CONSIDER REPORT UNDER PART 8 OF THE PLANNING & DEVELOPMENT REGULATIONS 2001 – N59 LEENAUN BRIDGE

1783

Report dated the 15th July, 2008 was already circulated to Each Member.

On the proposal of Cllr Conneely, seconded by Comh O Tuairisg, the proposed N59 Leenaun Bridge was approved.

DRAFT ANNUAL REPORT 2007

1784

Report was already circulated to Each Member.

On the proposal of CIIr Burke, seconded by CIIr S Walsh, the proposed Draft Annual Report 2007 was approved.

Mr. Kelly said that the Annual Report gives details on the activities of the Council for the year. He said that an information leaflet in a shorter format would be produced for distribution to the wider community.

In response to Cllr. Connaughton, Mr. Kelly said that the existence of the Western Regional Tourism Organisation and the County Tourism Committee would be checked out.

Cllr. Burke, while complimenting the Annual Report referred to the issue of derelict sites and the negative impact they were having in many places around the County. He said that there was a need for a greater level of enforcement to deal with derelict sites. Cllr. Regan supported Cllr. Burke and referred to the Town Hall in Loughrea as an example.

Mr. Cullen acknowledged that there were many derelict sites around the county and despite the efforts of the Council to work positively with communities through Tidy Towns and Community Grants Schemes, the derelict sites remained a problem. He said the Council would do whatever it could to address the situation within available resources.

Cllr. Burke referred to the water supply in Portumna and in particular the cryptosporidium risk assessment scores that had been circulated to the Councillors. In the same context Cllr. Joyce referred to the water supplies in Ballinasloe and Gort.

Mr. Cullen replied that the cryptosporidium risk scores formed part of an iterative process whereby the risk is reassessed after works have been carried out and the process repeated until the lowest possible score was achieved. He said works had already been carried out in Ballinasloe and that all schemes were included in the Remedial Action Programme that was approved by the Council at the monthly meeting in May.

Comh O'Cuaig said that all Clár money allocated to LIS was not spent last year as the notification was received very late in the year and thus could not be spent. He asked if the same situation would arise this year.

Comh O'Tuairisg said he thought that the unspent Clár funding could be carried forward to the following year.

Mr. Morgan said that the notification for 2007 was received in Sept 2007 and works had to be completed by Nov 2007. He said that works completed in 2007 could be paid in 2008 but that any unspent expenditure in 2007 could not be carried over to 2008.

Comh O'Cuaig proposed that the Council ask Minister O'Cuiv when he proposes to allocate 2008 Clár Funding for LIS. The request for a specific date is made in the light of the under spend on the monies in 2007 due to the late allocation date for that year. This was seconded by Cllr. Welby and agreed.

The Manager said that the Council would be in contact with Minister O'Cuiv's office regarding Clár funding for LIS.

HIGHER EDUCATION GRANT SCHEME 2008/09

1785

The Manager referred to the Higher Education Grant Scheme for 2008/09 details of which were circulated to the members and had only been received by Galway County Council last Friday 18th July. It was agreed that this item would be dealt with due to the deadline of the end of August for receipt of grant applications.

In response the Cllr. Mc Donagh, the Manager stated that while the administration of the scheme is to be transferred to the VEC this will not happen for the 2008/2009 scheme.

Cllr Kyne referred to page 3 of the scheme regarding Disability Allowance and asked if an anomaly in relation to Disability allowance that is paid to parents being deemed to be reckonable income could be referred to the Department. The Manager confirmed that his issue would be raised with the Department of Education.

On the proposal of Cllr. Mullins and seconded by Cllr. Canney the Higher Education Grants Scheme 2008/2009 was approved.

FINANCIAL UPDATE TO 30TH JUNE 2008.

1786

Report dated the 15th July, 2008 was already circulated to Each Member.

In relation to the Revenue Account Mr. Mullarkey confirmed that figures were broadly in line with expectations with the exception of Water − 61% of the budget has been spent on operation and maintenance. However, this is not the case on the Capital side and there is an urgent need to recoup outstanding monies due from Government Departments e.g. €17.5million had been expended on the Water Programme in the first 6 months and only €6million had been recouped. The members expressed concern at the impact on the Councils overdraft which was recently approved at €20million. Mr. Mullarkey advised that it may be necessary to come back to the Members to further increase the overdraft. Mr. Cullen pointed out

that recoupment on the Rural Water Programme works very efficiently. However, he said that recoupment on the Capital Water and Sewerage schemes are different. He said that these schemes also tend to have a high capital value. Once 95% is recouped for a project the remaining 5% is only payable when final accounts are completed. This amount must then be carried by the Council until the final accounts are cleared and this can take some time.

WESTERN RIVER BASIN DISTRICT – TIMEFRAME FOR MAKING RIVER BASIN DISTRICT MANAGEMENT PLANS 1787

Report dated the 14th July, 2008 was already circulated to Each Member.

Mr. Cullen referred to the report circulated to the members which set out the timelines for the River Basin District Management process including the publication of the Draft River Basin Management Plans by 22nd December 2008 leading to the making of the River Basin Management Plan by 16th October following a period of public consultation.

TO CONSIDER THE DRAFT COUNTY DEVELOPMENT PLAN 2009-2015 AS PER SECTION 11 OF THE PLANNING AND DEVELOPMENT ACT 2000 AS AMENDED 1788

Mr. Ridge referred to the documentation circulated to the members and in particular drew their attention to the relationship between the County Development Plan Process and the Strategic Environmental Assessment. He informed the members that at each step in the process of the review of the County Development plan each objective and policy and any amendment the members wish to make will have to environmentally proofed and if this is not done properly then there is a real risk that the plan will be sent back by the Minister. He stated that one of the main effects of this Strategic Environmental Assessment is that last minute changes before adopting the plan will not be possible as each change has to go through this process. He informed the members that the results of the Strategic Environment Assessment to date are contained in the Environmental Report that had been circulated and that he would go through this report with the members later in the meeting.

Mr. Ridge then informed the members that the Draft Plan had already been presented at each electoral area meeting and that the issues raised at the meetings were set out in a document which was now being circulated entitled Galway County Development Plan Review – Response to Issues Arising at Electoral Area Committee Meetings. He proposed the use this document to go through the plan but invited members to refer to the draft plan itself also.

Section 2 Spatial Planning and Settlement Strategy.

Page 11 Include new objective

Objective SP6

Investigate the potential for the development of integrated transportation hubs at Tuam and at Garraun to maximise the strategic integration of transport and rational land uses.

A number of members raised concern with this objective. They felt that too much emphasis was being given to facilitating development close to the city to the detriment of the existing towns in the county. They felt the Council was not investing in these county towns and that if Garraun and Ardaun were to develop it would deprive other areas of the county of funds to improve their infrastructure.

Mr. Ridge in response felt that the plan was well balanced and that ample opportunity was provided for in the plan to facilitate development in the whole county. He stated that there were huge interdependencies between City and County benefiting both areas and that it would be ill-advised not to plan for these eventualities. He stated that development at Garraun and Ardaun would be funded by the private sector and that it should not prevent investment in infrastructure in the county towns.

The County Manager informed the meeting that the Council was equally as committed to a transportation hub in Tuam as the one in Garraun. Mr. Morgan then informed the members of the background as to why Garraun was recommended and explained the advantages for that location.

It was proposed by Cllr. Reilly, seconded by Cllr. Joyce and agreed that this objective be included. It was further suggested by Cllr. Mannion that this objective should be included under Section 6 of the plan Roads and Transportation and this was agreed.

Amend Objective SP2

"...in particular, the advancement of the East Galway Waste Water Treatment Plant, the re-opening of the Western Rail Corridor.

This amendment was proposed by Cllr. Reilly, seconded by Cllr. Cuddy and agreed. It was further proposed by Cllr. Mannion, seconded by Cllr. Cuddy and agreed that this objective be made into two separate objectives.

A number of members raised concern in relation to the disposal of sludge from any new waste water treatment plant. Mr. Cullen confirmed that a Sludge Management Plan which will consider this matter will be placed before the members in due course and that these concerns could be better dealt with in that context. He confirm that any current practices in relation to the disposal of sludge and in particular in relation to the land spread of same was in line with current regulations.

Section 3 Settlement Strategy.

Page 20 Section 3.3.4.

Include Garraun as a potential site for new integrated settlement and development node.

This was proposed by Cllr. Willers, seconded by Comh. Ni Fhatharta and agreed subject to the wording being amended to state that the inclusion of Garraun was not to negatively impact on the balance of the county and that the infrastructure to service Garraun would be funded through development contributions.

Page 21 Section 3.3.11.

Include Briarhill and Carnmore as settlements in the Galway Gateway Metropolitan Area.

This was proposed by Cllr. McDonagh, seconded by Cllr. Hoade and agreed.

On the proposal of Cllr. D. Connolly and seconded by Cllr. S. Walsh, it was agreed to suspend standing orders in order for the meeting to continue after 6.00pm.

Page 22 Section 3.4 (Typo error) 20015 to change to 2015.

Section 3.4. Include "When the allocated household numbers in any single settlement are constructed/built out, consideration will be given to increasing the allocation to that particular settlement, based on evident demand. The allocation to the overall tier shall, in general, be maintained."

Carnmore to be included in the Gateway Metropolitan area tier (figures for the overall tier to remain at 2800)

This was proposed by Cllr. M.Connolly, seconded by Cllr. Reilly and agreed subject to a similar provision to that included in the current plan in relation to variation of the allocations by be included.

The meeting was then adjourned for a short period.

On the resumption of the meeting Mr. Ridge referred the members to the Environmental Report of the Strategic Environmental Assessment of the Draft Plan and also to his earlier comments. He explained the background to the document and it's purpose and how the objectives and policies within the plan must be considered vis a vis their effects on the environment. Having been considered then each must also be assigned mitigation measures where appropriate. He explained that in certain areas the baseline environmental data was not extensive but that over time it would become available and the effects of the plans objectives and policies would in the future be evaluated against such data.

Mr. Ridge then resumed the consideration of the Galway County Development Plan Review – Response to Issues Arising at Electoral Area Committee Meetings document.

Page 23 Section 3.4.5. "Small Settlements / Rural Areas"
Include the settlements of Abbeyknockmoy, Belclare,
Carlistrane, Laragh More, Fohenagh, Killoran and

This was proposed by Cllr. Hoade, seconded by Cllr. Regan and agreed.

Derrydonnell Beg.

A number of members queried why settlements included in the last plan were not listed in the current draft. Mr. Ridge stated there was no planning activity in many of the cases and recent appeals to An Bord Pleanala where refusals were issued

influenced what should be included. He further stated he would raise no objection to the inclusion of others but cautioned that the members could be raising unrealistic development expectations in a lot of these areas.

CONFIRMATION OF MINUTES OF MEETINGS

1749

Minutes of Monthly Meeting held on 26th May, 2008.

The Minutes of the Monthly Meeting held on 26th May, 2008 were approved by the Council and signed by the Mayor on the proposal of Comh. Ní Fhatharta, seconded by Cllr. Mullins.

Arising from the Minutes, the following issues were raised:

In response to a query by Cllr. Burke, Mr. Cullen confirmed that a schedule of the cryptosporidium risks scores which had recently been reviewed would be circulated to the Members and that this would be done as soon as possible. He advised the Members that it was important that the information was not misinterpreted as the scores themselves were merely intended to assist in prioritising the schemes where either catchment management measures or water treatment measures should be taken to reduce the risks.

Cllr. Cuddy asked if there was any progress on the Part 8 Planning Process regarding the Claregalway, Milltown and Craughwell Sewerage Schemes and the Manager stated that progress had been made and that an official from the National Parks & Wildlife Service is to come to Galway to meet with Council Officials next week in order to finalise discussions regarding the ecological issues which they had raised regarding the proposals.

Cllr. O'Cuaig asked for an update on the following: Caisla Regional Water Supply Scheme, Carna/Kilkieran Water Supply Scheme Appointment of Consultants to the R336 - Bearna to Screeb Road via Ros a Mhil.

In relation to Caisla R.W.S.S, Mr. Cullen stated that An Bord Pleanála had approved the Environmental Impact Statement and it was expected that the Contract Documents would be submitted to the Department of the Environment, Heritage & Local Government. by August, for approval.

In relation to Carna/Kilkieran Water Supply Scheme, Mr. Cullen stated that a Feasibility Study would be undertaken to examine further source options in relation to the supply of water for the Carna/Kilkieran Scheme.

He also stated that the Preliminary Report for Roundstone Water Supply Scheme had been approved and it was hoped that the contract for the pipework would commence shortly.

The Manager stated that with regard to the R336, the Bearna to Screeb Road, it was hoped that Consultants would be appointed within a few weeks to design this project.

In reply to Cllr. Mullins, Mr. Lavelle confirmed that no response had been received from the Department of Environment, Heritage & Local Government to the Council's request for additional funding to complete works on the Kilconnell to Cappataggle Road.

In reply to Cllr. S. Walsh, Mr. Cullen stated that the site acquisition process for the Oughterard Sewerage Scheme had not yet been completed. He also stated that the

Department of Environment, Heritage & Local Government had asked the Council to make certain amendments to the Brief for the Appointment of Consultants for the scheme and that it was hoped that the revised Brief would be submitted to the Department for approval by August.

In reply to Cllr. Canney, Mr. Cullen stated that the recommended tender regarding the Tuam Town Water Supply Scheme would be forwarded to the Department of Environment, Heritage & Local Government shortly for approval.

Cllr. Reilly thanked the Council officials involved in arranging the taxi rank at Tuam, on behalf of the taxi drivers.

In reply to Cllr. T. Walsh, Mr. Cullen stated that Consultants had been appointed to prepare Contract Documents for the Glenamaddy Sewerage Scheme and these would be forwarded to the Department of Environment, Heritage & Local Government as soon as possible for approval.

Cllr. Finnerty stated that he wished to correct the Minutes of the Council Meeting of the 26th May, 2008 where he said that the Esker Riada was being destroyed not eroded.

Cllr. McDonagh stated that he wished to remind the Members that applications for the LAMA Awards should be completed and sent to LAMA. as soon as possible.

Report dated 16th June, 2008 was already circulated to each Member.

On the proposal of Cllr. Kyne, seconded by Cllr. Welby, it was agreed that the following public road be abandoned by the Council:

A 435 metre long section of the original route of the N59 Galway Maigh Cuilinn road in the townland of An tÁth Buí (T. Bearna) and An tÁth Buí (T. Maigh Cuilinn)

Cllr. Kyne stated that there was an illegal encampment at this location which posed a health and safety risk. He also stated that some horses belonging to the people encamped there were being tied to poles and complaints had been received from passers by who had concerns regarding the welfare of these animals. He stated that the families concerned had moved out from Galway City and that the City Council should make efforts to sort out this problem. He asked Mr. Gilmore, Director of Housing Services, for his comments on the situation and Mr. Gilmore stated that once the procedure for the Abandonment of the Road had been completed, action could be taken by the Council with the assistance of the Gardaí under the Housing Acts in order to remove the encampment off this road. He also stated that he was meeting with officials of the City Council the following week and he agreed to inform the Conamara Area Members of the outcome of his discussions with them regarding this matter.

NOMINATION OF CHAIR OF THE ROADS & TRANSPORTATION STRATEGIC POLICY COMMITTEE 1753

Report dated 17th June, 2008 was already circulated to each Member.

Cllr. McDonagh proposed Cllr. Canney as Chairperson of the Roads & Transportation Strategic Policy Committee, and this was seconded by Cllr. Mullins, and agreed.

DEVELOPMENT CONTRIBUTION SCHEME 2008

1754

The Mayor invited Mr Ridge to present the Draft Development Contribution Scheme. Mr Ridge referred to three documents circulated to the Members:

- An introductory letter,
- An explanatory memorandum which sets out the background calculations to
 the scheme and includes information on the procedure for preparing a
 contribution and details of the various projects that have been taken into
 account in the preparation of the background data for the scheme.
- Draft Development Contribution Scheme which updates the existing 2004 scheme.

He stated that he was seeking the approval of the Members to put the Draft Development Contribution Scheme on public display for 6 weeks to give the public an opportunity to make submissions. He explained that when the public consultation period was completed, the Manager's Report on the submissions/observation received would be prepared and submitted to the Members for their consideration and to make any changes they considered necessary.

He explained that the changes to the scheme were not substantial, the contributions included in the 2004 scheme for Sewerage, Water and Recreation & Amenity facilities were adjusted upwards in accordance with the rate of inflation over the past four years. He added that the scheme has been expanded to include provision for the payment of a roads and transportation charge, which will allow the Council to draw down national funds for important projects in the county.

Included in this is a \in 2,000 per car space equivalent per house, a car space equivalent being the number of cars that a development would generate.

He also added that the development contribution scheme of €100,000 per acre of development land for Recreation and Amenities for the development of five or more houses prepared for the Oranmore Local Area Plan is included into the general county development contribution scheme but still remains applicable to the Oranmore area only. The Oranmore Scheme would no longer exist if adopted in the new County Development Contribution Scheme.

He also added that the roads, footpaths and transportation charge had been included in the industrial commercial and other developments at a rate of $\[mathcarcent \in \]$ on Sub area 1 and $\[mathcarcent \in \]$ and $\[mathcarcent \in \]$ or Sub area 2 and $\[mathcarcent \in \]$ or Sub area 3. He stated that this was equivalent to the charge that was being levied in Athenry and Bearna.

Cllr McHugh queried if it was the case that if Local authorities did not have a certain amount of funding available that National funding would not be forthcoming for projects

He also referred to sub-area 2 and stated that the total development contribution charge for a single house was now $\leq 10,200$.

He acknowledged that the Local Authority was struggling financially but added that the new charges in this scheme was not the way to acquire funding,

He proposed that the scheme be rejected as it was imposing taxes on young people in the 20-30year old age bracket.

Mr Ridge stated that none of monies collected through the development contribution schemes were used to fund the running of the organisation; he added that it was specifically used for capital projects, the details of which were in the Explanatory Memorandum Draft Scheme Document.

He also stated that the benefit to each individual was estimated at €30,914

Cllr Cuddy stated that he understood that funding was required for roads projects but added that the proposed development contribution scheme was not acceptable. He queried as to why the water and sewerage charges were not standard across the county and added that he did not agree with the roads, footpaths and transportation charge being referred to as 'car park space equivalent'

Cllr Cuddy also inquired as to the amount collected under the Development Contribution Scheme for Oranmore.

Mr Ridge explained that the charges are based on the benefits people are getting. Charges in the weaker parts of the county have been reduced so as to make these areas more attractive for people to develop projects.

Mr Ridge explained that in relation to monies collected from the Oranmore Scheme a significant benefit would be seen over time.

Cllr Kyne referred to 'Distribution of Development' page 6 of the Draft Development Contribution Scheme 2008. He added that Moycullen had not received anything from Development Contributions monies and made particular reference to the lack of basketball facilities in Moycullen.

Mr Ridge explained that the weaker parts of the county were benefiting from the charges collected from other parts of the county and added that Moycullen had secured some benefits such as a waste water treatment plant and a children's playground.

Cllr Finnerty stated that there had been a 20% reduction in planning applications, twice the national average and queried if this reduction had been accounted for in the calculations of Draft Development Contribution Scheme.

Mr Ridge stated that the projected number of houses to be built over the period of the scheme was used and this projection was based on the housing strategy.

Cllr Canney asked if agreement was not reached on the Contribution Scheme where does the Council stand as regards drawing down National Funding. Mr Ridge stated that he did not know what the situation for the Council would be if local funding was not available to match that from Central Government but added that it would greatly enhance the Council position if local funding was available.

Cllr S. Walsh stated that he did not agree with Roads, Footpaths and Transportation Charge/ ϵ 2,000 per car space equivalent for the one off rural house. He understood that the development contributions were for the provision of services but added that the charge of ϵ 5700 in Sub area 3 was too much

Mr Ridge stated that there was no charge for services that were not available. Cllr. Burke asked if there was a formal instruction from the Department of Environment, Heritage & Local Government to all Local authorities on the amount of Development Contributions to be collected and added that Galway and the West of Ireland would be at a disadvantage due to the higher amount of development taking place in the east of the country.

Comh O'Cuaig stated that it was unfair loading all of the development contributions on young couples.

Cllr Joyce stated that he was not in favour of introducing a charge for roads, he added that a small percent of the population of the county would be funding a very important aspect of the Council's expenditure, roads and footpaths a service that would benefit everyone and added that these were people struggling economically and financially.

Cllr Carey stated that it was not a good time to introduce a charge for roads footpaths and transportation and added that it should have been introduced during the economic boom. He added that it was a tax on young people.

Cllr Keaveney also enquired as to what the Department of Environment, Heritage & Local Government are specifically requesting in relation to Development Contribution Scheme and how it affects drawing down of National Funds for important projects for the county.

Cllr Hoade asked if Development Contributions from other neighbouring local authorities were examined.

She also stated that the carparking in sub-area 1 of & 2,000 per car space equivalent was too high for the one-off house.

She also stated that the \in 100,000 per 0.404 hectares (1 acre) of development site for "Oranmore Area only" should read "Oranmore Plan Area only"

Cllr Mannion stated that if the one off rural house is providing car-parking spaces then carparking charges should not therefore apply. He also added that the cost of infrastructure was being placed on those that can least afford it and stated that it was not related to the ability of people to pay. He also stated that development contributions should vary in relation to the size of the dwellinghouse.

Cllr Regan referred to the availability of funding to maintain existing infrastructure. He also referred to the possibility of placing a smaller charge on all dwellings in the County annually.

Cllr Welby suggested changing the term "car space equivalent". He added also that paying development contributions per square metre of dwelling would be more equitable.

He also added that development such as wind turbines should not be subjected to the same charges as mobile masts.

Mr Ridge stated that the Council can only charge for the service that it provides.

Mr Ridge explained that there were no guarantees as regards Government funding but added that if funding could be matched locally it would leave the Council in a better position for drawing down funds from Central Government.

Mr Ridge agreed to examine the term, car space equivalent and explained that it is based on the number of cars a particular development will put on the road.

He also emphasised that the development contribution paid by an applicant is only a proportion of the benefit that they will get from the service provided.

He also stressed that all the monies collected through the Development Contributions Scheme would be used to fund Capital Works. The maintenance of existing roads was not funded from Capital monies.

He stated that it would be difficult to get full agreement on this scheme but suggested putting it on public display and to consider the scheme after the public display period together with the submissions/observations received.

He added that he would examine the possibility of charging per metre square of dwelling house.

Mr Ridge also outlined the development charges set by other Local Authorities for example; Kerry County Council was charging €13,000 per dwelling.

Cllr Hynes stated that he did not support the draft Development Contribution Scheme being put forward.

Cllr S Walsh stated that the scheme was unfair as it was placing charges on such a small base of people at the most demanding time of their lives, for the benefit of everyone.

Mr Ridge explained that the scheme only charged new development for the portion of any service that they used, so new development did not subsidise existing development.

Cllr M. Connolly stated that he was opposed to the charge for roads, footpaths and transportation and added that the development contribution charges should vary in accordance with different types developments.

The Manager stated that the Roads, Footpaths and Transportation Charge was introduced in an effort to pay for major capital works .She added that it was the only option available to the Council, otherwise funding would be from the Revenue Budget and based on what the commercial sector can be charged.

Mr Ridge stated that the 2004 Development Contribution Scheme, adjusted to allow for inflation plus the addition of a Roads Footpaths and Transportation charge was not unreasonable for the 2008 Development Contribution Scheme.

Cllr S Walsh proposed that there would not be a Roads Footpaths and Transportation Charge outside the villages in Sub Area 3. This was seconded by Cllr .Reilly.

On the proposal of Cllr Welby and seconded by Cllr Cuddy it was agreed to amend the Draft Development Contribution Scheme as follows:

In Sub Area 1 the Roads, Footpaths and Transportation charge is proposed as €10 per m² for houses up to 200m² or €15 per m² for houses over 200m², in Sub Area 2 the Roads, Footpaths and Transportation charge is proposed as €7.50 per m² for houses up to 200m² or €15 per m² for houses over 200m²

and in Sub Area 3 the Roads, Footpaths and Transportation charge is proposed as €5.10 per m² for houses up to 200m² or €15 per m² for houses over 200m²

It was proposed by Cllr Canney and seconded by Cllr Finnerty to put the Draft Development Contribution Scheme as amended by Cllr Welby on public display. Cllr McHugh rejected Cllr Canney's proposal to put the amended Development Contribution Scheme on public display.

A vote was taken on Cllr. Canney's proposal and the result of the vote was as follows:

The County Secretary reminded the Members that there were still some places available for the Seminar to be held on 7th July, 2008 in Limerick regarding the Green Paper on Local Government Reform.

Mr. Ridge confirmed that the Draft County Development Plan would be on the Agenda for the July Meeting and he informed the Members that a Workshop had been arranged for the Members at the Claregalway Hotel on Wednesday 2nd July 2008, to open the debate on the Draft County Development Plan 2009-2015. He stated that among the items to be discussed are the Strategic Environment Assessment and its implications, the County Spatial Strategy and County Settlement Strategy and Ardaun Strategic Development Concepts.

MAYORS BUSINESS

1757

On the proposal of Cllr. Mullins, seconded by Cllr. Mannion, it was agreed that the July Monthly Meeting of the Council be held on Monday, 21st July, 2008 at 2.30 p.m.

It was pointed out that an item regarding the Bridge at Leenane which needs to be put before the Council in July may not be ready for the Meeting of the 21st July and that a further Special Meeting may be required for this item the following week. This will be decided at the meeting on July 21st.

Cllr. Hoade asked if the Draft Byelaws for Beaches and Personal Watercraft would be on the Agenda for the July Meeting and the County Secretary stated that they would not be on the Agenda for the July Meeting. Cllr. Hoade also stated that concern had been expressed regarding the practice of some people of bringing their horses down to piers in the Oranmore Electoral Area and washing the animals there. She asked if the Council would make provision in the Draft Bye-Laws to prohibit same. The Manager stated that this issue would be checked out and the Members informed.

Cllr. Carey asked if the Council could confirm which piers in the County were private and which public and the Manager stated that the Members would be given this information as soon as possible.

Cllr. Joyce proposed the following Motion be passed by the Council and be forwarded to Minister Éamon Ó Cuiv and Táiniste Mary Coughlan.

"In view of the increasing numbers coming on the Live Register of Unemployed, particularly from the construction sector, Galway County Council calls on the Government to make the following decision:

Arising from the minutes, the following issues were raised:

Cllr. Welby stated that at the last monthly meeting that the Bio Diversity Action Plan had been adopted without much debate and as such he wondered whether it could be adopted as a working plan and put back on public display.

The Mayor pointed out that is was not in order to do so in view of the fact that the plan was seconded and agreed for adoption at the last Council Meeting.

Mr. Ridge pointed out that it had gone before the SPC and that any changes to the plan were agreed at SPC level prior to submission to the full Council.

Cllr. Welby wished to know if the National Parks and Wildlife Service were aware of the new protocols contained in the plan.

Mr. Ridge said that he could not see any difficulty with the NPWS not accepting a protocol.

In reply to Cllr. Cuddy, Mr. Cullen said that a very detailed response had been sent to the NPWS in relation to the queries raised by them in relation to the 3 Part 8's but that no response had yet been received. He said that the costs of the ecological survey would form part of the overall capital costs which would be mostly funded by the Department but that the Council would also pay towards the cost under the polluter pays principle. Mr. Cullen advised that the approach being taken by the Council is to pursue one scheme in particular detail which will provide the template for others in order to avoid a similar situation in the future.

In response to Cllr. M. Connolly, Mr. Cullen confirmed that the Milltown Scheme was being used as the template.

In response to Cllr. Fahy the Mayor advised that the resolution regarding the WTO passed at the last Council Meeting had been forwarded to the Department of Agriculture.

In response to Cllr. Hynes, Mr. Ridge confirmed that to date no application for planning permission had been received in respect of an Incinerator or a Sludge Plant for Tynagh. If such applications are received Mr. Ridge confirmed that they will appear on the weekly planning lists, which are emailed to the Members. Cllr. The Report of the Tuam Area Committee Meeting held on 13th March 2008 was considered. It was adopted by the Council on the proposal of Cllr. McHugh and seconded by Cllr. Reilly.

Arising from the Report, Cllr Reilly referred to the condition of the R332 road at Ballygaddy Road, Tuam. Mr. Morgan in response confirmed that the roadway would be reinstated under a Water Services Contract.

Cllr. McHugh asked what was the situation with the tenders received for the Tuam Town Water Services Project. Mr. Cullen said that the tenders received were being assessed. He said that as one of the tenders was likely to be excluded, there was a legal requirement on the council to obtain legal opinion before submitting the tender recommendation to the Department for approval.

Cllr. T Walsh sought clarification on whether a CPO for a stretch of the Dunmore and Glenamaddy road could proceed without the funding being in place first. Mr. Morgan said that the CPO process is a legal requirement and that funding would have to be place before commencing the process.

The Report of the Ballinasloe Area Committee Meeting held on 10th April 2008 was considered. It was adopted by the Council on the proposal of Cllr. Mullins and seconded by Cllr. Joyce.

In reply to Cllr. Joyce, Mr. Morgan advised that no overlay grants were received to address the stretch of road on the N6 from Garbally Gates to Portiuncula Hospital and that an application had been made to the NRA.

Cllr Mullins referred to a shortfall of €285,000 to complete the Kilconnell to Cappataggle road. Mr. Morgan confirmed that funding will be sought from the Department of Environment.

In reply to Cllr. Finnerty, Mr. Kelly said that the issue of Esker Riada erosion is under the remit of Ballinasloe Town Council and is being followed up.

TO CONSIDER REPORT UNDER PART 8 OF THE PLANNING AND DEVELOPMENT REGULATIONS 2001 – CONSTRUCTION OF A SINGLE RURAL HOUSE AND EFFLUENT TREATMENT SYSTEM AT CILL MHUIRBHIGH, INIS MOR, ARAINN, COUNTY GALWAY 1705

Report dated 22nd April, 2008 was already circulated to each Member

On the proposal of Comh Ni Fhatharta, seconded by Comh O'Cuaig, the proposed construction of a single rural house and effluent treatment system at Cill Mhuirbhigh, Inis Mor, Arainn, County Galway was approved.

Report dated 20th May, 2008 was already circulated to each Member

Cllr. Kyne proposed that the vacancy on the Lough Corrib Navigation Trustees be filled by Mr. Paul Stewart, Ardvarnagh, Oughterard, Co Galway and this was seconded by Cllr. Carey and agreed.

FILLING OF CASUAL VACANCY ON THE GALWAY COUNTY COMMITTEE OF AGRICULTURE & RURAL DEVELOPMENT (CCARD)

1707

Report dated 13th May, 2008 was already circulated to each Member

Cllr. M Regan proposed that the Casual Vacancy on the Galway County Committee of Agriculture & Rural Development (CCARD) be filled by Cllr. M Connolly and this was seconded by Cllr Reilly and agreed.

APPOINTMENT OF 2 MEMBERS TO THE COUNTY GALWAY LOCAL SPORTS PARTNERSHIP 1708

Report dated 29th April, 2008 was already circulated to Each Member.

Cllr. Reilly proposed that Cllr Mannion be appointed as a member to the County Galway Local Sports Partnership this was seconded by Cllr. Joyce and agreed.

Cllr. Mannion proposed that Cllr D Connolly be appointed as the second member to the County Galway Local Sports Partnership this was seconded by Cllr. Feeney and agreed.

TO CONSIDER AND ADOPT GALWAY COUNTY COUNCIL APPOINTED STANDS (STREET SERVICE VEHICLES) TUAM BYE LAWS 2008 1709

Report dated 20th May, 2008 was already circulated to Each Member.

On the proposal of Cllr. Reilly and seconded by Cllr. M Connolly, the Galway County Council Appointed Stands (Street Service Vehicles) Tuam bye laws 2008 were adopted.

HOUSING ALLOCATION NOTIFICATION

1710

Report dated 7th May, 2008 was already circulated to Each Member.

Mr. Gilmore stated the Housing Unit had recently been notified of its capital Housing Allocation for 2008. He said that the Council had requested €34m for its Social Housing Programme but that the allocation received is only £23.6m. He said that for the Remedial Works Programme the Council had planned between £4-5m but the allocation is £2m. He stated that that there would be a shortfall of between £8m to £12m in the Housing Programme overall for 2008.

The Members expressed their concerns at the shortfall in funding pointing out that it would effect the most vulnerable in the community.

A number of issues were raised by the members and Mr. Gilmore responded as follows:-

- There was no shortage on the supply side of the Affordable Housing but there were difficulties with affordability for certain applications
- The number of starts proposed in the Multi Annual Programme for Social and Affordable Housing for the period 2004-2008 was 850.
- It is expected that the Council will provide 750 of those units. The balance will be provided for by the Part V and Voluntary Housing Schemes.
- Any vacant stock which requires repair will be targeted and relet as soon as possible.

REMEDIAL ACTION PROGRAMME FOR PUBLIC DRINKING WATER SUPPLIES AND REMEDIAL ACTION PROGRAMME BORROWING APPROVAL €20M 1711

Report dated 20th May was already circulated to each member.

It was proposed by Cllr. S Walsh, seconded by Cllr. Hoade and agreed that the Remedial Action Programme for Public Drinking Water Supplies and Remedial Action Programme borrowing of €20m be approved.

Arising from the Report, Cllr Burke said that it had taken 9 years to get a water scheme for Portumna. He said the County had been let down collectively over the years in relation to the provision of water and waste water infrastructure. He said that there was a high risk of cryptosporidium in our waters. He said that he felt that the vulnerable were at risk in the 34 Public Water Supply schemes identified as needing remedial work by the EPA.

Mr. Cullen said that Cryptosporidium is a recent issue for Local Authorities as the illness associated with it, cryptosporidiosis, had only became a notifiable disease since 1st January 2004. He said that drinking water regulations and standards had changed and many local authorities found themselves having to cope with the higher standards while relying on quite dated infrastructure. Historically the investment emphasis had favoured roads ahead of water and wastewater services. He said that the water quality results for the public water supplies were routinely good but the emphasis now was to further minimize risks to supplies. That was the purpose of the Remedial Action Programme before the council.

He said that the HSE is responsible for reporting cases of cryptosporidiosis. He stated that much of the supply of water for County Galway and other Western Areas is from surface sources and that this is very hard to treat. He said that in the EPA report an area could have a high risk because of its water source but a low potential score because of the level of water treatment.

Cllr Burke said that the scoring system was weighing heavily against the old infrastructures in the County.

Mr. Cullen said that the method for calculating the risk score is determined in the guidance book provided by the EPA and that the Council is complying with this. He said that by virtue of the types of source from which supplies are taken and the population served, it was possible to get a high result even where there is a modern treatment facility and there was potential for misinterpretation of the risk scores. He stated that the remedial action programme is to protect the source of water, improve treatment facilities where necessary and so decrease the associated risks.

On the proposal of Cllr. Welby and seconded by Cllr. Mannion it was agreed to suspend standing orders in order for the meeting to continue after 6.00pm.

Comh O'Cuaig said that the Costello and Carraroe schemes would need to be sorted out soon and that he doubts if the funding allocated in the action programme would be adequate for the two schemes.

He said he wanted to know where the Councils 25% contribution was to come from and when the remedial works on Roundstone would be carried out.

Cllr Mannion said it was important when making statements to the media that the full information is made available at Council meetings.

He said water quality was a sensitive issue and that it was important that the correct message is sent out to the public that the water is safe.

Cllr. Cuddy said that credit should be given to the Water Services Department of the Council and that it is the HSE that lays down the guidelines. He said he was optimistic that the boil notice in Clarenbridge would be lifted in the near future.

Cllr. Mullins said that unless the HSE dictate otherwise it was important that the message that the water was safe to drink was put out in the public domain. He said that the €20m loan should be approved for the remedial works action programme but he hoped that there would be no further cuts in funding from the Department.

Cllr Welby wanted to know what the risk status for Oughterard was now given that the report before the Council says that there is high aluminium content. He asked if the Council was looking at other low risk sources of water supply rather than Lough Corrib for Oughterard.

Cllr. T Walshe asked could people be as confident of drinking water as they were two years ago and do people need to boil the water in the areas that are listed as high risk

Cllr. Hoade asked how many boil notices were there in place in the County at the moment and requested that the Director issue a statement to the media stating that the water is safe.

The Mayor said that a boil notice is only put in place where necessary and it done by an independent agency. He said the issue is about managing the risk associated with water supply. He said he was confident that the executive would put in place a policy to deal with the risk.

Mr. Cullen responded to the issues raised as follows:-

- There were two boil notices in place in the County at the moment one in Clarenbridge and the other in Roundstone.
- The notice in Roundstone will remain in place until the scheme is connected to the Carna Kilkerrin scheme.
- Discussions with the HSE are currently taking place regarding Clarenbridge and the relevant Members will be updated once there are any developments.
- If there is a requirement to boil the water in an area then the Council will
 directly notify the public with leaflet drops. The requirement to boil the water
 is given by the HSE.
- Water Conservation measures were important and there was a need to reduce leakages. There was a high leakage in Spiddal from the group water supply that is being served from the public supply and measures would need to be put in place to address this.
- The Oughterard Public Water Supply was deemed to be a high risk because of its location. The Councils funding of 40% for the advanced works would be funded from development contributions which are an exhaustible source.
- There was no ranking for the programme of work and that all are urgent and will proceed together. Most of the works will be completed by the summer of 2009.

Comh Ni Fhatharta said it was unfair that An Bord Pleanala kept deferring the planning decision on the Costello Regional Water Supply scheme.

She proposed that "Galway County Council object to the manner in which the Costello RWS has been dealt with by An Bord Pleanala. Numerous dates have been given for a decision that is still awaited and that no Local Authority should be treated with such disrespect" this was seconded by Cllr. S Walshe and agreed.

ADOPTION OF THE (CILL RÓNÁIN HARBOUR & CILL ÉINNE HARBOUR) EXPLOSIVES BYE LAWS 2006, AS AMENDED MAY 2008

1712

Report dated 20th May was already circulated to each member.

On the proposal of Cllr. S Walshe and seconded by Cllr. Conneely the (Cill Rónáin Harbour & Cill Éinne Harbour) explosives bye laws 2006, as amended May 2008 were adopted.

Arising from the Report, Comh O'Cuaig asked was the figure of € 800,000 for security for this development correct and if so could this figure be looked at.

Mr. Morgan said that the figure was correct but that this was a result of the directions received from the Garda Siochana. He said that there were other costings such as health & safety issues that were included in this figure.

Comh O'Cuaig proposed that "the figure of €800,000 for security at Cill Rónáin, Inis Mor, during the reconstruction of the Pier seems to be excessive and that Council calls on the Garda Commissioner to comment on this matter", this was seconded by Cllr. Welby and agreed.

AUDIT REPORT ON THE ACCOUNTS AND ANNUAL FINANCIAL STATEMENT OF GALWAY COUNTY COUNCIL FOR YEAR ENDING 31ST DECEMBER, 2006 1713

Report was already circulated to each member.

On the proposal of Cllr. Hoade and seconded by Cllr. S Walsh the Audit report on the accounts and Annual Financial Statement of Galway County Council for year ending 31st December, 2006 was approved.

Mr. Mullarkey pointed out that the audit report had highlighted three areas:

- 1) Commercial Water
- 2) Capital Projects Review
- 3) Development Contribution

The collection rate for water charges was low he said and the Council had highlighted its concerns to Celtic Anglican who are the collecting agency on the Councils behalf.

The audit report was requesting the Council to review its capital balances and to highlight the areas where there are unfunded balances.

In response to Cllr. Cuddy, Mr. Mullarkey said that the €16.5m development contributions received have been allocated to the various programme groups in accordance with the scheme.

Cllr. Joyce asked if the money had been spent in accordance with the 50% rule which meant that half of what was collected in an electoral had to be spent in that electoral area.

Mr. Mullarkey replied that over the five year period that would be the case.

TO APPROVE AMENITY GRANTS 2008 (4TH ROUND ALLOCATIONS) 1714

Report dated the 26th May 2008 was already circulated to each member.

On the proposal of Cllr. Mannion and seconded by Cllr. Reilly the Amenity Grants 2008 (4th round allocations) were approved.

TO APPROVE COMMUNITY BASED ECONOMIC DEVELOPMENT FINANCIAL ASSISTANCE SCHEME GRANTS 2008 (4TH ROUND ALLOCATIONS) 1715

Report dated the 26th May 2008 was already circulated to each member.

On the proposal of Cllr. Regan and seconded by Cllr. S Walshe the Community based Economic Development Financial Assistance Scheme Grants 2008 (4th round allocations) were approved.

TO APPROVE OVERDRAFT ACCOMMODATION FOR 6 MONTHS 01/07/08 -31/12/08 1716

Report dated the 26th May 2008 was already circulated to each member.

On the proposal of Cllr. Joyce and seconded by Cllr. Ml Connolly the Overdraft accommodation for 6 months 01/07/08 - 31/12/08 was approved.

EVENTS TAKING PLACE ON THE PUBLIC ROAD (MOTOR SPORTS / RALLIES) 1717

Report dated the 20th May 2008 was already circulated to each member. Arising from the Report, Cllr Hoade asked how the amount of the deposit is decided upon and has it been called into use in the past.

Cllr. Joyce proposed that a policy document be drawn up at the SPC meeting and that the report already circulated would form the basis for the policy document in relation to events taking place on the public roads (motor sports/rallies). This was seconded by Cllr. Reilly and agreed.

Cllr. Mannion proposed that "the Chair of the Roads and Transportation SPC should attend any meeting with the Rally organisers, Gardai and the Council executive in relation to rally events on the public roads.

Cllr. Mannion also said that the €5000 deposit was not sufficient for the repairs required. He proposed that "the area engineer should examine in detail the damage done to the road surface on the Rally route with a view to costing same and having funding made available for repairs", this was seconded by Cllr. Reilly and agreed.

Cllr. Mullins said that the rally organisers would need to ensure that the followers of the rally are sufficiently controlled by the Gardai and the organisers. He said he does not agree that the route should be the same every year and he would like to see it rotated around the County.

TO CONSIDER THE MANAGER'S REPORT ON THE SUBMISSIONS
RECEIVED REGARDING THE REVIEW OF THE COUNTY
DEVELOPMENT PLAN 2003-2009 AND THE PREPARATION OF A NEW
COUNTY DEVELOPMENT AND STRATEGIC ENVIRONMENT
ASSESSMENT AS PER SECTION 11 (4) OF THE PLANNING AND
DEVELOPMENT ACT 2000.

1718

The Mayor invited Mr Ridge to present the Manager's Report. Mr Ridge explained that the Manager's Report on the submissions received regarding the review of the County Development was circulated to the Members on 9th May 2008 as per Section 11 of the Planning and Development Act 2000. He also added that the process was restarted as the initial public notification did not make reference to Strategic Environment Assessment which did not comply fully with the

Regulations. For future certainty regarding the validity of the plan especially for major projects later on it was agreed to restart the process.

98 submissions were received during the initial review period 4 May 2007 to the 29 June 2007 and 74 submissions were received during this review period 22 February 2008 to the 18 April 2008 one of which related to the Strategic Environment Assessment. He added that all of the same issues had been raised again as in the first review stage.

During the last review stage Electoral area meetings and SPC meetings were held where directions were received from the Elected Members on how to proceed with the County Development Plan.

Mr Ridge stated that Ms McConnell would present the Manager's report or otherwise direction could be given to proceed with the preparation of the Draft Development Plan which would be considered at a later date.

Cllr Walsh proposed that a Full Council Meeting would be necessary for the consideration of this issue alone.

Cllr McHugh questioned the need for discussion at this stage and proposed that the Draft County Development Plan be prepared first. This proposal was seconded by Cllr Finnerty and agreed.

Cllr Mannion queried that if a Draft Plan was prepared without this initial consideration, would it be more difficult for the Members to change it at draft stage. Mr. Ridge stated that this would definitely not be the case. The draft development plan would be prepared and the SEA would accompany the Draft and the implications of this identified. The Draft plan would then be presented to the Members for their consideration where it can be examined line by line. Mr. Ridge stated that the Draft Development Plan would be ready by 1st July, however it would need to be adopted at the July meeting in order to meet the deadline of May 2009. Mr. Morgan advised that Part 8 for Leenane Bridge needs to be submitted to the members at 28th July meeting as the process to be undertaken will not be completed on time for a Council meeting on 21st July. As there is no meeting in August he considers that the September meeting will be very late to deal with this issue. Mr. Ridge pointed out that the Draft Development Plan would be discussed at the Area Committee Meetings and Planning SPC meeting prior to submission to the full Council.

Cllr Regan requested that the draft plan be in a simplified form and easy to understand and that the interpretation of the Plan was crucial.

It was agreed to finalise the time and date of the July Council meeting at the monthy Council Meeting in June and also whether a special Council meeting would be required for the consideration of the Draft Plan.

SERVICE INDICATORS

1719

Report dated the 21st May 2008 was already circulated to each member.

Mr. Kelly referred to the report which was circulated to the members. He said that it allowed the members to compare the Councils performance year on year and that the changes in the format of the indicators were as a result of changes at National level.

Cllr. Regan enquired about the reduction in pre planning meetings.

Mr. Ridge in response said that this was due to the volume of work, staff shortages and the lack of suitably qualified people available to recruit at the time.

Cllr. Regan asked if there were any pre planning meetings taking place currently.

Mr. Ridge said that for any major project pre planning meetings are always held.

MANAGERS BUSINESS

1720

The Department of the Environment Circular on the Disabled Persons and Essential Repairs Grants was circulated to the members.

Mr Gilmore said that when the circular is examined in more detail that he would bring a full report before the members.

Cllr Reilly said that a HSE circular of April 08 stated that the Housing Scheme for the elderly would only be operated by them until June 08 after which it would be transferred over to the Local Authority. He said that there was confusion amongst people as to who they should be applying to and that clarification is needed on this.

Cllr Mannion said that the HSE were still accepting applications for this year for the scheme.

Mr. Gilmore said that he was not aware that the HSE were still accepting applications and that he would contact them to clarify the issue.

MAYORS BUSINESS

Cllr. Mannion proposed that "this Council recognises that in adopting the EU Lisbon Reform Treaty that the best economic and social interest of Ireland and the E.U will be served. This was seconded by Cllr. Ml Connolly and agreed.

Comh O'Cuaig and Cllr. T Walshe pointed out that they wished to be disassociated with this proposal.

The Mayor complimented Mr. Gilmore and his staff and in particular Ms. Angela Holian, Town Clerk for the excellent facilities provided in the Town Hall.
