MANAGERS BUSINESS

The Manager referred to the flooding crisis currently being experienced in many parts of the County due to the recent heavy rains.

She paid tribute to staff both indoor and outdoor who were working all weekend. She also paid tribute to the Civil Defence, the Gardai, the HSE, and all community volunteers. She said an Emergency Aid Package was requested to assist home owners. She also referred to the visits made by the Taoiseach and Minister Gormley

She sympathised with all those inconvenienced, and those whose businesses, homes and farms were flooded

She advised the Members that The Crisis Management Team convened on Thursday morning 19th November 2009 at 11.00am as a precautionary measure to deal with rising waters in some areas notably Craughwell and Claregalway. Since then Galway County Council and Ballinasloe Town Council are working with the; Gardai, Civil Defence, Army, NRA, PPP Company, Air Corps, Local Volunteers, HSE, OPW, Met Eireann, and the ESB, in order to deal with the flooding emergency.

She referred to the map which was displayed on the screen showing many flooded roads and pointed out that this was being updated regularly and was on the Council's Webside.

The main emergencies being dealt with are;

Public Health Risks associated with the water supply in Ballinasloe.

- A boil notice has been put in place and will remain in place until further notice.
- Water is being distributed to vulnerable groups.
- The water supply plant is being manned on a twenty four hour basis in an effort to ensure supply is maintained.
- All water supplies around the County are being monitored.

Evacuation

A number of evacuations have been necessary including the following:

- 1 family airlifted in Gort by the Air Corps
- 35 40 persons in Ballinasloe and 2 families in Craughwell were evacuated by the Civil Defence
- The Housing Section of Galway County Council assisted with the evacuation of 13 families in Athenry and 30 families in Claregalway
- Numerous other families are self evacuating.
- A further 25 families are on standby in Claregalway at present as water levels remain at a high level

Resources deployed

Approximately 180 outdoor staff and 70 indoor staff from Galway County Council and Ballinasloe Town Council were deployed to deal with the emergency with assistance from the Army, Gardai and the Civil Defence to deal with the following;

- Erecting signage on major routes and manning diversions
- Continuously monitoring Road maintenance and raising road levels where possible
- Filling and distributing sand bags

She advised that OPW have been asked to carry out an analysis in an effort to avoid a similar reoccurrence.

She also thanked the Unions for their suspension of strike action planned for tomorrow in respect of the staff of Galway County Council

We are very grateful, she said, to the NRA and the PPP Company on the M6 who facilitated the opening of sections of the M6 with the assistance of the Gardai and staff of Galway County Council.

We are also very grateful to all our suppliers who provided essential supplies and equipment at very short notice.

Transportation

The flooding has severely impacted on road transport throughout the area. The N6 (Galway – Dublin) was blocked from 4.00pm on Thursday 19/11/09 to Monday morning 23/11/09. A bypass in the M6 (new motorway) between Galway City and Loughrea for emergency vehicles was quickly arranged on Thursday evening 19/11/09. In Friday 20/11/09 the facility to use the bypass was extended to private vehicles and a bypass of Ballinasloe on the M6 was also opened as the bridge on the N6 there also became unusable.

The Council is very grateful to the N.R.A., Department of Transport, National Roads Design Office in Galway, the Garda Siochána and in particular to the cooperation and hard work of the N6 Construction for the speed and vital response received. The N17 National Primary Route is also blocked due to the Clare River bursting its banks at Claregalway Village. The only viable and accessible alternative for North Galway traffic is via the N84 National Secondary Route which is flooded but passable with extreme caution.

The Council has allocated in excess of 180 outdoor workers to deal with the flooding issues. The Civil Defence have deployed all available resources and are continuing to do so. Army personnel and vehicles have also been deployed where necessary and are on standby if required. The Council has also facilitated local voluntary groups and used local expertise and knowledge and will continue to do so until the crisis is over. Local communities and voluntary groups have for instance assisted in the filling, distribution and placing of sandbags throughout the County. Galway City Council is supplying them with resources such as sandbags, sand etc. The Garda Siochána have also deployed major resources and continue to work with the Council and the Crisis Management/Coordination Team.

The following major routes are currently still impassable.

N6 at Ballinasloe

N6 between Portumna and Tipperary Border.

N63 Galway to Roscommon Road between Loughgeorge and Annagh Cross Ballymoe to Castlerea Road.

N18 Galway to Gort Road at Crowe Street Gort, at Kiltartan and at Labane.

R333 Headford to Tuam

NI7 Galway to Tuam at Claregalway.

R349 Loughrea to Athenry Road

R339 Galway to Monivea from Carnmore Cross to Monivea

The structure of the Major Emergency Plan has been utilised she said, to mobilise resources and has been very successful in ensuring cooperation and communication in the day to day management of the crisis.

This event has certainly tested the emergency procedures and abilities of the Principal Response Agencies to deal with it. The extent of the area where the flooding has impacted covers approx 350,000 hectares (1350 sq miles, 860,000 acres) and was shown on the map displayed on the screen.

The principal cause of the flooding emergency has been the recent heavy rain fall over land which has been inundated over the summer and where water tables, lakes & rivers have remained at a high level.

The N17 and N84 have been blocked by waters draining the North of County Galway via the Clare River and the Lough Corrib which also drains most of Conamara Significant periods of rainfall and existing high lake levels have over spilled at Claregalway and on the N84 (Headford Rd). Raising the road level of the N84 will solve the problem on the route. However the problem at Claregalway will not be easily resolved. A bypass of Claregalway either as a stand alone route or at the M17/M18 Gort to Tuam is the only effective long term solution.

The risk to property at Claregalway will not be reduced by these measures and a wider solution involving the Clare River or Lough Corrib will be necessary.

The town of Ballinasloe will require more extensive investigation in relation to flooding.

Flooding at Craughwell tends to be more rapid in nature and may be dealt with by channel or bridge improvements at Craughwell

The Manager said she wished to take this opportunity to thank those who assisted over the past few days:

- The agencies eg. Gardaí, Army & HSE
- Civil Defence for their trojan work in Ballinasloe and throughout the County in assisting
 with evacuations, filling and distribution of sandbags, transportation of evacuees and
 other people who needed assistance and distributing water where necessary.
- Local volunteers around the County
- Elected Representative who assisted
- Council Staff, throughout the County, who worked tirelessly for long hours to deal with the requirements generated by the emergency.
- The media for providing public information throughout this difficult time.
- Members of the public for their patience and forbearance at a time when our resources
 are stretched and for complying with the advice given by the Council in relation to travel
 arrangements.

MAYORS BUSINESS

167

The Mayor afforded Members time to comment on the flooding issues of the last week. He asked if comments/issues could be kept to a minimum of 3 minutes.

The Members thanked the Manager and Staff for the courteous way in which they dealt with the public and also for the very long hours worked. They also thanked the Army, the Civil Defence and the ESB and HSE for their hard work.

The following are the main points raised by the Members

- The OPW, Galway Council and the National Parks & Wildlife need to work together to find a solution
- Reference was made to the difficulty experienced by people trying to get to work due to the number of impassable roads.
- Hardship was experienced by a large number of families, house owners, farmers and businesses where flooding occurred.
- Thanks were expressed to the N6 Construction Company for giving access to part of the M6 due to the closure of parts of the N6.
- Private Contractors who worked over and above call of duty were also thanked.
- Call on Government to come up with an Emergency Aid Package to assist home owners and farmers who had lost animals and winter fodder, and to assist with the clean up. Finance also required for funding to repair roads and bridges damaged by the flooding
- It is important that the Members do not zone lands liable to flooding.
- The drains and watertables need to cleaned regularly.

It was proposed by Cllr. Mullins, seconded by Cllr. Canney and agreed

"That Galway County Council calls on the Government to put in place a significant Emergency Aid Package for County Galway, to alleviate the significant hardship suffered by many homeowners, farmers and businesses throughout the County. The Government response should include funding to the Local Authority to repair roads and bridges, as well as putting resources in place for preventative measures to stop a recurrence in the future".

The Mayor thanked the Manager and staff and all the Members for their contribution to the Meeting.

The Manager in response said that quite a number of issues had been raised e.g.

- Resources
- Long Term impact
- Drainage Maintenance
- · Working with the OPW.

These issues will be addressed when the immediate problems are resolved.

Cllr Mullins referred to his NOM no 24 for today's meeting and he proposed that the Council calls on the Government to continue the Rural Transport Programme, as it provides a basic service to many elderly people who live in areas where there is no other Public Transport. This was seconded by Cllr Canney and it was agreed that the resolution be forwarded to the Minister for Transport and the Minister for the Environment, Heritage and Local Government.

WATER SERVICES ASSESSMENT OF NEEDS 2009

121

Report dated the 19th October 2009 was circulated to each member.

Mr. Cullen stated that since the completion of the last assessment there have been significant changes in the economic climate, and the introduction of more stringent requirements to achieve greater environmental sustainability. The Department issued circular L6/09 dated the 17th July 09 requesting the preparation of a Needs Assessment for 20009, which will be used to facilitate the preparation of a Water Services Investment Programme (WSIP) for the period 2010 – 2012. The completed Needs Assessment must be submitted to the Department by the 23rd October, 2009.

He said that while there are a considerable number of schemes in County Galway that require advancement, it is a requirement of the current circular to delineate proposals into those that are a priority for construction over the coming years and those that would need to be advanced once the first group are completed. The circular emphasises that schemes on the current WSIP will not automatically be included in the new WSIP.

He stressed that the future implications of any capital programme for Galway County Council will have an impact on its progression. Typically the funding breakdown between the Department and Galway County Council varies from 55: 45 to 75: 25. The element to be funded by the Council must come from either accumulated development levies or be recouped through the non domestic water charge. For

example the Tuam Town WS & MD scheme which is due to commence construction shortly is expected to be funded 64.3% by the Dept and 35.7% by the Council. This will mean that the Council will have to fund approximately € 10m of this project alone.

He said that the current system of water services funding carries a burden that the Council will find difficult to sustain and may in fact render the Water Services Capital Investment Programme unaffordable.

He referred to the four categories into which all schemes had to be categorized. Under each category two lists of priorities schemes are provided. The first list of schemes contains those that should progress to construction within the next three years, i.e. 2010 to 2012. The second list provides those schemes that will progress through planning over the next three years. He drew the Members attention to the list of prioritized schemes on Pages 15,16 & 17 on his report.

While acknowledging that it was important to have an Assessment of Water Services Needs, members expressed frustration at how long it takes to get schemes through planning and on to construction. They raised queries in relation to the current status of various schemes and Mr. Cullen replied on the status of each. They also raised concern about the capacity of the council to fund the portion of cost not covered by the Department of the Environment.

Cllr D Connolly proposed: that in the event that water would be extracted from the River Shannon that Galway County Council would pursue payment of a financial dividend which would be ring-fenced for water quality improvements in the Shannon River basin area of County Galway, such schemes would include Eyrecourt Sewerage Scheme, Mountbellew Sewerage Scheme, Ballygar and Ahascragh Sewerage Scheme, Caltra Sewerage Scheme, Ballinasloe Regional water Supply Scheme etc. This was seconded by Cllr T. Mannion and agreed.

TO APPROVE OVERDRAFT ACCOMMODATION OF €35MILLION FOR THE PERIOD 01/01/2010 – 30/06/2010 122

The Manager said that the decision of An Bord Pleanala to grant planning permission for the Eastern part of the Galway City Outer By Pass was heard in the High Court recently and that both challenges were unsuccessful. She said the question of leave to appeal to the Supreme Court and the question of legal costs have been adjourned to 6th November, 2009.

She advised that, under the Incentivised Early Retirement Scheme, the Council will be losing members of staff over the next few months and there will be an element of redeployment. A number of staff has applied to avail of the scheme including Mr. John Morgan, Director of Services, Roads & Transportation Unit who will be retiring in November and therefore this will be his last Council meeting. She paid tribute to Mr Morgan and said that he had overseen many major infrastructural developments in the County and without his interest and diligence these projects would not be at such an advanced stage. She thanked him for his service to Galway County Council.

The Mayor and Members also paid tribute to Mr Morgan and thanked him for his contribution to Galway County Council.

Cllr Roche requested a public light at the recycling facility in Monivea following its relocation from Athenry.

It was proposed by Cllr Kyne, seconded by Cllr Welby and agreed that "We the members of Galway County Council again give our full support to the Galway City Outer Bypass in light of the recent court decision to dismiss objections to the previous Bord Pleanála decision to grant approval for the planned road to Bushypark. Furthermore, we the Members recognize the importance of this project to Conamara, Galway City and as a vital link with the soon to be open M6 motorway." It was agreed that a copy of the Resolution be forwarded to the Minister for the Environment, Heritage and Local Government and the Minister for Transport.

It was proposed by Cllr T. Mannion, seconded by Cllr. T. Broderick and agreed that "we request Minister Dempsey to investigate the role of the NRA in relation to ongoing problems with the local community and N6 Concessions as there appears to be a total lack of supervision and enforcement of the contract between N6 Concessions and the NRA leading to a serious lack of respect for the wider community."

Cllr McClearn requested that the amount of literature being sent out to the members from the Council be examined by the CPG.

In relation to queries raised by the members Mr. Ridge said that he would check with the NPWS regarding their requirements for the assessing of new ESB poles.

Responding to issues again raised in relation to the alleged unauthorized development at Kilskeagh, the Manager said that it is the Councils intention to follow up this matter in an appropriate manner.
