In response to a query from Comh Ó Tuairisg, Mr Ridge said that the development of a reservoir to produce electricity in the Conamara area would be considered favourably if it meets the requirements of the County Development Plan. He said that such a development should have a pre planning meeting before any application is submitted.

The members raised concerns in relation to the Roads budget and Mr. Morgan responded as follows:-

The revised Roads Budget as agreed was based on the revised funding notified by the Department and works being carried out were based on this programme. The Council has no plans to cease filling potholes; the patching unit owned by the Council can only be used to repair potholes on National Routes for Health & Safety reasons.

In response to the concerns regarding proposed industrial action by the outdoor workers, the County Manager said that the Council had engaged with the Unions but that agreement could not be reached. She confirmed that the Council was available to discuss any proposals at short notice and was agreeable to have the dispute referred to a 3rd party if necessary.

In response to a query in relation to the landfill at Kilconnell, Mr. Cullen said that the environmental obligations under the EPA licence would be complied with and that the same level of methane burning monitoring would be available.

Cllr Kyne referred to two members of the Wallace family from Spiddal were present at the meeting and he stated that the flooding issue of their family home which had been raised at a previous meeting was still not resolved.

In response to Cllr Kyne, Mr. Morgan said that the Council had met with an engineer nominated by the Wallace Family and had agreed a programme. However, there was now a new engineer working on behalf of the Wallace family whom the Council would now have to meet and agree a programme of work.

In response to the queries raised by Comh Ó Cuaig, Mr. Cullen stated that

(a) The upgrade of the Rosmuc Water scheme is included in a bundle of schemes for which tender recommendation are expected in the next two weeks.

The Mayor invited Mr Ridge to present the Manager's Report which was prepared on the submissions that were received on the Draft Craughwell Local Area Plan during the public display period from 20/02/2009 to 3/4/2009.

Mr Ridge began by first outlining the Environmental issues associated with the Local Area Plan Process.

He explained that the Strategic Environmental Assessments (SEA) as per the Planning and Development (SEA) Regulations 2004 involves assessment of the likely significant environmental effects of plans and programmes prior to their adoption

An Appropriate Assessment screening of plans must also been undertaken in accordance with the Article 6 of the EU Habitats Directive 92/43/EEC.

He explained that in order to know what to apply a strategic environmental screening was carried out on the Draft Craughwell Local Area Plan in accordance with Planning and Development (SEA) Regulations 2004. It was considered that on the basis of the assessment undertaken so far a full SEA would not be required for the preparation of the Draft Craughwell Plan. It was also considered that an Appropriate Assessment was not required However Mr. Ridge stressed that if major amendments were made to the Draft Plan there was a strong possibility that this could trigger the necessity to carry out a Strategic Environmental Assessment .As this process must run parallel with the Local Area plan Process, the Craughwell Local area plan process to date would have to be abandoned and recommenced together with the SEA process.

Mr Ridge commenced with the consideration of the Manager's Report on Submission No 1. as follows:

1. Martina Connaughton, Senior Executive Engineer, Water Services, Galway County Council.

Synopsis

- The submission states that considering the delays and current status of the Craughwell Sewerage Scheme, it is unlikely that the dates in the Plan as contained within Section 8.1.1. Water Services – Wastewater Treatment and Disposal (p. 31) will now be achieved.
- 2. The submission recommends that the text of the Draft Plan be amended as follows: that '(subject to Departmental approval, construction of the scheme may start in late 2010, with completion in late 2011'), could still be considered relevant and could still be achievable.

Response

There are no existing public-wastewater treatment facilities in Craughwell. A number of developments within the village are currently serviced by privately operated sewerage networks and wastewater treatment plants and individual private houses, shops and public houses are served by septic tanks.

Section 8.1.1 Water Services of the Draft Craughwell LAP - states that currently

'the area is served by private wastewater treatment systems. Private wastewater treatment plants are a risk to the receiving environ when not operating correctly. It is envisaged that the population of the village will continue to grow. This growth will place pressure on the quality of the receiving waters, which at present is the groundwater via percolation from septic tank systems. To safeguard and protect these waters against pollution, superior wastewater treatment facilities are required. There are proposals for a sewerage treatment plant with reed bed tertiary treatment. If this development is permitted, it is envisaged that construction will start in late 2009 and be completed by the end of 2010. Development will be restricted in the area until a suitable wastewater treatment plant is in place'.

The Appropriate Assessment that was undertaken (dated 11th September 2007) for the Craughwell Sewerage Scheme envisaged that the population of Craughwell village will expand from approximately 500 to 3,500 over the next 20 years. The total design population equivalent (PE) for the Craughwell Sewerage Scheme is for 3,900 PE which is significantly lower than the threshold value (10,000 P.E.) as set out in the Environmental Impact Legislation and therefore an EIS is not mandatory. The treated effluent would discharge into the Craughwell River via a new outfall. The proposed works will be designed and constructed as a Design Build and Operate Contract.

The plan is to provide the sewerage scheme in 2 Phases: Phase 1 – will include a treatment plant of 2,600 PE capacity Phase 2- will provide the additional 1,300 P.E. (no timescale for Phase 2) Present Status- GCC consultants are presently having ongoing discussions with regard to the type and level of tertiary treatment that will be required for this plant with the NPWS, and as a consequence GCC have not completed the Part 8 procedure for this scheme yet. As a result, the contract documents have not yet gone to the Department for approval. In the present climate, it is impossible to say when this scheme might start the amended text '(subject to Departmental approval, construction of the scheme may start in late 2010, with completion in late 2011') could still be considered relevant and could still be achievable.

Population figures for Craughwell based on Census 2006, was 414 persons. Actual population change from 2002 to 2006 was 56 persons or 15.6 percentage population change (population in 2002 was 358). Using the MIF2 population projection scenario the future population horizon for Craughwell is estimated to be 470 persons by 2015.

Total housing stock based on S.A.P.S 2009 was 519 housing units of this 421 were occupied and 98 were unoccupied. Based on an average household size of 2.97 persons per occupied house, this would yield a population of 1,250 persons for 2009.

The Settlement Strategy as per the Draft County Development Plan 2005-2105 has placed Craughwell within Tier 4 of the Settlement Hierarchy - Local Services Centres and has allocate a total household allocation of 500 housing units over the CDP period. Based on an average household size of 2.97 persons, Craughwell has the capacity to grow by an estimated 1,485 persons over the plan period. Combining S.A.P.S housing figures and housing allocation as per the Settlement Strategy Craughwell has the potential to provide a total housing capacity of 921 housing units or a population horizon of 2,735 persons by 2015. The proposed sewerage scheme has design capacity for 3,500 persons over the following 20 years which leaves spare capacity of 765 persons up until 2027 based on the above

Recommendation

estimations.

1. Amend the text within **S. 8.1.1 Water Services** (p.31 of Draft Plan) to read as follows:

If this development is permitted, it is envisaged that <u>Subject to Departmental approval</u>, construction of the scheme will <u>may</u> start in late 2009 2010 and be completed with completion by the end of 2010 in late 2011.

Development will be restricted in the area until a suitable wastewater treatment plant is in place'.

No new significant development will be permitted in the area until such time as the WWTP has been substantially completed.

It was agreed to accept the recommendation in the Manager's Report

2. Michael Mc Cormack, Policy Advisor (Planning) National Roads Authority, St Martin's House, Waterloo Road, Dublin 4.

Synopsis.

This submission has requested the following be considered within the Draft Plan: Pending the completion and opening of the M6 and subsequent downgrading of the existing N6, it is important that policies are developed that protect the carrying capacity, operational efficiency and safety of the existing N6 through the town.

- 1. Reference is made by the NRA to **publications on official policy by the NRA** in relation to access onto National Roads such as 'Development Control Advice and Guidelines'(1982) and to 'Policy and Planning Framework for Roads' (1985) and to paragraph S.3.3.4 of the Sustainable Rural Housing Guidelines (2005). The submission makes reference to the following text in relation to national road network within this document
 - 'The objectives and policies of the development plan should make it clear that direct access from future development should not be permitted to national roads outside of the speed limit zones for towns and villages. Development control policy should, in the first instance, seek to channel traffic from new development onto existing local roads and in this way use established access points to gain entry onto national roads. The development plan should make such policies clear in relation to the designated national routes in the planning authority's functional area.'
- 2. The submission acknowledges the reference to DC Standard 1 and 6 of the GCDP 2003-2009 within S. 13.5.1 of the Draft Craughwell LAP, however the submission requests that it is advisable that a specific statement in relation to access to national roads be put directly into the Craughwell LAP given that the CDP is currently under review and a new CDP is in preparation.
- 3. In addition to such a statement being included within S 13.5.1 the submission also requests that the policy to restrict direct access to national roads, in accordance with national policy, is cross referenced to S. 4.1.1 Roads, Traffic and Parking to provide added clarity to the Plan.

Response

- The points raised in this submission are noted and a specific statement in relation to access to national roads will be incorporated into a <u>new paragraph(s)</u> (paragraph 2, p.63) of S 13.5.1 Access onto Public Roads of the Draft Craughwell Plan to read as follows:
 - The Planning Authority shall have regard to any new guidance on the integration of roads planning, development planning and development management practices that may issue from the DOEHLG and/or Dept of Transport and including the guidelines as contained within the Sustainable Rural Housing Guidelines and DOEHLG Retail Planning Guidelines during the lifetime of this Plan. The PA shall also be guided by the NRA official policy in relation to access to national roads and developments along such roads as set out in NRA publications Development Control Advice and Guidelines, Policy and Planning Framework for Roads and by the Authority's Policy Statement on Development Management and Access to National Roads.
 - As a general policy, the location of new means of access onto the existing N6 shall not be permitted except in areas where a speed limit of 50-60 km/h applies, or in the case of infilling, in the existing built-up areas. This is to ensure the protection of the carrying capacity, safety and operational efficiency of the national road network, pending the opening of the M6 and subsequent downgrading of the existing N6 through Craughwell. The Planning Authority shall in the first instance, seek to channel traffic from new development onto existing local roads and in this way use established access points to gain entry onto national roads. In exceptional circumstances, direct access maybe considered, in consultation with the NRA Dept of Environment, Heritage and Local Government and other relevant stakeholders on a case by case basis, onto national routes (non-motorways) to accommodate strategic infrastructure or regional significant development.

The Craughwell LAP shall also be guided by the policies and objectives as contained within the CDP 2009-2015, Section 6 Infrastructure: Roads and Transportation

Policy TA2:

(specifically to Policy RT3) and to S. 11 Development Management Standards and Guidelines – DM Standard 16, DM17 & DM22.

(Refer also to policies and objectives as contained within S. 4.3 Movement and Transportation Strategy of the Craughwell Draft Plan.)

Omit reference to DM1 and DM6 of the 2003-2009 CDP (p. 63)

- 2. In addition include a new Policy **Policy TA2** within S.4.3 of the Draft Craughwell LAP and including cross reference to same.
 - As a general policy, the location of new means of access to the National Primary Road and National Secondary Road network, for residential, commercial, industrial or other development dependent on such means of access, shall not be permitted except in areas where a speed limit of 50-60 km/h applies, or in the case of infilling, in the existing built-up areas. The Planning Authority shall in the first instance, seek to channel traffic from new development onto existing local roads and in this way use established access points to gain entry onto national roads.

The only exemptions to this general restriction that may be considered would be developments of national or regional strategic importance which by their nature are most appropriately located outside urban centres and where the developments proposed have specific locational requirements or are dependent on fixed physical characteristics. In this regard, Galway County Council shall engage with relevant stakeholders including the NRA, Dept of Environment, Heritage and Local Government and, if appropriate, neighbouring Local Authorities to develop a strategy to identify such strategic activities or strategic locations and a set of criteria which would guide development in such circumstances.

Relevant considerations may include:

- Relevance and appropriateness of the proposed development in supporting the aims and objectives of the National Spatial Strategy and the Regional Planning Guidelines.
- The nature of the proposed development and the volume of traffic to be generated by it
- The implications for the safe and efficient operation of the national road as well as any proposed upgrades or routes for new roads
- Implications for the traffic carrying capacity and service life of the road
- Suitability of the location vis-à-vis other locations
- Existing development in the area
- The precedent that could be created for follow-on development of a similar nature and potential implications for national roads

Amend Numbering within S 4.3: Movement and Transportation Strategy of the Draft Craughwell LAP

Recommendation

Policy TA2:

- Include a specific statement in relation to access to national roads into a <u>new paragraph(s)</u> (paragraph 2, p.63) of S 13.5.1 Access onto Public Roads of the Draft Craughwell Plan as outlined above.
 Include reference to S6 and S. 11 of the new CDP 2009-2019. Omit reference to DC Standard 1 and DC 6 of the 2003-2009 CDP.
- Include a new Policy Policy <u>Policy TA2</u> within S.4.3 of the Draft Craughwell LAP to read as follows:
 - As a general policy, the location of new means of access to the National Primary Road and National Secondary Road network, for residential, commercial, industrial or other development dependent on such means of access, shall not be permitted except in areas where a speed limit of 50-60 km/h applies, or in the case of infilling, in the existing built-up areas. The Planning Authority shall in the first instance, seek to channel traffic from new development onto existing local roads and in this way use established access points to gain entry onto national roads.

The only exemptions to this general restriction that may be considered would be developments of national or regional strategic importance which by their nature are most appropriately located outside urban centres and where the developments proposed have specific locational requirements or are dependent on fixed physical characteristics. In this regard, Galway County Council shall engage with relevant stakeholders including the NRA, Dept of Environment, Heritage and Local Government and, if appropriate, neighbouring Local Authorities to develop a strategy to identify such strategic activities or strategic locations and a set of criteria which would guide development in such circumstances.

Relevant considerations may include:

- Relevance and appropriateness of the proposed development in supporting the aims and objectives of the National Spatial Strategy and the Regional Planning Guidelines.
- The nature of the proposed development and the volume of traffic to be generated by it
- The implications for the safe and efficient operation of the national road as well as any proposed upgrades or routes for new roads

- Existing development in the area
- The precedent that could be created for follow-on development of a similar nature and potential implications for national roads

On the proposal of Cllr McDonagh and seconded by Comh Ó Tuairisg it was agreed to accept the recommendation in the Manager's Report.

3. Barry Kelly, 26 Gort Siar, Western Distributor Road, Knocknacarra, Galway.

Synopsis.

The submission requests that the subject lands on the attached Map 01 should be included as 'Village Core' in the adopted Craughwell Local Area Plan.

- 1. The submission agrees with part of the 'Village Core' area being north of the river but that there is also a strong need to counter balance this, by designating lands on the southern side of the river as part of the 'Village Core' area due to the existing commercial and community uses on the southern side of the river, which have contributed to the existing village urban fabric. The submission also notes that the Flood Risk Area should not act as a barrier by only designating a 'Village Core' area on the northern side of the village as outlined in the Draft Plan.
- 2. The submission notes that it is important to designate the Craughwell train station and part of its adjoining lands to the north (i.e. behind Cawley's pub and post office) as 'Village Core' area. Under the current Draft Craughwell LAP the train station is left isolated or separated from the area identified as 'Village Core'. The inclusion of these lands would provide a more sustainable and balanced approach to the development of the village centre and its surroundings.

Response

Craughwell village is predominantly linear in form and centres on the N6. The Craughwell / Dunkellin River traverse the south of the plan area and the west of the plan area is bounded by the rail line. The plan area is relatively low lying with a maximum elevation of 34m Ordnance Datum (OD) (see Appendix A as per Draft Plan).

- The N6 provides access to adjacent lands but also acts as an environmental and social barrier in terms of noise and safety.
- The rail line has acted as a constraint to the development of lands to the west of the N6.
- The flooding has also acted as a physical constraint in the consolidation of the village. This segregation is evident in the form of the village.

Development generally follows the north-south alignment of the main Galway-Dublin Road (N6). The existing land use pattern in Craughwell consists of a range of different uses. The LAP lands are comprised of residential, commercial, community and agricultural land uses. The **main street** has a mixture of residential, commercial, ecclesiastical and community functions. The **village environs** have an extensive ribbon development pattern of 'one off' rural housing. Traditionally development has generally been low density in Craughwell. New residential development has occurred to the south and the east of the Main Street in the 1990's and 2000's. These are also low density consisting of apartments, terraced, semi-detached and detached dwellings.

Land Use Strategy of the Draft Plan:

The Craughwell LAP (S. 3 Land Use Development) has adopted a Land Use Strategy which moves away from conventional land use zoning where single or limited uses, such as residential developments, are permitted in particular zones. The Plan provides a more flexible and facilitative approach that combines mixed use zoning and development areas.

- The **mixed use zoning** component of the Plan provides an overall framework designed to direct development in an orderly and appropriate manner and to provide for a greater mix of complementary uses in appropriate locations.
- The use of development areas provides more detailed guidance regarding the mix of
 uses and the type, density and design of development appropriate in the different
 areas.

This combined approach is considered necessary to allow the village to develop in a more organic and integrated manner and to follow the sequential approach of development from the Village Core out to the Outer Village.

The main aims for the development of Craughwell is to provide a mixed use zoning framework for the Plan Area, to direct development in a manner that ensures complimentary uses, consolidates development in the village centre, enhances the existing landscape setting, character and identity of the village and complies with the statutory requirements in the PDA 2000 and to direct development into locations that best suit the development areas and density provisions.

The objectives of the Draft Craughwell LAP are as follows:

Objective LU2.1: Promote the development of the Village Core as a vibrant well-

designed area and encourages development that compliments and contributes to the local mix of uses and provides definition to the

main street.

Objective LU2.2: Develop the Inner Village as a well connected accessible area and

promote development that contributes positively to the Village Core

Area and village environment.

Objective LU2.4: Promote the development of the Flood Risk Area as a natural

amenity area which contributes positively to the character of the

village.

S.9 Economic Development of the Draft Plan seeks to improve the overall quality of life by supporting the local economy and encouraging new development in the appropriate area to the character of Craughwell. The Draft Plan also encourages that any new planned development should be contained within the existing village structure as much as possible.

Objective ED.1.1 GCC will allow small scale commercial/retail developments, which

are in character with existing village properties provided that the scale of provision and the type of goods sold clearly indicate the shop is primarily designed to cater for the needs of the village and its

catchment population.

Objective ED2.5 To encourage medium and small scale- industrial development

within the Inner Village and Outer Village Area

The village is currently underprovided in terms of retail services and employment. A retail floor space survey carried out by GCC in 2007 revealed that there is 5,988m2 of retail floor space in Craughwell. The opening of the new village centre development has a total floorspace of 1,215m2 of retail floor space; however the village core currently lacks a supermarket.

The submission lands are located to the south of the Draft LAP development boundary including south of the Dunkellin/Craughwell River. Land immediately north and south of the N6 are presently zoned as Outer Village Area and the portion of lands behind Crawley's Pub and in the vicinity of the proposed railway stop are presently zoned as Inner Village Area.

The alteration of these designations to 'Village Core' would not be considered appropriate for the following reasons:

The Dunkellin/Craughwell River area provides a buffer between the built up area of
the village and the suburban extension of the village to the south. Altering the
designation of the subject lands would provide for mixed use development to extend
further towards the village environs while the current 'Village Core' has not reached

- its full commercial development capacity. This is not in keeping with the aim of the Draft Plan 'to follow the sequential approach of development from the Village Core out to the Outer Village'.
- The Outer Village area (both north and south of the N6) currently provides for a medium density of multiple unit/ housing estate type residential developments and ribbon development. It is considered that a predominance of residential type development is not appropriate within a Village Core zoning area where the objective is to provide a vibrant well-designed area and encourages development that compliments and contributes to the local mix of uses and provides definition to the main street.
- The present Draft Plan encourages medium and small-scale industrial development within the Inner Village and Outer Village Areas, the altering of these lands to 'Village Core' would reduce the potential within the current development strategy to deliver on small-scale to medium industrial development within the Plan area.
- The altering of Submission lands in the vicinity of the railway station to 'Village Core' may also lead to a competing 'Village Core' with inner village uses and densities which may lead for a relatively intensive development proposal around the railway which would be more appropriate at this time within the existing 'Village Core'. The aim of the Draft Plan is to protect and enhance the existing 'Village Core' rather than competing with it.
- Future potential of the area adjoining the railway stop will depend on the delivery of essential infrastructure including road improvements along the R347, the provision of public footpaths and public street lighting to the current 'Village Core' and including the provision of a public sewerage scheme. Current developments by Irish Rail include the provision of a new access road with a public foot path/lighting, 2 soakways, carpark, rail platform and a ticket shelter. Presently the main use in this vicinity is agriculture. By altering the present zoning of Inner Village Area to 'Village Core' would again reduce future development potential for small scale industrial development/enterprise creation. Also the inclusion of this area within a new 'Village Core' area will place additional pressure on the already limited public infrastructure and facilities that has been provided to this area.
- The development potential of the undeveloped lands in the Draft Plan area represents approximately twice the house construction allocation allowed for Craughwell in the new CDP 2009-2015. This development potential has been based on the Density Guidelines and Potential Development Yield as shown within Table 5a on Page 18 of the Draft Plan. By expanding the Village Core designation (average no of dwelling per h.a. is estimated at 25 housing units; PAR -1.00) to Outer Village Area (average no of dwellings per h.a. is estimated at 20 housing units; PAR- 0.3%), would result in an even greater potential development yield and including greater intensive development than is estimated within the Draft Plan and within the CDP 2009-2015. Given the availability of a substantial amount of undeveloped lands, in excess of that required of the 6 year plan period, future development should be strategically directed to best achieve orderly development and the sequential approach to development as outlined in the Draft Craughwell Plan.

In the absence of certain essential infrastructure this is also considered to be premature.

Recommendation

Map 1 - No change recommended. No change to present zoning status of the Draft Plan in relation to the submission lands. No change to Draft LAP.
