DECLARATION OF ROADS TO BE PUBLIC ROADS – SECTION 11 OF ROADS ACT, 1993 454

On the proposal of Cllr. Hynes seconded by Cllr. Willers, the Council approved the declaration of the following road to be a public road, the statutory procedure having been complied with:-

Road commencing at junction with County Road L82471 in the townland of Earlspark and extending east for a distance of 441 metres in the townland of Earlspark and finishing at Brian Barrett's gate in the townland of Earlspark.

On the proposal of Cllr. Keaveney, seconded by Cllr. Canney, the construction of a new fire station, training tower and associated works at Demesne, Milltown Road, Tuam, Co. Galway on a site of approximately l acre, was approved

Arising from this item the issue of an additional Fire Station for Conamara was raised. It was proposed by An Comh. O Cuaig seconded by Cllr. S, Walsh and agreed that the provision of a Fire Station in Conamara is a top priority of Galway County Council.

TO CONSIDER REPORT UNDER PART 8 OF THE PLANNING AND DEVELOPMENT REGULATIONS 2010 – DAWROS BRIDGE REPLACEMENT ON THE N59, LETTERFRACK 457

Report dated 21st September, 2010 was already circulated to each Member.

On the proposal of Cllr. S. Walsh, seconded by Cllr. E. Mannion, the demolition of the existing bridge structure and replacement of same was approved.

By unanimous agreement Item No. 13 was taken at this stage of the Meeting.

PRESENTATION BY RPS – PROPOSAL TO ABSTRACT WATER FROM RIVER SHANNON 458

The Mayor welcomed the following to the Meeting - Mr. Martin Kelly, Project Engineer, Dublin City Council, Mr. Gerry Geoghegan and Ms. Emily Ledwith, RPS Consulting Engineers, and Mr. Colm Ó Gógáin, Director of Strategic Infrastructure, Bord na Mona. He then invited Mr. Gerry Geoghegan to make the presentation on the Water Supply Project which proposes to address the long term water supply needs of Dublin, Meath and the Midlands Region.

The Mayor said that he was disappointed that the presentation did not address the issues of concern to Galway County Council

A questions and answer session followed where the Members raised the concerns regarding the proposal to extract water from Lough Derg

The Mayor thanked Mr. Geoghegan and the other attendees and advised that Galway County Council will discuss this matter further at a future meeting.

LEASING OF HOUSES SCHEME

459

Mr. Gilmore presented his Report dated 28th June, 2010 which had been previously circulated to each Member.

A number of issues were raised by the Members and clarification was given by Mr. Gilmore.

DRAFT DEVELOPMENT CONTRIBUTION SCHEME

460

Mr. Kelly referred to the revised report on the Draft Development Contribution Scheme 2010, with amendments, which had been discussed at the Area Committee Meetings and which had already been circulated to the Members.

It was proposed by Cllr. Mullins, seconded by Cllr. Cuddy and agreed to put the Draft Development Contribution Scheme, as amended, on Public Display.

ECONOMIC WORK OF GALWAY COUNTY COUNCIL

461

A Report was circulated to each Member

Mr. Barrett gave a presentation on the economic work of Galway County Council: what is in place, where we are as a County and the implications facing us. He advised that employment wise, the current figures on the live register are similar to 2004 figures. He continued by discussing the economic recovery envisaged. A lengthy discussion followed his presentation, with many concerns raised by the Members.

The Mayor and Members thanked Mr. Barrett for his very informative talk and slide presentation.

It was agreed that this issue required further debate and it was proposed by Cllr. Mullins, seconded by Cllr. McHugh, and agreed that this item be placed on the Agenda for the October Monthly Meeting for further discussion and debate.

SUSPENSION OF STANDING ORDERS

462

On the proposal of Cllr. Mullins, seconded by Cllr. Hoade it was agreed that Standing Orders be suspended to allow the Meeting to proceed after 6p.m.

PRESENTATION ON NEW CALENDAR OF EVENTS – GALWAY.IE

463

Mr. Barrett demonstrated to the Members how this website operates. All activities/events throughout the County can be included on the site. He requested the Members to bring the site to the attention of the local communities.

FLOODING UPDATE

464

Report dated 24th September 2010 was circulated to each Member and was presented by the Manager.

The Members were informed of an amendment in the report in relation to the Carnmore/Cashla area, and advised that the solution identified for Carnmore/Cashla will be included in the main works for the Claregalway Flood Relief Scheme.

In relation to Claregalway, disappointment was expressed that upstream of the Claregalway Bridge was not catered for in the Clare River Flood Relief Scheme.

In relation to the Dunkellin Flood Relief Scheme, concern was expressed regarding lack of plan for upstream of Craughwell.

The Members complimented Mr. Martin Lavelle, Senior Engineer and Mr. Christy Mannion, General Services Supervisor on the management of the works carried out on the Clarin River.

Concern was expressed regarding the difficulty being experienced by householders in obtaining insurance and the Manager was requested to follow up this issue with the Insurance Federation of Ireland.

In general the Members expressed their satisfaction with progress being made to date.

The Mayor requested that this item be kept on the Agenda.

NOMINEE FOR SOCIAL INCLUSION MEASURES (SIM) COMMITTEE

465

Report dated 21st September, 2010 was already circulated to each Member.

It was proposed by Cllr. Fahy, seconded by Cllr. Mullins and agreed that Cllr. Hynes be appointed to the Social Inclusion Measures Committee (SIM) of Galway County Development Board.

TO FIX DATES FOR OCTOBER AND DECEMBER COUNCIL MEETINGS

It was proposed by Cllr. McDonagh, seconded by Cllr. Maher and agreed that the October Monthly Meeting will take place on the 18th October, 2010, at 2.30 p.m. and that the December monthly will take place on the 17th December, 2010 starting at 2.00 p.m.

KILREEKIL WATER SUPPLY

467

Report dated the 27th September, 2010 was already circulated to each Member.

The Mayor said that this scheme was of high priority and he welcomed Mr. Dessie O' Brien, Chairman of the Local Committee to the meeting.

Mr. Cullen then read the report as circulated, and said he appreciated the opportunity to state the facts so that there is no misunderstanding. He said that Galway County Council is doing all it can to progress the Kilreekil Water Supply, and he hoped that the report clarifies where the Council stands in relation to this.

A lengthy debate followed and the Members expressed concern that a village the size of Kilreekil was still without their basic right of a water supply in 2010.

It was proposed by Cllr. Hynes, seconded by Cllr. Feeney and agreed that the following resolution be forwarded to the Minister for the Environment:

"that the Mayor/Loughrea Councillors and Officials of Galway County Council seek an urgent meeting with the Minister for the Environment Heritage, and Local Government and officials, with a view to securing funding for the Loughrea Regional Water Scheme, including the extension to Kilreekil."

The Members paid tribute to Mr. John Diskin, Senior Engineer in the Water Services Department who is retiring next week and said he had put a huge effort into progressing and completing works on Group Water Schemes.

MANAGERS BUSINESS

468

Cllr. Kyne requested an update on the Galway City Outer Bypass. The Manager reported as follows:

Following the decision of An Bord Pleanala on the 20th November 2008 to grant approval to the Galway City and County Councils for the Eastern portion of the Galway City Outer ByPass, Peter Sweetman environmentalist and Hands Across the Corrib brought two separate Judicial Review proceedings in the High Court to have

that approval quashed. In the course of the proceedings, the State joined Peter Sweetman in challenging the Board's decision. Both these cases were heard together by the High Court in June and July 2009. Judgment was later delivered on the 9th October 2009, where the Court found fully in favour of the decision of the Board to grant approval for the eastern section of the ByPass.

The decision was appealed to the Supreme Court and after requests by Galway County Council for a priority hearing, was heard in early June of this year.

The High Court had allowed the appeal to the Supreme Court on one ground only namely:

"What is the correct interpretation of the phrase "adversely affect the integrity of the site concerned" as that phrase appears in Article 6 (3) of Council Directive 92/43/EEC of the 21st May 1992 on the conservation of natural habitats and of wild flora and fauna and Regulation 30 of the European Communities (Natural Habitats) Regulations 1997".

The High Court had been asked to make a reference to the European Court of Justice prior to making a decision, but the High Court Judge was satisfied that the language of the Directive and the Regulations was sufficiently clear such that it was not necessary to ask the European Court of Justice for assistance in the interpretation of the law. During the Supreme Court appeal, the State repeated this request for a reference, urging the Chief Justice to make a reference to the ECJ seeking a response from them as to the correct interpretation of Article 6 and the correct interpretation of the phrase "adversely affect the integrity of the site".

The Supreme Court agreed to make the reference and asked for draft questions to be submitted by the parties to the case for consideration. Whilst this was done, agreement as to the questions was not possible and the Chief Justice is currently drafting the reference which will contain specific questions to be asked of the ECJ. It is hoped that this will be finalised soon and that the case will then be referred to the ECJ. On receipt of the reference the following occurs:

The Order for reference is translated in the other official languages of the Community

The Member States are notified and given a copy of the reference with a translation in their official language

The Commission is notified by the Registrar. In some circumstances, the Council of Europe and the European Parliament is notified.

The Member States, the Commission and the parties to the case may submit observations within 2 months of notification.

When all submissions have been received, the judge-rapporteur submits a preliminary report to the administrative meeting of the Court.

The President will decide on a Court of 3 or 5 judges

The President will prescribe time limits for written observations by the parties.

The President will fix a date for the hearing. Dates assigned are based on date or entry of cases in the list.

Priority may be given if an application by the Member State for an accelerated hearing is granted, only to be granted in cases of exceptional urgency

The Advocate General's(AG) opinion is generally delivered a few days after the conclusion of the hearing.

The Judgment of the ECJ issues after the AG's opinion and is final

The effect of the judgment will be to answer the questions put to it by the Supreme Court, whose hearing of the appeal against the High Court Order currently stands suspended. The Supreme Court will then resume the hearing of the case, with the benefit of the ECJ's response and give its judgment on the judicial review.

There is uncertainty regarding the timescale involved in this process, from date of reference to the ECJ to the delivery of judgment by the ECJ. However, after the case has been sent, it is Galway County Council's intention to promote an application for an accelerated hearing.

On the 7th July, the CPO (Extension of Time Limits) Act 2010 was passed which allows for an extension of the 18 month period for service of the Notice to Treat in certain cases where the project has been delayed by legal proceedings brought to challenge the approval. This was a very welcome development.

Cllr. Kyne required that the County Manager write to the 15 MEP's in relation to this issue based on the summary given to the Members. The Members were supportive of this.

MAYORS BUSINESS

Cllr. Dermot Connolly raised his Notice of Motion No. 22 "That Galway County Council will not issue a Waste Permit for which planning permission was granted by An Bord Pleannala for sludge treatment at Poolboy in the Ballinasloe Electoral Area."

Mr. Cullen confirmed that he is not aware of any role Galway County Council has in this regard.

The Mayor pointed out that this issue was not for debate as a response had been issued to Cllr. D. Connolly.

It was agreed that the implications of the New Planning Act will be an be an item on the Agenda for the next Council Meeting.

NOTICE OF MOTION NO 20 - CLLR. B. WILLERS

"It is considered that a Prohibition Order in accordance with Section 48 of the Local Government (Sanitary Services) Act 1948 offers a more immediate and effective means of regulating camping and overnight parking of campervans. "In line with national water pricing policy, Galway County Council implements a standard domestic allowance per house of 50,000 gallons (227m³) per annum or the actual consumption, whichever is the lower. For billing purposes, this annual allowance is applied as a daily allowance of 0.621m³ to each customer's bill. This daily allowance is multiplied by the number of days in the billing period to calculate the total domestic allowance to be deducted from that particular bill.

The purpose of the domestic allowance is to allow for reasonable consumption for domestic water usage. Applying a daily allowance per house for domestic usage is a fair and equitable method of achieving this end. While consumption for agricultural users will indeed vary considerably depending on the time of year, the domestic allowance is not intended to be used to offset higher levels of non-domestic consumption."

The following reply was given:-

"When assigning Fire brigade station areas and PDA's (Pre Determined Attendance) using the CAMP -Computer Aide Mobilising Project - System the base criteria used is the townland location. The PDA order of Fire station attendance is decided on the minimum travel time to the centroid of the townland in question. Hence Brigade area and PDA area boundaries are co-incident with townland boundaries. The CAMP system does not allow for the subdivision of town lands into different sub-PDA's .Hence it is possible that a particular building/ risk at the edge of a PDA and townland boundary can be closer to another Fire station than the Fire station that is assigned to the townland in which the premises is located.

A fire occurred at Arrawbawn Co-Op near Abbeyknockmoy on the morning of the 6th September 2010. The address given to the CAMP dispatcher in Castlebar was

Newtown Abbeyknockmoy, which is 3 km east of Abbeyknockmoy on the southern side of the N63. This location is near the intersection of 3 brigade areas Tuam, Athenry and Mountbellew respectively. The former two Brigade areas are subdivided by the N63 road, with Tuam area been to the north of the road and Athenry to the south of the road respectively. Mountbellew's boundary is just further east along N63.

It should be noted that Arrawbawn Co-Op is in fact located in the townland of Clashard, which has the same PDA as Newtown Townland.

The PDA for Newtown Townland is Athenry and Mountbellew The first Fire appliances (Pumps) from both stations were initially alerted as follows.

EUROPEAN ROAD SAFETY CHARTER

429

Report dated 16th July, 2010 was already circulated to each Member.

Mr. Gilmore referred to the report and stated that Galway County Council initially signed the European Road Safety Charter in 2007, thus committing to assuming its share of the responsibility in helping to achieve the common target of saving lives.

A number of the Members expressed the view that some people still do not appear to be getting the message regarding road safety and continue to drive dangerously and they asked what is being achieved through the European Road Safety Charter.

Mr. Gilmore outlined the various Road Safety Initiatives undertaken by the Council's Road Safety Together Committee in 2009 which included: Junior School Warden Scheme; Cycle Training Programme; Advanced Pitstop Initiative; Drive for Life Programme; "Check it Fits" Roadshow which aimed to identify child car seats which were fitted incorrectly; "Are you Daylighted" Road Safety Awareness Campaign; and the "Think Twice" Road Safety Show aimed at transition and senior year students in Galway County and City Secondary Schools and Youthreach Groups. He said that these Road Safety Initiatives are examples of the work being done as a result of the European Road Safety Charter and he said that work on these initiatives will continue over the next three years.

It was proposed by Cllr. Kyne, seconded by Cllr. Cuddy and agreed "That Galway County Council commence the process of reviewing speed limits on our county roads with the view to improving road safety".

It was proposed by Cllr. S. Walsh, seconded by Comh Ó Tuairisg and agreed "That the road junctions at Drimnahoon and Moyvoon on the N59 between Rosscahill and Oughterard be made safe as a matter of priority". Mr Gilmore undertook to examine this issue.

In relation to road safety, some Members referred to the matter of verge trimming and stated that where public safety is at risk, verge trimming should be carried out.

Mr Gilmore said that road safety is a priority on all roads and it is the Council's policy to carry out verge trimming at all locations that are considered dangerous.

He also pointed out that the speed limits shown on the road signs are maximum speed limits and drivers must be responsible and take the condition of the road and the environment into consideration when driving.

On the proposal of Cllr. Mullins, seconded by Cllr. Carroll, it was agreed that Galway County renew its commitment to the European Road Safety Charter up to end of 2012.

DEVELOPMENT CONTRIBUTION SCHEME

430

Report dated 20th July, 2010 was already circulated to each Member.

Mr. Comer presented the Draft Development Contribution Scheme to the Members.

It was proposed by Cllr. Welby that the Draft Development Contribution Scheme be put on public display and this proposal was seconded by Cllr. McHugh.

The Mayor pointed out that the review of the Development Contribution Scheme was being carried out at the request of the Members due to the downturn in the economy. He said that a sub-committee of the Council was set up in order to formulate the review and this sub-committee has met on a number of occasions and as a result the Draft Scheme was prepared.

Following a lengthy discussion, Mayor McClearn proposed that this item be referred back to the Area Committees for further discussion. This proposal was seconded by Comh. O Curraoin and agreed.
