# Minutes of Statutory Budget Meeting held on 16th December 2013

a wide variety of responsibilities some of which were statutory- these included not only the planning function but community and enterprise, economic development, social inclusion, heritage and conservation, registration of quarries, unfinished housing estates, the taking in charge function, review of the county development plan, strategic environmental assessments and the publication of local area plans for all towns in excess of 1,500 population. He confirmed that the staff levels in the planning department had reduced by 50% during the past few years and that each specific item on the budget was subject to specific analysis.

Cllr. McClearn stated that a budget of  $\pounds 122$  million represented a lot of economic activity for the county. He advised that while there was no increase in the commercial rate there was a requirement for more flexibility in the rating system which required legislation by the government. He stated that the technical group did not agree with the proposals submitted by the Head of Finance in regard to the required adjustments to fund the  $\pounds 202,000$  deficit. He advised that the election of 9 extra councillors in 2014 would involve additional expenditure of  $\pounds 97,650$  by the Council.

# PROPOSAL TO AMEND DRAFT BUDGET

It was proposed by Cllr. Noone, seconded by Cllr. Hoade to amend the draft budget for 2014 as follows:

- 1. To reduce the provision for local representation/civic leadership in Service H0904 Expenses LA Members by €2,350 and increase the provision for Community Sport and Recreational Development in Service F0401 Community Grants.
- If he is returned following the 2014 Local Elections to further reduce the provision for local representation/civic leadership in service H0904 Expenses LA Members by a further €1,808 and increase the provision for Community Sport and Recreational Development in Service F0401 Community Grants.

The total impact of same will be to transfer €4,158 from the Councillor's Conference allocation, in two tranches, to the provision of Community Grants in order to facilitate the Council providing a grant to Claregalway burial ground and the Abbey Restoration Committee, subject to the normal requirements pertaining to community grants.

The motion was agreed.

Also arising from the Minutes, Cllr. Cunniffe referred to the Report on the Taking in Charge of Housing Estates. He said that Residents Associations feel very disheartened that their estates are not taken in charge and many feel that the Council should give more resources to taking in charge of housing estates. He also proposed that as an interim measure that the public lighting in such housing estates be taken in charge by the Council pending the completion of the process for taking in charge the full estate.

Mr. Kelly said that it is recognized in the Report circulated at the November Monthly Meeting that it will take time to complete the work which is outstanding in unfinished housing estates. He said it remains the responsibility of the developers to complete the works and the Council could not expect the taxpayer to foot the bill for same. He said that he does not believe that current legislation would allow the Council to take on board Cllr. Cunniffe's proposal. He said that the Council is making a lot of progress with developers and he feels that the approach being taken by the Council is the correct one.

Cllr. Cunniffe said that the taking in charge of parts of estates can be done as it has happened previously. He said that it will take too long to get all estates to a stage where they can be taken in charge and he said that the Council should put more staffing resources in place to deal with this issue.

Cllr. Roche supported Cllr. Cunniffe on the issue of public lighting in housing estates and he said that it is unfair that residents of housing estates are liable for public lighting charges.

Cllr. McClearn said that it must be recognized that the Council made great progress during 2013 as regards the taking in charge of housing estates. He also outlined that a small number of estates existed with no public lighting due to the absence of a condition of planning requiring the provision of same and that this was a matter that would require attention by the Council at some stage.

Mr. Kelly stated that adequate staffing resources are in place to deal with unfinished estates and he feels that there will be a positive outcome in this regard.

Cllr. Hynes asked that where residents of housing estates request the Council to take the estate in charge and where there is no bond in place, the matter should be addressed at Planning SPC Meetings or by the Corporate Policy Group.

The Conamara Area Members raised the issue of Seanapheisteen Bridge and expressed their concern regarding the impact of the weight restrictions on the bridge of 1 ½ tonne and the hardship to local residents arising from same.

Mr. Gavin replied that the Council intends to replace the bridge and this will entail going through the formal planning process which will take at least three months to complete. However, he said that the weight restriction will be examined and if it can be increased, taking into account safety, this will be considered.

In reply to Comh. Ó Cuaig, Mr. Gavin said that the Council would have no problem in releasing the Engineers Report regarding the bridge.

In reply to Cllr. Fahy who referred to his Notice of Motion regarding a bridge requiring repair at Peterswell requesting that the Council secure emergency funding from the OPW to carry out necessary repairs to the bridge, Mr. Gavin said that it would be necessary to establish the status of the bridge and would revert to Cllr. Fahy on the matter.

Cllr. G. Finnerty referred to Notice of Motion No. 30 on the Minutes and proposed "that Galway County Council invite the various interest groups who represent rural areas and in particular deal with rural decline i.e. CEDRA etc. to give a presentation on their works and findings, and solutions if any, to rural decline and particular reference would be made to a Small Towns Study carried out by the Western Regional Authority in 2011". The Manager replied that the draft budget provided for funding for community grants as per previous years and it was a matter for the Members to decide on a different approach to the allocation of same, if they so wished, in determining the Budget for 2014.

Cllr. D. Connolly proposed that "a Vote of Sympathy be extended to the Ambassador to South Africa on the passing of Nelson Mandela, an iconic world figure, on behalf of Galway County Council". This proposal was seconded by Comh. Ó Curraoin, and agreed.

Cllr. D. Connolly asked if there was any progress regarding the problems of debris causing blockages in the River Suck and Mr. Gavin replied that the Council has forwarded a report in this regard to the River Suck Joint Drainage Committee as it is their responsibility to deal with any issues on the River Suck. He said he is aware that some works have been carried out to alleviate blockages on the river and the Council will revert to the Committee to determine what further works are proposed.

# LOCAL GOVERNMENT BILL 2013

1640

Mr. Cummins made a presentation to the Members on the Local Government Bill 2013.

He gave an overview of the Bill as follows:

- The Local Government Bill 2013 gives legislative effect to proposals set out in Putting People First — Action Programme for Effective Local Government (published October 2012) which outlines an overall vision for local government as the primary vehicle for governance and public service at local level.
- The Action Programme sets out Government policy for a range of reforms to the local government system including structures, functions, funding, operational arrangements and governance designed to strengthen local government.
- The Bill, which contains 65 sections in 10 Parts, together with 5 Schedules, sets out the necessary provisions to give effect to these measures and related matters.
- The two overarching objectives of the Bill are to provide for the significant reorganisation of local government structures and the strengthening of governance and accountability in local government, with particular emphasis on rebalancing powers appropriately between the executive and the elected council.

He listed the key aspects of the Bill as follows:

- Amalgamation of some County/City Authorities
- Abolition of Town Councils
- Establishment of Municipal Districts
- Reduction in Elected Member numbers
- Chief Executive Officer instead of County or City Manager
- National Oversight and Audit Commission
- Local Community and Development Committees

He concluded by stating that the Executive of the Local Authority will continue to have an oversight role in Local Government.

A discussion took place and the Members made the following observations regarding the Local Government Bill 2013:

- The introduction of the new Local Government Bill represents a major change in Local Government in particular the establishment of Municipal Districts which will bring Local Government closer to local people
- Meetings of the Local Authority will change as they will have less statutory business to consider
- The proposals for changes to the Regional Authorities and Regional Assemblies
- It will be up to the Members to make the new departure in relation to Local Government work well

The Mayor said that there are very exciting and challenging times ahead for Local Government and he referred to the fact that he will be the last Mayor of the County of Galway as this title will revert to Cathaoirleach under the proposed legislation.

The Members raised further issues regarding the implications of the Local Government Bill, and the Manager replied as follows:

- She agreed with the views expressed by some Members that there is fantastic potential for Local Government as a result of changed legislation but she said that it is important that Local Government makes the most of opportunities presented in order to maximise economic development and job creation for local communities.

- She said that the matter of raising and allocaion of finance locally will not be without difficulty as regards matching resources with demand in the various functions and areas.
- In relation to organisations such as the National Roads Authority, she said there is no change evident in the Local Government Bill.

Mr. Kelly replied to queries raised regarding the role envisaged for the Council in the areas of community, enterprise and economic development advising of the Local Enterprise Office (LEO) being incorporated into local authorities and the establishment of Local Community Development Committees (LCDC) with Galway County Council as one of the frontrunner local authorities for same.

Mr. Kelly advised that an LCDC will be established with a memembership envisaged of 15 comprised of the County Manager and representatives from the Elected Members, Members of Local Action Groups, Community & Voluntary Fora and State Agencies with a focus on community development while it was envisaged that a Economic Development Strategic Policy Committee will be established to focus on economic development.

He advised that the work programme will include advancing a local community and economic plan that will provide a framework for the operation of the Local Community Development Programme by the Local Action Groups. He confirmed that the Municipal Districts and Council will have a full role in considering the plan with a requirement for the plan to be aligned to the County Development Plan.

He confirmed that it was envisaged that the significant progress would be made early in the New Year in establishing the LCDC with the first task being to map and consider the various initiatives and services already in place in order to establish the current baseline to assist in setting priorities for the future.

Mr. Kelly in reply to questions from the Members confirmed that the LCDC would be formed prior to the local elections as a frontrunner and that it was envisaged that formal responsibilities would be attributed to the LCDC from July 2014. He confirmed that formal decisions in relation to the alignment process were yet to be finalised in the context of the legislation progressing through the Oireachtas but that it was clear that the LCDC would have a role in policy with the delivery mechanism requiring further clarity.

In reply to a request from Cllr. Maher it was agreed to circulate maps detailing the revised electoral areas to apply for the local elections in May 2014.

He outlined the smarter travel initiatives and schemes which were completed in 2013 including works on the bog road adjacent to the Gaelscoil in Oranmore and works in Loughrea on footpaths and pedestrian crossings and the introduction of one way streets.

He said that Walking and Cycling Strategies were prepared for individual towns including Ballinasloe, Tuam, Athenry, Gort and Clifden. These plans and strategies form the basis for future funding by the Department of Transport, Tourism and Sport when they come to consider funding applications under Active Travel Towns Schemes. These strategies are currently being considered by the Area Committees and the strategies will be available for public consultation for 4 weeks.

For the period 2014 to 2016 the Department has requested applications for funding under two headings related to Smarter Travel initiatives:

- 1 National Cycle Network Projects
- 2 Active Travel Towns Projects

Galway County Council has submitted two projects for funding under the National Cycle Network Initiative including Galway to Moycullen along the old Clifden/Galway rail line and the second project is Clifden to Letterfrack with further phases required from Letterfrack to Leenane. These two initiatives along the national cycle network Galway to Leenane will link in with the planning currently underway on the section of cycle network from Clifden to Oughterard. It is expected that the Department will advise if the Council's application for funding for the two schemes are successful early in 2014. Funding extends from 2014 to 2016 with each scheme costed at approximately €2.5 million.

For the Active Travel Towns, initiative Galway County Council has submitted three schemes to the Department for funding including the towns of Athenry, Gort and Loughrea. The schemes include for the provision of footpaths, cycle lanes, road crossings and speed reduction measures. Again it is expected we will be advise by January 2014 if funding is being made available for any of these schemes. The cost associated with each application is approximately €900,000.

Seperately, funding has been provided by the ERDF through the BMW Regional Authority for works in Tuam, identified in the Tuam Active Travel Plan. The works include pedestrian crossings within the town, footpath and cycle lanes along the Dunmore road and Bobby Burke road along with traffic calming measures and improved pedestrian facilities within the town. These works are likely to start before Christmas and continue into spring of 2014.

The Mayor thanked Mr. Gavin for the presentation. A discussion took place and Mr. Gavin replied to issues raised by the Members as follows:

- Bearna and Oranmore are included in the Galway City and Environs Walking & Cycling Strategy and funding for these will be sourced through a different mechanism
- Two options are being considered in relation to the Bridge at Oughterard, in conjunction with the National Roads Authority

In reply Mr. Cummins stated that the Galway Fire Service is one of the best fire services in the Country and that with the Members support the necessary budget to fund the service has been maintained over the years. He also referred to his presentation on this issue at the last meeting that clearly outlined the facts and the constraints within which the service has to be provided. He also said that ignoring the presentation was not an option and again reminded the Members that the design of the fire service is now based on the management of risk within available resources and is no longer based on geography and population. He stated that if any proposal or request for funding to the Department did not take on board the issue of the management of risk within available resources, then the case being made would be flawed.

Cllr. Mannion asked why was it flawed, and what would it cost, she stated that the people of South Conamara want a Fire Station in their community. In reply Mr. Cummins said that the report of the working group was not flawed in any respect and that the point he was making was that the Risk within the County had to be prioritised and managed within existing resources. He went on to say that there was no magical formula available other than the allocation of resources to the areas of highest risk. The Mayor read the Proposal to be sent to the Minister and asked the Members to await his response. An Comh. Ó Cuaig stated that the people in South Conamara have the same risk. Cllr. S. Walsh referred to the SPC meeting two months ago where this report was discussed, and he stated that the reality was keeping the Fire Budget of County Galway within its parameters, but this should not be done at the expense of the people in South Conamara. He said the report did not consider the callout time. Cllr. McHugh said that this matter should be dealt with by the Conamara Elected Members.

Cllr. D. Connolly referred to Paragraph 4 on Page 3 of the Minutes regarding his concerns on blockages caused in the River Suck channel due to fallen branches and the failure to undertake appropriate channel maintenance and this was still outstanding. He asked that the Flood Committee take this on board as a matter or priority. Replying Mr. Gilmore said that the River Suck Drainage Committee was funded by Galway and Roscommon County Councils and there were no further funds for maintenance on the River. He said that the Council will write to the Committee to consider this for next year's programme.

Cllr. Cuddy referred to Paragraph 2 on Page 3 of the Minutes regarding the distribution of the property tax, and referred to a Notice of Motion he had submitted regarding the provision of financial assistance in the Budget of €10,000 at least to cover Insurance Cover for the Galway Mountain Rescue Unit (GMRU) as the Department of the Environment had ceased funding them. Following an invitations issued to Irish Water asking that a representative meet with the Members of Galway County Council, the County Manager read the contents of a letter which had been received from Mr. John Tierney, Managing Director, Irish Water dated the 22<sup>nd</sup> November, 2013 outlining Irish Water's engagement with Local Elected Representatives.

The Members thanked Mr. Cullen for his report which was discussed and noted.

It was proposed by Cllr. McClearn, seconded by Cllr. Cuddy and agreed that the following Motion received from Wexford County Council be supported:-

This Council supports the call for the full national political commitment to ensuring that water and sanitation are publicly owned, democratically run and that all in the sector are fully accountable."

Mr. Cunniffe gave a very informative Powerpoint presentation on the workings of the Committee. He outlined the contents of a motion detailing a transport route linking Cork to Belfast via Limerick, Galway, Sligo, Donegal and Derry.

A discussion took place on the significant work done by the Group in the compilation of this initiative which highlighted the exclusion of the West of the Country from the Trans-European Transport Network (TEN-T) Core Project and that this region was not included for the funding, and it was felt that the IDA and the Government worked towards delivering on the East Coast only. It was stated that as the West does not have the necessary infrastructure, it cannot be marketed in the same way as the East, therefore jobs were not coming to the West. Western Arc had tied this area together and it was agreed that it should be supported, and that other County Councils should be asked to support it also. The West has been excluded for years.

It was proposed by Cllr. D. Connolly, seconded by Cllr. Canney and agreed "that Galway County Council propose that the Minister for Transport make a submission to the E.U. for TEN-T Core Funding to support the concept of the Western Arc, as requested by the Commission of Petitions of the European Parliament. This motion should be circulated to all local authorities served by the Western Arc."

For the Kiltiernan/Ballindereen the Cost Benefit Analysis was too low and was not approved by the OPW. Galway County Council were re-examining this scheme with a view to reassessing the works required and attempting to improve the Cost to Benefit whilst at the same time ensuring an effective scheme was put in place. The Manager outlined the contents of the Report to the Members. The Members congratulated and commended the Manager on purchasing the site and keeping it in public ownership. They said it was great value for money and said it was a huge step for economic development within the County, and understood that the matter could not be discussed publically until the process had been achieved. The following queries were raised by the Members.

- That Galway County Council should be the lead on this project as the site is in the County area
- Joint Committee of the County & City should be reactivated and used to discuss the issue relating to this protect.

The County Manager thanked the Members for their support. She referred to the time and energy that had been invested in the Airport, but said that it was not a viable endeavour. She said that times had changed, the Airport had been used a lot for Trips to Dublin in the past, but now with the significant road network people were not supporting it. She stated that the reason the Council did not go alone and purchase the site was that the City and County are shareholders and cannot be viewed separately, the broader picture needs to be looked at in terms of economic development. She said she took on board the issues that were raised e.g. interaction with Third Level Institutions, etc., and said that an Economic Development Plan for Galway would be prepared through the Strategic Policy Committee of the Council for adoption by the Council.

She pointed out that it was not just about enterprise, but that schemes like the Connemara Greenway, the Wild Atlantic Way, and the development of Walking & Cycling Groups were also very important and should be included in the long term development for the County and that benefits from those areas should be maximized in a context of balanced development.

Replying to the statement that the Council should lead, she informed the Members that Galway County Council were the lead in preparing the conveyancing and finalizing the Contract etc. and said it was a 50/50 arrangement. She confirmed that Rates have accrued, and that this was part of the negotiations. She also said that one of the costs would be security, but again this was a joint arrangement. She said that current users of the Airport would be looked at, but that the current owners are responsible at the moment. In

### Minutes of October Monthly Meeting held on 21st October, 2013

Mr. Owens replied that the Famine Bid which was presented to the Council at the September Meeting consisted of a 10-day programme of events, with a large number of events programmed for Portumna Workhouse, including the formal State Ceremony. He confirmed that following a review of the logistics of hosting the State Ceremony event at the Workhouse, it was decided that in order to strengthen the Bid, a second option should be included as a venue for the State Ceremony and that option was to host the Ceremony at Portumna Castle. He said that in the event that the bid was successful the events programmed for the Workhouse would continue to be hosted at the Workhouse Centre and that it would remain the preferred to host the formal State Ceremony provided the logistics associated with the venue could be addressed to the satisfaction of the OPW. He advised that the decision to provide the option of the Workhouse or Castle for the State Ceremony was to strengthen the Bid and submit the strongest possible proposal for the 2014 National Famine Commemoration to be held in County Galway and Portumna.

In reply to a point raised by Cllr. Cuddy regarding the property tax, the Manager said that proceeds from the property tax will become part of the Council's budgetary process which will be agreed by the Members at the Budget Meeting of the Council each year. Therefore it will be the Members who will determine how the property tax is spent. Cllr. Cuddy also referred to the fact that  $\leq 3.5$  billion in revenue was raised on an annual basis in various form of motor vehicle related taxation, yet only approximately a third of this revenue was available for investment in the road network.

In reply to Cllr. D. Connolly, Mr. Owens said that no detailed response had been received from the Department of Arts, Heritage & the Gaeltacht in relation to the Council's Motion to support those who cut turf for domestic use.

Cllr. D. Connolly also re-iterated his concerns regarding blockages caused in the River Suck channel due to fallen branches and the failure to undertake appropriate channel maintenance. In reply, Mr. Gilmore undertook to follow up on the matter with the River Suck Joint Drainage Committee.

Cllr. Canney expressed concern for the businesses that are being taken to court for nonpayment of commercial rates. He said that Government must do something to help ratepayers who cannot afford to pay rates and to help local Councils who are suffering as a result of reduced funds in this regard.

In reply to Cllr. Welby, Mr. Mullarkey said that the Roads Safety Authority is commencing a publicity campaign this coming week to inform the public of the transfer of the driver licencing function from County Councils to the National Driver Licencing Service (NDLS) from Tuesday 29th October 2013. He said that there will be a full-time NDLS Centre located at Ballybrit Business Park and a part-time facility will be provided at Clifden. The centre at Ballybrit will be open from 9am to 5pm Monday to Friday and from 9am to 2pm on Saturdays and will remain open through lunchtime. People will be required to present themselves at the centres bringing with them additional documentation to confirm identity such as proof of address, passport and old driving licence or permit. The process also involves a face-to-face meeting as well as having a digital photograph and signature captured.
