James Harrold informed the Committee that £1,200 would be assigned from his programme for a County Council visual arts programme based in Tuam. Tuam Library has a Gallery space which will be the centre for the visual arts in the county and it will be a very important part of the county arts policy. The venue will also be suitable for literature and music.

Clr. Finnegan expressed disappointment that Tuam did not feature in the group allocation and he was not in favour of the large amount of money being spent in the city. Mr.Harrold said that Tuam would be catered for in his programme on the visual arts.

Clr. M. Lynch asked if something could be done in Athenry on the 15th August, and the Arts Organiser said he would consider the matter but, in fact, no group had made application for a grant. He would, however, definitely include Athenry as part of his programme and there would be events in Athenry.

Clr. M. Fahy complimented the Arts Organiser on the work he had done during the year and said he felt the committee did very useful work and the arts in the county had benefited greatly.

The Chairman also thanked Mr. Harrold, Tom Kavanagh and Maura Moloney for their services.

4294 - RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955 - PLANNING APPLICATION NUMBER 62988 - APPLICANT: MARTIN MURPHY:

The resolution set out on the Agenda was proposed by MEP Killilea and seconded by Councillor J. Molloy.

The following report had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION OF SITE:

The site is located on a lay-by of the N.64 Claregalway/ Oranmore Route approximately 1 mile from Claregalway.

PLANNING HISTORY:

Ref. No. 8218: Outline Permission refused for a house by the Planning Authority and the Minister for Local Government - Applicant: James Moran.

Ref. No. 9543: Permission refused for a house -

Ref. No. 31783: Outline Permission refused for two houses - Applicant: Martin Murphy.

Ref. No. 33671: Outline Permission granted for a house on the basis of an essential housing need claim - Applicant: Martin Murphy.

PLANNING CONSIDERATIONS:

The site is located on a short lay-by which was formed by the realignment of the National Secondary Route. This is one of a number of similar lay-bys which are located along the Claregalway/Oranmore Road, and indeed along other National Routes which have been realigned. The Planning Authority have applied the same restrictions to development along these bypassed sections as it has on direct accesses because such development will generate turning movements to and from the road and consequently increase the risk of accidents

and reduce the carrying capacity of the routes and the return on the public investment in their realignment and improvement.

The precedent which would be set by the granting of this proposal would result in a considerable number of similar applications along this and other national routes thereby negativing our policy of restricting development in the interests of public safety.

The applicant has already obtained planning permission for a new house nearby as a replacement for his existing substandard house. He hopes to sell these two sites in order to finance the construction of his new house.

RECOMMENDATION:

Refusal is recommended as follows:

1. The proposed development would constitute a traffic hazard because it would be located on a National Secondary Route where the maximum speed limit applies, and the traffic generated by the development would interfere with the safety and free flow of the traffic along the route.

2. The proposed development would contravene Chapter 8, Table 8A of the County Development Plan which restricts development along the route to the essential housing needs of farmholders families, a category which does not apply in this case in that the sites are to be for sale."

MEP Killilea stated that the applicant for Permission had inherited the land, on which the site of the proposed houses was located, after a long delay due to the fact that his parents had died Intestate. He is a young man with a family of 5 children. They are in poor circumstances living in a two-bedroom thatched house with a County Council demountable nearby to provide sleeping accommodation for members of the family. His application to the County Council for rehousing had been refused and he was unable to obtain a loan to build a house of his own because of his financial circumstances. MEP Killilea said the statement in the Planning Officer's report that the applicant hopes to sell the sites, the subject of the Planning Application is true. He had advised the applicant to apply for Permission for two sites in order to raise the money to build a house for his family on the site in respect of which he had already obtained Planning

MEP Killilea disagreed with the report and said that the sites proposed to be developed are not located on a lay-by but on a serviced County Road which serves two houses and land. The County Council had recently repaired potholes on this particular road. The road was created as a result of still still serves the National Secondary Route but it was

a public road. For this reason and for humanitarian reasons, the Permission applied for should be granted. He stated that the Members had a moral duty to assist the applicant who was in such poor circumstances and he asked for a unanimous decision in favour of granting Permission.

Councillor Brennan stated that this application presented a difficult situation for the Members. They had been told previously that they could only consider planning grounds in dealing with a planning application and the recommendation made to the Members is against the proposal on planning grounds.

The County Engineer stated that the proposal is to construct houses on sites adjoining an old road which had been realigned. The road is still a National Secondary Route but it is such an important route that Class 1 Control has been applied to it in the County Development Plan which is the type of control normally applied to National Primary Routes. The volume of traffic on the route, including heavy vehicle traffic is increasing and the last section of the road is due for realignment next year. Alot of public money has been spent to improve the carrying capacity and safety of the route for traffic and it is not right to permit it to be used to facilitate speculative development. To permit dwellings on such old sections of realigned roads would have the same affect as permitting direct accesses from the point of view of traffic hazard. While he was sympathetic to the applicant's situation, he was obliged to confine himself to planning considerations and was therefore recommending refusal of the application.

MEP Killilea stated that he did not consider that the circumstances which applied in this case would apply on any other route in the County. He stated that the sites will have access to a functional County Road which cannot be described as a lay-by. The applicant and his family have no hope of ever putting a roof over their heads if this Permission is not granted. He stated that if the County Manager would give an assurance that the applicant would get the first County Council house to be built in this area, he would withdraw the resolution.

Councillor McHugh stated that the road adjoining the sites proposed for development is not a National Secondary Route but a County Road giving access to that route.

The County Engineer replied that it is still a National Secondary Route and that the lay-by is of limited standard. The lay-by was left there only for the use of the particular landowners at that location and the junctions were not constructed for any form of major development.

4295 - RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955 - PLANNING APPLICATION NUMBER 62341 APPLICANT: M. O'CONNOR:

The resolution set out on the Agenda was proposed by Councillor Molloy and seconded by MEP Killilea.

The following report had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION:

The site is located on the Galway/Headford National Secondary Road approximately 5 miles south of Headford.

PLANNING HISTORY:

- Ref. No. 36457 Permission for a house granted to Miss Mary Flaherty on the basis of an essential housing need.
- Ref. No. 52324 Permission for a house granted to
 Mary Flaherty, again based on housing
 need. This effectively was a renewal
 of the previous permission which had
 lapsed.

PLANNING CONSIDERATIONS:

The site is located on the N84 route where the maximum speed limit applies and where there has been considerable pressure for housing development in recent years. Permission was originally granted on the site because a housing need was pleaded by the daughter of the farmholder. The County Development Plan allows such an exception to the general policy of restricting development along the route in the interests of traffic safety. It does not permit housing which is unrelated to the working of family farms or the housing needs of farmholders families.

A request for further information inquired as to whether this application did relate to such essential housing need but no answer was made to the query. On the

presumption that the proposal is not related to the housing need of the farmholders family, refusal is recommended as follows.

RECOMMENDATION:

- 1. The proposed devlopment would endanger public safety by reason of a traffic hazard because the site is located on a heavily trafficked section of the National Secondary Road where the maximum speed limit applies and the traffic movements generated by the development would interfere with the safety and free flow of traffic on the road. In addition, the development would militate against the objectives of the Planning Authority to:-
- (a) Preserve the level of service and carrying capacity of the road so that it can fulfill its function as a through road for heavy traffic.
- (b) Protect the public investment in National road network.
- 2. The proposed development would contravene the County Development Plan (Chapter 8, Table 8B) which limits development along this road to particular categories of essential housing need which need does not apply in this case."

Councillor Molloy stated that Planning Permission has been granted in this case and the application before the Members is an application for alteration of house plans and should be granted.

The County Engineer stated that the Permission which Councillor Molloy had referred to was granted on the basis of housing need. The current application has been made by a different person who has not claimed any such housing need. The site is located adjacent to the main Galway/Headford road on a straight stretch of road on either side of which major realignment is required. The road carries a substantial volume of traffic and the traffic movements generated by an access onto this route would constitute a problem and a risk for the public using the road. The Council's policy in restricting accesses to this route is intended to prevent risk to traffic using the route.

Councillor Molloy stated that the situation with regard to traffic had not changed since the previous Permission was granted.

Councillor Brennan asked if the present applicant was related to the landowners and possibly entitled to claim housing need. He suggested that the matter be deferred in order to obtain clarification on this point.

The County Manager stated that the applicant would be afforded the opportunity to submit such information if the Members so wished.

The resolution set out on the Agenda was proposed by Councillor Mannion and seconded by Councillor Welby.

The following report had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION:

Site is located on the Galway-Moycullen National Secondary Route.

PLANNING HISTORY:

Ref. No. 7810: Outline Permission refused, on a smaller site which forms part of proposed site, for factory in 1970. Applicant: T. O hEigeartaigh. Ref. No. 9017: Outline Permission refused for 2 no. dwellinghouses on proposed site in February 1971. Applicant: P. Fahy. Ref. No. 23769: Outline Permission refused by Planning Authority and on appeal on proposed site in August 1977. Applicant: P. Fahy. Ref. No. 31008: Outline Permission for 1 no. dwellinghouse granted by Section 4 direction on proposed site in June 1979. Applicant: Patrick Fahy. Ref. No. 33865: Approval granted on proposed site for dwellinghouse in June 1980. Ref. No. 59807: Outline Permission for one house refused 23/11/89. The application was the subject of a Section 4 Resolution passed at the County Council Meeting on 10/11/89. An Appeal to An Bord Pleanala against the decision to refuse outline permission was lodged but later withdrawn.

PLANNING CONSIDERATIONS:

Site is located on a restricted National Secondary Road at a point where the maximum speed limit applies. Applicant has not made a housing need claim and has clearly replied no to all housing need categories on application form. During discussions on Outline Permission ref. no. 31008 granted by Section 4 direction it was stated (see Minutes) that applicant needed a house for himself and had no accommodation. The fact that the house was not constructed during the period of the Permission indicates that no housing need existed.

RECOMMENDATION:

Refusal is recommended as follows:

- 1. The proposed development would endanger public safety by reason of a traffic hazard because the iste is located on a heavily trafficked National Secondary Route where the maximum speed limit applies and the traffic movements generated by the development would interfere with the safety and free flow of traffic on the road.
- 2. The proposed development would contravene the County Development Plan (Chapter 8, Table 8B) which limits development along this road to local family housing needs, a category of development which does not apply in this case."

Councillor Mannion stated that the applicant is not the owner of the house in which he is living and he wants to build his own house. He had commenced building a road and laying foundations on foot of the Planning Permission granted to him in 1979 but was forced to discontinue work because of legal action taken against him by a neighbour for interference with a water course. The ensuing delay had resulted in the expiration of the Permission.

The County Engineer stated that the site of the proposed development adjoins an unrealigned section of the National Secondary Route on which improvements will have to be carried out when monies become available. It is a quite dangerous section of road and a dangerous place to have an entrance onto the National Secondary Route. The road is relatively narrow and visibility is not good at this location and there is a high accident rate at this point. The applicant had answered no to all the queries as to housing need category on the planning application form. The applicant is not a farmholder and owns only the site on which he has sought planning permission. The fact that he owns the site does not entitle him to a grant of Planning Permission. He recommended that Permission be refused.

Councillor Mannion proposed that consideration of the resolution be deferred and this was agreed.

"LOCATION:

Site is located on the Oughterard-Glann Road.

PLANNING HISTORY:

Ref. No. 4347: Outline Permission granted on the proposed site in August 1968. Applicant: P.J. Oulton - extension to same granted to 31st October, 1986.

Ref. No. 4906: Approval granted on a larger site in September, 1968. Applicant: P.J. Oulton.

Ref. No. 58857: Permission refused on the proposed site by Planning Authority and on appeal in January, 1990.

Ref. No. 61688: Outline Permission refused on the proposed site in January 1991. Applicant: Hilary Joyce Kelly.

PLANNING CONSIDERATIONS:

The site is located close to Lough Corrib in an area of Outstanding Scenic Amenity. Permission for housing development is only granted in such area to serve the essential housing needs of local farmholders and their families. No such need exists in this case and the proposal therefore is contrary to the provisions of the County Development Plan. The development in an elevated, exposed location, overlooking Lough Corrib would detract from the visual amenities of the area, would further erode the amenity of this highly scenic stretch of lakeshore.

RECOMMENDATION:

Refusal is recommended as follows:

- 1. The site is located in an Area of Outstanding Scenic Amenity where it is the policy of the Planning Authority to limit development to cases of essential housing need. No such need exists in this case and the proposed development if permitted would be contrary to the provisions of the County Development Plan and to the proper planning and development of the area.
- 2. The site is in an elevated location overlooking Lough Corrib in an area of Outstanding Scenic Amenity with views of special amenity value and the proposed development would be an obtrusive feature on the landscape which would not be capable of being assimilated into the surroundings. The development would obstruct views the preservation of which are an objective of the County Development Plan and would therefore be contrary to the proper planning and development of the area."

Councillor Welby stated that the applicant wants to build a house and live beside her parents as she is the only member of their family.

The County Engineer stated that the site is located in an area of Outstanding Scenic Amenity where no development is permitted other than single houses to meet the housing needs of local landowners. The erection of the dwellinghouse at the proposed location would lead to the erosion of the amenity of the lakeshore.

Councillor Welby stated that the applicant wishes to return from Dublin to live in the area in which she was born and bred and he could not understand why the applicant could not get Permission when Permission had been granted for a house just over the wall from the proposed site. He asked if a vote on the matter could be postponed as a number of Members were outside the Chamber at the time. The Chairman stated that a vote could not be postponed.

Councillor Welby then proposed that consideration of the resolution be deferred to the Meeting to be held on the 27th May, 1991, and this was agreed.

The following report had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION:

Site is located on Doonloughaun Road approximately a half mile north of the Ballyconneely - Bunowen Road.

PLANNING HISTORY:

Ref No. 62415 - decision to refuse permission on proposed site issued 20/12/'90 - application on appeal by applicant. (i.e. John Terence Sweeney).

Ref. No. 62958 - Permission refused on proposed site in March '91. (Applicant - John Terence Sweeney).

PLANNING CONSIDERATIONS:

The site of the proposed dwellinghouse is in extremely elevated and exposed location and the dwellinghouse proposed by reason of its scale and location would be extremely injurious to the visual amenities of the area. Through discussions with applicant and Deputy P. McCormack during the course of the above application, applicant was informed that alternative locations on family farm holding, not more than 150 feet from proposed location would be acceptable to the Planning Authority. Applicant refused to revise his proposal to the more acceptable locations and claimed that the surrounding lands were in his brothers ownership. However, the original proposal, reference number 62415 indicated the septic tank and percolation area within the confines of the site outlined. Applicant did not appear to have any difficulty relocating the septic tank and percolation area outside site boundaries to comply with Chief Medical Officer's

requirements without being requested to do so by planning Authority.

Any development on this site will be visible for miles in all directions and will be an extremely obtrusive feature in the landscape.

RECOMMENDATION:

1. The site proposed to be developed is in an extremely elevated and exposed location in an area of outstanding Scenic Amenity and the development proposed would be an obtrusive feature which would not be capable of being satisfactorily assimilated into its surroundings. The development would detract from views, the preservation of which are an objective of the County Development Plan. The proposal, therefore, would be contrary to the proper planning and development of the area."

Councillor Mannion stated that the applicant is retired and has returned from abroad and wants to build a house. He has no other site on which to build. He said that there is a conflict with the Plan but he was not qualified to speak on it and just wished to propose the resolution.

The Chairman asked if Councillor Welby wished to add anything in support of the resolution and he replied that he did not.

The County Engineer stated that the location proposed for the house in on an exposed and elevated site in an unspoilt area. Two people from the Planning Office had met the applicant on site to discuss alternative locations for the house with him but he would not compromise even though there are suitable alternative locations available. The applicant had already constructed a road into the site and had done a certain amount of environmental damage.

Councillor Mannion stated that there is a very small land holding and 15 or 16 members in the family and that it may not be easy for the applicant to choose an alternative site.

The County Engineer stated that he must be the owner of the land on which he built the road and that he could build a house where the road was being constructed but at a lower level in order to preserve the amenity of this unspoilt area. In reply to a question as to whether there were any objections from the public to the proposal, he replied that there were not.

Councillor Brennan stated that the applicant was being unreasonable.

Councillor Welby proposed that consideration of the resolution be deferred to a future Meeting of the County Council and this was agreed.

4301 - CLONTUSKERT GROUP WATER SCHEME:

Councillor Callanan asked for information as to the up-to-date situation with regard to the Clontuskert Group Water Scheme and expressed the hope that the matter is progressing with urgency.

The Assistant County Manager replied that excellent progress is being made in the preparation of documents and it was expected that these would be lodged with the Department of the Environment before the end of the month.

Councillor Brennan stated that the group had alot of questions that they required answers to. Rumours had been circulating that hold ups were being experienced in the matter and they required re-assurance.

The Assistant County Manager stated that when the documents had been received from the Consultants and examined, he would meet with the Group and provide them with details of the scheme prepared by the Consultants. He could not specify a date for such a meeting but expected that it would take place approximately two weeks after receipt of the documents from the Consultants. He reminded the Members that it was a matter for the Department of the Environment to provide the money necessary for the scheme and that the County Council had no information as to whether or not the Department will make the necessary money available.

The Chairman welcomed the Members of the Clontuskert Group who were present at the Meeting and assured them that

everything possible was being done to progress the matter. He stated that he appreciated the interest shown by so many people in the scheme and he thanked the Officials of the County Council for giving it the priority it had been given.

4302 - WILLIAMSTOWN SEWERAGE SCHEME:

Councillor Walsh referred to the possibility of a C.P.O. for the purpose of obtaining land for the siting of the Treatment Plant in connection with the Williamstown Sewerage Scheme and stated that Compulsory Purchase was not the best method for acquiring the land in this case. He said that people would prefer if the land were to be acquired by agreement.

He referred to a Notice of Motion which he had submitted asking that the C.P.O. be abandoned and to the reply he received to the effect that Members of the County Council Staff would enter into further negotiations with the landowner with a view to reaching agreement. An assurance had been given by the Minister for the Environment that money would be provided when the County Council had acquired the site for the Treatment Plant and the C.P.O. procedure would only delay the progress of the scheme. He had spoken to the landowner who was well disposed towards the transfer of the land. He said he was aware that there is a considerable gap between the amount required by the landowner by way of compensation and that offered by the County Council, but he felt that the landowner had a legitimate case in that a sewage treatment plant was not a very desirable thing to have on a person's land. The land is situated in the village of Williamstown and the presence of a sewage treatment plant would hinder the sale of sites by the landowner. He was also aware that an acre of land on the other side of the village was purchased last year for the sum of £13,500. expressed his gratitude to the County Manager for his assistance in the resumption of the negotiations for the acquisition of the land by agreement.

Councillor Finnegan welcomed the commencement of further negotiations and asked that the County Council would make every effort to reach agreement with the landowner rather than have the scheme delayed by the C.P.O. procedure.

Senator Hussey stated that he would not rule out the possibility of C.P.O. as the sewerage problem in Williamstown was on-going and needed to be dealt with urgently. He expressed the hope that the negotiations would be successful.

The Assistant County Manager stated that the County Council had written to the landowner requesting another meeting but the landowner had not yet replied. If further negotiations will proceed by way of C.P.O.

The Assistant County Manager referred to the various water and sewerage schemes to a total value of £39.758 M which are provided for in the Operational Programme for the period up to 1993.

Referring to the Capital Allocations, he said that the sum allocated to date was £1.394 M which relates only to schemes presently under construction. He said that further allocations will be made for new schemes during the year. He referred to the various schemes in respect of which allocations had been made.

Councillor Mannion asked what the situation was with respect to small sewerage schemes. He referred in particular to the Tully Scheme stating that the County Council had already agreed to undertake a scheme for this area but that the rules were changed resulting in the deferring of the scheme. The estimated cost in 1984 was £50,000 and the current estimate is £200,000.

The Assistant County Manager stated that the Operational Programme contains the priority listing for Water and Sewerage Schemes. The County Council has prepared other schemes but they are further down in the priority ratings. Small village schemes will be taken up in due course but the larger schemes are the County Councils own priorities.

The Chairman stated that many small villages in East Galway have no services and that the larger Centres always win out in the competition for funds. He suggested that the County Council should try to discriminate in favour of the smaller towns and villages and should have a definite policy to provide services for these villages before the end of the Century.

The County Manager stated that it is not a matter of policy and that for several years, the County Council had only got a trickle of money for Capital Schemes. In the current year, the situation is somewhat improved with the availability of Structural Funds but it will be many years before all of those schemes that are currently planned are provided. He reminded the Members that there is a considerable cost involved in putting schemes out to planning and that sewerage schemes are very expensive in terms of cost per house. There is also a considerable maintenance cost involved in all schemes that are provided and no provision is made in State funding to finance maintenance works. There has been a strong demand from Members for the larger schemes. In the case of Water Schemes, there is an immediate economic return for example, in terms of dairying, but it is only in recent times that money has been made available for sewerage

Councillor Ryan suggested that there should be a priority list drawn up for Small Schemes in addition to that drawn up

for Major Schemes.

Councillor Finnegan asked if any reply had been received from the Department of the Environment relating to the approval of the Tender Documents for the Tuam Sewerage Scheme and he suggested that a reminder be sent to the Department.

The Assistant County Manager replied that the County Council Officials had discussed the matter with the Department in the previous week and had pressed them for a decision.

Councillor Mannion asked for information as to the present position regarding the Letterfrack Water Supply Scheme and the Assistant County Manager replied that he would look into the matter and would write informing Councillor Mannion of the position.

4304 - OPENING OF TUAM TOWN LIBRARY:

Councillor Finnegan asked when the Tuam Library would be opened. The County Manager replied that the Contractor is still in possession of the site but that the County Council would like to have the books installed and to have the Library in operation as quickly as possible. He said he would check on the progress being made in the matter and would talk to the Chairman about a possible opening date.

4305 - TREE FELLING AND HEDGE CUTTING:

Councillor Brennan stated that there was a considerable amount of tree felling taking place in East Galway and people were expressing concern about it. He wondered if there was an excessive amount of tree felling being carried out. He said that he had also noticed hedge cutting being carried out and stated that this could cause disruption of wild life habitats.

The County Manager stated that, as he had previously informed the Members, the County Council has no expertise among its Staff in the matter of what constitutes a dangerous tree. The Council had, therefore, engaged the services of Coillte Teoranta who are marking trees that need attention, such attention may not necessarily mean the felling of the trees. Own advice as to what should be done with the trees that are with the landowners.

The County Engineer stated that most of the trees, which have been marked, have outlived their life span and many would be in excess of 100 years old. He stated that a licence was required in order to fell trees and that he believed a condition of such licences was that two trees should be planted for every one cut. These requirements did not, the Roads Authority. With regard to the question of hedge cutting, he stated that the County Council is not carrying out any hedge cutting at present.

The County Secretary referred to the letter dated 24th April, 1991, which had been received from the Tanaiste and Minister for the Marine in reply to the County Council's request to the Minister to receive a deputation from Galway County Council concerning storm damage and repairs to Roundstone Pier.

Councillor Mannion said that the reply was most unsatisfactory. He understood that the County Council had sought funds for the employment of a Consultant to carry out the necessary design work but the letter makes no mention of this. He proposed that the County Council write again to the Tanaiste and Minister for the Marine and ask him to clarify this.

The County Manager stated that it would be as easy for the Department to employ a Consultant as it would be for Galway County Council. The County Council would be willing to do so if the Department would provide the necessary funds.

Councillor Mannion proposed that a letter be written to the Department of the Marine asking them to clarify the situation with regard to the funding of a Consultant.

The proposal was seconded by Councillor Ryan and agreed.

4307 - COUNTY COUNCIL MEETING TO BE HELD ON 14TH JUNE, 1991:

The Chairman stated that he would lay the foundation stone for the Interpretative Centre at Aughrim on the 14th June, 1991, and suggested that the County Council Meeting on that date should be held in his Electoral Area. A likely venue for the Meeting would be the Community Centre at Kiltormer but he would have to confirm its availability.

On the proposition of Councillor Callanan, seconded by Councillor Finnegan, it was agreed that the County Council Meeting of the 14th June, 1991, would be held in the Ballinasloe Electoral Area.



Councillor Molloy stated that Planning Permission had already been granted for this site and that the application was just for a change of house plan.

The following report had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION:

The site is located on the Galway/Headford National Secondary Road approximately 5 miles south of Headford.

PLANNING HISTORY:

Ref. No. 36457 - Permission for a house granted to Miss Mary Flaherty on the basis of an essential housing need.

Ref. No. 52324 - Permission for a house granted to Mary Flaherty, again based on housing need. This effectively was a renewal of the previous permission which had lapsed.

PLANNING CONSIDERATIONS:

The site is located on the N84 route where the maximum speed limit applies and where there has been considerable pressure for housing development in recent years. Permission was originally granted on the site because a housing need was pleaded by the daughter of the farmholder. The County Development Plan allows such an exception to the general policy of restricting development along the route in the interests of traffic safety. It does not permit housing which is unrelated to the working of family farms or the housing needs of farmholders families.

A Request for Further Information inquired as to whether this application did relate to such essential housing need but no answer was made to the query. On the presumption that the proposal is not related to the housing need of the farmholders family, refusal is recommended as follows.

RECOMMENDATION:

1. The proposed development would endanger public safety by reason of a traffic hazard because the site is located on a heavily trafficked section of the National Secondary Road where the maximum speed limit applies and the traffic movements generated by the development would interfere with the safety and free flow of traffic on the road. In addition, the development would militate against the objectives of the Planning Authority to:-

- (a) Preserve the level of service and carrying capacity of the road so that it can fulfill its function as a through road for heavy traffic.
- (b) Protect the public investment in National Road Network.
- 2. The proposed development would contravene the County Development Plan (Chapter 8, Table 8B) which limits development along this road to particular categories of essential housing need which need does not apply in this case."

On the suggestion of the Chairman, the Members agreed to take the report as read.

The Senior Executive Engineer (Planning), Mr. Kavanagh, informed the Members that the existing Permission on the site was granted to meet an essential housing need as provided for in the Development Plan. The Permission was not subject to an Enurement condition and could, therefore, be availed of by any person who might be in possession of the site. The policy set out in the County Development Plan is to restrict housing development to single houses required to meet the essential housing need of local farmholders and their immediate families. Since the present applicant is not a farmholder, and has only purchased the site proposed to be refuse Permission.

No. 9017: Outline Permission refused for 2 no. dwellinghouses on proposed site in February 1971. Applicant: P. Fahy. Ref. No. 23769: Outline Permission refused by Planning Authority and on appeal on proposed site in August 1977. Applicant: P. Fahy. Outline Permission for 1 no. Ref. No. 31008: dwellinghouse granted by Section 4 direction on proposed site in June 1979. Applicant: Patrick Fahy. Ref. No. 33865: Approval granted on proposed site for dwellinghouse in June 1980. Ref. No. 59807: Outline Permission for one house refused 23/11/89. The application was the subject of a Section 4 Resolution passed at the County Council Meeting on 10/11/89. An Appeal to An Bord Pleanala against the decision to refuse outline permission was lodged but later withdrawn.

PLANNING CONSIDERATIONS:

Site is located on a restricted National Secondary Road at a point where the maximum speed limit applies. Applicant has not made a housing need claim and has clearly replied no to all housing need categories on application form. During discussions on Outline Permission ref. no. 31008 granted by Section 4 direction it was stated (see Minutes) that applicant needed a house for himself and had no accommodation. The fact that the house was not constructed during the period of the Permission indicates that no housing need existed.

RECOMMENDATION:

Refusal is recommended as follows:

- 1. The proposed development would endanger public safety by reason of a traffic hazard because the site is located on a heavily trafficked National Secondary Route where the maximum speed limit applies and the traffic movements generated by the development would interfere with the safety and free flow of traffic on the road.
- 2. The proposed development would contravene the County Development Plan (Chapter 8, Table 8B) which limits development along this road to local family housing needs, a category of development which does not apply in this case."

The Chairman reminded the Members that a full discussion on the proposal had taken place at the May Planning Meeting and it was agreed, therefore, that the report should be taken as read.

The Senior Executive Engineer (Planning), Mr. Kavanagh, stated that there was no change in the report from that presented to the previous meeting.

Deputy McCormack stated that he had not been present at the previous meeting but he understood that new information had come to light at that Meeting which caused the matter to be deferred. The information was to the effect that the applicant could not have availed of the Permission previously granted in respect of the site because of legal difficulties which had arisen after he had constructed the foundation for the house.

Councillor Mannion stated that there had been a Court case relating to the land and that a County Council Engineer, not connected with Planning, had advised the applicant to stop work until the Court case was resolved.

In reply to a question from Councillor Brennan as to whether or not this would affect the issue before the Members, Mr. Kavanagh stated that the previous grant of 'ermission in respect of this site was made in 1979 as a result of a direction under Section 4 and that the Planning situation was the same then as now. Refusal of Permission was recommended then and is recommended now.

In reply to a query from Councillor J. Burke, Mr. Kavanagh stated that he could not confirm that the foundations of a house had been constructed. The law required that substantial works pursuant to a planning permission should have been carried out within the life of the permission if an application to extend the duration of such permission were to be considered. He doubted if the laying of foundations could be regarded as constituting substantial works.

Ref. No. 4906: Approval granted on a larger site in September, 1968. Applicant: P.J. Oulton.

Ref. No. 58857: Permission refused on the proposed site by Planning Authority and on appeal in January, 1990.

Ref. No. 61688: Outline Permission refused on the proposed site in January 1991. Applicant: Hilary Joyce Kelly.

PLANNING CONSIDERATIONS:

The site is located close to Lough Corrib in an area of Outstanding Scenic Amenity. Permission for housing development is only granted in such area to serve the essential housing needs of local farmholders and their families. No such need exists in this case and the proposal therefore is contrary to the provisions of the County Development Plan. The development in an

elevated, exposed location, overlooking Lough Corrib would detract from the visual amenities of the area, would further erode the amenity of this highly scenic stretch of lakeshore.

RECOMMENDATION:

Ref. No. 30658: Outline Permission granted on the proposed site for a dwellinghouse by Section 4 direction in March 1979. Applicant: Miss Katleen Meenaghan.

Ref. No. 33252: Approval (of Outline Permission) granted on the proposed site in November 1979. Applicant: Miss K. Meenaghan.

Ref. No. 62923: Permission for erection of dwellinghouse refused 10/4/91. A Section 4 resolution relating to the application was considered at a number of County Council meetings but was lost for want of a sufficient number voting in favour at the County Council meeting on 8/4/1991.

PLANNING CONSIDERATIONS:

The proposed development is extremely elevated and exposed and is located in an area of Outstanding Scenic Amenity. The development would be visible over a wide area and from Lough Corrib. The site has no road frontage is not in accordance with requirements of County Development Plan and would, therefore, constitute backlands development.

Permission for housing development in areas of outstanding scenic amenity is limited to the essential housing needs of local farmholders and their families. Such a need has not been substantiated in this case. Such a need has not been substantiated in this case. Permission was previously refused by the Planning Authority on this site (i.e. ref. 28807) and the only permission granted was by way of Section 4 direction.

RECOMMENDATION:

1. The development is located in an area of Outstanding Scenic Amenity where it is the policy of the

planning Authority to limit development to the essential housing needs of local landowners and their families. No essential housing need has been substantiated in this case and the proposed development, if permitted, would be contrary to the provisions of the County Development plan and to the proper planning and development of the area.

The site is in an elevated and exposed location overlooking Lough Corrib in an area of Outstanding Scenic Amenity would be an obtrusive feature which would not be capable of being satisfactorily assimilated into its surroundings. The development would seriously detract from the visual amenities of the area and would be contrary to the proper planning and development of the area.

Kavanagh stated that the site is located in an area designated in the County Development Plan as being of outstanding scenic amenity where development is restricted to single houses required to meet the essential housing need of local farmholders. Since the last meeting, the applicant had completed a questionnaire form as to his housing need but had not submitted a map showing the family farm holding. The County Council normally required details of an applicant's farm holding in order to establish if a genuine housing need existed, and in the absence of such details from the applicant, it was difficult to establish if there was a housing need in this case.

Councillor Brennan stated that it was a pity that such information had not been submitted earlier by the applicant.

PLANNING CONSIDERATIONS:

The workshop is located in an area which is zoned for residential use in the Barna Development Plan. The proposed use is one which would not be permitted in a residential area without interference with the residential amenities of same.

RECOMMENDATION:

Refusal is recommended as follows:

1. The proposed development is located in an area which is zoned for residential use in the Barna Development Plan and the proposed use by reason of noise, hours of operation, etc. would be seriously injurious to the residential amenities of the area. The development would contravene the County Development Plan which prohibits such uses within residential zoned areas and would, therefore, be contrary to the proper planning and development of the area."

Councillor J. Molloy stated that the applicant is young man who does odd jobs and that the development, the subject of the application, is more a store for materials and tools than a Workshop.

Councillor U. Burke referred to the map circulated to the Members with the report and stated that the map shows that the site of the proposed development is at the end of a cul-de-sac road. He said that the owner of the dwellinghouse adjoining the site on one side, Mr. Shaw, had no objection to the development and that the applicant himself had recently purchased the nearest house on the other side. He read the following letters from Mr. Shaw and from the applicant to the Meeting;

He stated that these letters had not been available to the County Council Officials when the report was prepared through an oversignt on his part. He expressed the view that Permission should be granted in this case.

Councillor Brennan stated that he had assumed that the Workshop in question was for car repairs and he asked if this were the case.

Councillor U. Burke stated that the applicant is a Carpenter who works mostly away from the site. He would propose to carry out work in the Workshop only on an odd occasion and the situation was as Councillor Molloy had stated, that the premises would be more a Store than a Workshop.

The County Manager stated that this application would be reconsidered in the light of the new information furnished and if any difficulties arose, the applicant would be asked to extend the time so that the matter could come before the Members again. It was agreed, therefore, to defer consideration of the matter to a future meeting should such be necessary.

4314 - LOCAL ELECTION - POSTERS:

Councillor Glynn proposed that Political Parties involved in the Local Election should agree together not to erect posters in the interests of the amenity of the countryside and prevention of litter.

Deputy McCormack stated that his party would not be putting up posters in connection with the Local Elections, and that he hoped that other parties would agree with this. He also suggested that there should be no canvassing outside Polling Booths as this was unnecessary and unhelpful. Deputy Fahey stated that he would give a commitment on behalf of his Party

that no posters would be erected in public places subject to all other Parties agreeing to do likewise. He considered that a limited number of 8 x 4 posters might be acceptable if other Parties agree.

The Chairman stated that it might be difficult to enforce the ban on posters because people had a right to erect these and there would be many different individuals involved such as Independent Candidates. He could see nothing wrong with posters erected at Polling Booths which could be taken away when the Booths had closed.

A number of Members referred to the difficulties created by such posters for Tidy Towns Committees throughout the County.

15 - REMOVAL OF SAND FROM BEACH AT ROUNDSTONE:

An Comhairleoir O'Tuathail referred to a recent incident when sand was removed from the beach at Dogs Bay, Roundstone, and he asked for a guarantee from the County Council that this would not be permitted to occur again.

The County Manager stated that the situation in this case was that the Department of the Marine had asked the local Engineer if he had any objection to the taking of 30 tons of sand from below high water mark, i.e., two lorry loads, and the Engineer was of the opinion that the removal of such a quantity of sand for research purposes would not cause any problem. The County Council did not give Permission for the removal of the sand, such removal was licensed by the Department of the Marine and the County Council's Engineer was simply asked for his opinion and gave it. If any proposals are made for the removal of further quantities of sand, the County Council would look at the matter differently.

Deputy McCormack stated that he had been informed by the Department of the Marine that they had granted a Licence for the removal of the sand. He stated that the sand was taken from under a bank and a fence erected by way of a FAS Scheme had been removed. He said that the persons removing the sand did not have Permission to cross private property and he also asked for an assurance that no further sand would be removed from the beach at this location.

It was proposed by Councillor Ryan, seconded by Councillor Brennan and resolved:

A358 - RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT

(AMENDMENT) ACT, 1955, AS AMENDED - PLANNING APPLICATION

NUMBER 62752 - APPLICANT: CAOIMHIN O HARA:

The following report had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION OF SITE:

The site is located on the road from Carraroe to Bealadangan approximately 3/4 mile north of Carraroe.

PLANNING HISTORY:

No previous planning history.

PLANNING CONSIDERATIONS:

The applicant's site is very restricted measuring approximately 110 ft. wide by 150 ft. deep and rises from front to rear. The applicant's proposals involve siting the percolation area within 20 ft. of the public road and within 40 ft. of the proposed dwellinghouse. The proposed dwellinghouse would also be located within 40 ft. of the septic tank serving a permitted dwellinghouse to the east of the proposed dwellinghouse.

A trial hole was dug at the location of the proposed percolation area, and on inspection, this trial hole was completely full of water. The soil consists of peat overlying rock. In addition there are land drains running through the site.

The Chief Medical Officer has recommended that the application should be refused on public helath grounds.

RECOMMENDATION:

Refusal is recommended as follows:

- 1. The proposed development would be likely to give rise to a public health hazard as a trial hole inspection revealed the site to be unsuitable for the reception and disposal of septic tank effluent. The proposal, therefore, would be contrary to the proper planning and development of the area.
- 2. The proposed development would, if permitted, constitute substandard development in relation to the siting of the percolation area having regard to the provisions of the County Development Plan and would be liable to constitute a health hazard which would be contrary to the proper planning and development of the area."

Councillor O'Conchubhair proposed that the Section 4 be withdrawn on the basis of the report which had been circulated to the Members. He stated that he had examined the site and it appeared to him that the proposed septic tank was too near to the public road and he had asked the applicant to re-apply for Permission on a different site.

Councillor O'Conchubhair's proposal was seconded by Councillor O'Morain and agreed.

Councillor O'Morain referred to a letter which he had recently received from the County Manager relating to a Planning Application in respect of which he had made representations. He said that he accepted the points made in that letter with regard to Planning considerations but that there was one matter referred to in the letter which he wished to bring to the notice of Councillors. He quoted part of the letter which indicated that the applicant's mother-in-law did not come within the category of persons for whom exceptions are made in the Development Plan to the restrictions on development along certain Regional Routes. He said that if a father is entitled to provide a site on his holding for a son or a daughter, a mother should also be entitled to provide a site for her daughter and son-in-law.

Ref. No. 42716: Permission refused by the Planning Authority for 1 dwellinghouse. Similar application to

Ref. No. 44802: Approval for site development works granted by the Planning Authority. Applicant: John

Ref. No. 62971: Outline Planning Permission for 6 dwellinghouses refused by the Planning Authority. The 6 no. houses would be located on the parcels of open space, subdividing the two larger parcels of open space to the front of the site. Applicant: John Conroy.

PLANNING CONSIDERATIONS:

The site is located off a minor County Road and is serviced by an existing surfaced roadway. Condition no. 1 of Outline Planning Permission ref. no. 40725 required that only 6 no. houses shall be erected on the total lands submitted with that application.

The granting of further permissions would be contrary to this condition on the grant of Outline Planning Permission and would compromise the dwellinghouses in law. existing

There are 5 no. existing dwellinghouses and 1 no recently permitted development for a change of plan granted on the original 6 no. sites. The lands in question were designated Open Space in the grant of Outline Permission and Approval.

The granting of further houses would contravene a Development Control Objective of the County Development as indicated in Paragraph 7.1(iv) which seeks to control ribbon development and backlands development in the interests of preserving rural areas.

The granting of Permission would also contravene Paragraph 7.2.6 of the County Development Plan which seeks to strictly control the development of groups of houses within the defined environs of Galway City.

The granting of Permission would further contravene paragraph 7.2.8 of the County Development Plan which seeks to control ribbon development and groups of buildings in off road locations.

The granting of permission for the proposed development would lead to the establishment of precedent for the granting of further developments both within the site of the existing development and by extending the existing roadway further to the north.

Indeed since the current application was received by the Planning Authority 2 no. further applications have been received for individual houses on the open spaces on the MINUTES OF SPECIAL MEETING HELD ON 14/6/1991. right hand side by individuals other than the applicant but who claim to be the land owners.

The granting of permission would also lead to the establishment of precedent for such off road development in the immediate area which would overload the carrying capacity of the minor County Road.

RECOMMENDATION:

It is proposed to refuse the application on the grounds:

- The proposed development would in conjunction with the existing permitted development constitute an excessive density of housing and septic tank systems in the rural environs of Galway City and would contravent Chapter 7.1 (iv) and 7.2.6. of the County Development Plan which does not permit such groups of houses in this area of special Development Control.
- The proposed development being located on a minor rural roadway in the environs of Galway City would give rise, of itself and by precedent for other similar proposals in this area, to volume of traffic which would not be adequately catered for by width and alignment of the minor County Road serving the site and would thereby tend to create serious traffic congestion."

He added that Outline Permission for six houses had been granted approximately 10 years ago, and 5 of these houses had been built. If the houses now applied for were granted, there would be no open space left to serve the permitted houses as a playing area for children.

Councillor McCormack stated that the occupants of the 5 existing houses want the proposed houses to be built so that the estate can be finished. He expressed the view that the Devlopment in question is exactly the type of development which the County Council would like to see in rural areas. It is located off a minor road, there are no septic tank problems involved as one the proposed houses will be located on a site comprising an area of one acre and the other on a site comprising an area of half an acre. He said he had had a number of photographs taken for the information of the Members and he held up the photographs for the Members to see. He disagreed with the Planning Officer's report to the affect that the proposed development would lead to traffic congestion and he referred the Members to the photographs which he had displayed showing the road serving the development. He expressed the opinion that it would be in the interests of proper planning and development to grant Permission in this case.

In reply to a query from Councillor Brennan as to whether the location of the proposed development was a private housing estate, he stated that he would not describe it as such since the individual householders on the estate had arranged for the building of their own houses.

Councillor McCormack replied that there was a considerable amount of undeveloped land surrounding the development which would be made available as open space if needed and that the occupants of the existing houses welcomed the proposed development.

The County Engineer stated that all the fields around the development are not available for the enjoyment of the residents and he also pointed out that the County Road leading to the site is a narrow road where two cars would have difficulty passing each other. He said that the Permission for the existing houses was granted 10 years ago and that a similar proposal would not now be granted under the terms of the current Development Plan. The County Road leading to the site is not capable of taking any more development without causing serious traffic congestion.

He also pointed out that the requirements of the Development Plan in relation to the open space to be provided in connection with housing development was that 10% of the development site should to be allocated for the purpose of open space.

Councillor U. Burke stated that while he did not know the site in question, he regarded the County Engineer's comments as being anti-rural. If the proposed development had been ribbon development along a road, everybody would be against it but the development in question is a neat and compact little development and in a situation where people were leaving the country every day, the County Council should welcome the provision of such development in rural areas.

In reply to further assertions by Deputy McCormack and Councillor U. Burke that there would be ample open space available for the existing dwellings if the two proposed dwellings were permitted, the County Manager stated that the two dwellings proposed in the application under consideration by the Members were to be built on lands allocated as open space in the Permission granted for the existing dwellings, and that no provision whatsoever had been made by the applicant for open space in the application now before the Members.

The Chairman advised the Members that under the provisions of the Local Government Act, 1991, it was necessary that at least 22 Members should vote in favour of a Section 4 Resolution if such a Resolution were to be passed, and he therefore declared the resolution lost.

4360 - RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955, AS AMENDED - PLANNING APPLICATION NUMBER 62973 - APPLICANT: MICHAEL SHAUGHNESSY.

The County Engineer informed the Members that a decision to grant Planning Permission had been made in this case.

1361 - RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955, AS AMENDED - PLANNING APPLICATION NUMBER 63551 - APPLICANT: KEVIN WALSH.

The County Manager informed the Members that Further Information had been requested in connection with this application, and that the application would come before the Council again when the information had been furnished.

In reply to a query from Deputy McCormack, he stated that the Section 4 procedure with respect to this application had been validly initiated and that there was no difficulty in bringing the matter before the next Council should such be necessary whether or not the signatories of the Resolution were returned as Members of the next Council.

362 - SYMPATHY:

Resolutions of sympathy were adopted with the following:

363 - TRAVELLERS ENCAMPMENT AT LONG POINT CARPARK, LOUGHREA:

Councillor Loughnane stated that the carpark at Long Point, Loughrea, had, in recent days, been invaded by Travellers. He stated that a similar incident had occurred approximately 2 months previously and Loughrea Town Commissioners had been informed then that steps would be taken to prevent a recurrence of the problem. He asked what steps would be taken to have the caravans removed from the site and to prevent their re-entry.

Councillor U. Burke said that Long Point is a public swimming area but it had been rendered unfit for swimming because of

the encampment.

The County Manager stated that the County Council had been about to erect a barrier at the entrance to the carpark when the Travellers moved in and he informed the Members that whatever steps might be necessary to ensure that the carpark was vacated, would be taken.

Councillor Brennan said that this type of problem is costing Galway County Council a considerable amount of money.

The County Manager agreed that the frequency of such incidents is causing a severe problem to the County Council and diverting the Council's scarce resources. He said that people were being terrorised, and the County Council was unable to help them and that the Government should put legislation in place to deal with this problem.

4364 - ROADSIDE TRADING:

Councillor Glynn stated that he had become aware through the National Association of Hardware Merchants that the Government was considering legislation to control trading on the National Routes. He proposed that the County Council should set up a Committee to discuss the matter with a view to making representations to the Department as he felt that Members would wish to broaden the scope of the legislation to take in public roads other than the National Routes.

Councillor O'Conchubhair seconded Councillor Glynn's proposal.

Councillor J. Burke said that the Local Authority should be given the powers to licence roadside trading and he suggested that representatives from Galway County Council should go to the Department and point out the problems being experienced in County Galway to those drafting the legislation.

The County Manager said that he was aware that a new Roads Bill was being drafted by the Department but he had no information as to what stage it had progressed to. He said that the situation would be examined and if it was found that there was any urgency in the matter, it could be brought back before the Council. Following discussion, the following resolution was adopted unanimously:

"That the prohibition on temporary dwellings under Section 66 of the Roads Bill should apply to all roads and that all temporary dwellings be subject to a licensing system."

4365 - FLOODING OF PUBLIC ROAD AT COOLARNE:

Deputy McCormack asked if any reply had been received from the Office of Public Works to the County Council's request to have drainage works carried out in order to prevent flooding on the public road at Coolarne. MINUTES OF SPECIAL MEETING HELD ON 14/6/1991.

Councillor McDonagh stated that the local community have already purchased pipes to assist in the drainage work and he asked that an Engineer from the County Council be sent to examine the situation.

Deputy McCormack proposed that a reminder be sent to the Office of Public Works in the matter and the County Manager replied that this would be done.

366 - MINUTES:

On the proposition of Deputy Kitt, seconded by Councillor Callanan, the Minutes of the following Meetings were approved and signed by the Chairman:

67 - COUNTY ARTS FESTIVAL:

The Chairman informed the Members that a County Arts Festival was being held for the first time this year and that it would take place in Ballinasloe during the week commencing on Saturday, 15th June, 1991. He said that the Festival would comprise many fine artistic items and he invited the Councillors and the public to come to Ballinasloe for the Festival.

Mr. J. Harrold, County Arts Officer, gave an outline of the Programme of Events for the Festival and he invited the Members to attend the Opening which was to take place in the Town Hall, Ballinasloe, at 7.30 p.m. on Saturday, 15th June. He stated that the Festival would be a celebration of the Arts in County Galway and expressed the hope that the activities generated during the Festival might continue throughout the year.

68 - DECLARATION OF ROADS TO BE PUBLIC ROADS:

On the proposition of Councillor Lambert, seconded by Councillor J. Molloy, it was resolved that the following road be declared a public road:

Road (Estate Name)

Grattan Park, Mountbellew.

Description

Housing Estate located in the townland of Mouthbellew Demesne Roadway of Grattan Park from nearer edge of the carriageway of the N.63 measured southwards for a distance of 191 metres.

4369 - OVERDRAFT FOR 6 MONTHS ENDING 31ST DECEMBER, 1991:

The County Secretary drew the attention of the Members to the change in procedure which had been introduced by the Department of the Environment namely that the Council's approval for the raising of Overdraft should be obtained at 6 monthly intervals instead of quarterly as heretofore.

On the proposition of Councillor U. Burke, seconded by Deputy M. Kitt, it was resolved that:

"Galway County Council hereby approve the raising of Overdraft to the extent of £3 million on the Council's Revenue and Capital Accounts for the period of 6 months ending on the 31st December, 1991, subject to the sanction of the Minister for the Environment."

4370 - SALE OF PLOT OF LAND AT PARKMORE, TUAM:

The County Secretary informed the Members that the land was being sold for a nominal sum to the Tuam Voluntary Housing Agency for the provision of 10 houses for disadvantaged people.

On the proposition of Councillor J. Burke, seconded by CounCouncillor P. Finnegan, it was resolved:

"That Galway County Council hereby approve of the sale of a plot of land at Parkmore, Tuam, to Tuam Voluntary Housing Agency in accordance with the terms of notice dated 31st May, 1991, under Section 83 of the Local Government Act, 1946, and Section 88 of the Housing Act, 1966, which had been circulated to each Member of the Council."

4371 - SALE OF PLOT OF LAND AT MOYCULLEN TO PATRICK VICARY AND CARMEL WALSH:

It was proposed by Councillor J. Molloy, seconded by Councillor J. McDonagh, and resolved:

"That Galway County Council hereby approve of the sale of a plot of land at Gortyloughlin, Moycullen, to Patrick Vicary and Carmel Walsh, in accordance with the terms of notice dated 24th April, 1991, under Section 83 of the Local Government Act, 1946, and Section 88 of the Housing Axt, 1966, which had been circulated to each Member of the Council"

4372 - SALE OF PLOT OF LAND AT CULLAIRBAUN, ATHENRY, TO PETER HAVERTY:

On the proposition of Councillor Martin Lynch, seconded by Deputy N. Treacy, it was resolved:

"That Galway County Council hereby approve of the sale of a plot of land at Cullairbaun, Athenry, to Mr. Peter Haverty, Knockroe, Attymon, Athenry, in accordance

with the terms of notice dated 6th May, 1991, under Section 83 of the Local Government Act, 1946, and Section 88 fo the Housing Act, 1966, which had been circulated to each Member of the Council"

4373 - OFFICIAL OPENING OF TUAM BRANCH LIBRARY:

The Chairman suggested that it would be appropriate to have the Opening Ceremony during the term of office of the current County Library Committee and that the Opening should take place at 12 noon on Monday, 24th June, 1991, prior to the County Council Meeting. He also suggested that the Minister for the Environment should be asked to perform the Opening Ceremony.

It was proposed by Councillor Finnegan and seconded by Deputy Kitt that the Opening of the Tuam Branch Library should take place at 12 noon on Monday, 24th June, 1991, and that the Minister for the Environment be asked to perform the Opening Ceremony.

Councillor Ryan proposed by the County Manager should perform the Opening and Councillor U. Burke seconded the proposal.

The County Manager informed the Members that he would not perform the Opening Ceremony and after further discussion, it was agreed that the Minister for the Environment should be invited and if he was unable to attend, that the Chairman should perform the Opening Ceremony.

4374 - REVISION OF MAJOR EMERGENCY PLAN:

A copy of the revised Major Emergency Plan was circulated to each Member.

The County Manager informed the Members that the changes proposed were relatively minor ones and he listed the changes proposed.

On the proposition of Councillor J. Brennan, seconded by Councillor U. Burke, the Council approved the changes to the Major Emergency Plan.

In reply to questions raised by Members, the County Manager stated that an effort is being made at National level to guarantee the availability at all times of certain key people. He pointed out that with regard to other people involved, the County Council could have a problem at weekends. He said that the full availability arrangements would cost money but until these were in place, the County Council could not guarantee the availability of people and could not compel people to make themselves available.

Councillors complimented the Council's staff, the Fire Brigade and Ambulance Service on their prompt attendance at a recent accident at Kilrickle and complimented the County Manager and Staff on the Major Emergency Plan.

Councillor Lynch, referring to a recent fire tragedy at Craughwell, stated that the Athenry Fire Brigade had not been called although it was located nearer to the scene of the fire than the Loughrea Brigade which was called out.

The County Manager informed the Members that the fire had been notified to Galway Fire Station and the message received indicated that the location of the fire was a mile or a mile and a half on the far side of Craughwell. This was interpreted as being on the Loughrea side of Craughwell, and in fact, there would be no difference in the time taken to reach the scene of the fire as between to the two Fire Stations in view of the better road leading from Loughrea. In reply to a further question from Councillor Lynch, he stated that it would not be practical to place all Fire Stations on alert when a fire call was received.

On the proposition of Councillor Loughnane, seconded by Lynch, the Meeting was adjourned for a period as a mark of respect to the young man who had lost his life in the Fire at Craughwell.

4375 - ACCESS TO TOBER PADRAIC CEMETERY, RYEHILL, MONIVEA:

On the resumption of the Meeting, Councillor Mullins referred to the situation at the Cemetery in Ryehill where Remains had to be carried across 4 fields on a Tractor for burial at the Cemetery. He said that this situation was unacceptable and he asked that the County Engineer would look into the situation with a view to the provision of a suitable means of access to the cemetery.

Deputy Treacy stated that during his term as Chairman of the County Council, a sum of £28,000 had been allocated for the provision of an access to the cemetery. Negotiations had taken place with local landowners on the acquiition of land for the access, but there was one local objector who would not agree to sell the necessary land. An alternative route for the access was identified by the County Council, but the local community would not accept the alternative and the matter could not be progressed any further.

Deputy Kitt stated that there are bushes and briars causing obstruction on the access to the cemetery which is currently in use and he asked that the County Council would remove these.

4376 - AUDITOR'S REPORT ON COUNTY GALWAY V.E.C. FOR THE TWO YEARS ENDED 31ST DECEMBER, 1989:

On the proposition of Deputy M. Kitt, seconded by Councillor J. Brennan, the Council noted the Auditor's Report, a copy of which had been circulated to each Member of the Council prior to the Meeting.

4377 - REVISION OF REMUNERATION:

It was proposed by Councillor J. Brennan, seconded by Coun

cillor P. McHugh, and resolved:

"That Galway County Council approve of the revised salary scales for (a) Full-Time Firefighters; and (b) the County Librarian, in accordance with the sanctions of the Minister for the Environment dated 5th April, 1991, and 4th June, 1991, respectively."

4378 - QUALITY OF WATER IN MULROY AND KILKIERAN BAYS:

Councillor O'Morain said that newspaper reports of a paper read at a Conference in County Donegal had cast doubts on the quality of the waters in Mulroy and Kilkieran Bays. He said that this was part of a media campaign by certain elements that were anti-fish farming. He asked that the Ministers present at the County Council Meeting would suggest to the Minister for Tourism that Bord Failte should carry out the functions assigned to it and should not engage in the dissemination of inaccurate information. He quoted from the paper referred to in the Press reports and said that Bord Failte had made the Statement in question without having consulted with the Local Authority. He said that local fisherman were dependent on the Continent for their markets, and such unfounded statements could do untold damage to the local fishing industry.

He proposed that Galway County Council petition the Department of the Marine and the Department of the Environment to apply to the E.E.C. to have Kilkieran Bay redesignated as a shellfish bearing bay. He said that this would entail special control and monitoring and that the mechanism for such monitoring was already in existence as U.C.G. are already carrying out some monitoring in the area. He added that the title to the Bay is vested in the local co-operative. Councillor Welby seconded Councillor O'Morain's proposal.

Councillor O'Tuathail said that it is not sufficient to seek redesignation and that monitoring must take place as any redesignation will be lost if monitoring results are not made available as required. Part of the problem in relation to fish farming is the lack of monitoring because without such monitoring, there is no information to rebut claims that waters are being polluted.

Councillor O'Morain said that he thought he had made it clear that his proposal would entail monitoring and he stated that the fish farming industry is too valuable to be let go by default.

The County Manager stated that the proposed resoltuion could read that the Bay be redesignated and that the necessary monitoring take place.

Councillor Walsh stated that the water in the Town of Tuam Was of poor quality and that he had got information to the effect that there is a dysentery problem with children in certain areas in Tuam. He said that medical opinion has ad-

The County Manager replied that the reports referred to by Councillor Walsh would be examined.

4379 - LEADER PROJECT:

The County Manager stated that the Department of Agriculture is the administering authority for the Leader Project and that the County Development Team is working closely with Teagasc to help in the processing of applications for Grants. The main activator in the matter is the Corrib Country Group based in Tuam and they have indicated their willingness to liaise with other Groups in the County. Any groups who have good proposals should, therefore, try to get under their umbrella in order to enhance their prospects of success. Such groups would retain their independence but as part of the umbrella group, they would be likely to improve their case. The target population for such projects would be in the region of 100,000.

In reply to a question from Councillor Brennan, he stated that it was his understanding from discussions with the Department of the Environment that the group would be expected to provide 50% of the cost of approved projects.

The Chairman stated that groups should come together under the one umbrella in order to improve their prospects as the total monies available for the whole country amounted to only £23 million. The closing date for the submission of applications is the 15th July, 1991, and any groups who wished to become involved should act quickly. He said that the Udaras would be submitting one project and he considered that the remainder of the County should come together for the purpose of availing of the scheme.

The County Manager stated that the Department of the Environment will make the final decision as to the allocation of grants.

Deputy Treacy stated that proposals had been made that certain parts of the County might combine with adjoining areas in neighbouring Counties.

Deputy Fahey stated that he would be happy to see South Galway going in with the Corrib Country Group. He also said that he wished to take the opportunity to convey the apologies of the people of Gort to the County Development Officer for remarks expressed to him by one individual when he attended a public meeting in the area recently. He wished to assure the County Development Officer that the views expressed by the individual in question were not the views of the people of the area.

The County Manager replied that the Council's experience of the people in the area is as stated by Deputy Fahey.

280 - MARIAN PARK RESIDENTS GROUP, PORTUMNA:

Councillor U. Burke stated that the Marian Park Residents Group had done a considerable amount of work in order to gain national recognition as a tidy area. All the money that they had won by way of prizes in tidy areas competitions had been put into the purchase of a lawnmower used for the maintenance of the open spaces in the area. It had been the practice of the County Council to pay for the petrol used and he asked that this be continued.

The County Manager stated that he would have the matter looked into.

381 - BUSINESS SUBMITTED BY THE COUNTY MANAGER:

The County Manager informed the Members that there were no matters arising under this heading.

382 - BUSINESS SUBMITTED BY THE CHAIRMAN:

The Chairman thanked Mr. Paul Ridge, Senior Executive Engineer (Sanitary Services), for coming to Kiltormer to display the Plan fot the Clontuskert Regional Water Scheme.

He proposed that a resolution be passed calling on the Minister for the Environment to receive a deputation from the County Council which would be seeking the Minister's sanction for the Scheme to go to Tender without delay. The proposal was seconded by Deputy Kitt.

Deputy Treacy proposed that the scheme should provide for the bringing of a water supply to the Reservoir of the Laurencetown/Eyrecourt Scheme. The proposal was seconded by Deputy Kitt.

Deputy Treacy stated that Kiltormer Village is badly in need of a Sewerage Scheme and he asked the Council to give priority to the provision of such a scheme.

The Chairman supported Deputy Treacy's call for the provision of a Sewerage Scheme at Kiltormer and he added that the Council should have a special policy to provide Sewerage Schemes for villages in the County.

Councillor Glynn said that he was aware that a minimum of two to three small Sewerage Schemes are provided in the Counties of Carlow and Laois every year and asked why Galway County Council could not do the same.

Assistant County Manager, Mr. P.J. Gavin, stated that the Members had determined the priorities for Sewerage Schemes in the County and that policy was being implemented subject to the allocation of funds. It was misleading to compare well developed small Counties with a large County such as Galway where major developments require to be carried out.

The County Engineer stated that a separate grant comes from the Department of the Environment each year for Small Schmes. This had been £50,000 but was raised to £70,000 at the behest of Galway County Council. A sum of £70,000 would not be sufficient to finance a Village Scheme. He said that he had also noticed that some of the Counties given allocations for Small Schemes do not get money for larger schemes.

Deputy Kitt stated that the Minister for the Environment had announced Allocations this year for Small Schemes at Headford, Claddaghduff and Ballinasloe.

4383 - RETIREMENT OF COUNTY HURLERS:

Deputy N. Treacy said that Conor Hayes and Ollie Kilkenny had announced their retirement from County Hurling. He paid tribute to their contribution to the game of Hurling and wished them well in their retirement.

The Chairman joined in the good wishes to Messrs Hayes and Kilkenny.

384 - AGENDA:

The Chairman referred to Supplementary Agendas which had been circulated to the Members in addition to the main Agenda. He said that Item No. 1A was a Section 4 relating to a Planning Application. Item No. 2A related to the adoption of the Minutes of the County Council Meeting held on the 27th May, 1991.

He welcomed the Mayor of Galway, Alderman Michael D. Higgins, who was in attendance at the Meeting.

He proposed that Items Nos. 5 and 7 on the main Agenda for the Meeting be deferred without discussion to a future Meeting of the County Council and this was agreed.

The resolution set out on the Agenda was proposed by Councillor J. Molloy and seconded by Councillor J. McDonagh.

The County Engineer read the following report, which had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION:

The site is located in Roscahill opposite the Post Office on the main Galway-Oughterard Road.

PLANNING HISTORY:

Ref. No. 33666 - Permission refused for renovation of dwellinghouse and conversion of part of same to supermarket and installation of septic tank in November 1979 - Applicant: Lawrence Hurney.

Ref. No. 40790: Permission granted on the proposed site on the basis of housing need claim in February 1982 - Applicant: L. Hurney.

Ref. No. 63632: Permission refused for erection and construction of a septic tank on the proposed site in May 1991 - Applicant: F. Gorham.

PLANNING CONSIDERATIONS:

The site is located on a restricted national secondary road at a point where the maximum speed limit applies and the development would be likely to contribute to a traffic hazard. Housing development on this road is restricted to local farmholders and their family housing No such need exists and therefore the develo ment would be in contravention of the provisions of the County Development Plan.

e is approximately 0.1? acres in area and is totally inadequate to accommodate a dwellinghouse, septic tank and percolation area in accordance with County Council minimum requirements ...d minimum building line. Minimum half acre site required for housing development in unserviced rur. reas.

RECOMMENDATION:

- The site is located on a restricted National Secondary Road and the traffic generated by the proposed development would be likely to contribute to a traffic hazard and would interfere with the safety and free flow of traffic or the said road.
- The proposed development would contravene the County Development Plan, Chapter 8 (Table 8B) which

limits housing development along this route to the essential housing need of local farmholders and their families, a category of development which does not apply in this case.

The proposed development would contravene the County Development Plan, Chapter 7 (Table 7A) which requires minimum half acre site with minimum 100 ft. frontage for housing development in unserviced rural The site proposed does not meet this requirement and is inadequate in area to accommodate a dwellinghouse, septic tank, percolation area in accordance with County Council minimum building line and minimum distance requirements."

Councillor Molloy stated that the applicant in this case has a housing need. He is living with his parents who have a large family in the family home and is hoping to get married in the near future and is therefore in need of a house. said that some work had been carried out on the construction of a house on this site some years ago, and that he considered that Permission should be granted.

The County Engineer said that while the applicant may need a house, his housing need does not come within the categories for which special provision is made in the County Development Plan and, in completing his application form, he had indicated that his case does not come within the three categories of need provided for in the Development Plan and specified on the Planning Application form.

Councillor J. Burke asked if there was any point in the County Council considering this application if the site is inadequate in size to accommodate the proposed development.

Councillor Brennan asked if the applicant could get extra land in order to extend the site.

Councillor Molloy said that he had been led > believ : that there is sufficient land available for the siting of the septic tank and percolation area. He 'ded that the applicant is working in the area and that the it to be developed is the only land available to a.m.

The County Engineer informed the Meml rs that even if the applicant were n a position to provide additional lands to locate the septic ink and percolation area in accordance with the County Co l's requirements, he would still be obliged to oppose the application on grounds of traffic safety as the site is located adjacent to the National Secondary Route.

Councillor McCormack stated that there was a two-storey house on the site which had been demolished to make way for the building of a new house, and Council or Welby said that he could confirm that this was the case.

4386 - RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955, AS AMENDED - PLANNING APPLICATION NUMBER 63981 - APPLICANT: JARLATH BRENNAN:

The resolution set out on the Agenda was proposed by Deputy McCormack and seconded by Councillor J. McDonagh. The County Engineer read the following report which had been circulated to each Member of the County Council prior to the Meeting:

"LOCATION:

The proposed site is located to the rear of two dwellinghouses in the Townland of Cregboy, and taking its access onto the National Primary Route by means of a private driveway. The site is circa 1/2 mile on the Galway side of Claregalway, and is outside the 30 and 40 m.p.h. speed limits.

PLANNING HISTORY:

Ref. no. 60218: Planning Permission refused for one dwellinghouse in 1989. Applicant: Mr. J. Brennan. It was proposed to take the access via an overgrown laneway. No essential housing need claimed. Decision not appealed.

Ref. No. 61265: Application similar to 60218. Applicant: Mr. J. Brennan. Refused by County Council and An Bord Pleanala.

Ref. No. 63571: Application similar to 61265 and 60218 save that the access was to be taken via a private driveway. Refused by Planning Authority. Not appealed.

CONSIDERATION:

The proposed development is similar to the above applications. The applicant proposes to take his access onto the National Primary Route via a private driveway. The planning policy is to restrict traffic

movements to and from the National Route. There have been a number of applications recently on this road where it is proposed to build additional houses using existing private accesses. The Planning Authority have been consistent in refusing all such applications as to do otherwise would defeat the policy of minimizing the number of turning movements on the National Primary Route. This application is no different and in the absence of a genuine housing need there is no alternative but to recommend refusal.

RECOMMENDATION:

Refusal is recommended as follows:

1. The proposed development would endanger public safety by reason of a traffic hazard because the site will be serviced by a private lane which will open onto the National Primary Road via a private dwellinghouse gateway. This is a heavily trafficked section of the National Primary Road where the maximum speed limit applies and the traffic movements generated by the development would interfere with the safety and free flow of traffic on the road. In addition, the development would militate against the objectives of the Planning Authority to:

- (a) preserve the level of service and carrying capacity of the road so that it can fulfill its function as a through road for heavy traffic;
- (b) protect the public investment in National road network."

The County Engineer explained that the application before the Members is similar to the last of the previous applications referred to in the report circulated. He said that to grant Permission would be contrary to the policy set out in the Development Plan which is to restrict access to the National Primary route in the interests of traffic safety. The objective of the Development Plan is to eliminate in so far as is possible turning movements on National Primary Routes in areas where the maximum speed limit applies. He said that the area where the site is located adjoins a heavily trafficked section of the Galway/Tuam road and that it is essential that the safety and carrying capacity of the National Routes be preserved. He urged the Members to concur with the refusal of Permission in this case.

Deputy Kitt stated that he did not disagree with the County Engineer except that he wished to point out that in the case of this application, the applicant proposed to gain access to the National Route by way of a private driveway which already serves a dwellinghouse owned by his brother-in-law. There would be no new access and he considered that a person wishing to reside close to other Members of his family should be facilitated. He asked the Members to take this into consideration in coming to their decision.

Councillor J. Burke said that if the County Council were to permit every private access to be used for multiple development, it would be creating a precedent that could not be controlled. He would, however, take issue with the statement that the applicant in this case did not have an essential housing need as he understood that an applicant wishing to build on family lands came within the essential housing need category.

The County Engineer replied that the applicant in this case was not regarded as having a housing need in accordance with the provisions of the Development Plan. He was living in Galway City and at least 5 Planning Permissions had already been granted on the family land in this case.

Councillor 'Morain referred to a question he had raised at the County ouncil Meeting held on the 14th June, 1991, to the effect that a mother providing a site for her daughter and son-in-law was outside the scope of the housing need provisions in the Development Plan. He said that he wished to formally propose at this anomaly be cleared up.

The County Manager eplied that he would undertake to have the matter cleared up if necessary in the next Review of the Development Plan.

- RESOLUTION UNDER SECTION 4 OF THE CITY AND COUNTY MANAGEMENT (AMENDMENT) ACT, 1955, REQUIRING THE IMMEDIATE COMMENCEMENT OF WORKS ON THE N59 NORTH OF CLIFDEN AND ON THE R336 NORTH OF COSTELLO USING THE MONIES AMOUNTING TO £195,000 AND £360,000 ALLOCATED RESPECTIVELY FOR THE WORKS MENTIONED:

The Resolution set out on the Agenda was proposed by Councillor Mannion and seconded by Councillor J. Molloy.

The County Engineer informed the Members that all the steps necessary to commence the work were in train, Contractors had been appointed to produce the necessary stone locally and the works were programmed to commence at a time when they could be carried through to a conclusion without a break. explained that at the present time, the County Council was heavily involved in surface dressing, that this work was greatly dependent on the weather and that the inclement weather of recent times was causing some difficulties. roads, the subject of the resolution were heavily traficked tourist routes and there would be a considerable amount of disruption of traffic on the routes when the proposed work commenced. The Roads staff would be on holidays for a period of three weeks from the end of July and the most suitable time for the carrying out the works would be when the men returned from their holidays so that the work could be carried through without a break and the peak tourist season would have passed so that there would be less disruption of traffic and of the works.

Councillor Welby stated that the expenditure of the money from the Grants in question had been held up principally because the County Council had decided to open quarries and supply its own material. This should have been done in Winter time so that there would not have been any delays in the commencement of works. He said that money from Grants was being used to open up quarries in Connemara while there are tons of materials available at a reasonable price in quarries in Clonbur and other areas. When monies are allocated for Roadworks, they should be spent quickly.

The County Engineer stated that the work would not be done any earlier by taking stone from Private Suppliers, and that by doing what had been done, the County Council were obtaining materials cheaper so that a longer length of road could be done for the same money. The Council's Roadworks for the year were programmed according to the weather and according to the most efficient use of resources.

Councillor O'Tuathail asked if the sum allocated for Road no. R336 was f340,000 or f360,000. He stid with regard to the works, the subject of the resolution that he could not understand how the County Council could get value for money by carrying out the works during the peak tourist season when traffic was at its highest.

The County Engineer replied that the amount of the grant is £340,000. He also said that he considered that the works should not be commenced until September at which time the traffic should have reduced considerably and the Road Staff

would have returned from holidays so that the work could continue to its conclusion without a break.

In reply to a query from Councillor O'Conchubhair as to the amount of the saving which would arise from the Council's decision to quarry its own stone, he said that a rough estimate would be that a saving the region of £150,000 would be amde on the purchase of stone. The additional advantages accruing to the Council from this decision would be that a greater length of road could be completed from the same monies and that stock piles of stone would be available for Roadworks in the following year which would assist the County Council in making its case to the Department of the Environment for monies for Roadworks next year. Another advantage would be a lessening of damage to the Council's road network as the materials would be hauled over shorter distances to the point of use.

In reply to a further question from Councillor O'Conchubhair as to when works proposed for the Islands Road into Lettermullen would be commenced, he stated that the Council hoped to carry out these works before the annual holidays. He added, however, that it was difficult to be precise in the matter due to difficulties in the availability of machinery at this time of year.

Cour or O'Conchubhair proposed that a letter be written to Roin. Ha Gaeltachta requesting that they would allocate mores for Roadworks earlier in the year to facilitate the car ying out of the relevant works during suitable weather conditions, and it was agreed that this would be done.

Councillor O'Morain asked that something be done about the potholes on the Carna to Recess Road. He said that the work should not be left until the end of August and he referred to a particular location where there was a pothole on a bend which he considered to be dangerous particularly for tourists who would not know the area.

De ity Kitt asked if a vote was to be taken on the resolution.

The Chairman proposed that, as Members had got replies to their queries in the matter, the Council should pass on to the rat business and this was agreed.

4388 - WATER SUPPLY ON INISHMORE, ARAN ISLANDS:

At the invitation of the Chairman, a representative of the deputation from Inishmore addressed the Meeting. She said that a similar deputation had attended a County Council Meeting on the 22nd April last and had been told that the additional piping required to improve the water supply on the affected part of the island would be laid as a matter of top priority. Despite this, however, one-third of the island had been without water for a period of 8 days up to to-day. She said that the deputation was requesting the support of the County Council for the provision of water storage tanks on the island as a solution to the water supply problem.

She said that Polling in the Local Elections was to take place on Inishmore the following day, and that the people of the island would not vote in the Local Elections unless the water supply had been restored by 5.00 p.m. on that day.

Deputy McCormack welcomed the deputation and said that he had thought the problem had been solved on the previous Friday, but he now understood that the water supply had again been disrupted. He expressed the hope that the matter would be rectified with all possible speed.

Councillor O'Conchubhair said that the water supply problem was particularly severe because of the high volume of tourist traffic and he urged that a solution be found as quickly as possible. Councillor J. Molloy said that the problem had been on-going for a number of years and that appropriate action should be taken without delay.

Councillor O'Tuathail said that an Undertaking had been given at the April Meeting that the pipelaying would be carried out by mid-June. He said that pipelaying here and in other areas in the County seemed to take a long time, and he wondered if there was not an argument for putting such work out to Private Contract. He also said that a proper storage tank should be constructed as pumps appear to be unreliable. He also asked why a standby pump had not been provided.

The County Engineer stated that the water storage on Inishmore had been improved dramatically in recent years, nd he outlined the works which had been carried ou to improve the water supply. He said that it had always peen the Council's intention to phase out t' two pumps at Pollfliuch and that the provision of storage facilities is in planning but would take time. Two old diesel pumps had been in use at Pollfliuch, one of these had been replaced with a new pump and the other was retained as a standby pump. The problem which had arisen was outside the County Council's control in that the new pump failed and the standby pump also failed. A representative of the pump suppliers had been on the island at the weekend attempting to remedy the situation and it was expected that the pump would be restore to working condition on the day of the Meeting. He said that work is in hand on the laying of pipes from Kilronan and that this work to provide an alternative water supply would be finished within a week.

Councillor McDonagh said that he welcomed the County Engineer's reply and expressed his support for Councillor O'Tuathail's proposal that a lasting solution to this problem be found.

389 - MINUTES:

On the proposition of Councillor Ryan, seconded by Deputy Kitt, the Minutes of the Monthly County Council Meeting held on the 27th May, 1991, were approved and signed by the Chairman.

"RE: LOUGHREA BYPASS

GENERAL

A bypass route for Loughrea was proposed and adopted by Galway County Council on 28th March, 1983.

This proposal was subsequently voted off the Development Plan on 8th August, 1986, by the Council and subsequently removed from the Department of the Environment's road proposals.

Following a committment the landowners and their professional representatives were met on two occassions to explain the proposed route and to lessen if possible the effects of the route on some individual land holdings. I now believe that all of the landowners have been satisfied in relation to the line of the dual carriageway route. (Garden owners at Cosmona houses have not been consulted individually).

Further discussions in relation to access proposals for two landowners who have large severance problems will be necessary when the nature and location of junction or the method of traversing of public roads are agreed with the Department of the Environment.

COMPARISON WITH PREVIOUS BYPASS

- (i) The major difference in the present proposal is that the tie in to the N6 at both ends is now possible without roundabouts. This does not preclude the provision of roundabouts at some stage in the design process.
- (ii) All junctions of intersecting roads on the original proposal were priority junctions. It is hoped in further discussion with the Department of the Environment that agreement will be reached to provide at least one grade separated access to/from Loughrea. This type of access reduces vehicle conflict and is, therefore, safer.
- (iii) The length of the By-Pass proposa is 4.000 km as against the present road length of 4.220 through the town.

BENEFIT OF BYPASS

The benefits of the bypass to the community on be summarised as follows:

(i) Bypass traffic will have a shorter journey t me past Loughrea due to the shorter length of road and the higher speeds possible.

The estimated journey time will be cut from 7.868 minutes (4.220 km @ 30 kph) to 2.712 minutes (4.00 km @ 88 kph) a saving of 5.16 minutes.

Shorter journey length and time will also mean less fuel consumption with the consequent savings to the motorist and the environment.

(ii) By removing through traffic from Loughrea the comfort and safety of pedestrians is improved.

The reduction in fumes and pollution would be considerable. Furth damage to buildings particularly the older ones woul reduced by virtue of the reduction of vibration generated mainly by heavy commercial vehicles. Loughrea town would improve as a shopping area parking and pedestrian access around the town should be easier.

TRAFFIC

Origin/destination traffic surveys were carried out in 3. 1985 and they indicated that the AADT east of Loughrea is 5,...3 and west of Loughrea 4,593. Using the average figure of 5,058 vehicles and a bypass % of 85% (from the surveys) a traffic volume of approximately 4,299 would use the new route every day at mid 1985 levels.

Using an expansion figure of 4% per annum this gives a present bypass traffic of 4,299 x 1.265 = 5,438 (mid 1991). However, traffic counts published in RT480 (E.R.U.) for 1989 indicate that traffic volumes have increased at a greater level than anticipated and the 1989 AADT figures for the sections east and west of Loughrea are 6,792 (10%) and 5,527 (12%) respectively. Expanding these figures to 1991 levels @ 4% per annum increase gives equivalent AADT of 7,346 (10%) and 5,978 (12%) respectively.

The average AADT is 6,662 (11%) of which approximately 85% (based on the 1985 survey) is bypass traffic.

The design period is normally 20 years and expanding the present traffic at a rate of 4% per annum gives a design volume AADT of 14,590 (2.19 x 6.662).

The equivalent peak flow in passenger car units per hour for this volume is 2,105.

This is in excess of the capac_ty of a two lane road with a 7.5 metre carriageway width 'd is within the capacity of a 2 x 2 lane dual carriageway.

I recommend, therefor, that this bypass be designed and constructed as a 2 : lake dual carriageway with the normal median, hardshoulders, res side slopes etc also provided.

DESIGN

The design and land acquisition for the scheme should be carried out by Galway County Council staff

Design standards shall be to the requirements of RT180, RT181, RT182 for alignment.

TOPOGRAPHY

The route of the roadway does not present any insurmountable ground conditions.

With the exception of a short section east of the Bullaun road crossing which has a small amount of soft ground it appears that the ground consists of gravels and limestone bedrock.

The roadway will be designed to minimise the importation of fill material by balancing cut and fill this will reduce damage to adjacent routes at the construction stage.

PROPERTY

As mentioned earlier the landowners along the route were consulted and where possible the route was amended to minimise the affect of the roadway on their property.

Three houses will be demolished under the present proposal and all three landowners have been approached and advised of this fact.

The property owners involved have indicated their acceptance of the route subject to adequate compensation being paid.

Severance of agricultural holdings is insignificant with the exception of two landowners on the western end of the route and both have accepted the route in principle subject of course to any compensation or accommodation works necessary being carried out.

As these matters cannot be finalised until the design stage it is not intended to proceed any further with them at this point.

It will also be necessary to acquire part of the gardens at the rear of th "Cosmona" cottages.

These acquisitions are unavoidable and the amount of land required has been kept to the minimum necessary.

COSTS

The costs of the scheme cannot be quantified with accuracy at this stage but it is expected that it will cost between £5.0 m and £6.0 m.

PROGRAMME

If this line is agreed I see the work progressing to detailed design stage during 1991 and 1992 with a C.P.O. in late 1992/early 1993, enabling the scheme to be included in the next Government Roads Programme. Construction could be undertaken, grants permitting, in late 1993 or early 1994 with work being completed around the end of 1995.

RECOMMENDATION

I enclose a copy of the drawings for this proposal and I recommend that approval be given to proceed to the next stage which is detailed survey and design. The cost of a detailed which will be c. £15,000 and subject to approval I am looking at options for carrying out this survey.

On the propostion of Councillor Loughnane, seconded by Councillor U. Burke, it was agreed that the County Council would proceed with the Design of a road by-passing the Town of Loughrea in accordance with the proposals set out in the report circulated to the Members.

Councillor Loughnane complimented the County Manager, the County Engineer and the staff involved in the preparation of the proposals for the Loughrea By-Pass which he said had taken cognisance of the points raised by the people of He said that the proposals provide for a 2 x 2 lane dual carriageway which will be constructed in one operation. He welcomed the fact that no decision had been taken on proposals for the intersection at Cosmona pending further discussions with the local people.

Councillor U. Burke also welcomed the proposals for the By-Pass and said that they were evidence of what could be achieved by consultation. He had one reservation with respect to the proposals which related to the convergence of the by-pass with the National Primary Route to the west of Loughrea. He considered that there should be a roundabout at this location in order to provide easy access from the Town and to ensure the safety of traffic at the jun tion with the road leading to Athenry.

Deputy Treacy welcomed the proposals for the By-Pass and pointed out that although Drawings had been displayed at the Meeting for the information of Members, no Drawings had been circulated with the keport. He asked if copies of the Drawings could be circulated to the Members. He also said that he knew of some farmers affected by the proposed By-Pass who were not consulted and he asked that the County Council would consult with the people in question. He said he would like to know the exact points of intersection of the By-Pass with the National Primary Road to the east and to the west of Loughrea, and expressed the view that at least one roundabout would be required, and possibly an Overpass.

Councillor Michael Fahy said that the Town of Loughrea needs a By-Pass and expressed the view that a roundabout would be required at both ends of the By-Pass in order to slow down traffic. He also said that carparking facilities should be provided in the Town to alleviate traffic congestion.

Councillor Lynch expressed his agreement with proposals made by other Members for the provision of a roundabout at the

western extremity of the By-Pass. He said that the present situation was extremely dangerous for traffic turning right to go to Athenry. He also requested that the provision of carparking facilities in the Town should be looked into.

Councillor O'Morain also expressed his support for the proposal to provide a roundabout at the western extremity of the By-Pass.

The County Engineer informed the Members that it would be necessary to carry out a survey and to prepare a detailed design for the proposed By-Pass. He said that the County Council would be proposing to provide junctions to the highest design standards available but the Department of the Environment would be providing the necessary monies and they might require changes in the County Council's proposals. He said that the Members would be advised at every stage of the progress of the proposals.

In reply to a query from Councillor Brennan, he sated that lands owned by the Carmelite Order in Loughrea were not affected by the proposals and that a very rough estimate of the cost of the By-Pass including land acquisition would be in the region of £5-£6 million.

The Chairman adverted to the necessity for a By=Pass of the Town of Ballinasloe and suggested that the new County Council should be informed as early as possible of the County Council's proposals in the matter.

4391 - CONTRIBUTION TO IRELAND WEST TOWARDS NEW CO-OPERATIVE ADVERTISING PROGRAMME IN BRITAIN:

The County Manager said that this Programme is an interesting development in the strategy of Bord Failte involving a special advertising Programme for the three Counties in the Ireland West Region - Galway, Mayo, and Roscommon. He said that a special effort was being made this year which had begun with the tourist industry at a disadvantage due to the Gulf Crisis and other factors. He said that this was a commendable project which was a credit to Bord Failte. The amount of the contribution required is £5,000.

Councillor O'Conchubhair stated that it should be conveyed to Bord Failte and to Ireland West that they do not promote South Connemara at all and that the people of that area are totally dissatisfied with their efforts. He suggested that there should be a representative from the Gaeltacht on the Board of Ireland West.

Councillor O'Morain agreed with Councillor O'Conchubhair and suggested that if the County Council is to contribute £5,000 to this campaign, the advertising material should be looked at closely. He said that the advertising should not be specific in that it should not relate to specific location or specific businesses, but should be countywide. The promotion should be a co-ordinated exercise to cover the whole of County Galway and no area should be left out.

The Chairman said that Ireland West and Bord Failte are different organisations but they are often confused by members of the public. He said that Ireland West have shown that they are committed to tourism development in East Galway as proven by their support for the Aughrim Interpretative Centre and by the fact that tourism on the Shannon has increased twofold as compared with previous years.

Councillor J. Burke welcomed the proposal and stated that Galway City should also be asked to contribute to the promotion as they would be major beneficiaries of the campaign.

The County Manager said that the Corporation would be invited to participate.

Deputy Treacy also indicated his support, for the project.

It was proposed by Councillor Mannion, seconded by Councillor O'Morain and resolved:

"That Galway County Council contribute the sum of £5,000 towards the Co-Operative Advertising Programme in Britain of Bord Failte and the Ireland West Tourism Organisation."

Councillor O'Conchubhair referred to the matter of by-lingual signposting in Connemara which results in the English content of such advertising being painted over. He said that this is a result of the use of English place names on maps of the area.

The County Secretary stated that tourist maps are available on which place names are given in Irish.

392 - EUROPEAN CONFERENCE "HOUSING AND THE COMMUNITY" - DUBLIN -3RD/6TH JULY, 1991:

It was proposed by Councillor O'Conchubhair, seconded by Deputy Kitt, and agreed that Councillors J. Molloy and T. Welby be nominated to attend the European Conference on "Housing and the Community" on behalf of Galway County Council.

It was proposed by Councillor Mannion, seconded by Councillor McDonagh, and agreed that Councillor M. Ryan or Councillor J. Lambert attend the European Conference on "Housing and the Community" on behalf of Galway County Council.

393 - LOCAL GOVERNMENT ACT, 1991:

It was agreed to defer consideration of this matter to a future meeting of the County Council.

394 - TWINNING OF TUAM AND STRAUBING:

It was agreed to defer this matter to the next Meeting of the County Council.

It was proposed by Councillor Mannion, seconded by Councillor Welby and agreed:

"That Galway County Council contribute the sum of £43,750 towards the cost of works to be undertaken by the Department of the Marine for the repair of the pier at Roundstone, the sum to be paid in two equal instalments amounting to £21,875, the first of which shall be paid during the year 1992, and the second in the year 1993."

4396 - ARDRAHAN STUDY:

The Chairman stated that, prior to the Meeting, Mr. B. Winstone of the Gort District Rural Integration Development Council had given him a copy of a Study relating to the village of Ardrahan which had been carried out by Mr. Padraic O Cuimin on behalf of the Gort District Rural Integration Development Council. He said he had passed the Study on to the County Manager as it requested that part of the cost of the proposals in the Study would be provided by the County Council. He asked that the County Manager would consider the matter and advise the Members.

The County Manager said that he would do so.

Councillor Welby stated that part of the above Notice of Motion had been omitted from the Agenda and he proposed that the resolution be amended to include the proposal that Galway County Council request the Government not to allow the extradition of any person from the Republic of Ireland to Britain or to the 6 Counties.

The proposed motion, as amended, was seconded by Councillor Mannion and agreed.

4398 - WORKS FOR THE RELIEF OF THE FLOODING OF THE PUBLIC ROAD AT COOLARNE:

Councillor McCormack stated that a sum of £48,000 had been

provided by the County Council in the Estimates for the raising of the section of a public road at Coolarne in order to relieve floooding. He said that a Committee of local Residents had devised a scheme to alleviate the flooding and were proceeding to carry out the work themselves at a cost of £20,000.

He proposed that Galway County Council provide the sum of £20,000, from the monies provided in the Estimates for the raising of the public road, towards the cost of the works being undertaken by the local committee for the relief of flooding in the area provided that the County Council is satisfied with the Committee's proposals.

The County Engineer said that the County Council had proposed to raise the public road but Deputy McCormack and other Members had asked the County Council not to spend any money on the works until the local committee had put forward their proposals for a solution to the problem. It had been ascertained that the scheme being proposed by the local committee would be an acceptable scheme for the purpose of the allocation of Roads Funds subject to confirmation from the Office of Public Works that the scheme proposed by the Committee was acceptable to them and subject to the Council being satisfied on the question of liability to third parties who might be affected by the scheme. No reply had been received to date from the Office of Public Works. He said that it appeared to the County Council to be a worthwhile project and he had asked the Area Engineer to examine the work while in progress.

Deputy Fahey said that if the scheme works, the initiative is to be welcomed. He added that the allocation in the Estimates was intended to cover other roads in the area and that he wished to ensure that these roads would not be affected by anything that was done in connection with the Coolarne Scheme. He said that any monies to be allocated to this scheme should not exceed the sum allocated for the raising of the road in that area.

The County Engineer said hat if the scheme proposed by the local committee is effective, there will be a saving in the amount of money required for Roadworks in the area. He said, however, that the County Council had some reservations about the size of the pipes proposed to be installed.

Councillor McDonagh welcomed the County Engineer's guarded support for the project. He said that the local committee had first hand knowledge of the problem in the area which was supported by professional advice and they were satisfied that the pipe sizes which they proposed were adequate to meet the requirements of the situation. He asked that a decision be made quickly in the matter.

- DANGEROUS BEND ON THE ROAD BETWEEN NUTGROVE CROSS AND TYNAGH:

Deputy Treacy stated that there is a dangerous bend on the public road between Nutgrove Cross and Tynagh near Killeen's house. He said that there is a very serious traffic hazard

at this location and he asked that improvements be carried out in order to relieve the situation.

4400 - OUTGOING MEMBERS OF THE COUNTY COUNCIL NOT SEEKING RE-ELECTION:

Councillor O'Morain said that on the occasion of his retirement from the County Council, he wished to express his thanks to all his colleagues on the Council both past and present with whom he had served during his 17 years with the County Council. He paid tribute to the County Manager and to the County Engineer and to all the Council Staff with whom he had worked very well during the period of his service to Galway County Council. He also paid tribute to the Press which he said was the lifeline of local democracy.

Councillor O'Conchubhair expressed his thanks to the County Manager, to the Staff of the County Council and to his Colleagues for their kindness and courtesy to him during his 12 years of service with the County Council. He said that he enjoyed his time with the County Council and he also thanked the Press and in particular, Radio na Gaeltachta, which he said provides such a great service to the people of the Gaeltacht.

Councillor Lambert thanked the County Manager and the Staff of the County Council and his Colleagues, and expressed his sadness at leaving public life. He said that he had felt particularly honoured to have been chosen by his party colleagues to be their Chairman for the past three years, and he also expressed his thanks to the Press.

Deputy Fahey thanked the Chairman, the County Manager, and the Staff of the County Council and expressed his sadness on the occasion of his departure from the County Council. He expressed his appreciation of the hard work and dedication of the Members and Staff of the County Council. He said that the County Council is a vitally important Forum and that it was important that Local Government should continue to be strengthened and that powers should be levolved to it as far as possible. He said that given the esolve of Members and Staff of the County Council, he was confi ent that the difficulties facing Local Government can be overcome. thanked the Members of the Press for their contribution to Local Government and for their hard work and rofessionalism.

Councillor U. Burke expressed his gracitude to the Chairman, Members and Officials of the Count Council or their support and courtesy to him during his rvice with the County Council. He said he had always be proud to be a Member of Galway County Council and had the greatest respect for all the Staff from the County Manager to the Roadworkers. expressed his special thanks to the County Council's Area Engineers for their courtesy and co-operation. He expressed his regret that more effort had not been made to conduct the business of the County Council at Meetings through Irish.

Deputy Treacy said that he felt privileged to have been elected and to have served as a Member of Galway County

He thanked his Colleagues on all sides of the House, all of whom, without exception, were working in the interests of the community. He thanked the County Manager and all the County Council Staff and said that the work done by the County Council is not appreciated by the public in general. He suggested that the County Council should have an Information Officer to ensure that the public would be aware of the good work being carried on by the County Council.

He wished success to all out-going Members of the Council seeking re-election and he thanked the Press for their contribution to Local Government.

The County Manager said that he was conscious of the significance of the last Meeting of the Council's term of Office which was a milestone in the County Council's history. He said that it was sad for Officials to see Councillors not going forward for re-election, and on his own behalf and on behalf of the Staff, he thanked all the Members for their efforts on behalf of the people of Galway. He said he was aware of the thankless job which Members perform and of the pressures which they absorb. RIBBON DEVELOPMENT:

(Section 7.2.8.(i) of the County Development Plan)

GROUPS OF BUILDINGS (Ribbon Development)

For the purposes of this Chapter, ribbon Definition: development is defined as a group of three or more buildings located on contiguous sites which have frontage onto a public road. Similar groups of buildings in off-road locations are also incloded in this definition.

Development Control Policy:

Applications for such groups of buildings, whether wholly or singly in a piecemeal manner, or singly by addition to two existing or permitted contiguous

buildings will not be permitted.

Principal Considerations:

(a) It seriously impairs the visual amenity and essential character of rural areas by the introduction of inappropriate suburban-type development.

(b) It is in direct conflict with the development centres' policy (2.2.1.(i) of the Planning Authority if located close to urban centres. This policy seeks to direct all urban generated development into towns and villages where infrastructural services costing millions of pounds and community facilities exist or are planned to be provided. Such locations include the environs of Galway, Tuam and Loughrea as delineated in Maps 7A, 7B

(c) It creates undue traffic hazard by the generation of undesirable increases in traffic turning movements on heavily trafficked National Routes. It also leads to undesirable extra traffic flows along County Roads of substandard width or alignment (horizontal and vertical) particularly along sections close to junctions with National Routes. It is pointed out that these County Roads exist primarly to serve the needs of agriculture.

(d) It leads to undue concentrations of septic tanks, which would be prejudicial to public health (including underground water reserves which may be sources of drinking water)."
