The Swimming Pool Committee have been endeavouring to find a suitable site for the swimming pool. On behalf of the Committee, the Council wrote to the V.E.C. requesting that a particular site be made available and a reply is awaited. When a suitable site has been identified, a preliminary report may be prepared which will be submitted to the Department for approval. Should the V.E.C. site not become available, then the Committee will have to consider finding an alternative, in order for the Project to advance."

TO CONSIDER SUBMISSIONS/OBSERVATIONS

RECEIVED ON THE MATERIAL ALTERATIONS/AMENDMENTS TO THE LOUGHREA TOWN DRAFT DEVELOPMENT PLAN

Mr. L. Kavanagh referred to his Report dated 22nd May 2002, which had been circulated in advance. He explained that the issues remaining to be considered in connection with the Loughrea Draft Plan were: (a)lands at Cosmona adjacent to Carmelite Convent, Bullawn Road, (b)lands owned by Holohan; (c)lands owned by Scully and (d)lands owned by Cusack. In relation to the lands at Cosmona adjacent to the Carmelite Convent, he said the Council had reviewed a letter dated 23rd May 2002 from A&L Goodbody Solicitors, International Financial Services Centre, North Wall Quay, Dublin1 and a copy had been circulated to each Councillor at the meeting.

Referring to the letter dated 23rd May 2002, from A&L Goodbody Solicitors, Cllr. Joyce stated that legal opinion would be needed before the Council could proceed on the matter. The Deputy County Manager stated that he had discussed the letter with the Council's Law Agent and his advice was that the Council should be guided by the recommendation of the planners. Cllr. McClearn stated that the Loughrea Plan had been held up for a considerable time and should not be delayed further. The zoning of these lands had been dealt with by the Area Committee and it had been unanimously agreed that the site should remain zoned agricultural. Cllr. Burke referred to a previous letter from another firm of solicitors, which had been sent to each Councillor in the Loughrea Area, prior to consideration of this matter at an Area Meeting, and when investigated by him it was discovered that the author of the letter had a vested interest in the site. He said it was for the Councillors to make their decision on this site in a democratic way. Cllr. Cunningham said that as they were in receipt of a legal document now, they should obtain legal advice before proceeding. Cllr. Hynes said that he would stand by the decision of the Area Committee, regardless of any Solicitors letter. Cllr. Loughnane said the Carmelite Nuns were an Enclosed Order who needed silence and were part of the fabric of life in Loughrea for 300 years.

It was proposed by Cllr. Cunningham, seconded by Cllr. Connolly and agreed to defer consideration of this and the other remaining issues with regard to Loughrea Town Draft Development Plan to the next Council Meeting pending written legal advice on the letter dated 23rd May, 2002 from A & L Goodbody. It was agreed that the Council's Law Agent should attend this meeting also.

ASSESSMENT The proposed development consists of 32 no. detached houses, 16 semi-detached houses and 8 townhouses. The site size is 8.3 hectares. Density is 6.7 houses per acre (16.7 per hectare). The site is currently used for agricultural purposes and it adjoins an existing housing estate. The proposed development is in compliance with the County Development Plan's "Guidelines and Standards for residential development" (Appendix F of the County Development Plan). Reports were received by the Planning Authority from Sanitary Services, Road Design and Duchas. Further information was requested by the County Council and was satisfactorily replied to. A revised layout was submitted to the Planning Authority on 23rd January 2002, based on the Planning Authority's concerns. The revised layout included a crèche and a civic amenity site. The proposal for a housing development on agriculturally zoned lands was originally put forward by the developer due to the fact that residentially zoned lands in Portumna had been used up and because of the sites proximity to adjoining housing developments. A Zoning Plan for Portumna has not been prepared in the new draft County Development Plan, however, the settlement strategy for East

Galway identifies Portumna as a large settlement with a total projected household increase in the area over the Plan period as 60% or 148 residential units. This amounts to a household growth rate of 32% in Portumna over the Plan period.

OBJECTIONS: No objections to this planning application have been received.

<u>RECOMMENDATION</u>: Taking into consideration the shortage of undeveloped residentially zoned lands in Portumna and the draft County Development Plan (Settlement Strategy), a grant of permission is recommended. A crèche shall be included within the development by condition and shall be the subject of a separate planning application.

STATUTORY CONSIDERATION: A decision to grant permission cannot be made unless a resolution is passed by the members requiring that such a decision be made in accordance with Section 26(3) of the 1963 Planning Act as substituted by Section 39 (d) of the 1976 Planning Act as amended by Section 45 of the Local Government Act 1991.

Public notice of the Council's intention to consider deciding to grant permission was given on 16th April 2002 and the notice invited members of the public to submit representations or objections. None were submitted.

If a resolution is passed requiring that a decision to grant permission be made, such a decision will issue with suitable conditions, otherwise a decision to refuse permission must issue.

The latest date for a decision on this application is 10th June 2002.

Cllr. Burke proposed that having considered the Planning Application made by Mr. Eugene McEntee, for permission for the construction of 32 no. detached houses, 16 semi-detached houses and 8 townhouses in the townland of Portumna, and having considered the Report dated 17th May 2002, Galway County Council in accordance with the provisions of Section 26 (3) of Local Government (Planning & Development) Act 1963, as amended by Section 39 (d) of Local Government (Planning & Development) Act 1976, as amended by Section 45 of the Local Government Act, 1991 hereby require that a decision to grant permission be made in the case of this application.

Mr. Lusby informed the Council that financial services, including investment and both long and short term borrowing, were available to the Council from the National Treasury Management Agency and that transactions would be conducted by either the County Manager or Head of Finance, as required, and the Council agreed with this process.

TO APPROVE DRAFT SLUDGE MANAGEMENT PLAN 1582

On the proposal of Cllr. Connolly, seconded by Dep. McHugh, it was agreed that this item would be deferred and, in the meantime, a presentation of the Draft Sludge Management Plan be made to the Tuam Town Council and the Killaloonty Residents.

MANAGER'S BUSINESS

Mr. Murphy said that the Council has received grants totalling €1.753 M from An Roinn Ealaion, Oidhreachta, Gaeltachta agus Oilean towards the improvement of Strategic Gaeltacht Roads.
