MATERIAL CONTRAVENTION OF THE COUNTY DEVELOPMENT PLAN FOR THE CONSTRUCTION OF A HOUSING DEVELOPMENT IN THE TOWNLAND OF ORANMORE 1192

Planning Ref 00/5101

Townland Oranmore

Applicant: O'Grady Construction (Gort) Ltd

Mr. Albert Comer, S.E.O. outlined the details of Material Contravention set out in the following report dated 4th July, 2001 which had been circulated to the Members.

PROPOSED DEVELOPMENT:

The proposed development is for the construction of a housing development i.e. 150 no. detached houses, 18 no. semi-detached houses and 28 no. townhouses in the townland of Oranmore

LOCATION:

The site is located in the village of Oranmore and is served by a county road within the village speed limits just south of the village core.

PREVIOUS HISTORY:

There was a previous application on this site ref. No. 98/3471 for a housing development but it was refused by An Bord Pleanala.

ASSESSMENT: The proposed development is located on a site with a total area of 12.8 hectares (31.8 acres) which includes part of a Special Area of Conservation (S.A.C.). The area of the site proposed to be developed is 9.1 hectares (22.5 acres). There is an area of woodland to be retained which corresponds to that required to be retained on the previous application. The original proposal included for the construction of 124 no. detached houses, 20 no. semi detached houses and 26 no. duplexes (52 no. housing units) which would have residential floor area of 11,171 square feet per acre or 114 sq. metres per hectare. The number of houses has been reduced by eight due to restricted sites on one part of the site. The applicant has indicated a site for community submitted.

The site is currently within three different land uses as per the Oranmore Plan of which 7.0 hectares (17.3 acres) is zoned for residential use, 5.02 hectares (12.4 acres) is zoned for amenity purpose and 0.8 hectares (2.0 acres) is zoned for community facilities. The Draft Oranmore Plan has now included the above community facilities zoning in the residential zoning.

OBJECTIONS: One objection has been received from the owners of an adjoining property in relation to the duplex units but this problem can be solved by reorientating one block so that there will be no overlooking from windows of habitable rooms and the shadow will be reduced. The Western Fisheries Board has also an objection but conditions on the permission will overcome the problems raised.

STATUTORY CONSIDERATION: A decision to grant permission cannot be made unless a resolution is passed by the members requiring that such a decision be made in accordance with Section 26 (3) of the 1963 Planning Act as substituted by Section 39)(d) of the 1976 Planning Act as amended by Section 45 of the Local Government Act 1991.

Public notice of the Council's intention to consider deciding to grant permission was given on 6th June, 2001 and the notice invited members of public to submit representations or objections. None were submitted within the specified time limit, however, since the Material Contravention report was issued to the members, a late objection was received from a house holder whose site is adjacent to the proposed development as outlined in the report. The objector claims that the developer, O'Grady Construction (Gort) Ltd has included a portion of his site in the planning application. The Planning Department has no role in the adjudication of land ownership so this is a matter between the objector and the developer.

If a resolution is passed requiring that a decision to grant permission be made, such a decision will issue with suitable conditions, otherwise a decision to refuse permission must issue.

The latest date for a decision on this application is 5th August, 2001.

Cllr. Cunningham proposed that having considered the Planning Application made by O'Grady Construction (Gort) Ltd for planning permission for construction of a housing development i.e. 150 no. detached houses, 18 no. semi-detached houses and 28 no. townhouses in the townland of Oranmore, Co. Galway, planning reference no. 00/5101, and having considered the Report dated 6th June, 2001, on the matter, Galway County Council in accordance with the provisions of Section 26(3) of Local Government (Planning & Development) Act 1963, as amended by Section 39(d) of Local Government (Planning & Development) Act 1976, as amended by Section 45 of the Local Government Act, 1991 hereby require that a decision to grant permission be made in the case of this application. Cllr. Grealish seconded this proposal. A vote was then taken which resulted as follows:-

The Cathaoirleach declared the resolution carried.

N17/N18 EMERGING PREFERRED ROUTES

1193

A booklet on the Emerging Preferred Routes was circulated to the members. Mr. Eising, Senior Engineer, Regional Road Design Office made a short presentation on the following Emerging Preferred Routes:

1. N18 Gort to Crusheen Road Scheme.

This route was originally intended to be a single carraigeway but now it has been decided to provide a dual carraigeway.

- 2. N17 Galway to Tuam Road Scheme.
- 3. N17 Tuam Bypass
- 4. N17 Milltown to County Boundary.

Access to the Milltown National School is from the main road and the Council are investigating the possibility of providing an alternative access.

The Cathaoirleach thanked Mr. Eising for his presentation. He said that it was a great day for Galway and that the development of these roads would give a much needed impetus to the development of industry and tourism in the County. He stressed the importance of farmers being adequately compensated for their land.

Replying to concerns expressed by the members in relation to compensation to farmers, Mr. Eising said that the IFA, NRA and the Department of Environment and Local Government have been holding meetings regarding this matter. He said that the issue can not be resolved at regional level and will have to be decided at national level. He was satisfied, however, that farmers would get adequate compensation. In relation to members concerns regarding provision of tolls on these roads Mr. Eising said that M.C. O' Sullivan, Consulting Engineers, were currently carrying out a study on road tolling to see if it was viable. The location of the tolling will not jeopardise the route selection procedure.

The Deputy County Manager thanked the members for their contributions. He said that the provision of these roads represented a huge investment in the County and that it was important that the Council took advantage of this opportunity. It was proposed by Comh. O' Neachtain, seconded by Cllr. T. McHugh and agreed that the Emerging Preferred Routes as presented be approved.

Sen. McDonagh said that he wished to be recorded as dissenting from the above resolution.

7(a) SUBMISSIONS RECEIVED ON THE MATERIAL ALTERATIONS TO THE ORANMORE DRAFT DEVELOPMENT PLAN

1196

Ms. Coleman, Acting Senior Executive Planner, outlined the content of the submissions. She stated that four submissions had been received relating to proposed alterations to the Plan and two submissions related to protected structures.

Submission Ref. No. 1

"Mary O'Connor, Secretary, Old Graveyards Restoration Group, Main Street, Oranmore, Co. Galway.

Location: Old church and graveyard.

Submission/Request:

- Strongly objects to the opening up of the cemetery as a village pocket park.
- Object to the provision of a footpath through these sacred places.
- Cemeteries are designated as National Heritage Areas and so should be protected by Galway County Council.
- The committee proposes to employ an Archaeologist with a view to doing conservation work.
- There has always been a direct entrance from the Main Street to the graveyard gates.
- This entrance has been obstructed with a new building and gates have been erected in the middle of the road.
- In the past Galway County Council have looked after this road.

Observations/Recommendations of the Planning Department:

It is proposed to include an objective in the Plan that the old graveyard and church ruins be maintained and tidied and that existing access points from Castle Road and the Main Street be retained".

It was proposed by Cllr. Grealish, seconded by Sen. McDonagh and agreed to accept the Planning Officer's recommendation.

Submission Ref. No. 2

"Stephen Dowds Associates on behalf of Mrs. Pat King.

Zoning: 1997 County Development Plan - Residential

Proposed Zoning: Agriculture

Location: Triangular area (0.2699 ha) at the crossroads of Main Street and the Maree Road.

Submission/Request:

- Property is zoned for residential purposes in 1997 County Development Plan.
- Draft Plan shows that the site is zoned for agricultural purposes.
- Unsuitable for Agriculture development.
- Site is of limited extent, surrounded by roads and development land.
- Extensive rock outcrops on the site.
- An Bórd Pleanala has recently granted planning permission for an apartment development on the site. (Ref: 00/1173).
- Residential zoning is the only logical zoning.
- The proposed down-zoning is unjustifiable.

Observations/Recommendations of the Planning Department:

The land in question is not subject to a material alteration of the Draft Plan. The proposed zoning of this area in the Draft Plan is for Agricultural use with a specific objective to survey existing trees with a view to making a Tree Preservation Order. Planning permission was granted on the site by An Bórd Pleanala for the construction of 14 apartments (17/5/2000). The developer must submit certain documents for the agreement of the Planning Authority prior to the commencement of development on the site e.g. Landscaping scheme, design changes etc".

It was proposed by Cllr. Rabbitt, seconded by Sen. McDonagh and agreed to accept the Planning Officer's recommendation.

Submission Ref. No. 3

"Oranmore Community Development Association Ltd.

Location: Triangular area (0.2699 ha) at the crossroads of Main Street and the Maree Road.

Submission/Request no. 1:

- Actual zoning on the site is unclear, it does not appear on the County Development Plan map and is zoned Agriculture in the draft plan.
- Community Development Association want to develop this area as a village green.
- Actual zoning appears to be residential at the time of the 1997 County Development Plan.
- To rezone to Agriculture creates a compensation issue, therefore to rezone to recreation/community facilities will not increase the councils liability to compensation.
- Zoning to recreation/community facilities was fully supported by the area councillors and at a full council meeting on 18th December 2000, the draft plan should be amended to reflect this.

Submission/Request no. 2:

- Density objective of 11,500-sq. feet/acre passed by full council on 18th December 2000 has been re-worded.
- The draft reads that densities would normally not exceed 11,500-sq. ft./acre for residential development.
- At the Council meeting it was specifically stated that the area councillors were seeking to cap densities at 11,500-sq. feet/acre.
- The wording is a departure from that agreed and voted on.
- The wording allows for different interpretation.

Observations/Recommendations of the Planning Department:

The land in question is not subject to a material alteration of the Draft Plan. The proposed zoning of this area in the Draft Plan is for Agricultural use with a specific objective to survey existing trees with a view to making a Tree Preservation Order. The minutes of previous meetings do not indicate that the elected representatives voted to change the zoning of these lands.

Planning permission was granted on the site by An Bórd Pleanala for the construction of 14 apartments (17/5/2000). The developer must submit certain documents for the agreement of the Planning Authority prior to the commencement of development on the site e.g. Landscaping scheme, design changes etc.

With regard to the density objective, it is recommended that the wording as set out in the material alterations be retained as follows: "The density of residential development outside the village centre shall not normally exceed 11,500 square feet per acre (i.e. plot ratio of 0.26)".

It was proposed by Cllr. Rabbitt, seconded by Cllr. Grealish and agreed to accept the Planning Officer's recommendation.

Submission Ref. No. 4

"A.M. Lavery, Oranmore Community Development Association

Submission/Request:

- In the matrix table and development control standards the siting of a Refuse Transfer Station in a Business and Technology Park zoning is open for consideration, this is at variance with the wishes of the Association.
- The Association seeks an amendment to the plan to read a non-conforming use, this should apply to both facilities below and above 2000 sq. metres.

Observations/Recommendations of the Planning Department:

Non conforming uses apply to extensions/improvements to existing established developments where they do not conform to the designated zoning objective set out in the Plan. A non-conforming use is not part of the land use-zoning matrix. This classification does not take account of new developments.

Land uses shown as open for consideration in the zoning matrix are uses that are to be considered based on the merits of each individual proposal in the relevant use zone.

No change is recommended in the zoning matrix".

It was proposed by Cllr. Rabbitt, seconded by Cllr. Grealish and agreed to accept the Planning Officer's recommendation.

Assessment of Submissions Regarding Additions to Record of Protected Structures in Oranmore

Submission Ref. No. 1

"Sally and David Jordan

Location: Mike's Cottage, Bog Road, Oranmore. (RPS Ref. No. A3:7).

Submission/Request: Objection to inclusion on RPS.

Observations/Recommendations of the Planning Department:

- The thatched cottage in question is a well kept example of vernacular architecture, and as such merits inclusion in the RPS.
- Inclusion on the RPS will make the structure eligible for consideration for Conservation Grants, as administered by the local authority.
- A Declaration can be issued on request by owners/occupiers of protected structures.
 The purpose of a Declaration is for Planning Authorities to clarify in writing for owners/occupiers of protected structures the kind of works which would or would not materially affect the character of that structure or any element of that structure which contributes to its special interest.

Inclusion on the RPS does not preclude the adaptation of the building to meet current and future needs, while respecting its character, and ensuring its maintenance into the future.

It is recommended that the structure be included on the RPS". It was proposed by Cllr. Grealish, seconded by Cllr. Hoade and agreed to accept the Planning Officer's recommendation.

Submission Ref. No. 2

"Mr. Martin O'Connor, The Old School House, Oranmore.

Location: The Old School House, Oranmore. (RPS Ref no. A3:9).

Submission/Request:

- The owner requests a Declaration.
- States that the building was restored from a derelict condition.
- States that all restoration work was carried out at the owners expense, that the owner should be compensated and not penalised for the fact that the building is still intact enabling a preservation order to be placed on "a piece of our National Heritage".

Observations/Recommendations of the Planning Department:

- The owner of the structure will be issued with a Declaration. The purpose of a Declaration is for Planning Authorities to clarify in writing for owners/occupiers of protected structures the kind of works which would or would not materially affect the character of that structure or any element of that structure which contributes to its special interest.
- The structure is of Architectural Heritage Value and contributes to the townscape of Oranmore.
- Inclusion on the RPS will make the structure eligible for consideration for Conservation Grants, as administered by the local authority.
- Inclusion on the RPS does not preclude the adaptation of the building to meet current needs, while respecting its character, which would ensure its maintenance into the future.

It is recommended that the structure be included on the RPS".

It was proposed by Cllr. Grealish, seconded by Sen. McDonagh and agreed to accept the Planning Officer's recommendation.

LAND ADJOINING LIBRARY IN ORANMORE

Deputy Burke sought clarification in relation to lands adjoining the library in Oranmore.

Monthly Meeting 23rd July, 2001

Ms. Coleman, Acting Senior Executive Planner, explained that the current zoning is for commercial use in the 1997 County Development Plan, and that in the proposed Draft Plan, the zoning is for recreation and community facilities.

Deputy Burke asked if there had been a recent planning application in relation to this land and if so, what is the present status of the application?

Ms. Coleman, stated that a planning application had been received in relation to this land, and that it was currently on extension of time and if the zoning is changed to recreation and amenity it could be refused on the grounds that it is in contravention of such zoning.

Cllr. McClearn asked if the question of compensation would arise, and if so is it quantifiable? Mr. Ridge, Director of Planning and Economic Development, stated that the question of compensation may arise, but that it could not be quantified as there were legal issues involved. Cllr. Rabbitt said that this proposed rezoning was before the Council for the past 18 months, and that the issue of compensation had not arisen until now. He stated that he would be totally opposed to anything which would delay the Plan being adopted.

Cllr. Grealish indicated that he was of the opinion that down-zoning was non-compensatable. The Deputy County Manager, stated that this Plan is being made under the Local Government (Planning and Development) Act 1963, and therefore the down-zoning would be compensatable.

SALE OF LAND AT CLONBERNE, CO. GALWAY TO RESPOND! VOLUNTARY HOUSING, AIRMOUNT, DOMINICK PLACE, WATERFORD. 1182 A copy of report dated 28th June, 2001 was circulated to each member. On the proposal of Cllr Callanan, seconded by Cllr Loughnane the Council approved the sale comprising 0.8814 hectares of land at Clonberne, to Respond! in accordance with Section 83 of the Local Government Act 1946 and in accordance with Section 88 of the Housing Act 1966.

REPORT UNDER LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) REGULATIONS 1994 1183

A report outlining the proposed development had been circulated to each Member.

On the proposal of Cllr Fahy seconded by Cllr Callanan the Council approved the laying of twin culverts on the N67 at Cartron, Kinvara and the R347 at Sheeseragh, Kinvara to alleviate flooding in the South Galway Area.

Cllr Fahy asked for an up to date report on the alleviation of flooding in South Galway.

On the propoosal of Cllr Callanan, seconded by Cllr Fahy it was agreed to take item No 5 next..

PRESENTATION BY MR TOM ROCHE ON POTENTIAL WASTE MANAGEMENT SOLUTIONS 1184

Mr Roche from Roche Engineering Ltd explained to the members the proposals that his company could offer for the management of waste as follows;

- Design, build and finance a state-of-the-art waste process facility for Galway City and County with a capacity of up to 150,000 tons per annum.
- The facility would process 50% of the refuse, compost 30% and landfill the remaining 20%.
- Both export and domestic markets would be used for recyclable elements plastic, wood, paper, glass and metal and also grade one compost
- They would handle waste from all sources domestic, commercial, industrial and demolition and builder waste.
- 5 Cordinate and utilise all existing licensed infrastructure and provide a link between pre-segregated materials and the reprocessors
- They will be subject at all times to the directions and requirements of the local authority, E.P.A. and other controlling bodies.
- They guarantee to handle total waste stream from the region for 25 years up to 2030 allowing five years start-up time.

He said that the Company was providing a waste management service for over 250 million people in Europe at present. He said that the cost per ton of waste disposal in Europe at present was £45 stg and would be approximately £50 or £60 here. He would give a guarantee that this would not be exceeded for the first five years.

Cllr Callanan asked that the Manager examine this option for waste management and see if it was cost effective. Cllr Burke asked what was required from the Council and if the Department of Environment supported this concept of waste management and also what assurance Mr Roche could give if his business went bankrupt. Mr. Roche said that the Council must provide the landfill site, a licence and a commitment to grant the Company the contract for the waste processing of the region for 25 years. He said that he had not approached the Department of Environment but had spoken to the Minister for Environment and Local Government and made a nationwide offer. He assured that Council that he was fully insured.

Cllr J.J. Mannion said that the President would soon be signing the Waste Management Bill into law authorising County Managers to prepare Waste Management Plans and asked if Mr Roches Company would be in compliance with this new Bill.

The County Manager said that the Environmental and Conservation Strategic Policy Committee would be meeting on the 20th July, 2001 and a report on waste management would be presented to the members of the Strategic Policy Committee for discussion. He said that waste management had been discussed at 24 Council meetings to date, the Plan had been prepared over three years and this Plan must comply with Government Policy. He said that there was a need for recycling and this was being introduced in the county.

She welcomed the contribution that local groups and communities had made to the Council and said that she was proud to have been elected the first woman Cathaoirleach of Galway County Council. She especially thanked all the Councillors who had unanimously voted for her.

The members paid tribute to an Comh. Ni Fhatharta for her successful year as Cathaoirleach of the Council and complimented her on the excellent way she represented the Council at events both inside and outside the county. They congratulated her on being the first woman Cathaoirleach of Galway County Council.

The County Manager thanked her for her contribution to the office of Cathaoirleach and said that she had helped to raise the profile of the Council. He also thanked her on behalf of the staff whom she always treated with courtesy and kindness.
