John Costello of Allia, Kirock, wrote complaining of the delay in putting him on the Relief Works, after being recommended.
Referred to the Supervisors of Works.

McPatrick McDonogh, Paymaster on the Relief Works in the Union, submitted an explanation of the charges preferred against him by Margaret Feeney, a labourer employed on the Relief Works as follows:—
I deny absolutely and utterly the charge Widow Feeney preferred against me. Her mistake is owing to the fact that you decided that the Relief workers be paid on Friday instead of Monday in each week. On the 27th Nov I paid for four days labour ending on the preceding Thursday. Had I paid for a full week, there would have been only 4 days for the week ended on 2nd inst. I am charged with calling her a "strap", I did so, but under most extreme provocation for she annoyed me very much and caused me to lose my temper. She deserved worse treatment indeed at my hands, as she used most abusive language and nasty expressions.

A protest, purporting to come from Ratepayers

in Killamin Electoral Division, against the employment of persons named in the protest possessed of stock, on Relief Works in the Division.

The protest not being signed was marked "read".

Relieving Officer P. Sullivan, reported that he admitted to the Workhouse a male child found in the Augustinian Church, Galway, this morning.

On the motion of Mr. J. J. Kirwan, seconded by Mr. M. Cunningham it was Resolved - That the Workhouse R. C. Chaplain be requested to confer Conditional Baptism on the child.

In pursuance of notice given for this day, Mr. C. Lee moved -

"That owing to the extraordinary rise in the price of flour - as a result of the war between Spain and the United States of America - the contract for the supply of Bread to the Workhouse be annulled, and that Tenders be invited for the supply of Bread for short periods not exceeding four weeks in duration."

The motion was seconded by Mr. P. Hoole, and carried, in so far as cancelling the contract, and the Workhouse Master was authorised to buy Bread in the open market for a period of four weeks, giving a preference to the late Contractor.

On the motion of Mr. P. J. Hamon, seconded by Mr. J. A. Hostetto, it was Resolved That we request to be informed by the local Government Board whether we are authorised to place on the Relief Works in operation in the Union, persons in possession of stock, whom we consider stand in need of relief because of their inability to dispose of such stock. That we refer the Board to the reply given by the Chief Secretary for Ireland in the House of Commons on the 13th ultimo, that several persons who were employed on Relief Works in Galway and Mayo were in possession of stock.
