On reading the resolutions of the last Board day for the Election of Relieving Officers on Tuesday next.

The following objections were proposed by J<sup>r</sup> Lambert & seconded by P<sup>r</sup> A. Lacey & passed unanimously.

In reference to a letter of the Poor Law Commissioners calling upon the Board to elect competent persons to fill the situation of Relieving Officers in the Union. The Board beg to submit to the Commissioners, the following objections to the appointment of such officers.

That it would be impossible to find persons in whom the Board could repose confidence, who would be willing in consideration of the salary fixed, by the Commissioners to devote their whole time to the duties of the office.

That under the proposed system, the Board fear that lobbying would be carried on, to a serious extent, that the expence of the Union, would be fearfully increased, and without corresponding advantage to the Destitute.

That this objection is the more reasonable when the Duties of the Relieving Officers are considered, it is obvious that a strict discharge of these, would subject the Officer to much unpopularity, and possibly to personal risk, this he could virtually avoid, by a contrary course of conduct, to which bribery would probably offer an additional inducement.

That the Board is sensible that the appointment of these officers, is authorized by the act, they would submit to the Commissioners, whether it would not be advisable to postpone the matter, until it can be ascertained, whether the purpose of the act, cannot be fully carried out as at present, by the unpaid services of the district Wardens.

That referring the Commissioners, to the return of the Union debts furnished by their order, the Board submit that they have not, or are they likely to have funds to place at the disposal of Relieving Officers, should the proposed appointments be made.

That the Commissioners will recollect that the debts referred to were contracted, on account of the current expences of the Establishment, with individuals who are naturally urgent in their demands, and whose just claims must be satisfied, before the Board can

think themselves justified, in incurring fresh expences, and to which they can see no limit.

Resolved that while we decline under present circumstances, taking any steps for the appointment of Relieving Officers, to administer a system of Relief which has been found too expensive to be carried on, even with the aid of loans from the Government and Grants and subscriptions from various quarters, and to have been fraught with abuse, which no exertion on the part of the Ratepayers and Inspecting Officers have been capable of checking, even with the limitation of Relief to the article of food, we yet deem it our duty to follow out the spirit of the Poor Relief Extension act, and to make as far as may be practicable due provision for the increased numbers of the really destitute, that may apply for workhouse relief, on the cessation of the Temporary Relief act, and with this view, we pray the sanction of the Poor Law Commissioners, to our making a temporary arrangement, for providing additional workhouse accommodation for 500 poor persons, and if necessary to increase the same.

Resolved that the increased numbers who are likely to apply for relief under the operation of the act for the punishment of Vagrants, render it of importance that along with increased workhouse accommodation, a new classification should be made, having reference to character, so that male and female paupers, of notoriously profligate habits, or whom the Board may deem in the absence of a certificate of character, or from other causes, unfit to be associated with poor persons of unblemished reputation, should be clasped apart from the other inmates of the House, such classification not to include children under 16 years of age or adults over 60.

Resolved that in consequence of the assize the further consideration of the Election of Relieving Officers be postponed.

In reply to the letter of the Commissioners dated 29 July respecting the check given to Mess<sup>rs</sup> Tully & Keane for milk, the Board

has to state that the check for £271.5.5 was given in the usual way to the contractors Messrs Tully & Keane, and their receipts for the same was handed to the clerk who filed it with his other papers.
