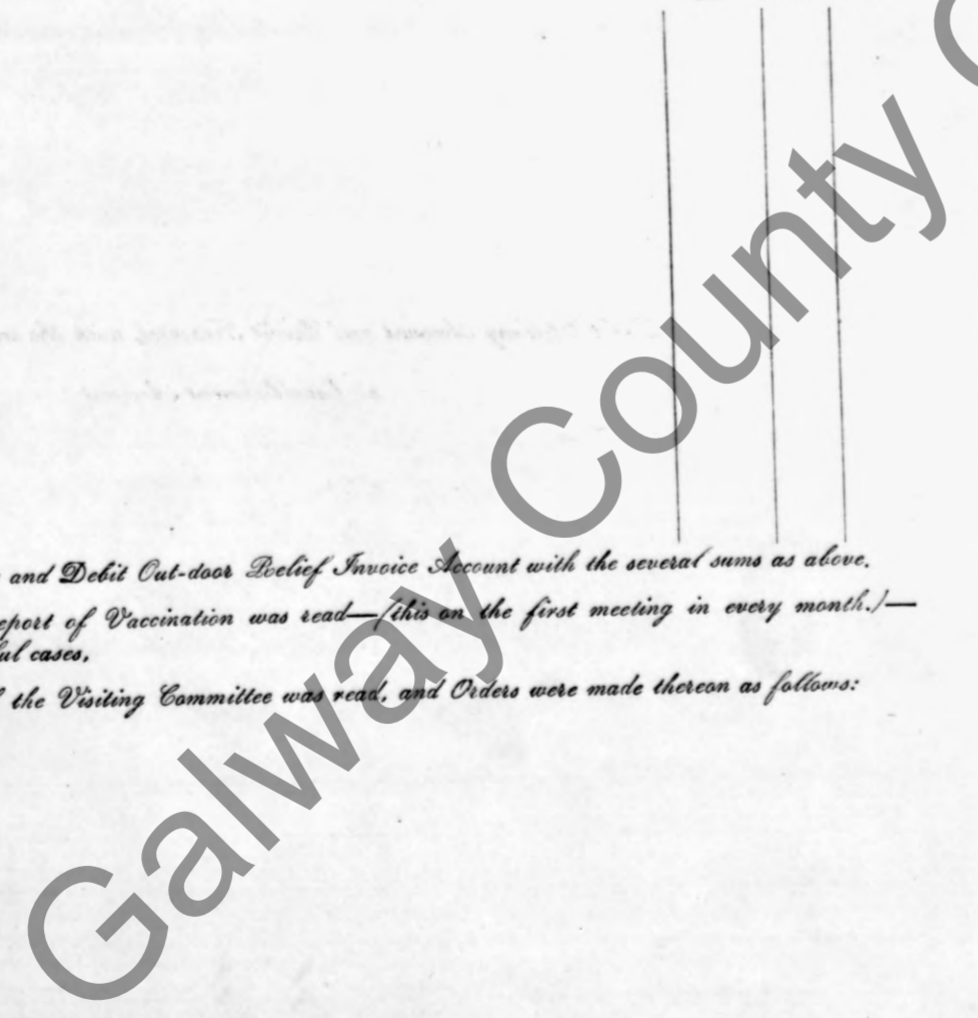

Mr. Lynch in very few instances complying with the Board's order. Sometimes not delivering the goods for three weeks after being ordered and in consequence of these delays the Master was necessitated to purchase the articles from

The Collected Abstract having been laid before the Board incomplete in consequence of the nonattendance of Mr. Cornelius O'Brien to settle his debt. Resolved that Mr. O'Brien be called upon to explain the Cause of his nonattendance.

Resolved that all extern Cases admitted to the Fever Hospital when discharged by the Med Officer shall be brought before the Board if necessary for Admission to the Workhouse

The Clerk of the Union made an application for leave of absence for three weeks and stating that he would attend every Board day and that in the intermediate time his duties will be performed by his son who is competent to do so

Leave was granted

Resolved that the Commissioners be requested to Vouch for the expenditure of a sum of Eighteen pounds to assist in the Emigration of Patrick Sheehan and five in Family to Philadelphia such sum of £18.0.0 chargeable to the Electoral Division of Killeenavarran

Ordered that the Master Supply Paupers leaving the House who have not their own clothes with any garments they may require from the old clothing left by Paupers who lately emigrated

It is noticed that Miss on the 14 Aug went to have Mary Walla & Family transferred from Killeenavarran Electoral Division to the Union at large
