Read Letter of Poor Law Commissioners, No 16027. 27 July, 1863  
forwarding Report of Doctor Hynes, against Mr Hardiman Collector

The Board deny that any representation on the subject of O'Dea's rate, was ever laid before them by Doctor Hynes.

Mr Hardiman our Collector having been interrogated states, that O'Dea's son coming into the office where he was receiving the Rates at Hinwara, asked him what was the amount of his father's rate. He told him the different amounts, and stated that the rate of 8/- was charged upon the house which he occupied, he asked are we liable for that, and I said of course the premises were liable, whereupon he paid the money without any objection. Mr O'Dea stated in the presence of two Guardians, that Mr Hardiman had not used any kind of threat of distraining, or had any kind of dispute about it.

The collector states, that he furnished D'Hynes with his bill of poor Rates, on the 10<sup>th</sup> of April last, to which he got no reply,  
until

the 23<sup>rd</sup> of June following, when the collector was not at home, but on the next morning he was in Hinwara for the purpose of collecting rates, and remained till the 28<sup>th</sup>. on the 24<sup>th</sup> he sent his man to D'Hynes to state that he was there and receiving the rates, D'Hynes's assistant mentioned that D'Hynes would come up immediately, the collector again asked the assistant on the 25<sup>th</sup> to beg of D'Hynes to come to the office to arrange about the rates, he did not come or send his rate, till about the 14<sup>th</sup> of July, O'Dea never mentioned a word about the time the house was occupied, nor did the collector know it.

The Clerk of Union states, that he rated the premises in question finding by the last revision that it was occupied by a man named John Hurney, there was no communication to the Board of Guardians, to his knowledge on this subject from D'Hynes, the collector has accounted with him for the money received out of the premises, and it has been lodged with the Treasurer.

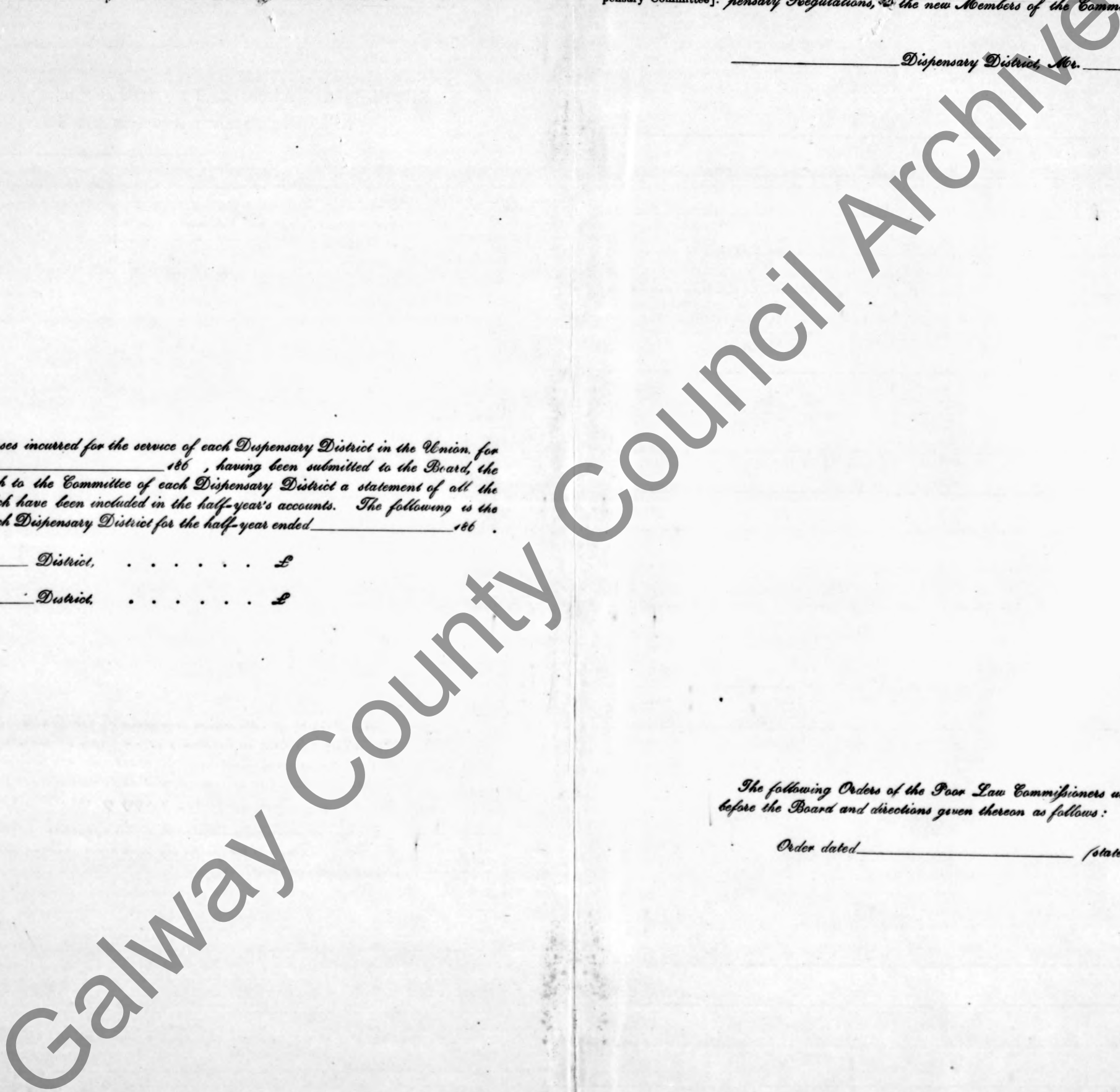
