The Reports of the Master and other Officers were read and Orders made thereon as follows:

The Medical Officer reports that in addition to the 3 deaths in the Infirmary there were 2 deaths in the Nursery both foundling Children and respectively 9 & 6 Months. He feels it his duty in the most serious manner to call the attention of the Guardians to the inferior quality of the Milk, having tested it his opinion it contained from 3/4 to 7/8 Water, had neither in appearance, or taste did it appear like pure Milk, which must produce a most injurious effect on the health of the inmates, and particularly those of the Junior Classes, & the Sick.

Ordered that the class from 2 to 5 get Beef Tea

The Master reports that from the insufficient supply of Milk from the Contractors he substituted Cocoa & issued it to the Able bodied Men & Women and Boys & Girls. He also issued 21 Gallons of Coffee to the Infirmary being short of Milk on these occasions; the Meat Contractor also failed in supplying meat on 4 days he went to market & secured 78 lb. Beef for Soup for the Classes that got Cocoa. He also reports that the Milk continues of an inferior quality.

Ordered that the Master procure a few tins of Butter to be given at Breakfast instead of Milk, and to be charged to the Contractors.



He could only procure in the market 102 Gallons of pure Milk.

He bought 119 lbs butter & 165 lbs Meat which was used instead of milk.

He also issued Cocoa, & Coffee as a substitute.


