Cllr. Nix advised the meeting that the Director of Services, St, Brendan's Community Nursing Home had approached her with regard to the Town Council giving a small contribution towards the remembrance garden at St. Brendan's home loughrea, Cllr. Nix asked that when estimates are being prepared that consideration be given to making a small contribution towards the remembrance garden.

Galway Senior Hurling Team Homecoming

Cllr. G. Burke congratulated the County Galway Senior Hurling Team on their achievement in getting to the All-Ireland Hurling final and expressed disappointment that the homecoming was held in Pearse stadium only and that the team did not stop in local towns such as Ballinasloe, or Loughrea.

Active Travel Towns Funding Programme Stream 2 Sub-set 2012(Smaller Towns) Loughrea, Co. Galway

Mr. Mulryan advised that meeting that on 18th September, 2012, Galway County Council were successful in securing funding of €425,000 for Smarter Travel under the Active Travel Towns Funding stream. Mr. Mulryan circulated the submission which was made by Galway County Council to the Department of Transport for five approved projects in Loughrea Town along with drawings for the proposed works and went through each project and the works which are to be carried out.

Cllr G. Burke expressed his disappointment in hearing of the secured funding from outside of Galway County Council, in reply Mr. Mulryan advised the meeting that the announcement was made on the 18th September, 2012 and this meeting has been his first opportunity to advise Loughrea Town Council on the matter.

He advised that meeting that GCC had engaged the services of Consulting Engineers to prepare designs for the various elements of the scheme which would allow for appropriate procurements of services necessary to complete the works, however he noted that given the fact that a large number of the designs had yet to be finalized and taking into account the time frame for the completion of the project by the end of November 2012 it would not be possible to bring all the detailed designs before the Loughrea Town Council members prior to commencing the works and as such he would be advancing the various elements of the schemes as the designs are finalized.

He provided a copy of drawings to each member which formed the detailed design for works on the following streets within Loughrea Town

- Cross Street
- Piggott Street
- Church Street
- Barrack Street

These works consisted of the implementation of traffic calming measures on both Cross and Barrack Streets, the installation of controlled and uncontrolled pedestrian crossing facilities along with the resurfacing of Cross, Piggott and Church Streets. The works also include for the implementation of a one way traffic management system as follows on the following streets in Loughrea Town:

- Piggott Street becoming a one-way street on a permanent basis with traffic flow in a North to South direction (i.e. from Main Street to Barrack Street only).
- Church Street becoming one-way street on permanent basis with traffic flow in a South to North direction (i.e. from Church Street onto Main Street only) from Galway County Council's Library (Old Church of Ireland Building) to its junction with Main Street only with the remainder of Church Street remaining two-way.

He outlined that the above traffic management system in relation to Church Street differed from the original proposal brought before the members during April meeting of Loughrea Town Council, however this changes was associated with a period of consultation with the residents and business on the street and he advised that this was the best comprise solution that was available to address the concerns of a particular business on the street while in tandem improving traffic flow and safety for all road users.

Finally he outlined proposal for the following works as part of the funding secured under Active Travel Towns for Loughrea Town for which designs works were underway but not yet finalised:

- Controlled Pedestrian Crossing Facility of Bride Street (R446) at Danesfort , Garrybreeda and Bohercom Junction.
- Provision of Greenway (Shared Pedestrian & Cycle Track) to Link St Laurence's Field Estate with N66 Athenry Road at the Loughrea Hotel.
- Provision of Controlled Pedestrian Crossing on the N66 Athenry Road, Old Galway Road and N66 Gort Road.

Following discussion on the projects and the one way system being put in place on Piggot and Church Streets, it was agreed that a letter of thanks be sent to Mr. Michael Owens for all his work in originally putting Loughrea Town forward for funding.

Plaque for World War One

Cllr Maher advised the meeting that on Saturday 10th November, 2012 at 3 pm there will be a presentation and lecture in remembrance of the seven sons lost by the Furey Family in World War 1 and the unveiling of remembrance plaque donated by Cllr Regan outside of the Loughrea Office, Cllr Maher requested that all Councillors attend on the day. Cllr Maher also requested the use of the Loughrea office for the afternoon.

Mr. Mulryan circulated drawings setting out proposals for the traffic flow from Bride Street down Pigott's Street to Barrack Street and from Barrack Street up Church Street towards Main Street. He stated that the Gardai had confirmed their support for the proposals which would greatly enhance traffic movement and safety. He advised that the proposals could only be implemented when funding became available but that it was important to have them ready. On the proposal of Cllr Maher, seconded by Cllr S Burke the proposals were unanimously agreed.

5. Any Other Business:

Cllr Morgan referred to a newspaper article about a planning permission on the East side of the town. It was noted that this was under appeal to An Bord Pleanala.

Cllr Bane asked if more prominent signage advising of gate closing times could be put up at the Long Point. Mr. Mulryan said he would review the current signage.

Cllr Bane suggested that a possible historical association with Patrick Sarsfield and Boys School Lane be looked in to and if it was the case that it be commemorated. Cllr Nix said she will ask the history project to investigate and Cllr Regan offered to provide a suitable plaque.

Cllr G Burke asked if there had been re-sequencing on the traffic lights at West Bridge. Mr. Mulryan said he would look in to this.

Cllr Maher asked if grass cuttings could be taken away by the council where volunteers had cut some open areas. Mr. Mulryan said this would be arranged for the specific projects.

Cllr Maher enquired about the possibility of a cycle lane on Bohereencom but was advised that such a proposal could only be looked at as part of a comprehensive plan.

Cllr S Burke enquired about the diving boards at the Long Point. Mr. Mulryan stated that these were being examined and costings prepared.

He said even if one of the teams were asked to visit the town to be received by the mayor and the council it might attract some interest.

Funding, if any, for a feasibility study will not be known until the Council sets aside its annual budget. Mr. Cullen stated that it is important that people's expectations do not become heightened un-necessarily and should a new developer come on board the project would be subject to the Public Procurement Competitive Tendering process as before.

Cllr. Hynes stated that the previous feasibility study established a public demand existed. He said an alternative site exists with planning permission for a 25M pool and that there is nothing in writing to indicate the initial grant is "ring fenced".

Cllr. Maher stated he understands from Minister Cannon the funding is available but not long term and provided it is a 25M pool with 8 lanes.

Mr. Cullen again re-iterated the initial grant was allocated for a particular project, subject to rigorous procurement measures and the Members have a responsibility to be realistic and not over-heighten expectations. He agreed to examine the Planning File for the next Meeting.

Hawthorn Hedge at Tennis Club

In reply to Cllr. Morgan Mr. Cullen stated that this is an operational issue which was reported on satisfactorily by the Town Engineer at the last meeting.

Gates at Long Point

Cllr. G. Burke asked would it be acceptable for a volunteer to open and close the gates at the Long Point during the off season period. Mr. Mulryan said a proposal will be forwarded to the Environment Section for consideration.

Athenry Road

In reply to Cllr. Maher, Mr. Mulryan stated that he has discussed the matter with Road Design and it is hoped to have works completed before the end of the year.

2. Correspondence

Correspondence was circulated in advance of the meeting and included:

Remembrance - Notice of Annual Memorial

Letter from Leixlip Town Council – stating that a motion was adopted "to request Kildare County Council & other Councils in light of the proposal to introduce a residential tax in 2012, that the commercial rates for businesses are reduced significantly (i.e. by 2/3's)

Letter from Ballina Town Council – seeking support for the following motion adopted by them: "that Ballina Town Council call on the Ministers for Social Protection and Environment to co-operate in the introduction of process:

It was also agreed to issue a letter of sympathy to the representatives of Ms. Eileen Payne, treasurer of the A.M.A.I. on the proposal of Cllr. Maher.

Cllr. Nix invited all members to the presentation of awards to local school children who participated in the recent Art Competition. The awards take place tomorrow at 5.00 p.m. in the Council Offices.

Cllr. Maher stated that the organisers of yesterday's Remembrance Cermony passed on sincere thanks to Jayne Baker, Enda Mulryan and Council Staff for the floral display at the memorial plaque.

1. Confirmation of Minutes of Meeting held on 10th October, 2011.

Minutes of Meeting held on 10th October 2011 were adopted on the proposal of Cllr. Regan, seconded by Cllr. Nix.

Vote of Sympathy

Cllr. Morgan proposed holding a minutes silence in honour of the late Peter Donnellan, brother of Brendan Donnellan who was a member of the Town Commissioners for 25 years. This was seconded by Cllr. Maher.

Matters Arising

Cllr. Bane read the following Statement on behalf of herself and Cllr. Nix. in connection with offensive remarks made by Cllr. Morgan at the AGM.

"At the A.G.M. of Loughrea Town Council in June 2011 remarks were made by Councillor Morgan which we considered personal & offensive. These comments have been a source of distress & upset to ourselves and our families.

Despite numerous interventions by colleagues and Council Officials, no apology has yet been received from Councillor Morgan for these offensive remarks.

In fact, the offensive comments have been added to during recent Town Council meetings.

However, having thought long and hard about the situation, we feel that the greater interest of the business of Loughrea Town Council and the need to hold efficient meetings is paramount. Also, taking into account the attitude of Cllr. Morgan – we have no option but to now declare the matter closed.

We would like to thank all the other six Town Councillors for their support in seeking an apology from Cllr. Morgan, but at this stage (in the absence of that apology) we feel that we have no choice but to put the matter to rest and continue with Town Council Business.

We realise that the next step would have been to have Councillor Morgan forcibly removed from the meeting, but out of regard for the reputation of the Town Council, and the respect for Councillor Morgan's family, we do not wish to pursue this course of action.

We have always shown respect and courtesy to our colleagues on the Town Council and are appalled by the fact that we were not afforded the same respect and courtesy by Councillor Morgan."

Clir. Maher congratulated Clir. Bane and Clir. Nix on how they dealt with the matter.

The Mayor declared that this matter is now formally closed.

2. Appointment of Representative to the Board of Galway Rural Development Company Ltd.

Cllr. Hynes was selected as a Representative on the above Board on the proposal of Cllr. Regan, seconded by Cllr. Maher.

3. Correspondence

- Audit Report for Year Ended 31st December 2010 Mr. Cullen informed the Members that
 the Auditors Certificate has been received and there are no issues.
- Letter to Dept. of Tourism Loughrea Swimming Pool.
 Mr. Cullen read letter dated 15th September 2011 from Eugene Cummins Director of Services to Mr. John O'Donoghue Dept. of Tourism. The letter stated it is with great regret that Mr. Brian Shaughnessy confirmed that due to the economic crisis and the limited funds available to the banking sector, the necessary funding to deliver the project in accordance with the Council's requirements is not in place.

The planning permission for the development expired on 6th June 2010. As the developer is no longer in a position to meet the Council's requirements and as the proposed site no longer has the benefit of planning permission the proposal no longer exists. Galway County Council is not in possession of a viable alternative proposal at present.

Cllr. Maher stated he will be seeking provision of a sum of €100,000 in Galway County Council's Budget for a scientific study on the viability of providing a swimming pool and he stated the population of the town has increased according to the 2011 Census to 5057. He also stated he understands from Minister of State Ciaran Cannon that funding is still available. He also recorded his thanks to Brian Shaughnessy for taking the project thus far.

Clir. Bane also complemented the foresight of the developer and stated that it was frustrating that the political will did not appear to be present when he could have secured the necessary funding. Clir. Regan stated that he did not think it would be possible to provide a sum of €100,000 for a feasibility study in the current financial climate and asked where the follow-up funding would be sourced. Clir. Morgan agreed with Clir. Regan and he stated that money collected for the provision of a swimming pool is lodged and will remain there until a decision is made and proposals for its use are decided.

Clir. Hynes said this was very bad news. He stated that permission for a pool in the Cross Street area was granted to a private entrepreneur and asked could consideration be given to moving the grant of €1.3M from the failed project to this new site. Cllr Maher stated that a pool must be a minimum of 25 meters with 8 lanes to attract government funding.

Mr. Cullen stated that it would be remiss to heighten expectations on provision of a pool when the reality is entirely different. He said the revenue budget of Galway County Council will not have funds in the region of €100,000 for a feasibility study and he acknowledged the contribution made by Brian Shaughnessy in advancing the project this far. He suggested the Council be asked to "set aside money for a feasibility study" and not put a figure on same.

Cllr. Gabriel Burke and Cllr. Curley also expressed disappointment at the news.

Cllr. Maher's proposal to ask Galway County Council to "set aside money for a feasibility study" was seconded by Cllr. Curley.

4. (1). Notice of Motion - Cllr. Norman Morgan proposed:

(a) that the hawthorn bushes/trees, which are not people friendly, along the footpath at the back of the tennis courts, Gort Road, Loughrea, be removed, as they can be a danger to adults and especially children's eyes.

This motion was seconded by Cllr. Curley.

Mr. Mulryan stated that this is an established native hedge species and he would not be seeking it's removal. He stated any risk will be substantially removed by having it cut back and adequately maintained.

Mr. Cullen stated that funds are not available to replace the hedge and the Council will manage the risk and while he accepts the Motion the Council will not be able to comply with it.

(b) that the bushes/trees by the north-south footpath on the town side of the drain in Corry's Field be removed, including roots; as they are an inconvenience to pedestrians, and do not allow for proper maintenance of the drain.

This motion was not seconded.

(c) that Galway County Council be requested to repaint all the dirty, rusted, Town Sign Posts in Loughrea, together with straightening the numerous bent sign posts.

This motion was seconded by Cllr. Gabriel Burke.

In relation to Motion (c) Cllr. Nix stated that the Tidy Towns Committee had discussions with the Town Engineer and a Programme of works is being put in place.

4. Any Other Business

Drain at Corry's Field

In reply to CIIr. Bane Mr. Mulryan stated that the drain referred to, forms part of the drainage works at the N66 – Gort Road and is not situated in a Special Area of Conservation.

Gates at Long Point

In reply to Clir. Bane Mr. Mulryan stated that a budget was allocated to cover the cost involved in opening and closing the gates at the Long Point during the summer season and in conjunction with the Blue Flag. There is no budget available to continue this arrangement at this point.

Works at Mount Carmel

In reply to CIIr. Bane Mr. Mulryan stated works at the Mount Carmel Road junction are designed to reduce HGV's using Mount Carmel as a short cut to the motorway and also to help pedestrians crossing.

In reply to Cllr. Gabriel Burke Mr. Mulryan stated that it is proposed to put a horizontal deflection with pinch-point at Gallows Hill. Cllrs. Gabriel Burke and J. Regan expressed dissatisfaction with the height of two of speed ramps at Mount Carmel. Mr. Mulryan stated that works are part of the Smarter Travel Scheme, the ramps are in accordance with guidelines, the location is still a live work site and advance warning signs will be put in place.

Clir. Morgan stated that had a slip-road been provided at Mount Carmel Road junction it would alleviate traffic problems on the Athenry Road at busy periods.

In reply to Cllr. Nix, Mr. Mulryan stated there are no proposals for a one-way system at Mount Carmel Crescent/Abbey Terrace at present.

Mr. Cullen stated that the engineers have to carry out roadworks under legal and statutory liability and personal accountability and responsibility.

Main Street

In reply to Cllr. Regan Mr. Mulryan stated that a traffic count would be required to decide if traffic calming measures are required on Main Street and if so a cost analysis would be carried out. In reply to Cllr. Gabriel Burke, he stated that providing a different colour surface on bus bays will be examined but this is not the best time of year to carry out such works.

Amenity Areas

Cllr. Morgan welcomed the sculpture recently erected at the Monearmore roundabout. Cllr. Maher thanked the technical staff and McInerney's Super Value for this joint initiative. Cllr. Maher said he expects further funding of €15,600 towards an outdoor gym concept which may be located at the Long Point area or Corry's Field.

Mr. Mulryan stated an application has been made under the Sports Capital Grant to upgrade facilities at the Long Point and the Tennis Club.

Footpaths

In reply to Cllr. Maher, Mr. Mulryan stated that footpaths at Abbey Terrace and The Hill can be looked at but funding will have to be sourced in advance of any necessary repairs.

Abbey Lane

In reply to Cllr. Gabriel Burke, Mr. Mulryan stated the Water Services Department are progressing plans to upgrade drainage in Abbey Street, Dolphin Street and Moat Bridge. Pedestrianisation of Abbey Street can be examined when drainage works are complete.

In reply to Cllr. Gabriel Burke, Mr. Mulryan stated that water lodging at the Traffic Lights at West Bridge today arose partly due to vegetation blocking the gratings. He also stated he will examine problems with water logging at the Traffic Lights on Main Street.

In reply to Cllr. Gabriel Burke, Mr. Mulryan stated that tenders have been prepared for an overlay of the Athenry Road and it is hoped to complete works before Christmas, weather permitting.

Proposed Traffic Calming - Smarter Travel Scheme

Mr. Mulryan outlined details of proposed works at Cross Street, Moore Street and Bride Street as circulated. He said all options were examined and it is proposed to introduce a one-way system on Moore Street heading towards Bride Street. He said the Gardai have authority to override a one-way system and this should solve the problem with funeral traditions. He said it is proposed to erect railings and zebra crossings. He also stated that line markings will be upgraded in the town. In reply to ClIr. Bane, Mr. Mulryan stated works must be complete by end of November. ClIr. Gabriel Burke asked if Bothar Com could be made a one-way street and ClIr. Hynes said he had queries regarding bad potholes there also. Mr. Mulryan agreed to examine this and stated Bothar Com would ideally require resurfacing which would cost in the region of €40,000 and we do not have a budget of this amount at present.

Presentation

Clir. Curley asked if he could have a small presentation to Ms. Evelyn Moorehead at the next meeting to recognise her four years of working with Goal in Africa. Clir. Maher stated that he was disallowed a similar request last year and that the Councillors agreed there would not be presentations unless the achievement was of national interest or the person represented Ireland or Loughrea. It was agreed to seek clarity from Minutes in April/May 2010.

This concluded the business of the Meeting

The Mayor thanked Cllr. Bane for officiating in his absence stating that she fulfilled her role laudably.

Minutes of the Monthly Meeting of the Loughrea Town Council held on 12thSeptember, 2011 were adopted on the proposal of Cllr. Regan, seconded by Cllr. Nix.

Matters Arising from Minutes

Cllr. Regan asked if Cllr. Morgan was going to apologise to Cllrs. Bane and Nix for remarks made at the June Meeting. Cllr. Morgan said he was refusing to apologise stating that if he did so "he would be telling a lie".

Cllr. Curley proposed that Cllr. Morgan leave the meeting and this was seconded by Cllr. Regan. Cllr. Morgan refused to leave the meeting.

Mr. Cullen advised that the business of the Town Council is carried out by resolution of the Town Council and the Standing Orders deal with this matter. He advised that in his opinion it was in order for the Town Councillors to make the proposal as has been done and the issue should be resolved by the Town Councillors.

Clir. Bane stated that she wished to record the comments made by Clir. Morgan to her and Clir. Nix i.e. "antichrists and hypocrites" and the remarks have been reported by the press and caused distress to her and her family. She stated that Clir. Morgan's interpretation of the Standing Orders would mean that members could insult each other "ad lib" and set a precedent for future meetings. Clir. Regan stated that the Members drew up the rules, with guidance and the Members must have respect for each other.

Clir. Bane asked Clir. Morgan to apologise and have the matter finished with so that the business of the Town Council could proceed. Clir. Nix agreed. Clir. Curley adjourned the Meeting for 5 minutes.

He said the business of the Town Council must be conducted and this matter could not be allowed to prevent that happening. He stated the Town Council as a body acts by resolution and decisions must be lawfully made. He repeated Standing Order 49 outlining the procedure for dealing with this matter.

Clir. Curley proposed to adjourn the meeting and this was seconded by Clir. Regan.

1. (b) Confirmation of Minutes of A.G.M. held on 12th June 2011.

Cllr. G. Burke proposed adoption of the Minutes of the A.G.M.

Cllr. Gunter-Nix proposed an amendment as follows:

"In the course of a discussion regarding the election of Mayor at the previous AGM, Cllr. Morgan made remarks towards Cllr. Bane and Cllr. Nix which both felt were personal and offensive. Cllr. Morgan declined to withdraw the remarks or apologise when asked to do so by the Mayor. Under the Standing Orders the Mayor then asked Cllr. Morgan to leave the meeting, which he did."

Cllr. Regan seconded the amendment and the Minutes of the A.G.M .of the Loughrea Town Council held on 12th June 2011 were adopted.

Matters Arising from Minutes

Cllr. Regan raised the matter of the remarks made by Cllr Morgan about Cllr Bane and Cllr Gunther-Nix at the annual meeting. Mr. Cullen stated as he was not present at the A.G.M., he did not know what remarks were made but it is a matter for the Town Council to decide how to proceed. The Town Council is entitled to decide if an apology is merited and that it was up to Cllr. Morgan to decide for himself what to do about that. Mr. Cullen said that this situation is covered by Section 49 of the Standing Orders.

Cllr. Regan proposed that Cllr. Morgan should be asked to apologise to Cllrs. Bane and Gunter-Nix and if that if he was unwilling to do so that he be requested to leave the Meeting. This was seconded by Cllr. Maher.

Cllr. Morgan stated that his interpretation of the Standing Orders was that as he had been required to leave the annual meeting then as far as he is concerned the matter is over.

Mr. Cullen stated that his role as Manager is to advise the Members of the Town Council. He clarified the matter and confirmed his interpretation of the Standing Orders that if the Members decide a retraction or an apology is warranted and if Cllr. Morgan refuses he may be asked to leave the Meeting and each subsequent Meeting until the matter is resolved. The Standing Orders are not open to exclude the Councillor indefinitely and there is no obligation on him to offer anything.

Cllr. Morgan stated he said nothing untrue and his explanation was not accepted on the night. Mr. Cullen stated that the issue at the moment was whatever remarks had been made and if they warrant an apology – not the motivation that led to the remarks. He said there is important business to be conducted and the Meeting must move on.

Cllr. Bane, as Deputy Mayor and colleague asked Cllr. Morgan if he was prepared to apologise for the remarks made to her and Cllr. Gunter-Nix. Cllr. Morgan said he was prepared to state no offence was intended on his part. Cllr. Bane stated she would have to ask him to leave the Meeting. Cllr. Morgan stated he may refer the matter to the Ombudsman and there was no organisation more undemocratic than Loughrea Town Council and he left the Meeting.

Minutes of Monthly Meeting held on 12th June 2011 were adopted on the proposal of Cllr. G. Burke, seconded by Cllr. Gunter-Nix.

Matters Arising

Flooding - OPW

In reply to Cllr. Maher, Mr. Finn stated that the OPW are not prepared to fund those works and it is a matter for the Local Authority. He said a water-main is to be placed in Abbey Street and any works will have to tie in with same.

Cllr. G. Burke raised a query in relation to surface water on the Athenry Road from the Hotel down to Westbridge and surface water ponding on the Old Galway Road at Mulhollands.

In reply to Cllr. G. Burke Mr. Finn stated that firstly in relation to ponding on the Old Galway Road, it was attempted to connect a gully to the surface water sewer at the time that the traffic lights and resurfacing works were carried out in 2010. However, due to the gradients available it was not possible to achieve a connection. Secondly, in relation to the Athenry Road there is a blocked stone shore that runs from Mount Carmel to Dolphin Street and into the stream. A camera survey was carried out on this shore and it was found to be blocked under private property. It is proposed to resurface the N66 Athenry Road this year and provision of a new surface water sewer on the Athenry Road and dolphin street is included in the works contract.

Blue Flag

Cllr. Maher complemented the Environment Section on the launch earlier today of the "Discover Beaches" brochure which included the loughrea Long Point.

Tidy Towns

Cllrs. Regan and G. Burke complemented all involved in securing this year's improved results and Cllr. G. Burke proposed an official letter of appreciation issue to the Committee. Cllr. Gunter-Nix

thanked Mr. Mulryan and Ms. Baker for their contribution and Cllr. G. Burke said the Fair Green and Long Point was like a lawn this year and that it hasn't looked as well for years.

In relation to the voluntary assistance, Mr. Cullen commented on their benefit during constrained budget times. The benefits and assistance we get from the voluntary sector and by taking ownership transform the effectiveness, particularly in environmental improvement. Mr. Cullen stated that the voluntary contribution is very strong in Loughrea and he hopes it continues and grows.

Cllr. G. Bane acknowledged the increase in marks this year and congratulated all involved. She said a core group of volunteers go out in all types of weather and a lot of people work individually also. Referring to Killarney where there is a mosaic covering and linking all the active groups including Chamber of Commerce, Triathlon Club, Tidy Towns, Lions Club, County Council and Town Council for a joint effort. She said this could push Loughrea to meet its potential. She proposed that we should officially write to them to congratulate them as a group on the mark that was achieved.

Cllr. Regan also proposed that the Local Authority come together with the committee and examine the documentation with a view to improving the result again in 2012. Cllr. Gunter-Nix supported this idea and suggested that the Tidy Towns group could be nominated under the Mayoral Awards 2011. Cllr. Maher supported the idea of a joined –up group with representatives from each of the authorities who might only meet every few months but that is what is needed to get to the next level and to win the Tidy Town's award.

Smarter Travel

In reply to Cllr. G. Burke, Mr. Finn stated an allocation of €150,000 was received under the jobs initiative and in support of smarter travel bid. This allocation is for a submission to improve the traffic and pedestrian movements at the school, Cross Street, Moore Street, Woodford Road junction. This has a tight timeframe and must be completed this year. A second submission for €100,000 was made for walking/cycling initiatives, speed ramps etc. and this is specific to the Smarter Travel Bid. We have made a submission for funding works at Mount Carmel to take the HGV's out of the residential areas and Coscarrig Area. We have included the provision of speed cushions on residential roads and around the school in the proposal. The objective is to encourage people, including children to walk or cycle.

In reply to ClIr. Bane's question on works at the schools, Mr. Finn stated the objective was to make the junction more accessible for children and children supervised by adults to walk to school, or at least to be dropped off and walk the final section to school. Traffic Lights are included in the Smarter Travel bid and may be considered but we are concerned that they could cause a backlog at peak times while a roundabout would favour traffic but not pedestrians. Finally we are considering maintaining the junction priority as it is at present but with improvements such as raised crossings for pedestrians. Mr. Finn stated that key to the proposal is that Moore Street must be made oneway. In reply to Clir. Bane Mr. Finn stated that we would have preferred to have had the works carried out during the school closure times but due to the late allocation of funds works will have to be carried out during the school term but it is intended works will not commence until after 9.30 a.m. and discussion will take place between the Local Authorities, School Management Board and Residents.

Cllr. Hynes stated he favoured provision of a footpath at the Swimming Pool site to link the old N6 with the two housing estates to facilitate access to shops. He said that many people in this area have no cars and that it is a long walk down the Old Galway Road and out the Athenry Road. This formed part of the submission on Smarter Travel. Cllr. G. Burke supports the idea of a walkway but noted it would require lighting also. Upon request, Mr. Finn stated that he would provide a cost estimate for such a footpath to provide pedestrian access from the residential area out onto the old N6. He stated that this cost estimate would also include for a crossing facility on the old N6 as it is important

that if we provide a footpath we must also include a safe crossing facility as at present it will lead directly out onto the hard shoulder of the old N6.

Clir. Nix asked if bicycle stands could be provided and considers the car parks beside the flower features would be a suitable location.

air Green

Cllr. Bane referred to a section of the Fair Green which remains unfinished. Mr. Finn stated that a contractor has been awarded the works and it will be completed when the weather is favourable and certainly within the next few weeks.

Mr. Finn informed the Meeting that Mr. Mulryan met representatives of the Tennis Club and hopes to receive funding for a programme of works to include fencing and lighting under the Sports Capital Project. He stated a separate grant is expected for up-grade works e.g. toilets at the Long Point.

All correspondence received since the last Meeting had been circulated to the members. Items discussed and decisions taken are as follows:

Family Fun Rubbish Day

Cllr. Nix stated a Family Fun day is being organised by the Tidy Towns on Sunday from 2.00 to 5.00 p.m. on Sunday 18th September in the Fair Green – no entry fee.

Botharín Cam

Cllr. G. Burke stated this road is in very bad repair and asked that it be examined in connection with Smarter Travel. He said speed ramps would be desirable near the back gates to St. Raphael's and perhaps a one-way system also.

Cllr. Gunter-Nix stated a light is required at the end of BotharIn-Cam at Bride Street.

Signage

Cllr. G. Burke stated the signage around the town needs attention as signs are bent and facing in the wrong direction. Mr. Finn will check out same.

Public Lighting

Cllr. Maher stated that a number of Public Lights are out of order. Mr. Finn will ask Area Engineer to follow up on this matter.

Gullies

Cllr. Maher asked if drains and gullies could be cleaned in advance of the wet weather. Mr. Finn stated it is normal practice to clear gullies in the Autumn after the leaves have fallen.

St. Brendan's Court

Cllr. Maher stated it is very dangerous exiting the Estate and asked if either the pillars could be lowered or a yellow box painted on the road. Mr. Finn will examine.

Ros an Óir Estate

Cllr. Maher said residents are unable to park there as other people use the estate as a car park and suggested the "Pay Parking" be extended. Mr. Cullen said the estate is private property.

Bus Bays

Cllr. Regan asked if the Bus Stop areas on Main Street could be highlighted in a different colour similar to Ballinasloe to prevent cars parking there. He also stated there is a problem with lorries mounting the footpaths on Main Street at Pat Loughnanes and Martin Dolans.

Abbey Street

Cllr. Bane stated that there is no regard for speed limits at the top of Abbey Lane where there are some new businesses and asked if it could be pedestrianised under Smarter Travel. Mr. Finn said this can be examined when the water-main is complete.

Lake Road

Cllr. Bane acknowledged the improvements carried out on Lake Road and asked if proposals for a walkway around the lake could be advanced.

Cllr. Hynes stated that the Galway Rural Development fund such projects and now might be the opportune time to advance the project.

Cilr. Maher stated that matching funding is required.

Grange

Cllr. Regan asked if a section at Grange could be piped as it is in a dangerous state. Cllr. Maher stated this would require Notice of Motion funding.

Cllr. G. Burke asked that Cusack's Botharín on the town side of Caherlavine Roundabout be considered under the hedge cutting Programme

Cllr. Maher complimented the Council for completing the works on the manhole cover on Main Street. He stated there were a few manhole covers around the town that the Council might look at that were also noisy.

Drain outside Dr. Flaherty's Surgery

Cllr. S. Burke asked if there was any update on the outdoor activities on the Lake. Cllr. Maher stated he hadn't heard anything but presumed it was not ruled out.

Bins, Barrack Street Car Park, Loughrea

Cllr. Regan asked if there was any update on the bins. Cllr. Maher stated it was ongoing.

Hazelwood Housing Estate, Cosmona

Cllr. Maher asked if anything could be done with the entrance to Hazelwood Housing Estate at Cosmona as it was a death trap due to a wall which is built out on your sight line. Mr. Raftery said this is due to the house on the left. Mr. Cullen stated this was a private estate so there was not much that could be done.
