## 2. Presentation from Jim Murren, Western Regional Director, IDA.

Mr. Murren outlined the workings, policies and strategies of the IDA in Ireland since its inception in 1970. With specific regard to Galway and the West of Ireland he expressed the IDA's continuous commitment to development in the Region. While a number of incentives are in place to attract investors, he advised that the client makes the sole decision with regards to location. The most important sectors in Galway were the Medical Technology and ICT Sector of which there had been 12 new investments in Galway last year. With specific regard to Loughrea, he advised that the Cigna Property site of 30,000 square feet was a major piece of infrastructure in Loughrea, but needed to find the client to suit same.

Cllr. Hynes suggested that perhaps the breaking of the Cigna Property into smaller units should be considered. Mr. Murren recommended that the property should be left as is for the foreseeable future.

Cllr. Bane queried the situation regarding Strategic Investment Location Site in Athenry and the monies being spent on same. Mr. Murren advised that while no clients had been identified for this locale, that the IDA would proceed with developing this location.

Ms. Moloney, Galway County Manager addressed the meeting. She advised that from her previous visit two years hence, many changes had happened in Galway County Council because of the adverse economic position of the County. However, even with the scarcity of staff and financial resources of the Council, projects were still progressing in the County, ie the upgrade to the Waste Water Treatment Plant along with the upgrade to the Loughrea Water Scheme and the extension to same. With regards to the Roads Infrastructure, the M6 would play a huge part into opening up accessibility to Loughrea and its environs with regards to Tourism potential for the area. She gave praise to the

work of the Tidy Towns Committee for their excellent work with ensuring the entrances to the town and the town itself always looked so well.

Ms. Moloney advised that the Loughrea Town Development Plan was being prepared in conjunction with a Core Strategy which would look at developing areas of tourism in rural areas, along with looking into assessing previous zoning decisions and amending same.

She acknowledged that the lack of response regarding Smarter Travel was very disappointing as it could have signalled Loughrea Town as a modern progressive centre for the future.

Cllr Regan recommended that the Footpaths Programme be carried out at an earlier time in the year, as by leaving until later in the year, works were being hampered by bad weather conditions. With regard to the issue of Pots being used instead of Bollards on Moore Street, it was agreed that due to the volumes of traffic using the road and the safety implications to pedestrians, to monitor the situation and if necessary, the bollards could be put in place.

© That the muck and rubbish be removed on a regular basis from all surface water shores throughout Loughrea Town so as to reduce the harm caused by flooding on our streets. Seconded by Cllr. Sylvia Burke

#### 4. Any Other Business

#### Potholes

The issue of potholes on Mount Carmel Crescent was raised and whether a ban could be put on large vehicles using the main street. Mr. Raftery advised that while a sign can be put in place, it is not enforceable as the An Garda Siochana don't have access to a Weighbridge. The only legal route to follow is to consider an Axle Ban in the Town.

#### Railing at Garrybreeda

Mr. Cullen advised that these works were important to the Town Council from a safety point of view and would commence prior to the end of the year.

Cllr. Maher wished all present Best Wishes for the Christmas and the New Year. He complimented all on their work on behalf of Loughrea Town Council during 2010.

## Matters Arising from Minutes of 11th October, 2010

#### Traffic Lights, Westbridge

All Councillors were complimentary of works completed on this project and that the lights were a great addition to the town with regard to traffic and pedestrian safety.

#### Loughrea Swimming Pool

Mr. Cullen stated that no reply had been received from the Promoter to a council letter of 14<sup>th</sup> September. A further letter had issued on the 8<sup>th</sup> November requesting a decision to be made by 31<sup>st</sup> Dec. Cllr. Burke stated that he had talked to the promoter and had been advised that a positive letter was on its way to Galway County Council. Cllr. Burke also stated that the accounts of the committee are audited on an annual basis and that the Accounts are placed in the local Library on a permanent basis for inspection. ## Matters Arising from Minutes of 13th September 2010

Traffic Lights, Westbridge

Cllr. Maher asked about the current status of Traffic Lights at Westbridge. Mr. Raftery stated that the road surfacing and road markings were now completed. Galway County Council is awaiting the ESB to connect. All relevant forms/fees have been issued to the ESB. Once the connection is made, the Contractor will come back to finalise job.

Cllr Regan also commented on the urgency to complete work as the junction was especially dangerous for pedestrians.

Election of the Mayor

Cllr Morgan asked for clarification regarding the election of the Mayor. Mr. Cullen reiterated that on the night of the Annual Town Council Meeting, the Mayor was elected and that was what the Meeting intended. He stated that he had no further advice to offer the Council on this matter.

Loughrea Swimming Pool

Cllr. Hynes asked for update. Mr. Cullen stated that the council had written to the Promoter of the Pool on the 14<sup>th</sup> September seeking clarification on a number of issues. However, no reply had been received to date.

#### Stony Brennan Plaque

Cllr. Maher stated that he had spoken to the owner of the Building on which the Plaque originally resided (Mr. Sweeney) and he said that he would be willing to fund the cost of putting the Plaque on a Plinth.

#### **IDA Invite**

Cllr Nix asked whether an invite had issued to the IDA. It was confirmed that Mr. Jim Murren, West Regional Manager IDA had accepted invite and confirmed that he will attend the November Town Council Meeting.

#### Tourism Initiative for Loughrea

Cllr Nix asked as to whether contact was made with Ireland West Tourism. It was agreed to contact them to see if Loughrea was included in their plan.

#### 2 Correspondence

- Letter from Monaghan Town Council that Member adopted the following "that this Council deplores the proposal by ESB to increase charges by almost 5% at a time when the wholesale cost of same has been reduced by 2%". This was proposed by Cllr Morgan and seconded by Cllr Bane.
- Letter from Clones Town Council "for a review of the application of the Habitual Residence Condition for social welfare claimants...". Cllr Hynes proposed this motion. He stated that this condition made it very hard on persons returning from abroad to look after elderly relatives to claim the Carers Allowance. Cllr Bane stated that there is an Appeals System in place for such situations. Cllr Morgan also agreed that this is a complex situation. There was no seconding of this proposal.
- Letter from Daithi Mhac Eireannach regarding organising a benefit dance for Galway Hospice. He requested coming in to address the Town Council. It was agreed that the letter be marked as read and to wish him well in the benefit, but to let him know that Loughrea Town Council are not in a position to fund same at present.
- Memo re Cas
- ual Trading. Proposed by Cllr Morgan and seconded by Cllr Maher.

## 3. Notice of Motion – Cllr. Gunther Nix

(a) "That a portion of the monies collected in Loughrea for paid parking be allocated for amenity use in the town".

It was proposed by Cllr. Gunther Nix and seconded by Cllr Maher. Mr. Cullen stated that while the monies collected were in Loughrea, the persons paying said monies were from many different districts and as such the Car Parking monies are not specifically monies generated in Loughrea from Loughrea people. Mr Cullen stated that while Galway County Council did financially support all Tidy Town Associations through the Community and Enterprise Section, he agreed that the Tidy Towns Association was in need of additional financial support. He suggested allocating additional monies from Loughrea Town Council when preparing the estimates for the 2011 Budget.

(b) "That Loughrea Town Council seeks funding from Galway County Council, in their budget provisions for 2011, to replace the dangerous and defective railing at Garrybreda Park".

It was proposed by Cllr Gunther Nix and seconded by Cllr. Morgan. Mr. Raftery stated that he had gotten a price to fix same which came in at €5,000, which was prohibitively high. Mr. Cullen stated that it was necessary to determine if this was the liability of the Loughrea Town Council and if so the works would have to be carried out and this was agreed because of the Health and Safety implications.

#### 4. Notice of Motion - Cllr, N. Morgan

(a) "That a recommendation be sent to Galway County Council to provide adequate shores in appropriate positions on Mount Carmel Road, Loughrea, where flooding occurs whenever it rains, causing a hazard to motorist and pedestrians attending the Adult Education Centre and the Carmelite Abbey Church"

It was proposed by Cllr. Morgan and Seconded by Cllr. Maher. Mr. Raftery stated that a new surface water pipe was needed at this location. A request had been made to the OPW for funding, however, they've stated that this is a drainage issue and there is currently no funding available for these works.

(b) "That Galway County Council be requested to state who is responsible for removing the tree branches, bushes or other growth which is blocking a full view of road signage by motorists, and take appropriate action"

Proposed by Cllr Morgan and seconded by Cllr Burke. Mr. Cullen stated that it is the responsibility of each landowner. Mr. Raftery stated that in case of Health and Safety concerns, that the Council has the power to remove anything that impairs the full view of the road signage.

(c) That Galway County Council be requested to arrange to have the remaining ivy on the Garrybreeda Old Church ruin removed and the stonework pointed. Its importance is that Garrybreeda was a religious site in the year 1160, and in relation to Loughrea Town Castle 1243 and the Carmelite Monks settlement in Loughrea in 1300, Garrybreeda is a site of major historical and archaeological importance in Loughrea. Galway County Council may consider asking the Board of Works for financial support.

Proposed by Cllr Norman. Not seconded.

#### 5. Any Other Business

Resurfacing of Gort Road

Cllr Regan asked for an update on the resurfacing of the Gort Road. Mr. Raftery stated the Contract for same has been signed. An amount of €300k was allocated for the project. The site has now been handed over to the Contractor and they are expected on site shortly. It is expected to be completed by the end of November.

Cllr Regan wanted to know if the road will be raised to avoid the flooding problems of last year. Mr Raftery stated that the raising of the road would have implications on the houses in the area and because of this the road was to be left at the same levels.

Cllr Bane asked where works would commence and end. Mr Raftery stated it was to start from Chartbuster and end at Coscarraig. Cllr Hynes and Morgan stated that this was very positive for the town.

Paid Parking in Loughrea

Cllr. Regan suggested free Car Parking in Long Term Car Parks up until 12 on a Saturday morning to accommodate persons leaving cars overnight. This was seconded by Cllr. Bane. Mr. Cullen agreed that this was an issue that needed some leeway. He stated that this issue is to be discussed at the next Management Team Meeting in Galway County Council and he will revert back re same.

Visit by County Manager, Martina Maloney

Cllr. Maher stated that an invite had issued to the County Manager to attend the next Town Council Meeting.

#### **Local Honours**

Cllr. Maher proposed that at the next meeting he would like to set aside some time to honour the following for their contribution to Loughrea Town: Mr. Barry Shiel, Loughrea Fire Brigade and Mr. J. Fitzgerald. This was seconded by Cllr. Morgan. Cllr. Morgan to provide Scrolls for presentation on the night.

#### Cash for Cans

Cllr. Gunther Nix asked if this Scheme which is operational in Galway City could be ran in Loughrea Town as a project for Transition Year Students. Mr. Cullen stated that because of the compactness of Galway City and its level of collection points that it is probably more suited to the larger urban areas. He also stated that the Waste Management Policy of Galway County Council would prohibit competing with the private Waste Contractors. However, he stated that he would look into the issue further.

#### Smart Travel.

Jim Cullen stated that no response had been received on our application to date.

#### **Tidy Towns**

Cllr Maher thanked Galway County Council for the use of its machinery in aiding the work of the Tidy towns Association. Cllr Gunther Nix informed the meeting of a Fundraising Walk in aid of the Tidy towns to be held on the 23<sup>rd</sup> October.

#### Tribute

## Matters Arising from Minutes of 12th July 2010

## Correspondence from Cllr. Morgan raised at last Meeting

Cllr. Morgan referred to correspondence that he had requested to be circulated at the July Meeting in relation to proceedings of the Annual Meeting and asked for Mr. Cullen to comment on same.

Mr. Cullen stated the proceedings of the Annual Town Council Meeting took place in a particular manner and the Mayor was duly elected. He said that everything that happened there and subsequently was perfectly valid.

Cllr. Morgan stated that certain aspects of the proceedings at that meeting were not legal or valid.

Cllr. Maher stated that Cllr. Morgan should have raised this matter on the night of the Annual Meeting. He said that he was disappointed with Cllr. Morgan in how he brought up the issue, gave no advance warning of same and on the night when Mr. Cullen was not in attendance to advise on same. Cllr. Regan stated that this type of unnecessary action was giving the town bad publicity. Cllr. Gunter-Nix stated that Cllr. Maher was the unanimous choice of the Members as Mayor and it was very infantile of any member to take this attitude. She said that they should be working together for the benefit of the town. Cllr. Maher stated that the query had been answered by Mr. Cullen and he asked that the Media would not report on the matter in the local press.

#### 3. Notice of Motion – Cllr. Curley

(a) "The revival of the Loughrea Seven Springs Festival. This festival successfully ran in Loughrea from 1970 to 1985 attracting large crowds of people. In the process it provided a boost to the economy of the town as well as great entertainment. Every town has its festival – the Athenry medieval festival, the Ballinasloe Fair, the Gort Brazilian festival. The Seven Springs Festival could run in conjunction with the heritage week and coincide with the Athletic Club 10km road race, thus providing a family focused festival week in Loughrea, with something to cater for all ages."

It was proposed by Cllr. Curley, seconded by Cllr. Maher. Cllr. Curley stated that Loughrea was one of the few towns that did not have an annual festival and he said that the revival of the Seven Springs festival would be a great boost for the town of Loughrea. He referred to the recent Summer Rally hosted by Loughrea and commented on the amount of business it had generated for the town. He suggested that other organizations in the town such as the Chamber of Commerce, the Lions Club, the G.A.A., etc. could all be involved. Cllr. Regan stated that he fully supported this proposal and suggested that a public meeting be called asking all interested parties to attend and this would determine the interest in it and where it should go from there.

(b) "That Stony Brennan is returned to his rightful place at the Westbridge, looking across at the Old Town Moat. He is part of our heritage and should be there for all to see if for no other reason to remind us where we came from. Additionally, in relation to my first point, he was always a central part of the Seven Springs Festival. People of Loughrea want him returned as was promised at the time of the redevelopment of the Westbridge area."

It was proposed by Cllr. Curley, seconded by Cllr. Morgan. Cllr. Curley stated that the Stony Brennan plaque was removed during redevelopment of the Westbridge area and it should be returned back there. It was agreed by the Members that contact be made with the owners of the building to come to an agreement as to where it can be erected.

(c) That an update be provided in relation to the commencement of works on the Loughrea Swimming Pool. Many representations have been made in relation to the funding-raising carried out in 1996 querying what has happened with this money; what stage is the process at; how much money has been collected; who has control over the money; has any of it being spent and if so on what? There seems to be a lack of communication and information to the general public on this issue?

It was proposed by Cllr. Curley, seconded by Cllr. S. Burke. Cllr. Maher stated that at a recent Area Meeting, the Members were advised that planning permission for the pool had recently expired and the Council would be seeking confirmation from the proposed developer that the swimming pool development was still going ahead.

Cllr. Regan and other Members stated that they were shocked to hear that the planning permission had expired and queried why they were not made aware of same. Mr. Cullen said that this matter had been raised on many occasions. He said that he advised the members previously that the developer had been written to stating that the planning permission was about to expire and asking him what his plans were to which they had not received a comprehensive reply as yet. He said that further correspondence was being sent in the coming week asking him if he was going ahead and if so, to set out a project time-frame for it. In relation to the monies raised, he said that the Swimming Pool Committee had filed their audited accounts each year and which were available for public viewing and there could not be the slightest question in relation to everything being above board. He said that the Council had always been supportive of this proposal and had done all that was required on their part.

## 4. Notice of Motion - Cllr. Mary Gunter-Nix

(a) That Town Council Delegates to any Conference or Seminar furnish a summary to this Council on items discussed and issues raised, as required by Local Government Act – Section 142.

It was proposed by Cllr. Gunter-Nix, seconded by Cllr. Bane. Cllr. Gunter-Nix stated that this was a requirement of the Local Government Act and said that it was a reminder of members attending conferences to furnish the members with a summary. Cllrs. Regan & Curley stated that they would have a summary of the recent AMAI conference attended by them available for the next meeting.

(b) That Loughrea Town Council joins with other stake holders in town to plan a Tourism initiative for the town and its environs.

It was proposed by Cllr. Gunter-Nix, seconded by Cllr. Maher. Cllr. Gunter-Nix stated that Loughrea Town has never really capitalized nor highlighted its unique heritage and was unknown to the wider tourist world. She said that other towns were ahead of Loughrea in terms of tourism. She said that they needed to highlight what they had in Loughrea and promote it.

(c) That this Council invites the IDA to address a forthcoming Town Council Meeting on their attempts to attract/employment to the town.

It was proposed by Cllr. Gunter-Nix, seconded by Cllr. Curley. Cllr. Gunter-Nix stated that the number of people on the live register in Loughrea was now at 2,700 and it was important to find out from the I.D.A. what efforts have been made to try and attract industry into the town. Mr. Cullen advised that the I.D.A. would be written to and asked to attend a future meeting of the Town Council.

#### 5. Any Other Business

#### **Derelict Buildings**

Cllr. Maher stated that there were slates coming off the roof of the house beside the Town Hall on Church Street. Mr. Cullen stated that the owner of the house has been written to and notice has been served.

Cllr. Regan queried how many Council houses in Loughrea town were vacant at present. Mr. Cullen said that he would make enquiries with the Housing Section in advance of the next meeting.

#### Cleaning of Gullies

Cllr. Maher stated that gullies around the town were being blocked up with litter, debris and leaves and asked that they be cleared out so as to avoid unnecessary flooding. Mr. Raftery advised that some had already been cleared but would continue to monitor them.

#### **Casual Trading**

Cllr. Maher asked for the update in relation to the proposed moving of the Casual Trading Area to the Main Street Car-Park. Mr. Cullen stated that there was a delay in implementing the Casual Trading Bye-Laws countywide and would have an update in advance of the next meeting.

#### Town Hall

Cllr. Maher said he was asked to enquire what exactly would have to be done to enable the Council to hand over the Town Hall to a group/committee/organisation. Mr. Cullen stated that it was his understanding that there was some proposal emerging that was going to come forward to the Council for consideration. He said that the Council would be happy to work with any group that had the necessary finance available to undertake such a project.

#### Galway Motor Club

Cllr. Curley proposed that a letter be sent to the Galway Motor Club to highlight how beneficial the recent summer rally was to the town of Loughrea. This was seconded by Cllr. Maher. Cllr. Regan also proposed that a letter be sent to the organisers of the Loughrea Sprint Triathlon held in Loughrea which was very successful and very well organised.

#### Litter Pick

Cllr. Maher referred to a recent litter pick carried out in a car-park in town in which two bags of rubbish were found. He advised that there was evidence in the bags which would

allow prosecution to take place but when the Community Warden on duty was asked to remove the bags, he advised that it was not his area and he would report it to the local office the following Monday. Cllr. Maher said that it was very frustrating for the Tidy Towns Committee because when the bags were eventually collected, the evidence was destroyed at that stage. Mr. Cullen advised that this matter would be addressed.

#### Traffic Lights, Westbridge

Cllr. Regan queried when the traffic lights on Westbridge would be in working order. Mr. Raftery advised that the application for connection had gone to the ESB and they were waiting for the connection to be completed. He further advised that the surface at this junction would be done in the coming days and marking/lining would be carried out shortly after.

#### Drainage Works at Fitzy's Corner

Cllr. Regan queried what works were being carried out in order to prevent the flooding problems that occurred at Fitzy's Corner/Woodford Road last winter. Mr. Raftery advised that they were going to carry out more maintenance and redirect the flow of water around the town and the main works would be concentrated on Cross Street. He said that the proposal was sent to the Parks & Wildlife Section for their comments.

The Meeting opened with prayer.

Cllr. Norman Morgan presented the meeting with a letter which was read out by Lorraine Cooney, Clerical Officer it stated the following:

"At the Annual Meeting of Loughrea Town Council, held on 21<sup>st</sup> June 2010, in the County Council Offices, Barrack Street, Loughrea, I, Cllr. Norman Morgan, an Elected Member of Loughrea Town Council, for 38 years, proposed Cllr. Michael Maher for the position of Mayor. This I did after outgoing Mayor Pat Hynes stated "We'll get on to the next item – the election of Mayor".

After I had made the above proposal Mayor Hynes said "I'll now say a few words," and he went on to thank those who had helped him in his year as Mayor.

Next he said that he was "Adjourning the meeting for fives minutes, as a mark of respect to the late Mrs. Donohue", and he left the meeting. This was contrary to the 'accepted practice' of "Observing a minute's silence," in all such events.

When Mayor Hynes returned he, improperly, asked for proposals for Mayor. As I had already proposed Cllr. Michael Maher, it was Mayor Hynes' duty to say "Cllr. Morgan has proposed Cllr. Maher for Mayor, do I have a seconder." Instead, he cast aside my proposal and took an identical proposal from his friend, Cllr. Jimmy Curley.

All Cllrs. have a right to propose and Mayor Hynes, or any other Mayor, has no authority to deny any elected Cllr. his or her rights.

It should be noted that a Mayor may not properly adjourn a meeting; he or she is obliged to propose that an adjournment take place, and that the Cllrs. decide by vote. Otherwise, a Mayor may for a personal reason, for no reason, or for any reason, adjourn a meeting.

The legal position is that from the time Mayor Hynes came back from "His Adjournment", what transpired was not legal. It is now required that the meeting in question be reconvened at the point after I, Cllr. Norman Morgan, proposed Cllr. Michael Maher for Mayor.

Be it known to the Elected Members of Loughrea Town Council, that I, Cllr. Norman Morgan, am obliged to do everything in my power to restore to all Loughrea Town Cllrs., the rights legally conferred on them by the Voters of Loughrea."

She also referred to the open area at the Lake at the entrance to the car-park on the Gort Road where there are a number of metal barriers stored. Mr. Raftery stated that that the drains referred to in the Walks had been inspected by an Inspector from the O.P.W. in recent times and stated that an application for funding had been made.

After a discussion on problems of under-age drinking/littering, etc at the Walks and the Long Point, it was agreed to raise the issue at the next J.P.C. Meeting due to be held in June.

#### Railing at Garrybreeda

Cllr. Gunter-Nix stated that a section of the railing at the play area in Garrybreeda was broken and required replacement. She asked that the matter be addressed as soon as possible.

#### Athenry Road, Loughrea

Cllr. G. Burke queried if a DBM surface was going to be laid on the section of the Athenry Road where the water main was recently laid and referred to the poor road surface there presently. Mr. Raftery stated that a submission had been made to the N.R.A. for funding of same but no allocation had been made as yet.

## Loughrea Smarter Travel Bid

Cllr. G. Burke asked what was the up-to-date in relation to the Loughrea Smarter Travel Bid. Mr. Cullen advised that the application had been made and it has been broadly supported by the vast majority of people in Loughrea. He advised that Consultants appointed by the Department were meeting Members of the Loughrea Smarter Travel Forum next week and interviews would be taking place the following week. He advised that a copy of the bid would be circulated to each Member in the next few days.

Cllr. Gunter-Nix complimented the Forum on getting the submission completed in a very short length of time and on the great job done. She proposed that a letter of thanks be sent to Mr. Owens who put so much work into the project. This was seconded by Cllr. S. Burke.

# **Potholes**

Cllr. Maher referred to the condition of Mount Carmel Crescent Road and Abbey Terrace. Mr. Raftery advised that patching would not be adequate to address the potholes at Mount Carmel Crescent and they would have to be dug out and reconstructed. He stated that if monies were left over from the jobs that had been approved they would try and repair them.

## Signage for Loughrea Town

Cllr. G. Burke requested that more signage for Loughrea Town be erected on the motorway and the link road into Loughrea Town. He used the example of Ballinasloe Town that had signs indicating Ballinasloe East and Ballinasloe West and asked if something similar could be done for Loughrea. Mr. Raftery stated the N.R.A. was responsible for such signage and he would request extra signage for Loughrea. Cllr. Regan stated that lake was an asset that Loughrea town has and it was not being sold as a tourist attraction. Mr. Cullen advised that the N.R.A. only erected standard direction signs on motorways and they operated to very specific regulations regarding signage.

## Set Date for Annual General Meeting

It was agreed that the Annual General Meeting would be held following the J.P.C. Meeting at 6.30 p.m. on the 21<sup>st</sup> June 2010 and the June Monthly Meeting would follow immediately after the A.G.M.

## DEPUTATION FROM FRANK MITCHELL & MICHAEL MAHON

Cllr. G. Burke stated that Naomh Brendain Credit Union are holding a meeting Thursday night regarding the Town Hall and that something would be out on display in the next 4-6 weeks as to what their proposal for the Town Hall would be.

Cllr. Maher suggested that all the Voluntary Groups come together to see what could be done with the building and unless it was a viable proposal it would never get off the ground.

Mr. Raftery stated that he would focus on getting the building secured and look at basic repairs but he had no funding as the Town Maintenance funding was not even enough to keep the basics in the town done.

The deputation then left the meeting.

#### Gort Road

Cllr. Bane stated that she had queries from residents on the Gort Road regarding planned works for the Gort Road. He advised that Galway County Council would be commencing survey works followed by design works for this road. Contract Documents would then be prepared and the resultant tenders assessed and a suitable Contractor appointed to undertake the works. He stated the extent of the works would involve drainage works, road surfacing and footpath construction. In relation to how far out the Gort Road these works would go, Mr. Raftery advised that it depended on the tender prices received for the job. He advised that the allocation had to be spent by November and the works would have to be complete at that stage.

Cllr. Curley queried if works at the junction of Courthouse road was included in this proposal. Mr. Raftery advised that there was currently a difference in road levels at the junction and this was due to the Gort Road having to be raised due to the floods and it was therefore closed to deal with these differences in levels. He stated that it was proposed to reopen this road once the Gort Road was improved and to revert back to the original traffic layout. However, he advised that only the junction would be included in these works.

# **Bottle Banks**

Cllr. Maher queried if there was information in relation to how many litter fines were issued at the Bottle Banks at Station Road in recent times and how many had been paid to-date. Mr. Cullen advised that the information would be forwarded to Cllr. Maher.

Mr. Owens referred to report circulated to the Members and outlined the background to the National Competition for Smarter Travel Areas. He said that the Stage 1 Bid for Loughrea Smarter Travel Town provided for the development of a range of infrastructural and promotional measures to achieve a significant change in travel behaviour in Loughrea with a particular emphasis on measures to promote walking and cycling. He said the key element of the bid was the development of a new sustainable transportation corridor with design emphasis on segregated high premium cycling and walking facilities, providing direct, safe and high quality access to Loughrea's educational sector. He outlined the key goals contained in the Vision for Sustainability in Transport; the criteria for Stage 1 selections; the bids shortlisted to Stage II; scoring system for Stage II; Stage II criteria; the key high level measures proposed; and timeframe for the development of the Stage II Bid. He explained that the preparation of Stage II Bid would involve an extensive public information and consultation process to ensure the bid benefits from and reflects the input of all the relevant stakeholders. In this regard and to facilitate the local community and stakeholders in actively participating in the preparation of the Stage II Bid, he said it was proposed to establish the Loughrea Smarter Travel Forum. He said it was intended the membership of the Forum would include representatives of all the key stakeholders including Electoral Members from the Loughrea Electoral Area and Loughrea Town Council, Roads & Transportation SPC,

Loughrea Chamber of Commerce, Loughrea Community Forum, local employers, Educational Sector, Sports Clubs, An Garda Síochána. He also advised that it was proposed that an Elected Member from the Loughrea Electoral Area would serve as Chair of the Forum. He informed the Members that the Stage II Bid must be submitted by the end of April and funding for the successful bids would be from July 2010 to 2015. Mr. Owens stated that the overall budget for the successful bids was €50m. The Loughrea Bid, if successful, would mean funding of €5m with matching contribution of €1m. He said that the Department were providing funding of €50,000 for appointment of Consultants who will assist the Council in preparation of the bid. He said that he looked forward to coming back to the Members in April for a presentation on the Stage II Bid.

Mayor Hynes thanked Mr. Owens for his very comprehensive and detailed presentation to the Members. He congratulated and complimented the staff for including and getting Loughrea to the next stage of the competition and acknowledged that there was still a lot of work to be done. He said that it would be a wonderful project for the area if successful and would be immense benefit for the area. He said this project will have the support of all the Councillors here. Cllr. G. Burke asked what ideas they had in mind for inclusion in the plan. Mr. Owens stated that included in Stage 1 was a list of high level measures, some of which included the development of new transportation corridor; looking at options of putting in cycle lanes; development of a transportation node that will serve as an area for taxis; bicycle park, etc.; community cycle training programme; review of speed limits. He said that in the Stage II bid it was proposed to broaden this out and any additional new areas can also be included. Cllr. G. Burke asked that a copy of the Stage I bid would be circulated to the Members. Mr. Owens agreed that this would be circulated to the Members in advance of the next meeting. He said that it was intended that there would be a number of public meetings held between now and April. The consultants being employed would be reviewing the measures included in Stage I and would develop these further. Cllr. Bane said the possibility of having €5m invested in the town was very exciting and a huge possibility. She said she hoped the Forum would be successful as from previous experience, lack of information creates problems and it was important to keep the public informed. Cllr. Regan stated that the possibility of €5m in the town has to be welcomed, the Forum gave the opportunity for everyone to be involved and this was good news for Loughrea. In response to Cllr. Morgan, Mr. Owens stated that the total funding being allocated was €50m and there would be in the region of 3/4 successful bids and the final number of successful bids would depend on the value that the bids come in at. Mr. Cullen stated that it needed to be emphasised how much time Mr. Owens had put into this and that he really had been the driving force behind this project. He said the aim of the competition was to show how we are going to achieve changes in travel patterns and it had to be obvious we are capable in making change. He said that if the town were to have a chance to win this competition then cross-community grouping agreement is of vital importance. He referred to the interview process which forms part of the selection criteria and stated that what was included in the Bid, there had to be a genuine buy-in to what was being proposed. He said that he was confident that this can be pulled off.

# 3 Correspondence

- Response from Roads & Transportation Unit in relation to Notice raised at last meeting requesting CCTV cameras is installed at Bus Stops on Main Street, Loughrea. Cllr. Morgan stated that he wanted to clarify that funding for the cameras should be made available from the monies taken in the parking meters. Mr. Cullen explained there were a number of issues to be considered. The monies taken in from paid parking are not generated by the people of Loughrea town and therefore the monies cannot be ring-fenced for any particular part of the county. He further explained that the Council has introduced paid parking to significantly increase the amount of parking in the town. He explained that they had to buy and extend Main Street Car-Park and Station Road Car-Park and develop them at a considerable cost. He said loans were raised at the time for this and they were still being paid off. He said there were ongoing maintenance costs such as traffic management; street lining, installation and maintenance of machines, emptying of machines, etc. He said Mr. Lavelle's reply was correct; there are no funds available to meet the cost of provision of CCTV cameras at Bus Stops on Main Street.

## 4 Any Other Business

## **Bottle Banks**

Cllr. Maher stated that the Bottle Banks in Station Road car-park were in a bad state over the past few weeks. He asked that information be supplied in relation to how many fines were issued in the past few weeks and many had been paid to-date.

# Traffic coming off Slip-Road off Motorway

Cllr. G. Burke requested that extra signs for Loughrea Town be put up at Monearmore Roundabout for traffic coming off the slip road from the Motorway. Presently all traffic is directed towards the Cosmona Road to gain access to Loughrea Town. He stated that the Cosmona Road is in a very bad state and requested that extra signs be put in place to direct traffic north and south of the town. He also noted that when travelling from Ballinasloe to Loughrea, there were no signs indicating direction towards Loughrea Town as you exit Ballinasloe Town and asked that these would be put in place. It was agreed to pass on to these requests to the Roads & Transportation Unit.

## **Disabled Parking Bays**

Cllr. Bane stated that the use of Disabled Parking Bays by able-bodied persons had become a problem and had witnessed on many occasions people parking in these spaces who were not entitled to do so. She asked that these bays would be monitored by the Community Warden and the local Gardai would be asked to patrol it and to issue Fixed Charge Notices for those who were not in compliance. Mr. Cullen stated that they would ask the Community Warden to pay particular attention to this.

The Meeting opened with prayer.

# 1 Confirmation of Minutes of Budget Meeting held on 14th December 2009

It was proposed by Cllr. G. Burke, seconded by Cllr. Maher and agreed that the Minutes of the Budget Meeting be adopted.

# 2 Confirmation of Minutes of Monthly Meeting held on 14th December 2009

It was proposed by Cllr. G. Burke, seconded by Cllr. Gunter-Nix and agreed that the Minutes of the Monthly Meeting be adopted.

# Matters Arising from Minutes of 14th December 2009

#### Flooding

Cllr. Bane referred to the condition of the Gort Road which was raised at the last meeting and which has since deteriorated. Mr. Raftery stated that some funding had been secured for improvements on the Gort Road. He advised that a survey of the proposed works was needed, followed by a detailed design and preparation of contract documents. In response to Mayor Hynes regarding requested improvements to Courthouse Road, Mr. Raftery stated that the only works proposed are works which will tie in with the proposed improvements on the Gort Road, therefore the level of works on the Courthouse Road will be minimal at this stage.

Referring to Courthouse Road, Cllr. Bane stated that this road had not been used for through traffic since the flooding in November and people had got used to not using this stretch. Cllr. G. Burke supported this and stated that they should look at other alternatives for this road.

Mr. Raftery stated that they were currently compiling a report in relation to the effects of the flooding in November for the Loughrea area. He stated that between 25/30 roads were badly affected by the flooding in the Loughrea Engineering Area. Cllr. G. Burke stated that the flooding at the entrance to Cannon's Sandpit in Masonbrook was particularly bad. He asked that the Council would examine this to see what can be done to relieve flooding at this location in future and suggested that part of the problem may be due to the water-tables not being opened regularly enough.

## **Swimming Pool**

Cllr. Curley asked if it was still hoped that construction of the swimming pool for Loughrea would commence in February. Cllr. G. Burke said that it was his understanding that it would be commencing in February 2010.

## Traffic Lights at Westbridge

Cllr. Regan queried when works would commence on the proposed traffic lights at Westbridge. Mr. Raftery stated that Outdoor staff was tied up at the moment between manning the distribution of water to households without water and maintenance of potholes on the road network, etc. and that it was hoped that works would commence on this job as soon as weather conditions improved.

#### **Smarter Travel Areas**

In response to Cllr. G. Burke, Mr. Cullen stated that Consultants had not yet been appointed.

## 4 Notice of Motion - Cllr. N. Morgan

(a) That a recommendation be sent to John Gormley, Minister for Local Government, that where houses that were flooded, having been granted Planning Permission by Galway County Council, to build on ground "liable to flooding", that the Council Officials who granted such Planning Permission be dismissed and sued by his, John Gormley's Dept.

It was proposed by Cllr. Morgan. This proposal was not seconded.

(b) That a recommendation be sent to Galway County Council to erect CCTV cameras at the two Bus Stops at Main Street, Loughrea, to stop the almost continuous illegal parking in these said locations; and such be paid from funds collected from the parking meters.

It was proposed by Cllr. Morgan, seconded by Cllr. Maher.

(c) That Mr. Jim Cullen be requested to give a report to Loughrea Town Council on the effects of the flooding in Loughrea Town, including (a) if the bridges were adequate; (b) how the sluice gates were managed at the time; (c) what can be done to reduce such damage in the event of such a recurrence in future. This report could be given at the March Meeting, or as soon as possible after that.

It was proposed by Cllr. Morgan, seconded by Cllr. G. Burke.

Mr. Cullen stated that Mr. Raftery had advised earlier that a report was being compiled in relation to the effects of the flooding that took place in November and listing the roads affected for the Loughrea area.

## 5 Any Other Business

#### Loughrea Lake

Cllr. Morgan referred to an incident which happened on the lake over the weekend where a young girl fell into the lake and was rescued by Gerry McDonnell and his brother-in-law. He complimented the Council for putting up signs advising people not to go out onto the lake and closing the gates at the Long Point which helped prevent further accidents and tragedies from happening. He proposed that the Town Council present a scroll to Gerry McDonnell for his bravery. Councillors stated that it was important to get the message out to the public of the dangers posed with the thaw in place and to appeal to people to stay off the lake. Mr. Cullen said that all they can do was to send out the message that it was dangerous.

# Exit at St. Brendan's Home

Cllr. Maher asked if it were possible to put a safety barrier in place on the Lake Road next to the lake at the exit out of St. Brendan's Home to prevent cars from slipping across the road, especially in frosty weather.

## Ard Breeda Housing Estate, Loughrea

Cllr. G. Burke referred to the very steep slope coming out of Ard Breeda Housing Estate onto the Caheronaun Road, which was particularly dangerous during frosty weather and asked if anything could be done about this problem. Mr. Raftery advised that the

Housing Estate was not in the Council's charge. He agreed that the gradient at this junction was very excessive and stated that a planning application had recently been lodged and part of the application included realignment of this junction, which if granted would help improve the situation there.

## Town Hall Loughrea

Cllr. G. Burke advised the Meeting that it had been announced at the Naomh Brendain Credit Union AGM that Galway County Council had given permission to a committee set up by the Credit Union to invite and seek ideas as to what use could be made of the Town Hall. He said that the Committee was made up of five people and they would be inviting ideas/submissions from groups/companies as to what use can be made for the Town Hall. Any submissions would also have to include proposals as to how they would fund same.

The Members welcomed the announcement and agreed that it was a good concept. They stated that they would support them in whatever direction they go.

#### **Derelict Sites**

Cllr. Maher asked was there a time-frame on property owners whose site/buildings are deemed derelict, to carry out the necessary works. He said that there are a number of properties around the town that are derelict and asked was the onus on the owner to make their site/building safe. Mr. Cullen stated that the issue was covered under legislation and the Environment Section keeps a Derelict Sites Register. He said that they would continue to monitor these sites on an ongoing basis.

## Water Supply

Mr. Cullen advised the Meeting that a big issue for Councils for the next while was water shortages owing to wastage of water and water leakages. He said that the Council has called on all households, businesses and farmers to immediately reduce the amount of water being used.
